FLOOR SCHEDULE AND BILL SUMMARY

<u>H.Res. 907</u> - Rule Providing for consideration of <u>H.R. 4411</u> – Internet Gambling Bill (*Rules*). The Rules Committee has recommended a Rule that provides one hour of general debate, one motion to recommit with or without instructions, and makes in order one amendment.

➤ Berkley/ Wexler/Conyers Amendment (20 minutes). To eliminate the exceptions to the bill's general prohibition against online gambling, thereby establishing a complete ban on all internet gambling-related activities.

H.R. 4411 - Internet Gambling Bill (Rep. Leach/Goodlatte - Financial Services/Judiciary) (Subject to a Rule). This bill was amended in the Rules Committee to include provisions from both Rep. Goodlatte's internet gambling prohibition Judiciary Committee-reported bill (H.R.4777), and Rep. Leach's unlawful internet gambling enforcement Financial Services-reported bill (H.R. 4411). Title I of the combined bill includes the Goodlatte provisions and amends the 1961 Interstate Wire Act to prohibit interstate gambling on the internet, particularly through wireless or cable connections; makes it illegal for gambling businesses to accept credit cards, checks or other bank instruments from customers in connection with unlawful internet gambling; and increases criminal penalties for violating these provisions. The legislation expressly exempts (1) interstate Internet betting on horse racing; (2) intra-state Internet betting on lotteries; (3) intra-tribal Internet betting; and (4) various other forms of intra-state Internet betting. At the same time, the bill prohibits (1) Internet betting on dog racing; (2) Internet betting on jai alai; (3) interstate Internet betting on lotteries; and (4) Internet betting on casino games. Title II of the combined bill includes the Leach provisions adding a new subchapter to Chapter 53 of Title 31 (which deals with monetary transactions) to prohibit persons engaged in a gambling business from knowingly accepting credit, electronic funds transfers, any checks or other similar monetary instruments for unlawful gambling (though this prohibition only defines the types of transactions that are to be blocked by financial institutions under this title and does not provide an additional criminal penalty, which is already provided for under the Goodlatte provisions amending the Wire Act). Title II also requires the Treasury Secretary and the Federal Reserve Board, in consultation with the Attorney General, to prescribe regulations requiring each designated payment system to identify and block restricted gambling transactions through the establishment of policies and procedures; and provides that these requirements shall be enforced exclusively by the Federal functional regulators with respect to the designated payment systems, and the Federal Trade Commission with respect to any payment systems not subject to regulation by any of the functional financial regulators. Title III of the bill requires the Treasury Secretary to submit an annual report to Congress on any deliberations between the U.S. and other countries on issues related to internet gambling.
