1	SECTION 1. DIABETES SCREENING EVALUATION AND OUT-
2	REACH PROGRAM RECOMMENDATIONS.
3	Part P of title III of the Public Health Service Act
4	(42 U.S.C. 280g et seq.) is amended by inserting after
5	section 399V–3 the following new section:
6	"SEC. 399V-3A. DIABETES SCREENING EVALUATION AND
7	OUTREACH PROGRAM RECOMMENDATIONS.
8	"(a) Establishment.—With respect to diabetes
9	screening tests and for the purposes of reducing the num-
10	ber of undiagnosed seniors with diabetes or prediabetes,
11	the Secretary shall—
12	"(1) review utilization of diabetes screening
13	benefits under programs of the Department of
14	Health and Human Services to identify and address
15	any existing problems with regard to such utilization
16	and related data collection mechanisms; and
17	"(2) make recommendations (informed by the
18	review under paragraph (1)) on outreach activities
19	being carried out by the Secretary as of the date of
20	the enactment of this section to ensure awareness
21	among seniors and health care providers of—
22	"(A) such diabetes screening benefits; and
23	"(B) the advantages of knowing one's dia-
24	betic or prediabetic status for the purpose of di-
25	abetes self management.

1	"(b) Consultation.—The Secretary shall carry out
2	this section in consultation with—
3	"(1) the heads of appropriate health agencies
4	and offices in the Department of Health and Human
5	Services; and
6	"(2) entities with an interest in diabetes, in-
7	cluding industry, voluntary health organizations
8	(such as diabetes advocacy groups and other related
9	stakeholders), trade associations, and professional
10	societies.
11	"(c) Report.—For each of the fiscal years 2011,
12	2012, and 2013, the Secretary shall submit to Congress
13	an annual report on the activities carried out under this
14	section during such respective year.
15	"(d) Definition.—For purposes of this section, the
16	term 'senior' means an individual who is at least 65 years
17	of age.".
