## HOUSE ETHICS COMMITTEE INVESTIGATION CLEARS U.S. REPRESENTATIVE CAROLYN CHEEKS KILPATRICK (D-MICH)

#### February 26, 2010

The U.S. House Committee on Standards of Official Conduct ("House Ethics Committee" has just announced that it has completely cleared U.S. Rep. Carolyn C. Kilpatrick (D-Mich.) in its investigation of the attendance, by several Members of the Congressional Black Caucus, of the Carib News Foundation Conference in 2008. The House Ethics Committee fully adopted the finding of an Investigative Subcommittee that Congresswoman Kilpatrick "did not knowingly violate any provision of the House gift rule or other applicable rules of conduct when she accepted payment or reimbursement of travel to the 2008 conference." House Ethics Committee, Investigation Into Officially Connected Travel of House Member to Attend the Carib News Foundation Multinational Business Conferences, 111th Cong., 2d Sess. p. 11 (Feb. 25, 2010)("House Ethics Report"). The House Ethics Report concludes that "Representative Kilpatrick followed the procedures in place at the time for pre-travel approval and did, in fact, receive approval from the Standard Committee....." House Ethics Report, p. 183.

Under its procedural rules, the House Ethics Committee was also required to release a report prepared earlier by the Office of Congressional Ethics ("OCE"), an office set up by the House to review ethics complaints against House Members before they are referred to the Ethics Committee. The OCE Report—as the House Ethics Committee also explained—was improperly conducted, is inaccurate in numerous respects, misapplies the ethics rules and is devoted, in large part, to a 2007 trip that Congresswoman Kilpatrick did not attend and that has nothing to do with her.

Here are the facts relating to the Congresswoman's attendance of the 2008 Carib News Conference and the Ethics Committee investigation of that trip:

House Rules on Privately-Sponsored Travel. At the beginning of the 110<sup>th</sup> Congress (2007), the House adopted new rules about payment of expenses by private companies and organizations for travel by Members of the House. Under the rules, a Member is permitted to accept, from a private source, travel expenses for international travel related to the official duties of the Member—for example, attendance at a meeting or a speaking engagement—for a trip of up to seven days, exclusive of travel time. (House Rule 25, clause 5(b)(1)(A), (b)(4); House Ethics Manual pp. 90, 93 (2008 ed.)). The new rules provide, however, that a Member *cannot* accept travel expenses from an entity that employs or retains registered lobbyists, unless the trip is limited to one day. (House Rule 25, clause 5(b)(1)(C); House Ethics Manual, pp. 92-93).

The rules allow a Member participating in an officially-connected trip to accept travel expenses, from the private source, for one relative. (House Rule 25, clause, 5(b)(4)(D); House Ethics Manual, p. 101).

The new rules also set up a procedure for mandatory advance approval of privately-sponsored travel, by the House Ethics Committee, so that Members can be sure they are complying with the rules. *First*, the private sponsor must fill out, and submit to the Member's office, a "Private Sponsor Travel Certification Form" in which the entity sponsoring the trip must, among other things, certify who is paying the expenses for the trip. *Second*, the Member fills outs a "Privately Sponsored Travel: Traveler Form," providing information about the proposed trip, and attaching the "Private Sponsor" form. *Third*, the Ethics Committee then reviews the information and decides whether to approve the trip; if it does approve, it issues a written approval letter to the Member. *Fourth*, after the trip, the Member must fill out a "Post-Travel Disclosure Form," setting out, among other things, the amount of expenses actually reimbursed by the private sponsor—information the Member is supposed to obtain from the sponsor.

The Carib News Conference and Its Sponsor: Carib News is a weekly newspaper that has been in existence for 28 years, serving the Caribbean –American community. A private foundation established by the publication, the Carib News Foundation, is devoted to strengthening ties between the Caribbean American and African-American communities in the U.S. For the last 13 years, first the company, then the Foundation, have sponsored an annual Caribbean Multi-National Business Conference, bringing together federal and state officials and business leaders from the U.S. and leaders of the Caribbean nations.

Congresswoman Kilpatrick has attended several of the conferences in the past. She did *not* attend the 2007 Conference. In 2008, she was invited, by the leader of the Government of St. Maarten, N.A., to attend and speak at the 2008 Conference, to be held in St. Maarten, from November 6<sup>th</sup> through the 9<sup>th</sup>, 2008. As then-Chair of the Congressional Black Caucus, the Congresswoman was invited to speak at the opening business session, on "Building Alliances for Progress," together with the leader of the St. Maarten Government; and to attend the other workshops and panel presentations, as well as a closed door meeting limited to Members of Congress and Prime Ministers and ministers of Government of several Caribbean nations.

The Congresswoman determined that she would accept the invitation to attend and speak at the 2008 Conference.

Congresswoman Kilpatrick Followed All of the Proper Procedures. Following the proper procedures, the Congresswoman's office obtained from the trip sponsor the filled-out "Private Sponsor Travel Certification Form" (attached to this Fact Sheet as Tab 1). That form, filled out and signed by Karl Rodney, head of Carib News, represented that Carib News Foundation itself was paying all the costs of the trip—specifically, that "the trip sponsor(s0 has not accepted from any other source funds earmarked directly or indirectly to finance any aspect of the trip." (Tab 1, item 3). On item 9(b) of the Form, Carib News stated that the trip sponsor, i.e., Carib News itself, does not retain any registered lobbyists.

The Congresswoman then filled out and signed the "Privately Sponsored Travel: Traveler Form" (attached to this Fact Sheet as Tab 2). She submitted that form to the Ethics Committee, together with the "Private Sponsor Travel Certification Form." Rep. Kilpatrick's form indicated that she would not be accompanied by a family member. The Congresswoman then submitted a revised form, however, indicating that she would be accompanied by her sister "at the sponsor's expense." (Revised form attached to this Fact Sheet as Tab 3).

On October 21, 2009, the House Ethics Committee issued a letter to the Congresswoman approving the proposed trip and the payment of travel expenses by Carib News for the Congresswoman and her sister (attached to this Fact Sheet as Tab 4).

Rep. Kilpatrick did attend the event, spoke as scheduled and attended most of the workshops and panels, including the closed session with Members of Congress and leaders of the governments of several Caribbean nations. The Congresswoman was accompanied by her sister, whose travel expenses were covered by Carib News; and by her daughter and granddaughter, whose travel expenses were paid for by the Congresswoman herself, from her personal funds.

Following the trip, the Congresswoman filled out the "Member/Officer Post-Travel Disclosure Form" (attached to this Fact Sheet as Tab 5). That form instructs the Member to "Obtain actual dollar amounts from the sponsor" to be reported as the amounts of travel expenses paid. The Congresswoman's office did obtain that information from the sponsor; see fax from Carib News attached to the Post-Travel Form, Tab 5. That information was fully and accurately reported on the Post-Travel Form.

OCE/Ethics Committee Proceedings. Peter Flaherty, president of a right-wing group called the "National Legal and Policy Center," attended the 2008 Conference, uninvited, taped the proceedings and took photos. He then charged, in the press, that various corporate sponsors, which retained lobbyists, were acknowledged during the Conference as sponsors and may have actually paid the costs of the Conference.

On March 6, 2009, the OCE began a preliminary review of the trip with respect to the participation of Rep. Kilpatrick and four other members of the Congressional Black Caucus. On March 27, 2009, OCE determined to undertake a more extended investigation. OCE conducted numerous interviews and examined extensive documentation. OCE forwarded its report to the House Ethics Committee on May 29, 2009.

On June 24, 2009, the House Ethics Committee, as permitted under its rules, established an Investigative Subcommittee to investigate the allegations on behalf of the Committee. The Investigative Subcommittee reviewed the OCE Report, conducted its own interviews and reviewed all of the relevant documents.

The Investigative Subcommittee concluded that Congresswoman Kilpatrick had *not* violated any of the House Ethics rules. That conclusion was adopted by the full Ethics Committee on February 25, 2010, and, in accordance with its rules, the Ethics Committee reported that conclusion to the House.

Under the resolution establishing OCE, the Ethics Committee was required to publicly release the OCE Report as well as the Ethics Committee's own report.

<u>The OCE Report</u>. Much of the OCE Report is devoted to a review of allegations relating to the Ethics Committee's approval of the 2007 Carib News Conference, which Rep. Kilpatrick did not attend, and to attacking the former Chair of the Ethics Committee, the late Rep. Stephanie Tubbs Jones (D-Ohio) and her staff. OCE itself concedes that these allegations "did not involve Congresswoman Kilpatrick." (OCE Report p. 5).

The OCE Report faults Rep. Kilpatrick for three things: (1) accepting reimbursement of expenses from corporations that retain lobbyists; (2) under-reporting the value of travel reimbursements received; and (3) having more than one family member accompany her on the trip. As explained in the Congresswoman's sworn statement in response to the OCE Report, these findings are absolutely baseless. Those findings completely misconstrue the House Rules and ignore the evidence presented to OCE.

(1) Knowledge of Other Sponsors. OCE's investigation—based on interviews, documents and other information never seen by or made available to Rep. Kilpatrick until OCE's Report was released—revealed that corporations had made in fact contributions to Carib News earmarked to cover the costs of the Conference. OCE does not suggest that Rep. Kilpatrick had any reason to know this when she submitted the travel forms. Rather, OCE contends that "once at the conference, Congresswoman Kilpatrick was presented with evidence that other corporations were sponsors" (OCE Report p. 7 ¶16). That so-called "evidence" consists of the facts that (i) there were signs hung behind the speaker's podium at the conference displaying the logos of several corporations and (ii) during Rep. Kilpatrick's remarks at the Conference, she stated, in passing, "and to the sponsors, by the way, all of you we couldn't do this, be with you, help Karl if you weren't here with us so we say thank you..." (OCE Report, p. 11 ¶¶ 24, 27-28).

The signs, however, did not designate the corporations as sponsors of the Conference, and there was no information available to Rep. Kilpatrick before, during or after the Conference to suggest that any corporation had earmarked any contribution to cover the costs of the Conference. Rep. Kilpatrick understood nothing more from the signage, and meant nothing more in her remarks, than that the corporations were participants in the conference, as speakers/panelists, and/or had contributed at some point generally to support the work of Carib News.

OCE suggests that Members of Congress have some kind of independent obligation to investigate the sponsor of travel even after the Ethics Committee has reviewed and approved the trip. (OCE Report, pp. 13-14 ¶32). But no Member has the capability to conduct such an investigation. And a basic purpose of the new pre-approval process for privately-sponsored travel, obviously, is to allow Members to rely on that process as a means of ensuring compliance with the rules. That is precisely what Rep. Kilpatrick did.

The House Ethics Committee concluded that "Representative Kilpatrick followed the procedure sin place at the time for pre-travel approval and did, in fact receive approval from the Standards Committee to attend the 2008 conference.... Because Representative Kilpatrick did not have any knowledge of the true source of funding for this trip, the Subcommittee does not find that she violated any law, House Rule, regulation or any other standard of conduct. She was therefore entitled to rely upon the Standards Committee's approval of her trip....." House Ethics Report, p. 183 (emphasis added).

(2) Reporting of Travel Reimbursements. The OCE Report faults Rep Kilpatrick for allegedly under-reporting, on the Post-Travel Disclosure Form, the value of travel expenses paid for her by Carib News. Specifically, OCE contends that the Congresswoman should have reported the cost of airfare as being about \$200 more based on fine print appearing on the airline ticket; and should have reported a value for her hotel room based on a figure appearing in an online hotel registration document. OCE suggests that these other documents showed the "true value" of the travel and that this "true value" is what should have been reported. (OCE Report p.  $5 \ \$8(c)$ ).

But the disclosure form does *not* call for reporting the "value" of the travel. It calls for reporting what the sponsor *paid* for the travel. And the form specifically instructs Members to "Obtain actual dollar amounts from the sponsor." (See Tab 5 to this Fact Sheet, item 9). That instruction is appropriate because the rules call for reporting the amount of actual "expenses reimbursed." (House Rule 25, clause 5(b)(1)(A)(ii)). What the sponsor paid could well differ, of course, from the "value" of the transportation or hotel because of bulk discounts, special convention rates, etc. What Rep. Kilpatrick reported is precisely what she was required to report—the amount paid by the sponsor, as reported *by* the sponsor *to* the Member of Congress.

(3) Family Members Accompanying the Congresswoman. The OCE Report faults Rep. Kilpatrick for "violat[ing] the limitation that Member may only bring one family member with them" on privately sponsored travel. (OCE Report p. 4 ¶5). That charge is absurd. The Ethics Committee approved payment by Carib News of travel expenses for Rep. Kilpatrick's sister, and Rep. Kilpatrick paid the travel costs for two other family members—her daughter and granddaughter—herself, out of her own personal funds.

There is no "limitation" that a Member can only bring one family member with them. The limitation is that the Member of Congress cannot accept payment of travel expenses by the private sponsor, for more than one relative. The House Ethics Manual specifically states that, "A Member, officer or employee who wishes to be accompanied on a trip by more than one such individual...may personally pay the travel expenses of that individual..." (House Ethics Manual p. 101 footnote 19 (emphasis added)). That is precisely what Rep. Kilpatrick did.

\* \* \*

The OCE Report is thus inaccurate about the facts and wrong about the rules. The House Ethics Committee, after a full review of this matter, correctly found that Rep. Kilpatrick acted in good faith belief that she was abiding by all of the ethics rules.
