Dear Friend:

As you know, the American Recovery and Reinvestment Act is a historic \$787 billion economic recovery package. It is a bold, critical step aimed at rebuilding American through job creation and economic revitalization.

The bill is important to families in the 13<sup>th</sup> Congressional District and the State of Michigan. We have been hit hard by the economic downturn, the worst financial crisis since the Great Depression. At 12.6%, our unemployment rate is the highest in the nation. Home values are decreasing, and communities are struggling to provide important services and jobs.

Michigan will receive billions in direct aid, including \$2.2 billion in Medicaid assistance, \$1.5 billion to help state and local governments fund education and other critical services, and \$1.1 billion to repair, replace, and rehabilitate infrastructure. *\$27.5 billion was included for Highway Infrastructure Investment.*

<b>Administrator:</b>	Michigan Department of Transportation
<b>Purpose:</b>	For transportation projects including resurfacing and pavement preservation projects, traffic signal system upgrades, bridge projects, transit projects and intelligent transportation systems.
<b>Description:</b>	Funds are distributed by formula, with a portion of the funds within each State being sub allocated by population areas.

## Transit Capital Assistance

*\$6.9 billion was included for transit capital assistance grants.*

<b>Type:</b>	Funds are distributed through the existing urban and rural transit formulas: 80% of the capital assistance funds are to be distributed through the Federal Transit Administration's (FTA) urbanized formula; 10% through its rural formula; and 10% through its growing states and high density formula
<b>Administrator:</b>	Michigan Department of Transportation
<b>Description:</b>	These funds will be used to purchase buses and equipment needed to provide additional public transportation service and to make improvements to intermodal and transit facilities

## Fixed Guideway Modernization

*\$750 million was included for transit capital assistance grants.*

<b>Type:</b>	Funds are allocated by a statutory formula to urbanized areas with rail systems that have been in operation for at least seven years.
<b>Administrator:</b>	Federal Transit Administration / U.S. Department of Transportation
<b>Purpose:</b>	These funds will be used for capital projects to modernize or improve existing fixed guideway systems, including purchase and rehabilitation of rolling stock, track, line equipment, structures, signals and communications, power equipment and substations, passenger stations and terminals, security equipment and systems, maintenance facilities and equipment, operational support equipment including computer hardware and software, system extensions, and preventive maintenance.

**Michigan will receive \$168 million in formula funding**

<b>Type:</b>	Funding provided to states is used to makes loans to communities, individuals, and others for high-priority water-quality activities
<b>Administrator:</b>	Michigan Department of Environmental Quality
<b>Provisions:</b>	Waives mandatory 20% matching requirements for revolving funds; Directs the Administrator to reallocate revolving funds monies where projects are not under contract or construction within 12 months of the date of enactment; Directs priority funding to projects on State priority lists that are ready to proceed to construction within 12 months of enactment; Requires at least 20% of the capitalization grants each State receives be available for projects for green infrastructure, water and/or energy efficiency, innovative water quality improvements, decentralized waste water treatment, storm water runoff mitigation and water conservation, unless state lack applicants with these types of projects
<b>Purpose:</b>	To provide relief to communities by requiring a greater Federal share for local clean and drinking water projects and greater flexibility for States to reach communities that would otherwise not have the resources to repay a loan with interest.
<b>Activities:</b>	Loans are used to build or improve wastewater treatment plants; agricultural, rural, and urban runoff control; estuary improvement projects; wet weather flow control, including storm water and sewer overflows; alternative treatment technologies; and water reuse and conservation projects.

Funds will capitalize revolving funds and provide low interest loans, job training grants, and technical assistance to local governments and non-profit organizations.

**Diesel Emission Reduction Program**  
*\$300 million was included for Diesel Emission Reduction Act (DERA) grants.*

<b>Type:</b>	Competitive grants fund technologies to retrofit emission exhaust systems, such as on school buses and other vehicles, replace engines and vehicles, and establish anti-idling programs - 70% of the funding supports nation-wide, competitive grants, the remaining 30% funds grants to states with approved programs. Grants will be awarded in May 2009; projects that receive funding must be implemented between June 9, 2009-September 30, 2010. The application deadline is April 27, 2009 for the Smartway Transport Partnership and May 4, 2009 for the Clean Diesel Emerging Technologies Program.
