Additional Items:

LIHEAP: The bill shifts \$750 million in LIHEAP funding provided in the Deficit Reduction Act (P.L. 109-171) from FY 2007 to FY 2006. Some conservatives may question the appropriateness of shifting these funds to FY 2006 (and thus increasing spending) on an emergency supplemental spending bill.

Outreach to Iran: The bill provides \$5 million for academic and cultural exchanges with Iran and an additional \$15 million to expand public diplomacy to the country.

Radio Free Europe: The bill provides \$36 million for International Broadcasting Activities, including \$2 million for Radio Free Europe/Radio Liberty, a program which the RSC FY07 Budget terminates.

FEMA Preparedness: The bill provides \$5 million for FEMA to hire 60 new employees for preparedness, mitigation, response and recovery.

Historic Preservation: The bill provides \$3 million for financial assistance to State Historic Preservation Offices in states affected by the hurricanes.

Flood Insurance: The bill includes language allowing the National Flood Insurance Program to repay interest on the amounts borrowed from the Treasury by removing a \$30 million cap (included in the FY 2006 Homeland Security Appropriations bill, P.L. 109-90) and allowing "such sums as necessary for interest on Treasury borrowings."

Earmarks:

- Changes a \$100,000 NJ project from "an economic development study" into "the Main Street Revitalization Project." According to the Committee, this change corrects an error in the original language providing the earmark.
- Changes a \$280,000 FL project from "City of St. Petersburg, Florida for facilities construction and renovation for the Mid-Pinellas Science Center" and inserting "St. Petersburg College, City of Seminole, Florida for the development of a Science and

Nature Park." According to the Committee, this change corrects an error in the original language providing the earmark.
