

**AMENDMENT TO THE AMENDMENT IN THE
NATURE OF A SUBSTITUTE TO H.R. 5504
OFFERED BY MRS. MCCARTHY OF NEW YORK**

Insert after section 362, the following:

1 **SEC. 363. INTERAGENCY AGREEMENT TO PROMOTE NUTRI-**
2 **TION ASSISTANCE PROGRAMS.**

3 (a) INTERAGENCY AGREEMENT.—

4 (1) SECRETARY OF AGRICULTURE.—

5 (A) IN GENERAL.—From the amounts ap-
6 propriated under subsection (c), the Secretary
7 of Agriculture may enter into an interagency
8 agreement, in accordance with section
9 192A(g)(10) of the National and Community
10 Service Act of 1990 (42 U.S.C. 12651b(g)(10)),
11 with the Corporation for National and Commu-
12 nity Service to support, under the authority of
13 the national service laws, a Nutrition Corps to
14 support programs described in subsection (b)
15 that—

16 (i) increase access to, and participa-
17 tion in, the nutrition assistance programs
18 administered by the Secretary of Agri-
19 culture;

1 (ii) improve the quality of the nutri-
2 tion assistance programs; and

3 (iii) support local agriculture and
4 farm to school initiatives undertaken by
5 the Secretary of Agriculture.

6 (B) NUTRITION CORPS ASSISTANCE.—

7 From the amounts appropriated under sub-
8 section (c), the Secretary of Agriculture, in en-
9 tering into the interagency agreement under
10 subparagraph (A), may provide to the Corpora-
11 tion for National and Community Service—

12 (i) funds to be transferred to the Na-
13 tional Service Trust established under sec-
14 tion 145 of the National and Community
15 Service Act of 1990 (42 U.S.C. 12601) to
16 provide post-service benefits to participants
17 who successfully complete a term of service
18 in an approved national service position in
19 a Nutrition Corps program under this sec-
20 tion; or

21 (ii) funds to otherwise support Nutri-
22 tion Corps programs, including support for
23 participants serving in a Nutrition Corps
24 program under this section.

1 (2) CORPORATION FOR NATIONAL AND COMMU-
2 NITY SERVICE.—The Corporation, in entering into
3 the interagency agreement under paragraph (1),
4 may approve, in accordance with sections 129(i) and
5 192A(g)(10) of the National and Community Service
6 Act of 1990 (42 U.S.C. 12581(i); 12651b(g)(10)),
7 positions for the national service programs carried
8 out by the Nutrition Corps as approved national
9 service positions.

10 (b) NUTRITION CORPS.—

11 (1) NATIONAL SERVICE PROGRAMS.—The na-
12 tional service programs carried out by the Nutrition
13 Corps shall—

14 (A) address unmet health needs within
15 communities by providing services that—

16 (i) improve access to, and increase
17 participation in, the nutrition assistance
18 programs administered by the Secretary of
19 Agriculture;

20 (ii) improve the quality of the nutri-
21 tion assistance programs; and

22 (iii) support local agriculture and
23 farm-to-school initiatives undertaken by
24 the Secretary of Agriculture; and

1 (B) comply with the nonduplication and
2 nondisplacement requirements of section 177 of
3 the National and Community Service Act (42
4 U.S.C. 12637).

5 (2) SERVICES AUTHORIZED TO BE PROVIDED.—

6 The services provided by the national service pro-
7 grams under paragraph (1) may include—

8 (A) helping expand in-classroom breakfast
9 under the school breakfast program authorized
10 under section 4 of the Child Nutrition Act of
11 1966 (42 U.S.C. 1773) by assisting with set up
12 and clean up;

13 (B) expanding access to the summer food
14 service program authorized under section 13 of
15 the Richard B. Russell National School Lunch
16 Act (42 U.S.C. 1761) by assisting with activi-
17 ties for children, transporting and preparing
18 food, and conducting outreach to recruit spon-
19 sors and participants;

20 (C) helping educate and train program
21 providers for the nutrition assistance programs,
22 which may include assisting home providers
23 under the child and adult care food program
24 authorized under section 17 of the Richard B.
25 Russell National School Lunch Act (42 U.S.C.

1 1786) in promoting healthy food choices and
2 physical activity among children;

3 (D) helping clinics participating in the spe-
4 cial supplemental nutrition program for women,
5 infants, and children authorized under section
6 17 of the Child Nutrition Act of 1966 (42
7 U.S.C. 1786) with services requested by such
8 clinics;

9 (E) conducting community needs assess-
10 ments in support of efforts to reduce obesity,
11 promote healthy eating, and end childhood hun-
12 ger;

13 (F) helping promote local agriculture and
14 farm-to-school initiatives undertaken by the
15 Secretary of Agriculture; and

16 (G) coordinating and convening community
17 stakeholders to cross-promote nutrition pro-
18 grams and lead related planning processes.

19 (c) DEFINITIONS.—For purposes of this section, the
20 terms “approved national service position”, “national
21 service laws”, and “participant” have the meanings given
22 the terms in section 101 of the National and Community
23 Service Act of 1990 (42 U.S.C. 12511)

24 (d) AUTHORIZATION OF APPROPRIATIONS.—There
25 are authorized to be appropriated such sums as are nec-

- 1 essary to carry out this section for fiscal year 2011 and
- 2 each of fiscal years 2012 through 2015.
