Dear Mr. Chairman:

During a May 16, 2005, hearing before the Subcommittee on Oversight and Investigations, I raised a concern that Congress has held 14 hearings on allegations of abuse relating to the Oil for Food program, but no hearings on the widespread abuses within the Development Fund for Iraq (DFI), the successor to the Oil for Food program controlled by the Coalition Provisional Authority after the invasion of Iraq.

In my opening statement, I said that I believe Congress should investigate both the Oil for Food program and the Bush Administration's stewardship of Iraqi funds in the DFI. I also quoted from several reports by U.S. and other independent auditors that have concluded that the Bush Administration violated U.N. Security Council Resolution 1483, which requires that DFI funds be spent in a "transparent" manner for the benefit of the Iraqi people.

You raised two concerns with my statement. First, you objected to my request for unanimous consent that the audit reports I quoted from — all of which are available on the Internet — be made part of the official hearing record. You stated that you had never heard of these reports before. This claim was surprising, especially given the gravity of the abuses identified and the press attention they received when issued (*e.g., Occupation Authority Did Not Properly Monitor Spending of Iraqi Money, U.S. Audit Says,* New York Times (Jan. 31, 2005)). Your second objection was that I was not acting in a bipartisan manner because I had not formally requested a hearing on the DFI.

This letter is intended to address both of your concerns. First, I formally request that the Committee hold hearings on the Bush Administration's mismanagement of Iraqi funds in the DFI and the Administration's failure to comply with U.N. Security Council Resolution 1483. Second, I direct your attention to the following Internet websites, which provide links to all of the reports mentioned in my opening statement:
