Since taking office, President Obama has appointed a number of senior Administration advisors, otherwise known as "czars." These appointees, many of whom are not confirmed by the Senate, are responsible for coordinating high-level Administration policy within the Executive Office of the President and across the agencies. While they address a variety of important issues facing Americans, there is considerable confusion surrounding the exact nature of their positions, and the level of decision-making authority granted to them by the President and Department heads. More importantly, the vetting undertaken by this Administration during its hiring processes, as well as the standards it imposes, appear inadequate. In some cases, individuals have displayed troubling behavior that renders them unfit to serve the American people. This is especially true for Safe Schools Czar Kevin Jennings.

On September 15, 2009, the Committee Minority wrote to White House Counsel Greg Craig asking for specific information regarding these czars. The letter requested details regarding the exact nature of their positions, such as job descriptions, policymaking authority, budgetary responsibility, and compensation. It also asked the Administration to explain its hiring process, including what criteria it uses to vet seniorlevel appointees, the means by which it gathers background material, and which Administration officials, particularly within the Presidential Personnel Office, are responsible at each level of the hiring process. We requested that the White House respond by September 29, 2009, but it has yet to furnish a response.

In his memoir, Mr. Jennings also describes his past illegal drug abuse. At no point does he express any regret for his actions, recognition of the dangers of illegal drugs, or any cautionary note to young people to avoid drugs. Yet, President Obama has entrusted Mr. Jennings with keeping our schools drug-free.

Perhaps most troubling, Mr. Jennings, while a teacher, failed to protect the safety of a 15 year-old male student when he reported sexual abuse from an older man. It is likely that his failure to report this incident violated the law. This reckless and, perhaps, illegal behavior embodies a disturbing pattern that renders Mr. Jennings unqualified to fulfill the duties of his Presidentially appointed position.

Mr. Jennings' past behavior calls into question not only his fitness to serve the American people, but also the Administration's vetting procedures and standards for his employment. This Committee is duty-bound to investigate these matters in a public forum. We therefore request that you schedule a hearing to examine Mr. Jennings, the details of his employment, the processes by which he was hired, and the personnel responsible for making that decision. If non-confirmed czars are not required to appear before a Senate confirmation panel, then they should, at the very least, appear before this Committee to justify their behavior to the American people.
