The May 8 letter seeks information regarding executive compensation and other consulting services your firm has provided to large U.S. companies. The deadline for responding to the Committee's request was May 29, 2007.

Your May 25, 2007, response to the Committee does not contain any of the requested information. Your counsel subsequently informed my staff that Towers Perrin does not intend to provide voluntarily the information requested by the Committee. I hope you will reconsider Towers Perrin's refusal to cooperate with the Committee's inquiry. It should not be necessary for the Committee to invoke compulsory process in order to obtain information on whether Towers Perrin's advice to corporate boards on executive compensation is tainted by conflicts of interest.
