The Federal Register and Your Business

What is the Federal Register?

The Federal Register was created in 1935 by the Federal Register Act. The Federal Register is one of the most important sources for information on the Executive Branch. Published daily, Monday through Friday, the Federal Register carries all proposed and finalized regulations and many significant legal notices issued by the various agencies, as well as presidential proclamations and executive orders. The Federal Register provides opportunities for individuals to partsicipate in an agency's rulemaking process. Agencies utilize the Federal Register for multiple purpose. The primary uses are as follows: advance notice, proposed regulations, and final regulations.

ADVANCE NOTICE - Agencies publish "Notices of Intent" in the Federal Register to give you the earliest possible opportunity to participate in its decisions. These notices are designed to inform you that agencies are considering an issue and to solicit your feedback before a formal proposal is made.

PROPOSED REGULATIONS - "Notice of Proposed Rulemaking" are published when a formal proposal is under consideration. In addition to submitting written comments you can submit a written request that Agency officials extend the comment period. If an extension is granted, a notice of the extension is published in the Federal Register.

FINAL REGULATIONS - Upon the publication of the final rule, the rule specifies the date when the new regulatory requirements or regulations become effective. It is important to monitor the final rule implementation because this is the phase that has the final impact on your business.

How do I use the Federal Register?

The Federal Register is split into four different categories: Presidential Documents (executive orders and proclamations), rules and regulations (policy statements and interpretations of rules by federal agencies), proposed rules (petitions by agencies for assistance in rulemaking and other proposals), and notices (scheduled hearings and meetings open to the public, grant applications, and administrative orders). The category most relevant to your business are the proposed rules, also known as the Notice of Proposed Rule Making (NPRM). This category, allows agencies to solicit public feedback before changing a rule. In order to provide feedback to the agency, comments must be sent in by the deadline stated in the Federal Register. The agency will then use the comments to make the final rule, which will also be printed in the federal register.

Why is the Federal Register Important to My Business?

The Federal Register serves as the official record for the government, but most importantly it allows individuals to provide comments on rules that may have an impact on his/her business. Using the Federal Register allows a business to proactively anticipate changes and properly prepare themselves for changes that agencies make.

How Do I find the Federal Register?

The Federal Register can be accessed online for free at http://www.gpoaccess.gov/fr. You can also find a copy of the federal register at most law libraries. If you prefer a hard copy, you can order one from the Government Accounting Office (GAO). However, be advised that updates are made to the Register daily, and the hardcopy will have limited updates. The online version allows you to not only sign up for daily updates, but search the registry by key terms that may be relevant to your business.

Contracting with the S& T Directorate

Part 35 of the Federal Acquisition Regulations (FAR) provides guidance on research and development (R&D) contracting. Interested companies, organizations, and other entities may use FedBizOpps to identify R&D opportunities, which may be posted as solicitations or broad agency announcements (BAA). The Department of Homeland Security's Science and Technology Directorate (S&T) aligned its near-term research and development initiatives with its customers' needs by breaking them down along 12 Capstone Integrated Product Teams.

High priority technology needs are those that DHS would like assistance with from industry and research organizations in those 12 categories, which include border security, cargo security, chemical/biological defense, cyber security, transportation security, counter-IED (Improvised Explosive Devices), incident management, information sharing, infrastructure protection, interoperability, maritime security, and people screening. As the central R&D organization for the Department of Defense, the Defense Advanced Research Projects Agency (DARPA) is charged with "sponsoring revolutionary, high-payoff research that bridges the gap between fundamental discoveries and their military use." The DARPA website, available at http://www.darpa.mil, includes links to solicitations and BAAs, and a publication, *Doing Business with DARPA*, that provides information on the agency's procurement process. The Department of Homeland Security (DHS) has an organization, the Homeland Security Advanced Research Projects Agency (HSARPA) that performs a similar function for DHS.
