Dear Mr. President:

We write to express our deep concern over the devastation suffered by Haiti as a result of the magnitude 7.0 earthquake that struck near Port-au-Prince Tuesday evening. Initial reports indicate that the capital city has been largely destroyed, including hospitals and other first-response infrastructure. We appreciate that the Department of Homeland Security is focusing all available emergency response resources to ameliorate the impact of the earthquake and that removals to Haiti have been temporarily suspended.


In addition to these initial emergency response efforts, we believe it is imperative that the Administration exercise its authority to designate Haiti for Temporary Protected Status (“TPS”) pursuant to section 244 of the Immigration and Nationality Act (“INA”). Many of us had previously written the Department in support of a TPS designation for Haiti after the country was crippled by four hurricanes and tropical storms in a three-week period in late 2008. Despite the massive devastation to living conditions that precluded Haiti from safely handling the return of its nationals then in the United States, no such designation occurred at that time.

Tuesday’s earthquake plunged Haiti into chaos while the country was still struggling to recover from the ongoing humanitarian crisis resulting from the 2008 storms. It is abundantly clear that extraordinary and temporary conditions now exist preventing Haiti from being able to adequately and safely handle the return of its nationals currently in the United States. Haiti has officially requested TPS


on multiple prior occasions and we believe such requests allow the Administration to designate Haiti for TPS pursuant to INA section 244(b)(1)(B). Regardless, authority exists under INA section 244(b)(1)(C) to designate a foreign state without such a request if "there exist extraordinary and temporary conditions in the foreign state that prevent aliens who are nationals of the state from returning to the state in safety."

We hope that you carefully consider this request and would appreciate your prompt attention to this urgent matter.


