UNANIMOUS CONSENT AGREEMENT

Ordered, That on Monday, December 8, 2014, following Leader remarks, the time until 5:30 p.m. be in morning business, for debate only, equally divided in the usual form; and that at 5:30 p.m., all post-cloture time be considered expired and the Senate proceed to vote on confirmation of the following nominations in the order upon which cloture was invoked:

Jeffery Martin Baran, of Virginia, to be a Member of the Nuclear Regulatory Commission for the remainder of the term expiring June 30, 2018;

Lauren McGarity McFerran, of the District of Columbia, to be a Member of the National Labor Relations Board for the term of five years expiring December 16, 2019; and

Ellen Dudley Williams, of Maryland, to be Director of the Advanced Research Projects Agency-Energy, Department of Energy.
