A BILL

- To designate the Cedar Creek Battlefield and Belle Grove Plantation National Historical Park as a unit of the National Park System, and for other purposes.
 - 1 Be it enacted by the Senate and House of Representa-
 - 2 tives of the United States of America in Congress assembled,
 - 3 SECTION 1. SHORT TITLE.
 - 4 This Act may be cited as the "Cedar Creek Battle-
 - 5 field and Belle Grove Plantation National Historical Park
- 6 Act".

1 SEC. 2. PURPOSE.

- 2 The purpose of this Act is to establish the Cedar
- 3 Creek Battlefield and Belle Grove Plantation National
- 4 Historical Park in order to—
- 5 (1) help preserve, protect, and interpret a na-
- 6 tionally significant Civil War landscape and ante-
- 7 bellum plantation for the education, inspiration, and
- 8 benefit of present and future generations;
- 9 (2) tell the rich story of Shenandoah Valley his-
- tory from early settlement through the Civil War
- and beyond, and the Battle of Cedar Creek and its
- significance in the conduct of the war in the Shen-
- 13 andoah Valley; and
- 14 (3) preserve the significant historic, natural,
- 15 cultural, military, and scenic resources found in the
- 16 Cedar Creek Battlefield and Belle Grove Plantation
- areas through partnerships with local landowners
- and the community.
- 19 SEC. 3. FINDINGS.
- 20 Congress finds the following:
- 21 (1) The Battle of Cedar Creek, also known as
- the battle of Belle Grove, was a major event of the
- 23 Civil War and the history of this country. It rep-
- resented the end of the Civil War's Shenandoah Val-
- ley campaign of 1864 and contributed to the reelec-

- tion of President Abraham Lincoln and the eventual
 outcome of the war.
 - (2) 2,500 acres of the Cedar Creek Battlefield and Belle Grove Plantation were designated a national historic landmark in 1969 because of their ability to illustrate and interpret important eras and events in the history of the United States. The Cedar Creek Battlefield, Belle Grove Manor House, the Heater House, and Harmony Hall (a National Historic Landmark) are also listed on the Virginia Landmarks Register.
 - (3) The Secretary of the Interior has approved the Shenandoah Valley Battlefields National Historic District Management Plan and the National Park Service Special Resource Study, both of which recognized Cedar Creek Battlefield as the most significant Civil War resource within the historic district. The management plan, which was developed with extensive public participation over a 3-year period and is administered by the Shenandoah Valley Battlefields Foundation, recommends that Cedar Creek Battlefield be established as a new unit of the National Park System.
 - (4) The Cedar Creek Battlefield Foundation, organized in 1988 to preserve and interpret the

- Cedar Creek Battlefield and the 1864 Valley Campaign, has acquired 308 acres of land within the boundaries of the National Historic Landmark. The foundation annually hosts a major reenactment and living history event on the Cedar Creek Battlefield.
- (5) Belle Grove Plantation is a Historic Site of the National Trust for Historic Preservation that occupies 383 acres within the National Historic Landmark. The Belle Grove Manor House was built by Isaac Hite, a Revolutionary War patriot married to the sister of President James Madison, who was a frequent visitor at Belle Grove. President Thomas Jefferson assisted with the design of the house. During the Civil War Belle Grove was at the center of the decisive battle of Cedar Creek. Belle Grove is managed locally by Belle Grove, Incorporated, and has been open to the public since 1967. The house has remained virtually unchanged since it was built in 1797, offering visitors an experience of the life and times of the people who lived there in the 18th and 19th centuries.
 - (6) The panoramic views of the mountains, natural areas, and waterways provide visitors with an inspiring setting of great natural beauty. The historic, natural, cultural, military, and scenic re-

- sources found in the Cedar Creek Battlefield and Belle Grove Plantation areas are nationally and regionally significant.
- (7) The existing, independent, not-for-profit organizations dedicated to the protection and interpretation of the resources described above provide the foundation for public-private partnerships to further the success of protecting, preserving, and interpreting these resources.
- 10 (8) None of these resources, sites, or stories of 11 the Shenandoah Valley are protected by or inter-12 preted within the National Park System.
- 13 SEC. 4. DEFINITIONS.
- 14 In this Act:
- 15 (1) COMMISSION.—The term "Commission"
 16 means the Cedar Creek Battlefield and Belle Grove
 17 Plantation National Historical Park Advisory Commission established by section 9.
- 19 (2) MAP.—The term "Map" means the map en-20 titled "Cedar Creek Battlefield and Belle Grove 21 Plantation National Historical Park", numbered 22 CECR-80,000, and dated June 12, 2002.
- (3) PARK.—The term "Park" means the Cedar
 Creek Battlefield and Belle Grove Plantation Na-

| 5 | SEC. 5. ESTABLISHMENT OF CEDAR CREEK BATTLEFIELD |
| 6 | AND BELLE GROVE PLANTATION NATIONAL |
| 7 | HISTORICAL PARK. |
| 8 | (a) Establishment.—There is established the |
| 9 | Cedar Creek Battlefield and Belle Grove Plantation Na- |
| 10 | tional Historical Park, consisting of approximately 3,000 |
| 11 | acres, as generally depicted on the Map. |
| 12 | (b) AVAILABILITY OF MAP.—The Map shall be on file |
| 13 | and available for public inspection in the offices of the Na- |
| 14 | tional Park Service of the Department of the Interior. |
| 15 | SEC. 6. ACQUISITION OF PROPERTY. |
| 16 | (a) Real Property.—The Secretary may acquire |
| 17 | land or interests in land within the boundaries of the |
| 18 | Park, from willing sellers only, by donation, purchase with |
| 19 | donated or appropriated funds, or exchange. |
| 20 | (b) Boundary Revision.—After acquiring land for |
| 21 | the Park, the Secretary shall— |
| 22 | (1) revise the boundary map of the Park to in- |
| 23 | clude newly acquired land within the boundary; and |
| 24 | (2) administer newly acquired land subject to |
| 25 | applicable laws (including regulations). |

- 1 (c) Personal Property.—The Secretary may ac-
- 2 quire personal property associated with, and appropriate
- 3 for, interpretation of the Park.
- 4 (d) Conservation Easements and Covenants.—
- 5 The Secretary is authorized to acquire conservation ease-
- 6 ments and enter into covenants regarding lands in or adja-
- 7 cent to the Park from willing sellers only. Such conserva-
- 8 tion easements and covenants shall have the effect of pro-
- 9 tecting the scenic, natural, and historic resources on adja-
- 10 cent lands and preserving the natural or historic setting
- 11 of the Park when viewed from within or outside the Park.
- 12 (e) Support Facilities.—The National Park Serv-
- 13 ice is authorized to acquire from willing sellers up to 50
- 14 acres of land outside the park boundary, but in close prox-
- 15 imity to the park, to develop facilities for one or more of
- 16 the following:
- 17 (1) Visitors.
- 18 (2) Administrative functions.
- 19 (3) Museums.
- 20 (4) Curatorial functions.
- 21 (5) Maintenance.
- 22 SEC. 7. ADMINISTRATION.
- The Secretary shall administer the Park in accord-
- 24 ance with this Act and the provisions of law generally ap-
- 25 plicable to units of the National Park System, including—

- 1 (1) the Act entitled "An Act to establish a Na-2 tional Park Service, and for other purposes", ap-3 proved August 25, 1916 (16 U.S.C. 1 et seq.); and
- 4 (2) the Act entitled "An Act to provide for the 5 preservation of historic American sites, buildings, 6 objects, and antiquities of national significance, and 7 for other purposes", approved August 21, 1935 (16 8 U.S.C. 461 et seq.).

9 SEC. 8. MANAGEMENT OF PARK.

- 10 (a) Management Plan.—The Secretary, in con-
- 11 sultation with the Commission, shall prepare a manage-
- 12 ment plan for the Park. In particular, the management
- 13 plan shall contain provisions to address the needs of own-
- 14 ers of non-Federal land, including independent nonprofit
- 15 organizations within the boundaries of the Park.
- 16 (b) Submission of Plan to Congress.—Not later
- 17 than 3 years after the date of the enactment of this Act,
- 18 the Secretary shall submit the management plan for the
- 19 Park to Congress.
- 20 SEC. 9. CEDAR CREEK BATTLEFIELD AND BELLE GROVE
- 21 PLANTATION NATIONAL HISTORICAL PARK
- 22 ADVISORY COMMISSION.
- 23 (a) Establishment.—There is established the
- 24 Cedar Creek Battlefield and Belle Grove Plantation Na-
- 25 tional Historical Park Advisory Commission.

| 1 | (b) Duties.—The Commission shall— |

| 18 | (A) IN GENERAL.—Each member shall be |
| 19 | appointed for a term of 3 years and may be re- |
| 20 | appointed for not more than 2 successive terms. |
| 21 | (B) Initial members.—Of the members |
| 22 | first appointed under paragraph (1), the Sec- |
| 23 | retary shall appoint— |

| 10 | (7) Meetings.—The Commission shall meet at |
| 11 | least quarterly at the call of the chairperson or a |
| 12 | majority of the members of the Commission. |
| 13 | (8) Quorum.—8 members shall constitute a |
| 14 | quorum. |
| 15 | (d) Compensation.—Members shall serve without |
| 16 | pay. Members who are full-time officers or employees of |
| 17 | the United States, the Commonwealth of Virginia, or any |
| 18 | political subdivision thereof shall receive no additional pay |
| 19 | on account of their service on the Commission. |
| 20 | (e) Travel Expenses.—While away from their |
| 21 | homes or regular places of business in the performance |
| 22 | of service for the Commission, members shall be allowed |
| 23 | travel expenses, including per diem in lieu of subsistence, |
| 24 | in the same manner as persons employed intermittently |

- 1 in the Government service are allowed expenses under sec-
- 2 tion 5703 of title 5, United States Code.
- 3 (f) Hearings; Public Involvement.—The Com-
- 4 mission may, for purposes of carrying out this Act, hold
- 5 such hearings, sit and act at such times and places, take
- 6 such public testimony, and receive such evidence, as the
- 7 Commission considers appropriate. The Commission may
- 8 not issue subpoenas or exercise any subpoena authority.
- 9 (g) FACA NONAPPLICABILITY.—The Federal Advi-
- 10 sory Committee Act shall not apply to the Commission.
- 11 SEC. 10. CONSERVATION OF CEDAR CREEK BATTLEFIELD
- 12 AND BELLE GROVE PLANTATION NATIONAL
- 13 HISTORICAL PARK.
- 14 (a) Encouragement of Conservation.—The Sec-
- 15 retary and the Commission shall encourage conservation
- 16 of the historic and natural resources within and in prox-
- 17 imity of the Park by landowners, local governments, orga-
- 18 nizations, and businesses.
- 19 (b) Provision of Technical Assistance.—The
- 20 Secretary may provide technical assistance to local govern-
- 21 ments, in cooperative efforts which complement the values
- 22 of the Park.
- 23 (c) Cooperation by Federal Agencies.—Any
- 24 Federal entity conducting or supporting activities directly
- 25 affecting the Park shall consult, cooperate, and, to the

- 1 maximum extent practicable, coordinate its activities with
- 2 the Secretary in a manner that—
- 3 (1) is consistent with the purposes of this Act
- 4 and the standards and criteria established pursuant
- 5 to the general management plan developed pursuant
- 6 to section 8;
- 7 (2) is not likely to have an adverse effect on the
- 8 resources of the Park; and
- 9 (3) is likely to provide for full public participa-
- tion in order to consider the views of all interested
- 11 parties.
- 12 SEC. 11. ENDOWMENT.
- 13 (a) In General.—In accordance with the provisions
- 14 of subsection (b), the Secretary is authorized to receive
- 15 and expend funds from an endowment to be established
- 16 with the National Park Foundation, or its successors and
- 17 assigns.
- 18 (b) Conditions.—Funds from the endowment re-
- 19 ferred to in subsection (a) shall be expended exclusively
- 20 as the Secretary, in consultation with the Commission,
- 21 may designate for the interpretation, preservation, and
- 22 maintenance of the Park resources and public access
- 23 areas. No expenditure shall be made pursuant to this sec-
- 24 tion unless the Secretary determines that such expenditure
- 25 is consistent with the purposes of this Act.

SEC. 12. COOPERATIVE AGREEMENTS.

- 2 (a) In General.—In order to further the purposes
- 3 of this Act, the Secretary is authorized to enter into coop-
- 4 erative agreements with interested public and private enti-
- 5 ties and individuals (including the National Trust for His-
- 6 toric Preservation, Belle Grove, Inc., the Cedar Creek Bat-
- 7 tlefield Foundation, the Shenandoah Valley Battlefields
- 8 Foundation, and the Counties of Frederick, Shenandoah,
- 9 and Warren), through technical and financial assistance,
- 10 including encouraging the conservation of historic and
- 11 natural resources within and near the Park.
- 12 (b) Technical and Financial Assistance.—The
- 13 Secretary may provide to any person, organization, or gov-
- 14 ernmental entity technical and financial assistance for the
- 15 purposes of this Act, including the following:
- 16 (1) Preserving historic structures within the
- 17 Park.
- 18 (2) Maintaining the natural or cultural land-
- scape of the Park.
- 20 (3) Local preservation planning, interpretation,
- and management of public visitation for the Park.
- (4) Furthering the goals of the Shenandoah
- Valley Battlefields Foundation.
- 24 SEC. 13. ROLES OF KEY PARTNER ORGANIZATIONS.
- 25 (a) In General.—In recognition that central por-
- 26 tions of the Park are presently owned and operated for

the benefit of the public by key partner organizations, the Secretary shall acknowledge and support the continued 3 participation of these partner organizations in the man-4 agement of the Park. 5 (b) Park Partners.—Roles of the current key partners include the following: 6 7 (1) Cedar Creek Battlefield FOUNDA-8 TION.—The Cedar Creek Battlefield Foundation 9 may-10 (A) continue to own, operate, and manage 11 the lands acquired by the Foundation within 12 the Park; 13 (B) continue to conduct reenactments and 14 other events within the Park; and 15 (C) transfer ownership interest in portions 16 of their land to the National Park Service by 17 donation, sale, or other means that meet the 18 legal requirements of National Park Service 19 land acquisitions. 20 (2) National trust for historic preserva-21 TION AND BELLE GROVE INCORPORATED.—The Na-22 tional Trust for Historic Preservation and Belle

Grove Incorporated may continue to own, operate,

and manage Belle Grove Plantation and its struc-

tures and grounds within the Park boundary. Belle

- and grounds known as Bowman's Fort or Harmony
- 3 Hall for the purpose of permanent preservation, with
- 4 a long-term goal of opening the property to the pub-

- 6 (3) SHENANDOAH COUNTY.—Shenandoah
- 7 County may continue to own, operate, and manage
- 8 the Keister park site within the Park for the benefit
- 9 of the public.
- 10 (4) Gateway communities.—The adjacent
- 11 historic towns of Strasburg and Middletown shall be
- acknowledged as Gateway Communities to the Park.
- 13 (5) Shenandoah valley battlefields
- 14 FOUNDATION.—The Shenandoah Valley Battlefields
- 15 Foundation may continue to administer and manage
- the Shenandoah Valley Battlefields National His-
- toric District in partnership with the National Park
- 18 Service and in accordance with the Management
- 19 Plan for the District in which the Park is located.
- 20 SEC. 14. AUTHORIZATION OF APPROPRIATIONS.
- There is authorized to be appropriated such sums as
- 22 are necessary to carry out this Act.
