## AN ACT

To make technical amendments to update statutory references to certain provisions classified to title 52, United States Code.

1        *Be it enacted by the Senate and House of Representatives of the United*  
2        *States of America in Congress assembled,*

1 **SECTION 1. TITLE 2, UNITED STATES CODE.**
