## A BILL

To improve the administration of certain programs in the  
insular areas, and for other purposes.

1        *Be it enacted by the Senate and House of Representa-*  
2        *tives of the United States of America in Congress assembled,*

3        **SECTION 1. SHORT TITLE.**

4        This Act may be cited as the “Omnibus Territories  
5        Act of 2015”.

1 **SEC. 2. RESETTLEMENT AND RELOCATION FOR THE PEOP-**  
 2 **PLE OF BIKINI.**

3 The first proviso under the heading “TRUST TERRI-  
 4 TORY OF THE PACIFIC ISLANDS” under the heading “OF-  
 5 FICE OF TERRITORIAL AFFAIRS” under the heading “DE-  
 6 PARTMENT OF THE INTERIOR” in chapter VIII of  
 7 title I of the Supplemental Appropriations Act, 1982  
 8 (Public Law 97-257; 96 Stat. 840), is amended by strik-  
 9 ing “in the Marshall Islands, principally on Kili and Ejit  
 10 Islands”.

11 **SEC. 3. RELIABLE AIR SERVICE IN AMERICAN SAMOA.**

12 Section 41703(e) of title 49, United States Code, is  
 13 amended—

14 (1) in paragraph (1), by striking “or” at the  
 15 end;

16 (2) in paragraph (2), by striking the period at  
 17 the end and inserting “; or”; and

18 (3) by adding at the end the following:

19 “(3) notwithstanding subsection (a)(1), the  
 20 navigation under this subsection is necessary to pro-  
 21 vide and sustain air commerce in American Samoa  
 22 between the islands of Tutuila and Manu’a.”.

23 **SEC. 2. RESETTLEMENT AND RELOCATION FOR THE PEOP-**  
 24 **PLE OF BIKINI.**

25 *The matter under the heading “TRUST TERRITORY OF*  
 26 *THE PACIFIC ISLANDS” under the heading “OFFICE OF TER-*

1 *RITORIAL AFFAIRS” under the heading “DEPARTMENT*  
 2 *OF THE INTERIOR” in chapter VIII of title I of the Sup-*  
 3 *plemental Appropriations Act, 1982 (Public Law 97–257;*  
 4 *96 Stat. 840), is amended by striking the first proviso and*  
 5 *inserting “Provided, That such funds, including funds pro-*  
 6 *vided pursuant to the Department of the Interior and Re-*  
 7 *lated Agencies Appropriations Act, 1989 (Public Law 100–*  
 8 *446; 102 Stat. 1774), shall be available for the relocation*  
 9 *and resettlement of the Bikini people living on Kili and*  
 10 *Ejit Islands, on the condition that the Secretary of the Inte-*  
 11 *rior submits to the Committee on Energy and Natural Re-*  
 12 *sources of the Senate and the Committee on Natural Re-*  
 13 *sources of the House of Representatives a resettlement plan*  
 14 *developed in coordination with the Bikini Atoll leadership:*  
 15 *Provided further, That for any fiscal year, annual expendi-*  
 16 *tures from the Resettlement Fund established by this section*  
 17 *and pursuant to the Department of the Interior and Related*  
 18 *Agencies Appropriations Act, 1989 (Public Law 100–446;*  
 19 *102 Stat. 1774) may not exceed an amount that is greater*  
 20 *than 90 percent of the average annual earnings of the Fund*  
 21 *for the preceding 5 years unless for resettlement purposes*  
 22 *outside of the Marshall Islands:”.*

23 **SEC. 3. RELIABLE AIR SERVICE IN AMERICAN SAMOA.**

24       Section 40109(g) of title 49, United States Code, is  
 25 amended—

1           (1) *in paragraph (2), by striking subparagraph*  
 2 *(C) and inserting the following:*

3           “*(C) review the exemption at least every 30*  
 4 *days (or, in the case of exemptions that are nec-*  
 5 *essary to provide and sustain air transportation*  
 6 *in American Samoa between the islands of*  
 7 *Tutuila and Manu’a, at least every 180 days), to*  
 8 *ensure that the unusual circumstances that es-*  
 9 *tablished the need for the exemption still exist.”;*  
 10 *and*

11           (2) *by striking paragraph (3) and inserting the*  
 12 *following:*

13           “(3) *RENEWAL OF EXEMPTIONS.—*

14           “*(A) IN GENERAL.—Except as provided in*  
 15 *subparagraph (B), the Secretary may renew an*  
 16 *exemption (including renewals) under this sub-*  
 17 *section for not more than 30 days.*

18           “*(B) EXCEPTION.—An exemption that is*  
 19 *necessary to provide and sustain air transpor-*  
 20 *tation in American Samoa between the islands*  
 21 *of Tutuila and Manu’a, may be renewed for not*  
 22 *more than 180 days.*

23           “(4) *CONTINUATION OF EXEMPTIONS.—An ex-*  
 24 *emption may continue for not more than 5 days after*

1        *the unusual circumstances that established the need*  
2        *for the exemption cease.”.*

3    **SEC. 4. DRIVERS’ LICENSES AND PERSONAL IDENTIFICA-**  
4                                    **TION CARDS.**

5        (a) DEFINITION OF STATE.—Section 201(5) of the  
6 REAL ID Act of 2005 (49 U.S.C. 30301 note; Public Law  
7 109–13) is amended by striking “the Trust Territory of  
8 the Pacific Islands,”.

9        (b) EVIDENCE OF LAWFUL STATUS.—Section  
10 202(c)(2)(B) of the REAL ID Act of 2005 (49 U.S.C.  
11 30301 note; Public Law 109–13) is amended—

12            (1) in clause (viii), by striking “or” at the end;

13            (2) in clause (ix), by striking the period at the  
14 end and inserting “; or”; and

15            (3) by adding at the end the following:

16                            “(x) is a citizen of the Republic of the  
17                            Marshall Islands, the Federated States of  
18                            Micronesia, or the Republic of Palau who  
19                            has been admitted to the United States as  
20                            a nonimmigrant pursuant to a Compact of  
21                            Free Association between the United  
22                            States and the Republic or Federated  
23                            States.”.
