When exercised, the Contract # became FA8721-10-C-0008, with an expiration date of 30 June 2015. Contract # FA8721-10-C-0008 was then modified to continue services through 31 December 2016. The new Contract # FA8702-15-D-0002 was awarded 27 July 2015 for a period of performance of 27 July 2015 through 30 June 2020, with a five-year option term. The original ceiling for the base period was \$411,105,411.00. The total for the original period of performance plus the option period is \$1,065,084,166.00. For Contract # FA8702-15-D-0002, the base year ceiling is \$731,987,632.00. The option year ceiling is \$997,568,646.00. The total ceiling for the base period of performance plus the option is \$1,729,556,278.00.
