- 5 SEC. 2. (a) In carrying out its powers, duties, and
- 6 functions under the Standing Rules of the Senate, and
- 7 under the appropriate authorizing resolutions of the Sen-
- 8 ate, there is authorized for the period March 1, 1993,
- 9 through September 30, 1994, in the aggregate of
- 10 \$55,696,935 and for the period March 1, 1994, through

- 1 February 28, 1995, in the aggregate of \$56,428,119, in
- 2 accordance with the provisions of this resolution, for all
- 3 Standing Committees of the Senate, the Special Commit-
- 4 tee on Aging, the Select Committee on Intelligence, the
- 5 Select Committee on Indian Affairs, and the Joint Com-
- 6 mittee on the Operation of the Congress.
- 7 (b) Each committee referred to in subsection (a) shall
- 8 report its findings, together with such recommendations
