A BILL

To require the Secretary of the Treasury to strike medals in commemoration of the 10th anniversary of the September 11, 2001, terrorist attacks on the United States and the establishment of the National September 11 Memorial & Museum at the World Trade Center.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "National September
- 5 11 Memorial & Museum Commemorative Medal Act of
- 6 2009".

7 SEC. 2. STRIKING AND DESIGN OF MEDALS.

- 8 (a) Striking of Medals.—In commemoration of
- 9 the 10th anniversary of the September 11, 2001, terrorist
- 10 attacks on the United States and the establishment of the
- 11 National September 11 Memorial & Museum at the World
- 12 Trade Center, the Secretary of the Treasury (hereinafter
- 13 referred to as the "Secretary") shall strike and make
- 14 available for sale not more than 2,000,000 silver medals,
- 15 each of which shall contain 1 ounce of silver.
- 16 (b) Design Requirement.—
- 17 (1) IN GENERAL.—The design of the medals
- struck under this Act shall be emblematic of the
- 19 courage, sacrifice, and strength of those individuals
- who perished in the terrorist attacks of September
- 21 11, 2001, the bravery of those who risked their lives
- 22 to save others that day, and the endurance, resil-
- ience, and hope of those who survived.
- 24 (2) Inscriptions.—On each medal struck
- 25 under this Act, there shall be—

| 5 | (c) Selection.—The design for the medals struck |
| 6 | under this Act shall be— |
| 7 | (1) selected by the Secretary, after consultation |
| 8 | with the National September 11 Memorial & Mu- |
| 9 | seum at the World Trade Center and the Commis- |
| 10 | sion of Fine Arts; and |
| 11 | (2) reviewed by the Citizens Coinage Advisory |
| 12 | Committee. |
| 13 | SEC. 3. ISSUANCE OF MEDALS. |
| 14 | (a) QUALITY OF MEDALS.—The medals struck under |
| 15 | this Act shall be made available for sale in the quality |
| 16 | comparable to proof coins. |
| 17 | (b) MINT FACILITY.— |
| 18 | (1) In general.—Only 2 facilities of the |
| 19 | United States Mint may be used to strike medals |
| 20 | under this Act. |
| 21 | (2) Use of the united states mints at |
| 22 | WEST POINT, NEW YORK, AND PHILADELPHIA, |
| 23 | PENNSYLVANIA.—It is the sense of Congress that, to |
| 24 | the extent possible, approximately one-half of the |
| 25 | goins to be struck under this Act should be struck |

- at the United States Mint at West Point, New York,
- and approximately one-half struck at the United
- 3 States Mint at Philadelphia, Pennsylvania.
- 4 (c) Date of Issuance.—The Secretary may make
- 5 the medals available for sale under this Act beginning on
- 6 January 1, 2011.
- 7 (d) Termination of Authority.—No medals shall
- 8 be struck under this Act after December 31, 2012.
- 9 SEC. 4. NUMISMATIC ITEMS.
- For purposes of sections 5134 and 5136 of title 31,
- 11 United States Code, all medals struck under this Act shall
- 12 be considered to be numismatic items.
- 13 SEC. 5. NATIONAL MEDALS.
- 14 The medals struck under this Act are national medals
- 15 for purposes of chapter 51 of title 31, United States Code.
- 16 SEC. 6. SALE OF MEDALS.
- 17 (a) Sales Price.—The medals made available for
- 18 sale under this Act shall be sold by the Secretary at a
- 19 price equal to the sum of—
- 20 (1) the cost of designing and selling such med-
- 21 als (including labor, materials, dies, use of machin-
- ery, overhead expenses, marketing, and shipping);
- 23 and
- 24 (2) the surcharge provided in section 7 with re-
- 25 spect to such medals.

- 1 (b) Bulk Sales.—The Secretary shall make bulk
- 2 sales of the medals at a reasonable discount.
- 3 (c) Introductory Orders.—
- 4 (1) IN GENERAL.—The Secretary shall accept
- 5 introductory orders for medals made available for
- 6 sale under this Act.
- 7 (2) DISCOUNT.—Sale prices with respect to in-
- 8 troductory orders under paragraph (1) shall be made
- 9 at a reasonable discount.
- 10 SEC. 7. SURCHARGES.
- 11 (a) IN GENERAL.—All sales of medals made available
- 12 for sale under this Act shall include a surcharge of \$10
- 13 per medal.
- 14 (b) DISTRIBUTION.—Subject to section 5134(f) of
- 15 title 31, United States Code, all surcharges received by
- 16 the Secretary from the sale of medals under this Act shall
- 17 be paid to the National September 11 Memorial & Mu-
- 18 seum at the World Trade Center to support the operations
- 19 and maintenance of the National September 11 Memorial
- 20 & Museum at the World Trade Center following its com-
- 21 pletion.
- (c) Audits.—The Comptroller General of the United
- 23 States shall have the right to examine such books, records,
- 24 documents, and other data of the National September 11
- 25 Memorial & Museum at the World Trade Center as may

- 1 be related to the expenditures of amounts paid under sub-
- 2 section (b).
