TPA/ TPP MYTHS AND FACTS

Myth: TPP will prevent state and local governments from having control over issues like energy development, GMO's, and other health, safety, or environmental issues.

FACT: Nothing in TPA or TPP will prevent Boulder, Fort Collins, Loveland or any other state or local government, from making any other law they find in the public interest. On a federal level, Congress retains its authority to decide public health, safety, and environmental laws for the United States.

TPA has specific language clarifying U.S. sovereignty:

SEC. 8. SOVEREIGNTY.

2 (a) UNITED STATES LAW TO PREVAIL IN EVENT OF

3 CONFLICT.—No provision of any trade agreement entered

4 into under section 3(b), nor the application of any such

5 provision to any person or circumstance, that is incon-

6 sistent with any law of the United States, any State of

7 the United States, or any locality of the United States

8 shall have effect.

FACT: In fact, during trade negotiations, the United States urges other potential trade partners to rise to our high standards; we never agree to lower our health, public safety, or environment standards.

MYTH: Corporations are given even more rights in TPP and will have the ability to sue local governments who ban fracking for loss profits.

FACT: TPA specifically outlines that corporations will be given more rights than what they already have under the U.S. Constitution.

Myth: Only the 600 large corporations at the table will benefit, leaving Coloradans behind.

FACT: The Administration has done extensive outreach and received tremendous input from a diverse group of stakeholders including small and large businesses, labor unions, environmental groups, and other public interest groups.

FACT: Leaders for every major environmental and labor group have had access to negotiating text through advisory committees to USTR.

FACT: all Members of Congress have access to the text during detailed briefings from the lead trade negotiators.

FACT: In Colorado, the benefits of increased trade are widely shared. Last year, 88% percent of the companies in Colorado that exported goods or services were small and medium sized businesses.

Myth: TPA gives away congress' duty to oversee foreign trade.

FACT: TPA is the primary tool for congress to clarify state their priorities in every trade agreement. Additionally, TPA allows congress to revoke TPA if their priorities are not met.

Myth: TPP will negatively affect the environment.

FACT: One of the top goals of our current trade negotiations is to set the highest environmental standards ever included in a trade agreement.

FACT: The United States has engaged other environmentally conscious nations, including Australia and New Zealand, to ensure TPP promotes improved environmental standards throughout the region.

FACT: Our TPP negotiators have put an emphasis on cracking down on the illegal trade of animals, timber, and ending over-fishing, to ensure TPP goes beyond existing international agreements.

FACT: The United States is demanding that all commitments made in TPP are fully enforceable. This means that breaking environmental
