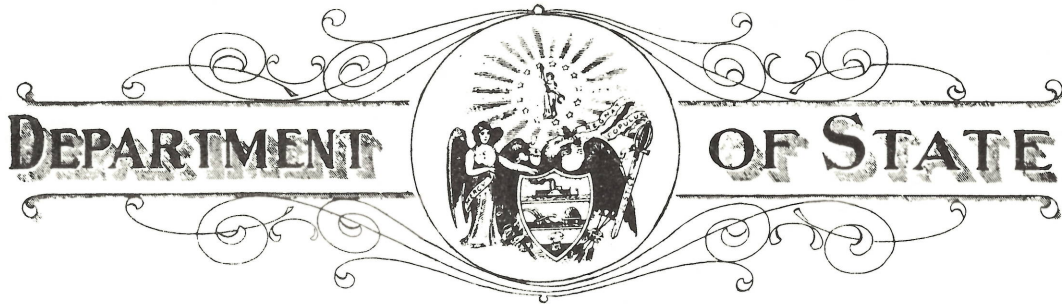

2 HOUSE JOINT RESOLUTION

3 TO MAKE APPLICATION TO THE CONGRESS OF THE UNITED
4 STATES FOR THE CALLING OF A CONVENTION FOR PROPOSING
5 AN AMENDMENT TO THE CONSTITUTION OF THE UNITED STATES
6 TO PROVIDE THAT EVERY HUMAN BEING SUBJECT TO THE
7 JURISDICTION OF THE UNITED STATES OR ANY STATE SHALL
8 BE DEEMED TO BE A PERSON FROM THE MOMENT OF CONCEPTION
9 OR FERTILIZATION, AND ENTITLED TO THE RIGHT TO LIFE
10 GUARANTEED IN THE UNITED STATES CONSTITUTION.

11
12 WHEREAS, the Constitution of the United States guarantees the right
13 to life, and this right to life should be proclaimed to exist from the
14 moment of conception or fertilization; and

15 WHEREAS, the Constitution of the United States provides that
16 upon application of the legislatures of two-thirds of the states, the
17 U. S. Congress shall call a constitutional convention for proposing
18 constitutional amendments,

20 NOW THEREFORE,

21 BE IT RESOLVED BY THE HOUSE OF REPRESENTATIVES OF THE SEVENTY-FIRST
22 GENERAL ASSEMBLY OF THE STATE OF ARKANSAS, AND BY THE SENATE, A
23 MAJORITY OF THE MEMBERS OF EACH HOUSE AGREEING THERETO:

25 SECTION 1. The State of Arkansas hereby applies to the Congress
26 of the United States of America, under the authority granted in Article
27 V of the United States Constitution, to call a convention for the purpose
28 of proposing an amendment to the United States Constitution and to do the
29 following:

30 (a) With respect to the right to life guaranteed in the United
31 States Constitution, to provide that every human being subject to the
32 jurisdiction of the United States or any state shall be deemed from the
33 moment of fertilization to be a person and entitled to the right to life.

34 (b) To provide that Congress and the several states shall have
35 concurrent powers to enforce such an amendment by appropriate legislation.

3 described in Section 1 hereof.

5 SECTION 3. Copies of this Resolution shall be sent to the legislatures
6 of all the states, to the clerk of the United States House of Representatives
7 and the Secretary of the Senate in Washington, D. C., requesting the several
8 states to also pass an identical application to the United States Congress
9 so as to meet the constitutional requirements for application for such
10 a convention by two-thirds of the states.
