Continues Critical Disaster Recovery Following Historic, Widespread Destruction Caused by Hurricanes and Wildfires

\$81B

in FY18 emergency funding for ongoing disaster recovery needs from Hurricanes Harvey, Irma, and Maria, and wildfires

\$44B OMB request

- Fulfills next phase of most immediate needs to help Florida, Texas, Louisiana, Puerto Rico, the U.S. Virgin Islands, California, and other states recover from recent disasters
- The Appropriations Committee closely reviewed the President's request and held eight oversight hearings
- Bill includes strong oversight provisions and funding for oversight support agencies to monitor spending, and prevent fraud and misuse of disaster assistance

Homeland Security

\$24.1B OMB request

- Provides funding for the Disaster Relief Fund to *cover disaster costs for hurricane and wildfire relief and recovery*
- Increases funding for FEMA operations and *ensures FEMA's readiness for future disasters*
- Allows the transfer of up to **\$4B** to the Disaster Assistance Direct Loan Program account for *Community Disaster Loans*
- Provides up to 90% federal cost share for disasters declared in 2017 for wildfires
- Address damage at important Coast Guard, Customs and Border Protection, Immigration and Customs Enforcement, and Transportation Security Administration facilities

Transportation, Housing and Urban Development

\$12.7B OMB request

- Includes **\$1.37B** for the Federal Highway Administration's Emergency Relief program to *address all current damages to federal highways* caused by designated disasters, provided directly to states and localities
- Supports other recovery efforts related to transportation assets, including *public transit and FAA facilities*
- Includes **\$26B** for Community Development Block Grants Disaster Recovery for *housing, business, and infrastructure needs for communities devastated by disasters*, including
 - **\$13.56B** for grants to states, tribes, and territories
 - **\$12.5B** set-aside to help communities protect against future natural disasters and to protect American taxpayers from recurring costs of rebuilding after storms

Energy and Water

\$515M OMB request

- Includes **\$12.1B** for the *Army Corps of Engineers* to repair existing projects damaged by natural disasters and for studies and projects to reduce the risks of future disasters
- Provides **\$21.7M** for the Department of Energy to repair damages to the Strategic Petroleum Reserve and provide technical assistance to *restore the electrical grids in Puerto Rico and the U.S. Virgin Islands*

Labor, HHS, Education

\$1.5B OMB request

- Supports critical *public health response* activities
- Helps *displaced students get back to school* by providing **\$2.9B** in flexible funding for schools impacted by disasters

\$3.8B

Agriculture

\$1B OMB request

- Includes **\$2.6B** for agriculture assistance, including *support for crop losses in disaster-designated areas*
- Provides **\$541M** for *watershed and flood prevention efforts*
- Helps *mitigate future disaster risks* by including **\$400M** for emergency conservation efforts
- Contains **\$165M** for repairs and mitigation for *rural water and waste disposal systems*

Financial Services

\$1.79B OMB request

- Helps *small businesses get back on their feet* by providing **\$1.66B** for Small Business Administration disaster loans. This funding will allow SBA to provide up to **\$12.2B** in disaster loans

\$1.2B

Departments of Defense
and Veterans Affairs

\$1.2B OMB request

- Repairs *critical military facilities and equipment* that were substantially damaged by hurricanes
- Ensures *veterans have continued access to their medical benefits* by providing funding for critical medical services and repairs to 36 medical facilities damaged by three hurricanes

\$984M

Commerce, Justice, Science

\$493M OMB request

- Provides **\$600M** to states and localities for *economic development grants for planning and infrastructure rebuilding*
- Repairs *storm-damaged equipment and facilities*, including life-saving weather forecasting technology, federal detention facilities, and NASA facilities

\$616.4M

Interior

\$576M OMB request

- Provides funding for repairs, cleanup, and recovery at the Fish and Wildlife Service, National Park Service, US Geological Survey, EPA, and Forest Service
