## RESOLUTION

Providing for consideration of the bill (H.R. 6199) to amend the Internal Revenue Code of 1986 to include certain over-the-counter medical products as qualified medical expenses, and providing for proceedings during the period from July 27, 2018, through September 3, 2018.

1       *Resolved*, That upon adoption of this resolution it  
2 shall be in order to consider in the House the bill (H.R.  
3 6199) to amend the Internal Revenue Code of 1986 to  
4 include certain over-the-counter medical products as quali-  
5 fied medical expenses. All points of order against consider-

1 ation of the bill are waived. In lieu of the amendment in  
2 the nature of a substitute recommended by the Committee  
3 on Ways and Means now printed in the bill, an amend-  
4 ment in the nature of a substitute consisting of the text  
5 of Rules Committee Print 115-82 shall be considered as  
6 adopted. The bill, as amended, shall be considered as read.  
7 All points of order against provisions in the bill, as amend-  
8 ed, are waived. The previous question shall be considered  
9 as ordered on the bill, as amended, and on any further  
10 amendment thereto, to final passage without intervening  
11 motion except: (1) one hour of debate equally divided and  
12 controlled by the chair and ranking minority member of  
13 the Committee on Ways and Means; and (2) one motion  
14 to recommit with or without instructions.

15 SEC. 2. On any legislative day during the period from  
16 July 27, 2018, through September 3, 2018—

17 (a) the Journal of the proceedings of the pre-  
18 vious day shall be considered as approved; and

19 (b) the Chair may at any time declare the  
20 House adjourned to meet at a date and time, within  
21 the limits of clause 4, section 5, article I of the Con-  
22 stitution, to be announced by the Chair in declaring  
23 the adjournment.

24 SEC. 3. The Speaker may appoint Members to per-  
25 form the duties of the Chair for the duration of the period

1 addressed by section 2 of this resolution as though under  
2 clause 8(a) of rule I.

3       SEC. 4. Each day during the period addressed by sec-  
4 tion 2 of this resolution shall not constitute a calendar  
5 day for purposes of section 7 of the War Powers Resolu-  
6 tion (50 U.S.C. 1546).

7       SEC. 5. Each day during the period addressed by sec-  
8 tion 2 of this resolution shall not constitute a legislative  
9 day for purposes of clause 7 of rule XIII.

10       SEC. 6. Each day during the period addressed by sec-  
11 tion 2 of this resolution shall not constitute a calendar  
12 or legislative day for purposes of clause 7(c)(1) of rule  
13 XXII.
