Benefits Delivery at Discharge

VA BENEFITS DELIVERY AT DISCHARGE (BDD) PROGRAM

Service members who are separating and plan to file for disability can file their claim before separation. This is done through the Veterans Affairs (VA) Benefits Delivery at Discharge (BDD) program. This program allows Service members to apply for VA disability compensation benefits prior to separation. Claims must be filed between 180 to 90 days prior to separation.

How Can BDD Help Me?

The BDD program allows Service members to apply for their disability benefits before separation. This provides time for VA to schedule exams, review treatment records and evaluate the claim before separation, with most claimants receiving their decision the day after leaving active duty.

Program Requirements

To be eligible for BDD, Service members must:

- Know their separation date
- File their claim between 180 and 90 days prior to separation
- Provide a copy of their service treatment record
- Be available for 45 days from the date the claim is submitted to attend VA exams

The following issues and conditions are excluded from BDD:

- Service members who do not meet the requirements above,
- Claims requiring case management, such as Service members who:
 - Are seriously ill or injured
 - Lost a body part

- Are terminally ill
- Claims requiring a VA exam in a foreign country, except those that can be processed through Landstuhl, Germany or Camp Humphreys, Korea,
- Claims for Service members awaiting discharge while hospitalized in a VA or military treatment facility,
- Claims for pregnant service women, or
- Claims that require a character of discharge determination.

How Do You Get Started?

Submit your application and service treatment records online through eBenefits. You can access eBenefits at <https://www.ebenefits.va.gov>. This helps process your claim faster and more efficiently. Include the following in your claim:

- Any personnel or other records that document the injuries, illnesses or events that contributed to your service-related disability
- A copy of your service treatment records from the current period of service. Note: if you have electronic service treatment records, contact your local BDD intake site to receive instructions on how to send them securely.
- Dental records
- Mental health records, if applicable
- Marriage Certificate/Divorce Decrees (for self and spouse)
- Birth certificate (for spouse and dependent children, if applicable)
- Direct Deposit Information (account number, name of financial institution and routing or transit number are required for direct deposit)
- DD Form 214 Member-4 or Service-2 Copy, for all periods of service
- Buddy statements, if applicable.

You can also fill out and mail VA Form 21-526EZ, “Application for Disability Compensation and Related Compensation Benefits.” Access this form at <https://www.vba.va.gov/pubs/forms/VBA-21-526EZ-ARE.pdf>. Submit it and any additional paper records to:

What Else Should You Know?

BDD is a time-sensitive process. You must submit your claim 180 to 90 days prior to your release from active duty. This is necessary to complete the exams and rate your claim before discharge. File your claim as close to the 180-day mark as possible to ensure VA can make a decision the day after your discharge.

Service members who do not meet the BDD requirements can submit a claim through the Fully Developed Claim program, the standard VA claims process, or any other qualifying VA claims program. However, these claims may not be processed until after discharge. If you are a Service member who has less than 90 days remaining on active duty, the [Decision Ready Claim Program](#) is the fastest way to get your VA claim processed.
