



## Parents' Dependency and Indemnity Compensation

### What is Parents' DIC?

Parents' Dependency and Indemnity Compensation (DIC) is a need-based benefit paid to the parents of a military Servicemember or Veteran who died from one of the following:

- A disease or injury acquired or worsened while on active duty or active duty for training.
- An injury acquired or worsened in the line of duty, or certain diseases acquired while on inactive duty for training.
- A service-connected disability.

The Veteran must have received an other than dishonorable discharge. Parents do not need to be financially dependent on the Veteran or Servicemember to be eligible for this benefit.

### Who are eligible parents?

The term "parent" includes biological, adoptive and foster parents.

### How much does VA pay?

The Parents' DIC rate charts

VA rates for recipients of Parents' DIC are based on countable incomes. When a parent's countable income is more than the legal limit, VA pays no benefit. Eligible parents must report all sources of income to VA. This includes wages, retirement payments, insurance proceeds or annuity payment, interest and dividends.



VA deducts certain expenses you pay from your household income. This decreases your countable income and increases your monthly Parents' DIC payment. ### **How can you apply?**

Apply for Parents' DIC by completing [VA Form 21P-535](#), "Application for Dependency and Indemnity Compensation by Parent(s)" located at [www.vba.va.gov/pubs/forms/VBA-21P-535-ARE.pdf](http://www.vba.va.gov/pubs/forms/VBA-21P-535-ARE.pdf). Mail or fax the form and Veteran's death certificate to the Pension Management Center serving your state.
