 - 1 Be it enacted by the Senate and House of Representa-
 - 2 tives of the United States of America in Congress assembled,

5 Operation and Maintenance, Marine Corps

For expenses, not otherwise provided for, necessary
for the operation and maintenance of the Marine Corps,
as authorized by law, \$5,539,740,000.

9 OPERATION AND MAINTENANCE, AIR FORCE

10 For expenses, not otherwise provided for, necessary for the operation and maintenance of the Air Force, as 11 12 authorized by law; and not to exceed \$7,699,000 can be 13 used for emergencies and extraordinary expenses, to be expended on the approval or authority of the Secretary of 14 15 the Air Force, and payments may be made on his certificate of necessity for confidential military purposes, 16 17 \$36,062,989,000.

18 OPERATION AND MAINTENANCE, DEFENSE-WIDE

19 (INCLUDING TRANSFER OF FUNDS)

For expenses, not otherwise provided for, necessary for the operation and maintenance of activities and agencies of the Department of Defense (other than the military departments), as authorized by law, \$30,210,810,000: *Provided*, That not more than \$50,000,000 may be used for the Combatant Commander Initiative Fund authorized

under section 166a of title 10, United States Code: Pro-1 vided further, That not to exceed \$36,000,000 can be used 2 3 for emergencies and extraordinary expenses, to be ex-4 pended on the approval or authority of the Secretary of 5 Defense, and payments may be made on his certificate of necessity for confidential military purposes: Provided fur-6 7 ther, That of the funds provided under this heading, not 8 less than \$31,659,000 shall be made available for the Pro-9 curement Technical Assistance Cooperative Agreement 10 Program, of which not less than \$3,600,000 shall be available for centers defined in 10 U.S.C. 2411(1)(D): Pro-11 12 *vided further*, That none of the funds appropriated or oth-13 erwise made available by this Act may be used to plan or implement the consolidation of a budget or appropria-14 15 tions liaison office of the Office of the Secretary of Defense, the office of the Secretary of a military department, 16 17 or the service headquarters of one of the Armed Forces into a legislative affairs or legislative liaison office: Pro-18 19 vided further, That \$8,251,000, to remain available until 20 expended, is available only for expenses relating to certain 21 classified activities, and may be transferred as necessary 22 by the Secretary of Defense to operation and maintenance 23 appropriations or research, development, test and evalua-24 tion appropriations, to be merged with and to be available 25 for the same time period as the appropriations to which

transferred: *Provided further*, That any ceiling on the investment item unit cost of items that may be purchased
with operation and maintenance funds shall not apply to
the funds described in the preceding proviso: *Provided fur- ther*, That the transfer authority provided under this heading is in addition to any other transfer authority provided
elsewhere in this Act.

8 Operation and Maintenance, Army Reserve

9 For expenses, not otherwise provided for, necessary 10 for the operation and maintenance, including training, or-11 ganization, and administration, of the Army Reserve; re-12 pair of facilities and equipment; hire of passenger motor 13 vehicles; travel and transportation; care of the dead; re-14 cruiting; procurement of services, supplies, and equip-15 ment; and communications, \$2,840,427,000.

16 OPERATION AND MAINTENANCE, NAVY RESERVE

For expenses, not otherwise provided for, necessary for the operation and maintenance, including training, organization, and administration, of the Navy Reserve; repair of facilities and equipment; hire of passenger motor vehicles; travel and transportation; care of the dead; recruiting; procurement of services, supplies, and equipment; and communications, \$1,344,264,000. Operation and Maintenance, Marine Corps

 plants; reserve plant and Government and contractor owned equipment layaway; and other expenses necessary
 for the foregoing purposes, \$1,847,066,000, to remain
 available for obligation until September 30, 2013.

7 OTHER PROCUREMENT, ARMY
8 (INCLUDING TRANSFER OF FUNDS)

9 For construction, procurement, production, and 10 modification of vehicles, including tactical, support, and non-tracked combat vehicles; the purchase of passenger 11 12 motor vehicles for replacement only; communications and 13 electronic equipment; other support equipment; spare parts, ordnance, and accessories therefor; specialized 14 15 equipment and training devices; expansion of public and private plants, including the land necessary therefor, for 16 the foregoing purposes, and such lands and interests 17 therein, may be acquired, and construction prosecuted 18 19 thereon prior to approval of title; and procurement and installation of equipment, appliances, and machine tools 20 21 in public and private plants; reserve plant and Govern-22 ment and contractor-owned equipment layaway; and other 23 expenses necessary for the foregoing purposes, 24 \$8,145,665,000, to remain available for obligation until September 30, 2013: Provided, That of the funds made 25

During the current fiscal year, cash bal-7 ances in working capital funds of the Department of De-8 fense established pursuant to section 2208 of title 10, 9 United States Code, may be maintained in only such 10 amounts as are necessary at any time for cash disbursements to be made from such funds: *Provided*, That trans-11 fers may be made between such funds: Provided further, 12 13 That transfers may be made between working capital funds and the "Foreign Currency Fluctuations, Defense" 14 15 appropriation and the "Operation and Maintenance" appropriation accounts in such amounts as may be deter-16 mined by the Secretary of Defense, with the approval of 17 the Office of Management and Budget, except that such 18 transfers may not be made unless the Secretary of Defense 19 20 has notified the Congress of the proposed transfer. Except 21 in amounts equal to the amounts appropriated to working 22 capital funds in this Act, no obligations may be made 23 against a working capital fund to procure or increase the 24 value of war reserve material inventory, unless the Secretary of Defense has notified the Congress prior to any
 such obligation.

3 SEC. 8009. Funds appropriated by this Act may not 4 be used to initiate a special access program without prior 5 notification 30 calendar days in advance to the congres-6 sional defense committees.

7 SEC. 8010. None of the funds provided in this Act 8 shall be available to initiate: (1) a multiyear contract that 9 employs economic order quantity procurement in excess of 10 \$20,000,000 in any one year of the contract or that includes an unfunded contingent liability in excess of 11 12 \$20,000,000; or (2) a contract for advance procurement 13 leading to a multiyear contract that employs economic 14 order quantity procurement in excess of \$20,000,000 in 15 any one year, unless the congressional defense committees have been notified at least 30 days in advance of the pro-16 17 posed contract award: *Provided*, That no part of any appropriation contained in this Act shall be available to ini-18 19 tiate a multiyear contract for which the economic order 20 quantity advance procurement is not funded at least to 21 the limits of the Government's liability: *Provided further*, 22 That no part of any appropriation contained in this Act 23 shall be available to initiate multiyear procurement con-24 tracts for any systems or component thereof if the value 25 of the multiyear contract would exceed \$500,000,000 un-

less specifically provided in this Act: Provided further, 1 2 That no multiyear procurement contract can be termi-3 nated without 10-day prior notification to the congres-4 sional defense committees: Provided further, That the exe-5 cution of multiyear authority shall require the use of a present value analysis to determine lowest cost compared 6 7 to an annual procurement: *Provided further*, That none of 8 the funds provided in this Act may be used for a multiyear 9 contract executed after the date of the enactment of this 10 Act unless in the case of any such contract—

11 (1) the Secretary of Defense has submitted to 12 Congress a budget request for full funding of units 13 to be procured through the contract and, in the case 14 of a contract for procurement of aircraft, that in-15 cludes, for any aircraft unit to be procured through 16 the contract for which procurement funds are re-17 quested in that budget request for production be-18 yond advance procurement activities in the fiscal 19 year covered by the budget, full funding of procure-20 ment of such unit in that fiscal year;

(2) cancellation provisions in the contract do
not include consideration of recurring manufacturing
costs of the contractor associated with the production of unfunded units to be delivered under the contract;

(3) the contract provides that payments to the
 contractor under the contract shall not be made in
 advance of incurred costs on funded units; and

4 (4) the contract does not provide for a price ad5 justment based on a failure to award a follow-on
6 contract.

7 Funds appropriated in title III of this Act may be8 used for a multiyear procurement contract as follows:

9 Navy MH–60R/S Helicopter Systems.

10 SEC. 8011. Within the funds appropriated for the operation and maintenance of the Armed Forces, funds are 11 12 hereby appropriated pursuant to section 401 of title 10, 13 United States Code, for humanitarian and civic assistance costs under chapter 20 of title 10, United States Code. 14 15 Such funds may also be obligated for humanitarian and civic assistance costs incidental to authorized operations 16 17 and pursuant to authority granted in section 401 of chap-18 ter 20 of title 10, United States Code, and these obligations shall be reported as required by section 401(d) of 19 20 title 10, United States Code: *Provided*, That funds avail-21 able for operation and maintenance shall be available for 22 providing humanitarian and similar assistance by using 23 Civic Action Teams in the Trust Territories of the Pacific 24 Islands and freely associated states of Micronesia, pursu-25 ant to the Compact of Free Association as authorized by

Public Law 99–239: Provided further, That upon a deter-1 mination by the Secretary of the Army that such action 2 is beneficial for graduate medical education programs con-3 4 ducted at Army medical facilities located in Hawaii, the 5 Secretary of the Army may authorize the provision of medical services at such facilities and transportation to such 6 7 facilities, on a nonreimbursable basis, for civilian patients 8 from American Samoa, the Commonwealth of the North-9 ern Mariana Islands, the Marshall Islands, the Federated 10 States of Micronesia, Palau, and Guam.

11 SEC. 8012. (a) During fiscal year 2011, the civilian 12 personnel of the Department of Defense may not be man-13 aged on the basis of any end-strength, and the manage-14 ment of such personnel during that fiscal year shall not 15 be subject to any constraint or limitation (known as an 16 end-strength) on the number of such personnel who may 17 be employed on the last day of such fiscal year.

(b) The fiscal year 2012 budget request for the Department of Defense as well as all justification material
and other documentation supporting the fiscal year 2012
Department of Defense budget request shall be prepared
and submitted to the Congress as if subsections (a) and
(b) of this provision were effective with regard to fiscal
year 2012.

(c) Nothing in this section shall be construed to apply
 to military (civilian) technicians.

3 SEC. 8013. None of the funds made available by this
4 Act shall be used in any way, directly or indirectly, to in5 fluence congressional action on any legislation or appro6 priation matters pending before the Congress.

7 SEC. 8014. None of the funds appropriated by this 8 Act shall be available for the basic pay and allowances of 9 any member of the Army participating as a full-time stu-10 dent and receiving benefits paid by the Secretary of Vet-11 erans Affairs from the Department of Defense Education 12 Benefits Fund when time spent as a full-time student is 13 credited toward completion of a service commitment: Pro*vided*. That this section shall not apply to those members 14 15 who have reenlisted with this option prior to October 1, 1987: Provided further, That this section applies only to 16 17 active components of the Army.

18 SEC. 8015. (a) None of the funds appropriated by 19 this Act shall be available to convert to contractor per-20 formance an activity or function of the Department of De-21 fense that, on or after the date of the enactment of this 22 Act, is performed by Department of Defense civilian em-23 ployees unless—

(1) the conversion is based on the result of apublic-private competition that includes a most effi-

1 that is paid by the Department of Defense for 2 health benefits for civilian employees under 3 chapter 89 of title 5, United States Code. 4 (b)(1) The Department of Defense, without regard 5 to subsection (a) of this section or subsection (a), (b), or 6 (c) of section 2461 of title 10, United States Code, and 7 notwithstanding any administrative regulation, require-8 ment, or policy to the contrary shall have full authority 9 to enter into a contract for the performance of any com-10 mercial or industrial type function of the Department of 11 Defense that— 12 (A) is included on the procurement list es-13 tablished pursuant to section 2 of the Javits-Wagner-O'Day Act (section 8503 of title 41, 14 15 United States Code); 16 (B) is planned to be converted to perform-17 ance by a qualified nonprofit agency for the 18 blind or by a qualified nonprofit agency for 19 other severely handicapped individuals in ac-20 cordance with that Act; or 21 (C) is planned to be converted to perform-22 ance by a qualified firm under at least 51 per-23 cent ownership by an Indian tribe, as defined in 24 section 4(e) of the Indian Self-Determination 25 Education Assistance Act and (25)U.S.C.

450b(e)), or a Native Hawaiian Organization,
 as defined in section 8(a)(15) of the Small
 Business Act (15 U.S.C. 637(a)(15)).

4 (2) This section shall not apply to depot con5 tracts or contracts for depot maintenance as pro6 vided in sections 2469 and 2474 of title 10, United
7 States Code.

8 (c) The conversion of any activity or function of the 9 Department of Defense under the authority provided by 10 this section shall be credited toward any competitive or outsourcing goal, target, or measurement that may be es-11 12 tablished by statute, regulation, or policy and is deemed 13 to be awarded under the authority of, and in compliance with, subsection (h) of section 2304 of title 10, United 14 15 States Code, for the competition or outsourcing of commercial activities. 16

(TRANSFER OF FUNDS)

18 SEC. 8016. Funds appropriated in title III of this Act 19 for the Department of Defense Pilot Mentor-Protege Pro-20gram may be transferred to any other appropriation con-21 tained in this Act solely for the purpose of implementing 22 Mentor-Protege Program developmental assistance a 23 agreement pursuant to section 831 of the National De-24 fense Authorization Act for Fiscal Year 1991 (Public Law 101–510; 10 U.S.C. 2302 note), as amended, under the 25

authority of this provision or any other transfer authority
 contained in this Act: *Provided*, That subsection (j) of sec tion 831 of the National Defense Authorization Act for
 Fiscal Year 1991 is amended by striking "September 30,
 2010" and inserting "September 30, 2011", and by strik ing "September 30, 2013" and inserting "September 30,
 2014".

8 SEC. 8017. None of the funds in this Act may be 9 available for the purchase by the Department of Defense 10 (and its departments and agencies) of welded shipboard anchor and mooring chain 4 inches in diameter and under 11 12 unless the anchor and mooring chain are manufactured 13 in the United States from components which are substantially manufactured in the United States: Provided, That 14 15 for the purpose of this section, the term "manufactured" shall include cutting, heat treating, quality control, testing 16 17 of chain and welding (including the forging and shot blasting process): *Provided further*, That for the purpose of this 18 19 section substantially all of the components of anchor and 20mooring chain shall be considered to be produced or manu-21 factured in the United States if the aggregate cost of the 22 components produced or manufactured in the United 23 States exceeds the aggregate cost of the components pro-24 duced or manufactured outside the United States: Pro-25 *vided further*, That when adequate domestic supplies are

not available to meet Department of Defense requirements
on a timely basis, the Secretary of the service responsible
for the procurement may waive this restriction on a caseby-case basis by certifying in writing to the Committees
on Appropriations that such an acquisition must be made
in order to acquire capability for national security purposes.

8 SEC. 8018. None of the funds available to the De-9 partment of Defense may be used to demilitarize or dis-10 pose of M-1 Carbines, M-1 Garand rifles, M-14 rifles, .22 caliber rifles, .30 caliber rifles, or M-1911 pistols, or 11 to demilitarize or destroy small arms ammunition or am-12 13 munition components that are not otherwise prohibited from commercial sale under Federal law, unless the small 14 15 arms ammunition or ammunition components are certified by the Secretary of the Army or designee as unserviceable 16 or unsafe for further use. 17

18 SEC. 8019. No more than \$500,000 of the funds ap-19 propriated or made available in this Act shall be used dur-20 ing a single fiscal year for any single relocation of an orga-21 nization, unit, activity or function of the Department of 22 Defense into or within the National Capital Region: *Pro-*23 *vided*, That the Secretary of Defense may waive this re-24 striction on a case-by-case basis by certifying in writing

to the congressional defense committees that such a relo-1 2 cation is required in the best interest of the Government. 3 SEC. 8020. In addition to the funds provided else-4 where in this Act, \$15,000,000 is appropriated only for 5 incentive payments authorized by section 504 of the In-6 dian Financing Act of 1974 (25 U.S.C. 1544): Provided, 7 That a prime contractor or a subcontractor at any tier 8 that makes a subcontract award to any subcontractor or 9 supplier as defined in section 1544 of title 25, United 10 States Code, or a small business owned and controlled by an individual or individuals defined under section 4221(9)11 12 of title 25, United States Code, shall be considered a con-13 tractor for the purposes of being allowed additional compensation under section 504 of the Indian Financing Act 14 15 of 1974 (25 U.S.C. 1544) whenever the prime contract or subcontract amount is over \$500,000 and involves the 16 17 expenditure of funds appropriated by an Act making Appropriations for the Department of Defense with respect 18 to any fiscal year: *Provided further*, That notwithstanding 19 section 430 of title 41, United States Code, this section 20 21 shall be applicable to any Department of Defense acquisi-22 tion of supplies or services, including any contract and any 23 subcontract at any tier for acquisition of commercial items 24 produced or manufactured, in whole or in part by any sub-25 contractor or supplier defined in section 1544 of title 25,

United States Code, or a small business owned and con trolled by an individual or individuals defined under sec tion 4221(9) of title 25, United States Code.

4 SEC. 8021. Funds appropriated by this Act for the
5 Defense Media Activity shall not be used for any national
6 or international political or psychological activities.

7 SEC. 8022. During the current fiscal year, the De-8 partment of Defense is authorized to incur obligations of 9 not to exceed \$350,000,000 for purposes specified in sec-10 tion 2350j(c) of title 10, United States Code, in anticipation of receipt of contributions, only from the Government 11 12 of Kuwait, under that section: *Provided*, That upon re-13 ceipt, such contributions from the Government of Kuwait shall be credited to the appropriations or fund which in-14 15 curred such obligations.

SEC. 8023. (a) Of the funds made available in this
Act, not less than \$30,374,000 shall be available for the
Civil Air Patrol Corporation, of which—

(1) \$27,048,000 shall be available from "Operation and Maintenance, Air Force" to support Civil
Air Patrol Corporation operation and maintenance,
readiness, counterdrug activities, and drug demand
reduction activities involving youth programs;

24 (2) \$2,424,000 shall be available from "Aircraft
25 Procurement, Air Force"; and

(3) \$902,000 shall be available from "Other
 Procurement, Air Force" for vehicle procurement.

3 (b) The Secretary of the Air Force should waive reim4 bursement for any funds used by the Civil Air Patrol for
5 counter-drug activities in support of Federal, State, and
6 local government agencies.

7 SEC. 8024. (a) None of the funds appropriated in this 8 Act are available to establish a new Department of De-9 fense (department) federally funded research and develop-10 ment center (FFRDC), either as a new entity, or as a separate entity administrated by an organization man-11 12 aging another FFRDC, or as a nonprofit membership cor-13 poration consisting of a consortium of other FFRDCs and other nonprofit entities. 14

15 (b) No member of a Board of Directors, Trustees, Overseers, Advisory Group, Special Issues Panel, Visiting 16 17 Committee, or any similar entity of a defense FFRDC, and no paid consultant to any defense FFRDC, except 18 19 when acting in a technical advisory capacity, may be com-20 pensated for his or her services as a member of such enti-21 ty, or as a paid consultant by more than one FFRDC in 22 a fiscal year: *Provided*, That a member of any such entity 23 referred to previously in this subsection shall be allowed 24 travel expenses and per diem as authorized under the Federal Joint Travel Regulations, when engaged in the per formance of membership duties.

3 (c) Notwithstanding any other provision of law, none 4 of the funds available to the department from any source 5 during fiscal year 2011 may be used by a defense FFRDC, 6 through a fee or other payment mechanism, for construc-7 tion of new buildings, for payment of cost sharing for 8 projects funded by Government grants, for absorption of 9 contract overruns, or for certain charitable contributions, 10 not to include employee participation in community service and/or development. 11

12 (d) Notwithstanding any other provision of law, of 13 the funds available to the department during fiscal year 2011, not more than 5,750 staff years of technical effort 14 15 (staff years) may be funded for defense FFRDCs: Pro*vided*, That of the specific amount referred to previously 16 17 in this subsection, not more than 1,125 staff years may be funded for the defense studies and analysis FFRDCs: 18 19 *Provided further*, That this subsection shall not apply to 20staff years funded in the National Intelligence Program 21 (NIP) and the Military Intelligence Program (MIP).

(e) The Secretary of Defense shall, with the submission of the department's fiscal year 2012 budget request,
submit a report presenting the specific amounts of staff
years of technical effort to be allocated for each defense

FFRDC during that fiscal year and the associated budget
 estimates.

3 (f) Notwithstanding any other provision of this Act,
4 the total amount appropriated in this Act for FFRDCs
5 is hereby reduced by \$125,000,000.

6 SEC. 8025. None of the funds appropriated or made 7 available in this Act shall be used to procure carbon, alloy 8 or armor steel plate for use in any Government-owned fa-9 cility or property under the control of the Department of 10 Defense which were not melted and rolled in the United States or Canada: Provided, That these procurement re-11 12 strictions shall apply to any and all Federal Supply Class 13 9515, American Society of Testing and Materials (ASTM) or American Iron and Steel Institute (AISI) specifications 14 15 of carbon, alloy or armor steel plate: Provided further, That the Secretary of the military department responsible 16 17 for the procurement may waive this restriction on a caseby-case basis by certifying in writing to the Committees 18 on Appropriations of the House of Representatives and the 19 20 Senate that adequate domestic supplies are not available 21 to meet Department of Defense requirements on a timely 22 basis and that such an acquisition must be made in order 23 to acquire capability for national security purposes: Pro-24 *vided further*, That these restrictions shall not apply to

contracts which are in being as of the date of the enact ment of this Act.

3 SEC. 8026. For the purposes of this Act, the term "congressional defense committees" means the Armed 4 5 Services Committee of the House of Representatives, the Armed Services Committee of the Senate, the Sub-6 7 committee on Defense of the Committee on Appropriations 8 of the Senate, and the Subcommittee on Defense of the 9 Committee on Appropriations of the House of Representa-10 tives.

11 SEC. 8027. During the current fiscal year, the De-12 partment of Defense may acquire the modification, depot 13 maintenance and repair of aircraft, vehicles and vessels as well as the production of components and other De-14 15 fense-related articles, through competition between Department of Defense depot maintenance activities and pri-16 vate firms: *Provided*, That the Senior Acquisition Execu-17 tive of the military department or Defense Agency con-18 cerned, with power of delegation, shall certify that success-19 20ful bids include comparable estimates of all direct and in-21 direct costs for both public and private bids: Provided fur-22 ther, That Office of Management and Budget Circular A– 23 76 shall not apply to competitions conducted under this 24 section.

1 SEC. 8028. (a)(1) If the Secretary of Defense, after 2 consultation with the United States Trade Representative, 3 determines that a foreign country which is party to an 4 agreement described in paragraph (2) has violated the 5 terms of the agreement by discriminating against certain types of products produced in the United States that are 6 7 covered by the agreement, the Secretary of Defense shall 8 rescind the Secretary's blanket waiver of the Buy Amer-9 ican Act with respect to such types of products produced 10 in that foreign country.

(2) An agreement referred to in paragraph (1) is any
reciprocal defense procurement memorandum of understanding, between the United States and a foreign country
pursuant to which the Secretary of Defense has prospectively waived the Buy American Act for certain products
in that country.

17 (b) The Secretary of Defense shall submit to the Con-18 gress a report on the amount of Department of Defense purchases from foreign entities in fiscal year 2011. Such 19 20 report shall separately indicate the dollar value of items 21 for which the Buy American Act was waived pursuant to 22 any agreement described in subsection (a)(2), the Trade 23 Agreement Act of 1979 (19 U.S.C. 2501 et seq.), or any 24 international agreement to which the United States is a 25 party.

(c) For purposes of this section, the term "Buy
 American Act" means chapter 83 of title 41, United
 States Code.

SEC. 8029. During the current fiscal year, amounts
contained in the Department of Defense Overseas Military
Facility Investment Recovery Account established by section 2921(c)(1) of the National Defense Authorization Act
of 1991 (Public Law 101–510; 10 U.S.C. 2687 note) shall
be available until expended for the payments specified by
section 2921(c)(2) of that Act.

11 SEC. 8030. (a) Notwithstanding any other provision 12 of law, the Secretary of the Air Force may convey at no 13 cost to the Air Force, without consideration, to Indian tribes located in the States of Nevada, Idaho, North Da-14 15 kota, South Dakota, Montana, Oregon, Minnesota, and Washington relocatable military housing units located at 16 Grand Forks Air Force Base, Malmstrom Air Force Base, 17 Mountain Home Air Force Base, Ellsworth Air Force 18 Base, and Minot Air Force Base that are excess to the 19 needs of the Air Force. 20

(b) The Secretary of the Air Force shall convey, at
no cost to the Air Force, military housing units under subsection (a) in accordance with the request for such units
that are submitted to the Secretary by the Operation
Walking Shield Program on behalf of Indian tribes located

in the States of Nevada, Idaho, North Dakota, South Da kota, Montana, Oregon, Minnesota, and Washington. Any
 such conveyance shall be subject to the condition that the
 housing units shall be removed within a reasonable period
 of time, as determined by the Secretary.

6 (c) The Operation Walking Shield Program shall re7 solve any conflicts among requests of Indian tribes for
8 housing units under subsection (a) before submitting re9 quests to the Secretary of the Air Force under subsection
10 (b).

(d) In this section, the term "Indian tribe" means
any recognized Indian tribe included on the current list
published by the Secretary of the Interior under section
104 of the Federally Recognized Indian Tribe Act of 1994
(Public Law 103–454; 108 Stat. 4792; 25 U.S.C. 479a–
1).

17 SEC. 8031. During the current fiscal year, appropria-18 tions which are available to the Department of Defense 19 for operation and maintenance may be used to purchase 20 items having an investment item unit cost of not more 21 than \$250,000.

SEC. 8032. (a) During the current fiscal year, none
of the appropriations or funds available to the Department
of Defense Working Capital Funds shall be used for the
purchase of an investment item for the purpose of acquir-

ing a new inventory item for sale or anticipated sale dur-1 2 ing the current fiscal year or a subsequent fiscal year to 3 customers of the Department of Defense Working Capital 4 Funds if such an item would not have been chargeable 5 to the Department of Defense Business Operations Fund during fiscal year 1994 and if the purchase of such an 6 7 investment item would be chargeable during the current 8 fiscal year to appropriations made to the Department of 9 Defense for procurement.

10 (b) The fiscal year 2012 budget request for the Department of Defense as well as all justification material 11 12 and other documentation supporting the fiscal year 2012 13 Department of Defense budget shall be prepared and submitted to the Congress on the basis that any equipment 14 15 which was classified as an end item and funded in a procurement appropriation contained in this Act shall be 16 17 budgeted for in a proposed fiscal year 2012 procurement 18 appropriation and not in the supply management business 19 area or any other area or category of the Department of Defense Working Capital Funds. 20

SEC. 8033. None of the funds appropriated by this
Act for programs of the Central Intelligence Agency shall
remain available for obligation beyond the current fiscal
year, except for funds appropriated for the Reserve for
Contingencies, which shall remain available until Sep-

tember 30, 2012: *Provided*, That funds appropriated, 1 transferred, or otherwise credited to the Central Intel-2 3 ligence Agency Central Services Working Capital Fund 4 during this or any prior or subsequent fiscal year shall 5 remain available until expended: *Provided further*, That any funds appropriated or transferred to the Central Intel-6 7 ligence Agency for advanced research and development ac-8 quisition, for agent operations, and for covert action pro-9 grams authorized by the President under section 503 of 10 the National Security Act of 1947, as amended, shall remain available until September 30, 2012. 11

12 SEC. 8034. Notwithstanding any other provision of 13 law, funds made available in this Act for the Defense In-14 telligence Agency may be used for the design, develop-15 ment, and deployment of General Defense Intelligence 16 Program intelligence communications and intelligence in-17 formation systems for the Services, the Unified and Speci-18 fied Commands, and the component commands.

19 SEC. 8035. Of the funds appropriated to the Depart-20 ment of Defense under the heading "Operation and Main-21 tenance, Defense-Wide", not less than \$12,000,000 shall 22 be made available only for the mitigation of environmental 23 impacts, including training and technical assistance to 24 tribes, related administrative support, the gathering of in-25 formation, documenting of environmental damage, and developing a system for prioritization of mitigation and cost
 to complete estimates for mitigation, on Indian lands re sulting from Department of Defense activities.

SEC. 8036. (a) None of the funds appropriated in this
Act may be expended by an entity of the Department of
Defense unless the entity, in expending the funds, complies with the Buy American Act. For purposes of this
subsection, the term "Buy American Act" means chapter
83 of title 41, United States Code.

10 (b) If the Secretary of Defense determines that a person has been convicted of intentionally affixing a label 11 12 bearing a "Made in America" inscription to any product 13 sold in or shipped to the United States that is not made in America, the Secretary shall determine, in accordance 14 15 with section 2410f of title 10, United States Code, whether the person should be debarred from contracting with 16 the Department of Defense. 17

18 (c) In the case of any equipment or products purchased with appropriations provided under this Act, it is 19 the sense of the Congress that any entity of the Depart-2021 ment of Defense, in expending the appropriation, purchase 22 only American-made equipment and products, provided 23 that American-made equipment and products are cost-24 competitive, quality competitive, and available in a timely fashion. 25

SEC. 8037. None of the funds appropriated by this
 Act shall be available for a contract for studies, analysis,
 or consulting services entered into without competition on
 the basis of an unsolicited proposal unless the head of the

(b) The Secretary of Defense, in consultation with the
Secretary of State, shall ensure that prior to a decision

SEC. 8061. Notwithstanding any other provision of 1 2 law, funds appropriated in this Act under the heading 3 "Research, Development, Test and Evaluation, Defense-4 Wide" for any new start advanced concept technology 5 demonstration project or joint capability demonstration 6 project may only be obligated 30 days after a report, in-7 cluding a description of the project, the planned acquisi-8 tion and transition strategy and its estimated annual and 9 total cost, has been provided in writing to the congres-10 sional defense committees: *Provided*, That the Secretary of Defense may waive this restriction on a case-by-case 11 basis by certifying to the congressional defense committees 12 13 that it is in the national interest to do so.

SEC. 8062. The Secretary of Defense shall provide
a classified quarterly report beginning 30 days after enactment of this Act, to the House and Senate Appropriations
Committees, Subcommittees on Defense on certain matters as directed in the classified annex accompanying this
Act.

SEC. 8063. During the current fiscal year, none of the funds available to the Department of Defense may be used to provide support to another department or agency of the United States if such department or agency is more than 90 days in arrears in making payment to the Department of Defense for goods or services previously provided

1 to such department or agency on a reimbursable basis: 2 *Provided*, That this restriction shall not apply if the de-3 partment is authorized by law to provide support to such 4 department or agency on a nonreimbursable basis, and is 5 providing the requested support pursuant to such author-6 ity: *Provided further*, That the Secretary of Defense may 7 waive this restriction on a case-by-case basis by certifying 8 in writing to the Committees on Appropriations of the 9 House of Representatives and the Senate that it is in the 10 national security interest to do so.

11 SEC. 8064. Notwithstanding section 12310(b) of title 12 10, United States Code, a Reserve who is a member of 13 the National Guard serving on full-time National Guard duty under section 502(f) of title 32, United States Code, 14 15 may perform duties in support of the ground-based elements of the National Ballistic Missile Defense System. 16 17 SEC. 8065. None of the funds provided in this Act may be used to transfer to any nongovernmental entity 18 19 ammunition held by the Department of Defense that has 20a center-fire cartridge and a United States military nomenclature designation of "armor penetrator", "armor 21 piercing (AP)", "armor piercing incendiary (API)", or 22 23 "armor-piercing incendiary tracer (API-T)", except to an 24 entity performing demilitarization services for the Depart-25 ment of Defense under a contract that requires the entity

to demonstrate to the satisfaction of the Department of 1 2 Defense that armor piercing projectiles are either: (1) ren-3 dered incapable of reuse by the demilitarization process; 4 or (2) used to manufacture ammunition pursuant to a con-5 tract with the Department of Defense or the manufacture of ammunition for export pursuant to a License for Per-6 7 manent Export of Unclassified Military Articles issued by 8 the Department of State.

9 SEC. 8066. Notwithstanding any other provision of 10 law, the Chief of the National Guard Bureau, or his designee, may waive payment of all or part of the consider-11 12 ation that otherwise would be required under section 2667 13 of title 10, United States Code, in the case of a lease of personal property for a period not in excess of 1 year to 14 15 any organization specified in section 508(d) of title 32, United States Code, or any other youth, social, or fra-16 17 ternal nonprofit organization as may be approved by the 18 Chief of the National Guard Bureau, or his designee, on a case-by-case basis. 19

SEC. 8067. None of the funds appropriated by this Act shall be used for the support of any nonappropriated funds activity of the Department of Defense that procures malt beverages and wine with nonappropriated funds for resale (including such alcoholic beverages sold by the drink) on a military installation located in the United

States unless such malt beverages and wine are procured 1 2 within that State, or in the case of the District of Colum-3 bia, within the District of Columbia, in which the military 4 installation is located: *Provided*, That in a case in which 5 the military installation is located in more than one State, purchases may be made in any State in which the installa-6 tion is located: Provided further, That such local procure-7 8 ment requirements for malt beverages and wine shall 9 apply to all alcoholic beverages only for military installa-10 tions in States which are not contiguous with another State: *Provided further*, That alcoholic beverages other 11 than wine and malt beverages, in contiguous States and 12 13 the District of Columbia shall be procured from the most 14 competitive source, price and other factors considered.

SEC. 8069. Of the amounts appropriated in this Act

the Secretary of Defense is authorized to transfer such

funds to other activities of the Federal Government: Pro-1 2 *vided further*, That the Secretary of Defense is authorized 3 to enter into and carry out contracts for the acquisition 4 of real property, construction, personal services, and oper-5 ations related to projects carrying out the purposes of this 6 section: Provided further, That contracts entered into 7 under the authority of this section may provide for such 8 indemnification as the Secretary determines to be nec-9 essary: *Provided further*, That projects authorized by this 10 section shall comply with applicable Federal, State, and 11 local law to the maximum extent consistent with the na-12 tional security, as determined by the Secretary of Defense.

13 SEC. 8070. Section 8106 of the Department of De-14 fense Appropriations Act, 1997 (titles I through VIII of 15 the matter under subsection 101(b) of Public Law 104– 16 208; 110 Stat. 3009–111; 10 U.S.C. 113 note) shall con-17 tinue in effect to apply to disbursements that are made 18 by the Department of Defense in fiscal year 2011.

19 SEC. 8071. In addition to amounts provided else-20 where in this Act, \$4,000,000 is hereby appropriated to 21 the Department of Defense, to remain available for obliga-22 tion until expended: *Provided*, That notwithstanding any 23 other provision of law, that upon the determination of the 24 Secretary of Defense that it shall serve the national inter-25 est, these funds shall be available only for a grant to the Fisher House Foundation, Inc., only for the construction
 and furnishing of additional Fisher Houses to meet the
 needs of military family members when confronted with
 the illness or hospitalization of an eligible military bene ficiary.

Of the amounts appropriated in this Act 8 under the headings "Procurement, Defense-Wide" and 9 "Research, Development, Test and Evaluation, Defense-10 Wide", \$415,115,000 shall be for the Israeli Cooperative Programs: *Provided*, That of this amount, \$205,000,000 11 12 shall be for the Secretary of Defense to provide to the Gov-13 ernment of Israel for the procurement of the Iron Dome 14 defense system to counter short-range rocket threats, 15 \$84,722,000 shall be for the Short Range Ballistic Missile Defense (SRBMD) program, including cruise missile de-16 17 fense research and development under the SRBMD pro-18 gram, \$58,966,000 shall be available for an upper-tier 19 component to the Israeli Missile Defense Architecture, and 20 \$66,427,000 shall be for the Arrow System Improvement 21 Program including development of a long range, ground 22 and airborne, detection suite, of which \$12,000,000 shall 23 be for producing Arrow missile components in the United 24 States and Arrow missile components in Israel to meet 25 Israel's defense requirements, consistent with each na-

tion's laws, regulations and procedures: Provided further, 1 2 That funds made available under this provision for pro-3 duction of missiles and missile components may be trans-4 ferred to appropriations available for the procurement of 5 weapons and equipment, to be merged with and to be available for the same time period and the same purposes 6 7 as the appropriation to which transferred: *Provided fur-*8 ther, That the transfer authority provided under this pro-9 vision is in addition to any other transfer authority con-10 tained in this Act.

11 SEC. 8073. None of the funds available to the De-12 partment of Defense may be obligated to modify command 13 and control relationships to give Fleet Forces Command administrative and operational control of U.S. Navy forces 14 15 assigned to the Pacific fleet: *Provided*, That the command and control relationships which existed on October 1, 16 17 2004, shall remain in force unless changes are specifically 18 authorized in a subsequent Act.

3 SEC. 8081. None of the funds provided in this Act 4 shall be available for integration of foreign intelligence in-5 formation unless the information has been lawfully collected and processed during the conduct of authorized for-6 7 eign intelligence activities: *Provided*, That information 8 pertaining to United States persons shall only be handled 9 in accordance with protections provided in the Fourth 10 Amendment of the United States Constitution as implemented through Executive Order No. 12333. 11

12 SEC. 8082. (a) At the time members of reserve com-13 ponents of the Armed Forces are called or ordered to ac-14 tive duty under section 12302(a) of title 10, United States 15 Code, each member shall be notified in writing of the ex-16 pected period during which the member will be mobilized.

(b) The Secretary of Defense may waive the requirements of subsection (a) in any case in which the Secretary
determines that it is necessary to do so to respond to a
national security emergency or to meet dire operational

6 (b) The Army shall retain responsibility for and oper7 ational control of the MQ-1C Sky Warrior Unmanned
8 Aerial Vehicle (UAV) in order to support the Secretary
9 of Defense in matters relating to the employment of un10 manned aerial vehicles.

11 SEC. 8086. Notwithstanding any other provision of 12 law or regulation, during the current fiscal year and here-13 after, the Secretary of Defense may adjust wage rates for 14 civilian employees hired for certain health care occupa-15 tions as authorized for the Secretary of Veterans Affairs 16 by section 7455 of title 38, United States Code.

17 SEC. 8087. Up to \$15,000,000 of the funds appropriated under the heading "Operation and Maintenance, 18 Navy' may be made available for the Asia Pacific Re-19 20 gional Initiative Program for the purpose of enabling the 21 Pacific Command to execute Theater Security Cooperation 22 activities such as humanitarian assistance, and payment 23 of incremental and personnel costs of training and exer-24 cising with foreign security forces: *Provided*, That funds 25 made available for this purpose may be used, notwithstanding any other funding authorities for humanitarian
 assistance, security assistance or combined exercise ex penses: *Provided further*, That funds may not be obligated
 to provide assistance to any foreign country that is other wise prohibited from receiving such type of assistance

SEC. 8088. None of the funds appropriated by this

Schedule Profile.

17 SEC. 8092. The Secretary of Defense shall create a major force program category for space for each future-18 19 years defense program of the Department of Defense sub-20 mitted to Congress under section 221 of title 10, United 21 States Code, during fiscal year 2011. The Secretary of De-22 fense shall designate an official in the Office of the Sec-23 retary of Defense to provide overall supervision of the 24 preparation and justification of program recommendations and budget proposals to be included in such major force
 program category.

3 SEC. 8093. (a) Not later than 60 days after enact-4 ment of this Act, the Office of the Director of National 5 Intelligence shall submit a report to the congressional in-6 telligence committees to establish the baseline for applica-7 tion of reprogramming and transfer authorities for fiscal 8 year 2011: *Provided*, That the report shall include—

SEC. 8094. The Director of National Intelligence 1 2 shall submit to Congress each year, at or about the time 3 that the President's budget is submitted to Congress that 4 year under section 1105(a) of title 31, United States 5 Code, a future-years intelligence program (including associated annexes) reflecting the estimated expenditures and 6 7 proposed appropriations included in that budget. Any such 8 future-years intelligence program shall cover the fiscal 9 year with respect to which the budget is submitted and 10 at least the four succeeding fiscal years.

(a) Any agency receiving funds made 11 available in this Act, shall, subject to subsections (b) and 12 (c), post on the public website of that agency any report 13 required to be submitted by the Congress in this or any 14 other Act, upon the determination by the head of the agen-15 cy that it shall serve the national interest.

16 (b) Subsection (a) shall not apply to a report if—
17 (1) the public posting of the report com18 promises national security; or

(2) the report contains proprietary information.
(c) The head of the agency posting such report shall
do so only after such report has been made available to
the requesting Committee or Committees of Congress for
no less than 45 days.

24 SEC. 8102. (a) None of the funds appropriated or 25 otherwise made available by this Act may be expended for 1 any Federal contract for an amount in excess of
2 \$1,000,000 unless the contractor agrees not to—

3 (1) enter into any agreement with any of its employees or independent contractors that requires, 4 5 as a condition of employment, that the employee or 6 independent contractor agree to resolve through ar-7 bitration any claim under title VII of the Civil 8 Rights Act of 1964 or any tort related to or arising 9 out of sexual assault or harassment, including as-10 sault and battery, intentional infliction of emotional 11 distress, false imprisonment, or negligent hiring, su-12 pervision, or retention; or

For purposes of this subsection, a "covered subcon-6 7 tractor" is an entity that has a subcontract in excess of 8 \$1,000,000 on a contract subject to subsection (a).

1 reporting and certifications required by section 325 of the 2 National Defense Authorization Act for Fiscal Year 2010 3 (Public Law 111–84) have been satisfactorily completed. 4 SEC. 8104. (a)(1) No National Intelligence Program 5 funds appropriated in this Act may be used for a mission critical or mission essential business management infor-6 7 mation technology system that is not registered with the 8 Director of National Intelligence. A system shall be con-9 sidered to be registered with that officer upon the fur-10 nishing notice of the system, together with such informa-11 tion concerning the system as the Director of the Business 12 Transformation Office may prescribe.

(a) Of the amounts made available in this 6 Act under the heading "Operation and Maintenance, 7 Navy", not less than \$2,000,000, shall be made available 8 for leveraging the Army's Contractor Manpower Reporting 9 Application, modified as appropriate for Service-specific 10 requirements, for documenting the number of full-time contractor employees (or its equivalent) pursuant to 11 12 United States Code title 10, section 2330a(c) and meeting 13 the requirements of United States Code title 10, section 2330a(e) and United States Code title 10, section 235. 14 15 (b) Of the amounts made available in this Act under the heading "Operation and Maintenance, Air Force", not 16 less than \$2,000,000 shall be made available for 17 leveraging the Army's Contractor Manpower Reporting 18 Application, modified as appropriate for Service-specific 19 20 requirements, for documenting the number of full-time 21 contractor employees (or its equivalent) pursuant to 22 United States Code title 10 section 2330a(c) and meeting 23 the requirements of United States Code title 10, section 24 2330a(e) and United States Code title 10, section 235.

1 (c) The Secretaries of the Army, Navy, Air Force, and the Directors of the Defense Agencies and Field Ac-2 3 tivities (in coordination with the appropriate Principal 4 Staff Assistant), in coordination with the Under Secretary 5 of Defense for Personnel and Readiness, shall report to the congressional defense committees within 60 days of 6 7 enactment of this Act their plan for documenting the num-8 ber of full-time contractor employees (or its equivalent), 9 as required by United States Code title 10, section 2330a.
