AN ACT

Making appropriations for the Department of Defense for the fiscal year ending September 30, 2011, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

5 **DIVISION A—DEPARTMENT OF DEFENSE**

6 **APPROPRIATIONS, 2011**

7 The following sums are appropriated, out of any
8 money in the Treasury not otherwise appropriated, for the
9 fiscal year ending September 30, 2011, for military func-

1 tions administered by the Department of Defense and for
2 other purposes, namely:

5 MILITARY PERSONNEL, ARMY

6 For pay, allowances, individual clothing, subsistence,
7 interest on deposits, gratuities, permanent change of sta-
8 tion travel (including all expenses thereof for organiza-
9 tional movements), and expenses of temporary duty travel
10 between permanent duty stations, for members of the
11 Army on active duty, (except members of reserve compo-
12 nents provided for elsewhere), cadets, and aviation cadets;
13 for members of the Reserve Officers' Training Corps; and
14 for payments pursuant to section 156 of Public Law 97-
15 377, as amended (42 U.S.C. 402 note), and to the Depart-
16 ment of Defense Military Retirement Fund,
17 \$41,042,653,000.

18 MILITARY PERSONNEL, NAVY

19 For pay, allowances, individual clothing, subsistence,
20 interest on deposits, gratuities, permanent change of sta-
21 tion travel (including all expenses thereof for organiza-
22 tional movements), and expenses of temporary duty travel
23 between permanent duty stations, for members of the
24 Navy on active duty (except members of the Reserve pro-
25 vided for elsewhere), midshipmen, and aviation cadets; for

1 members of the Reserve Officers' Training Corps; and for
2 payments pursuant to section 156 of Public Law 97-377,
3 as amended (42 U.S.C. 402 note), and to the Department
4 of Defense Military Retirement Fund, \$25,912,449,000.

5 MILITARY PERSONNEL, MARINE CORPS

6 For pay, allowances, individual clothing, subsistence,
7 interest on deposits, gratuities, permanent change of sta-
8 tion travel (including all expenses thereof for organiza-
9 tional movements), and expenses of temporary duty travel
10 between permanent duty stations, for members of the Ma-
11 rine Corps on active duty (except members of the Reserve
12 provided for elsewhere); and for payments pursuant to sec-
13 tion 156 of Public Law 97-377, as amended (42 U.S.C.
14 402 note), and to the Department of Defense Military Re-
15 tirement Fund, \$13,210,161,000.

16 MILITARY PERSONNEL, AIR FORCE

17 For pay, allowances, individual clothing, subsistence,
18 interest on deposits, gratuities, permanent change of sta-
19 tion travel (including all expenses thereof for organiza-
20 tional movements), and expenses of temporary duty travel
21 between permanent duty stations, for members of the Air
22 Force on active duty (except members of reserve compo-
23 nents provided for elsewhere), cadets, and aviation cadets;
24 for members of the Reserve Officers' Training Corps; and
25 for payments pursuant to section 156 of Public Law 97-

1 377, as amended (42 U.S.C. 402 note), and to the Depart-
2 ment of Defense Military Retirement Fund,
3 \$27,105,755,000.

4 RESERVE PERSONNEL, ARMY

5 For pay, allowances, clothing, subsistence, gratuities,
6 travel, and related expenses for personnel of the Army Re-
7 serve on active duty under sections 10211, 10302, and
8 3038 of title 10, United States Code, or while serving on
9 active duty under section 12301(d) of title 10, United
10 States Code, in connection with performing duty specified
11 in section 12310(a) of title 10, United States Code, or
12 while undergoing reserve training, or while performing
13 drills or equivalent duty or other duty, and expenses au-
14 thorized by section 16131 of title 10, United States Code;
15 and for payments to the Department of Defense Military
16 Retirement Fund, \$4,333,165,000.

17 RESERVE PERSONNEL, NAVY

18 For pay, allowances, clothing, subsistence, gratuities,
19 travel, and related expenses for personnel of the Navy Re-
20 serve on active duty under section 10211 of title 10,
21 United States Code, or while serving on active duty under
22 section 12301(d) of title 10, United States Code, in con-
23 nection with performing duty specified in section 12310(a)
24 of title 10, United States Code, or while undergoing re-
25 serve training, or while performing drills or equivalent

1 duty, and expenses authorized by section 16131 of title
2 10, United States Code; and for payments to the Depart-
3 ment of Defense Military Retirement Fund,
4 \$1,940,191,000.

5 RESERVE PERSONNEL, MARINE CORPS

6 For pay, allowances, clothing, subsistence, gratuities,
7 travel, and related expenses for personnel of the Marine
8 Corps Reserve on active duty under section 10211 of title
9 10, United States Code, or while serving on active duty
10 under section 12301(d) of title 10, United States Code,
11 in connection with performing duty specified in section
12 12310(a) of title 10, United States Code, or while under-
13 going reserve training, or while performing drills or equiv-
14 alent duty, and for members of the Marine Corps platoon
15 leaders class, and expenses authorized by section 16131
16 of title 10, United States Code; and for payments to the
17 Department of Defense Military Retirement Fund,
18 \$612,191,000.

19 RESERVE PERSONNEL, AIR FORCE

20 For pay, allowances, clothing, subsistence, gratuities,
21 travel, and related expenses for personnel of the Air Force
22 Reserve on active duty under sections 10211, 10305, and
23 8038 of title 10, United States Code, or while serving on
24 active duty under section 12301(d) of title 10, United
25 States Code, in connection with performing duty specified

1 in section 12310(a) of title 10, United States Code, or
2 while undergoing reserve training, or while performing
3 drills or equivalent duty or other duty, and expenses au-
4 thorized by section 16131 of title 10, United States Code;
5 and for payments to the Department of Defense Military
6 Retirement Fund, \$1,650,797,000.

7 NATIONAL GUARD PERSONNEL, ARMY

8 For pay, allowances, clothing, subsistence, gratuities,
9 travel, and related expenses for personnel of the Army Na-
10 tional Guard while on duty under section 10211, 10302,
11 or 12402 of title 10 or section 708 of title 32, United
12 States Code, or while serving on duty under section
13 12301(d) of title 10 or section 502(f) of title 32, United
14 States Code, in connection with performing duty specified
15 in section 12310(a) of title 10, United States Code, or
16 while undergoing training, or while performing drills or
17 equivalent duty or other duty, and expenses authorized by
18 section 16131 of title 10, United States Code; and for pay-
19 ments to the Department of Defense Military Retirement
20 Fund, \$7,511,296,000.

21 NATIONAL GUARD PERSONNEL, AIR FORCE

22 For pay, allowances, clothing, subsistence, gratuities,
23 travel, and related expenses for personnel of the Air Na-
24 tional Guard on duty under section 10211, 10305, or
25 12402 of title 10 or section 708 of title 32, United States

1 Code, or while serving on duty under section 12301(d) of
2 title 10 or section 502(f) of title 32, United States Code,
3 in connection with performing duty specified in section
4 12310(a) of title 10, United States Code, or while under-
5 going training, or while performing drills or equivalent
6 duty or other duty, and expenses authorized by section
7 16131 of title 10, United States Code; and for payments
8 to the Department of Defense Military Retirement Fund,
9 \$3,060,098,000.

OPERATION AND MAINTENANCE

OPERATION AND MAINTENANCE, ARMY

13

14 For expenses, not otherwise provided for, necessary
15 for the operation and maintenance of the Army, as author-
16 ized by law; and not to exceed \$12,478,000 can be used
17 for emergencies and extraordinary expenses, to be ex-
18 pended on the approval or authority of the Secretary of
19 the Army, and payments may be made on his certificate
20 of necessity for confidential military purposes,
21 \$33,306,117,000.

22

OPERATION AND MAINTENANCE, NAVY

23

24 For expenses, not otherwise provided for, necessary
25 for the operation and maintenance of the Navy and the
Marine Corps, as authorized by law; and not to exceed
\$14,804,000 can be used for emergencies and extraor-

1 dinary expenses, to be expended on the approval or author-
2 ity of the Secretary of the Navy, and payments may be
3 made on his certificate of necessity for confidential mili-
4 tary purposes, \$37,809,239,000.

5 OPERATION AND MAINTENANCE, MARINE CORPS

6 For expenses, not otherwise provided for, necessary
7 for the operation and maintenance of the Marine Corps,
8 as authorized by law, \$5,539,740,000.

9 OPERATION AND MAINTENANCE, AIR FORCE

10 For expenses, not otherwise provided for, necessary
11 for the operation and maintenance of the Air Force, as
12 authorized by law; and not to exceed \$7,699,000 can be
13 used for emergencies and extraordinary expenses, to be ex-
14 pended on the approval or authority of the Secretary of
15 the Air Force, and payments may be made on his certifi-
16 cate of necessity for confidential military purposes,
17 \$36,062,989,000.

18 OPERATION AND MAINTENANCE, DEFENSE-WIDE

19 (INCLUDING TRANSFER OF FUNDS)

20 For expenses, not otherwise provided for, necessary
21 for the operation and maintenance of activities and agen-
22 cies of the Department of Defense (other than the military
23 departments), as authorized by law, \$30,210,810,000:
24 *Provided*, That not more than \$50,000,000 may be used
25 for the Combatant Commander Initiative Fund authorized

1 under section 166a of title 10, United States Code: *Pro-*
2 *vided further*, That not to exceed \$36,000,000 can be used
3 for emergencies and extraordinary expenses, to be ex-
4 pended on the approval or authority of the Secretary of
5 Defense, and payments may be made on his certificate of
6 necessity for confidential military purposes: *Provided fur-*
7 *ther*, That of the funds provided under this heading, not
8 less than \$31,659,000 shall be made available for the Pro-
9 curement Technical Assistance Cooperative Agreement
10 Program, of which not less than \$3,600,000 shall be avail-
11 able for centers defined in 10 U.S.C. 2411(1)(D): *Pro-*
12 *vided further*, That none of the funds appropriated or oth-
13 erwise made available by this Act may be used to plan
14 or implement the consolidation of a budget or appropria-
15 tions liaison office of the Office of the Secretary of De-
16 fense, the office of the Secretary of a military department,
17 or the service headquarters of one of the Armed Forces
18 into a legislative affairs or legislative liaison office: *Pro-*
19 *vided further*, That \$8,251,000, to remain available until
20 expended, is available only for expenses relating to certain
21 classified activities, and may be transferred as necessary
22 by the Secretary of Defense to operation and maintenance
23 appropriations or research, development, test and evalua-
24 tion appropriations, to be merged with and to be available
25 for the same time period as the appropriations to which

1 transferred: *Provided further*, That any ceiling on the in-
2 vestment item unit cost of items that may be purchased
3 with operation and maintenance funds shall not apply to
4 the funds described in the preceding proviso: *Provided fur-*
5 *ther*, That the transfer authority provided under this head-
6 ing is in addition to any other transfer authority provided
7 elsewhere in this Act.

8 OPERATION AND MAINTENANCE, ARMY RESERVE

9 For expenses, not otherwise provided for, necessary
10 for the operation and maintenance, including training, or-
11 ganization, and administration, of the Army Reserve; re-
12 pair of facilities and equipment; hire of passenger motor
13 vehicles; travel and transportation; care of the dead; re-
14 cruiting; procurement of services, supplies, and equip-
15 ment; and communications, \$2,840,427,000.

16 OPERATION AND MAINTENANCE, NAVY RESERVE

17 For expenses, not otherwise provided for, necessary
18 for the operation and maintenance, including training, or-
19 ganization, and administration, of the Navy Reserve; re-
20 pair of facilities and equipment; hire of passenger motor
21 vehicles; travel and transportation; care of the dead; re-
22 cruiting; procurement of services, supplies, and equip-
23 ment; and communications, \$1,344,264,000.

1 OPERATION AND MAINTENANCE, MARINE CORPS

2 RESERVE

3 For expenses, not otherwise provided for, necessary
4 for the operation and maintenance, including training, or-
5 ganization, and administration, of the Marine Corps Re-
6 serve; repair of facilities and equipment; hire of passenger
7 motor vehicles; travel and transportation; care of the dead;
8 recruiting; procurement of services, supplies, and equip-
9 ment; and communications, \$275,484,000.

10 OPERATION AND MAINTENANCE, AIR FORCE RESERVE

11 For expenses, not otherwise provided for, necessary
12 for the operation and maintenance, including training, or-
13 ganization, and administration, of the Air Force Reserve;
14 repair of facilities and equipment; hire of passenger motor
15 vehicles; travel and transportation; care of the dead; re-
16 cruiting; procurement of services, supplies, and equip-
17 ment; and communications, \$3,291,027,000.

18 OPERATION AND MAINTENANCE, ARMY NATIONAL

19 GUARD

20 For expenses of training, organizing, and admin-
21 istering the Army National Guard, including medical and
22 hospital treatment and related expenses in non-Federal
23 hospitals; maintenance, operation, and repairs to struc-
24 tures and facilities; hire of passenger motor vehicles; per-
25 sonnel services in the National Guard Bureau; travel ex-

1 penses (other than mileage), as authorized by law for
2 Army personnel on active duty, for Army National Guard
3 division, regimental, and battalion commanders while in-
4 specting units in compliance with National Guard Bureau
5 regulations when specifically authorized by the Chief, Na-
6 tional Guard Bureau; supplying and equipping the Army
7 National Guard as authorized by law; and expenses of re-
8 pair, modification, maintenance, and issue of supplies and
9 equipment (including aircraft), \$6,454,624,000.

10 OPERATION AND MAINTENANCE, AIR NATIONAL GUARD

11 For expenses of training, organizing, and admin-
12 istering the Air National Guard, including medical and
13 hospital treatment and related expenses in non-Federal
14 hospitals; maintenance, operation, and repairs to struc-
15 tures and facilities; transportation of things, hire of pas-
16 senger motor vehicles; supplying and equipping the Air
17 National Guard, as authorized by law; expenses for repair,
18 modification, maintenance, and issue of supplies and
19 equipment, including those furnished from stocks under
20 the control of agencies of the Department of Defense;
21 travel expenses (other than mileage) on the same basis as
22 authorized by law for Air National Guard personnel on
23 active Federal duty, for Air National Guard commanders
24 while inspecting units in compliance with National Guard

1 Bureau regulations when specifically authorized by the
2 Chief, National Guard Bureau, \$5,963,839,000.

3 UNITED STATES COURT OF APPEALS FOR THE ARMED
4 FORCES

5 For salaries and expenses necessary for the United
6 States Court of Appeals for the Armed Forces,
7 \$14,068,000, of which not to exceed \$5,000 may be used
8 for official representation purposes.

9 ENVIRONMENTAL RESTORATION, ARMY
10 (INCLUDING TRANSFER OF FUNDS)

11 For the Department of the Army, \$464,581,000, to
12 remain available until transferred: *Provided*, That the Sec-
13 retary of the Army shall, upon determining that such
14 funds are required for environmental restoration, reduc-
15 tion and recycling of hazardous waste, removal of unsafe
16 buildings and debris of the Department of the Army, or
17 for similar purposes, transfer the funds made available by
18 this appropriation to other appropriations made available
19 to the Department of the Army, to be merged with and
20 to be available for the same purposes and for the same
21 time period as the appropriations to which transferred:
22 *Provided further*, That upon a determination that all or
23 part of the funds transferred from this appropriation are
24 not necessary for the purposes provided herein, such
25 amounts may be transferred back to this appropriation:

1 *Provided further*, That the transfer authority provided
2 under this heading is in addition to any other transfer au-
3 thority provided elsewhere in this Act.

4 ENVIRONMENTAL RESTORATION, NAVY

5 (INCLUDING TRANSFER OF FUNDS)

6 For the Department of the Navy, \$304,867,000, to
7 remain available until transferred: *Provided*, That the Sec-
8 retary of the Navy shall, upon determining that such
9 funds are required for environmental restoration, reduc-
10 tion and recycling of hazardous waste, removal of unsafe
11 buildings and debris of the Department of the Navy, or
12 for similar purposes, transfer the funds made available by
13 this appropriation to other appropriations made available
14 to the Department of the Navy, to be merged with and
15 to be available for the same purposes and for the same
16 time period as the appropriations to which transferred:
17 *Provided further*, That upon a determination that all or
18 part of the funds transferred from this appropriation are
19 not necessary for the purposes provided herein, such
20 amounts may be transferred back to this appropriation:
21 *Provided further*, That the transfer authority provided
22 under this heading is in addition to any other transfer au-
23 thority provided elsewhere in this Act.

1 ENVIRONMENTAL RESTORATION, AIR FORCE

2 (INCLUDING TRANSFER OF FUNDS)

3 For the Department of the Air Force, \$502,653,000,
4 to remain available until transferred: *Provided*, That the
5 Secretary of the Air Force shall, upon determining that
6 such funds are required for environmental restoration, re-
7 duction and recycling of hazardous waste, removal of un-
8 safe buildings and debris of the Department of the Air
9 Force, or for similar purposes, transfer the funds made
10 available by this appropriation to other appropriations
11 made available to the Department of the Air Force, to be
12 merged with and to be available for the same purposes
13 and for the same time period as the appropriations to
14 which transferred: *Provided further*, That upon a deter-
15 mination that all or part of the funds transferred from
16 this appropriation are not necessary for the purposes pro-
17 vided herein, such amounts may be transferred back to
18 this appropriation: *Provided further*, That the transfer au-
19 thority provided under this heading is in addition to any
20 other transfer authority provided elsewhere in this Act.

21 ENVIRONMENTAL RESTORATION, DEFENSE-WIDE

22 (INCLUDING TRANSFER OF FUNDS)

23 For the Department of Defense, \$10,744,000, to re-
24 main available until transferred: *Provided*, That the Sec-
25 retary of Defense shall, upon determining that such funds

1 are required for environmental restoration, reduction and
2 recycling of hazardous waste, removal of unsafe buildings
3 and debris of the Department of Defense, or for similar
4 purposes, transfer the funds made available by this appro-
5 priation to other appropriations made available to the De-
6 partment of Defense, to be merged with and to be avail-
7 able for the same purposes and for the same time period
8 as the appropriations to which transferred: *Provided fur-*
9 *ther*, That upon a determination that all or part of the
10 funds transferred from this appropriation are not nec-
11 essary for the purposes provided herein, such amounts
12 may be transferred back to this appropriation: *Provided*
13 *further*, That the transfer authority provided under this
14 heading is in addition to any other transfer authority pro-
15 vided elsewhere in this Act.

16 ENVIRONMENTAL RESTORATION, FORMERLY USED
17 DEFENSE SITES
18 (INCLUDING TRANSFER OF FUNDS)

19 For the Department of the Army, \$316,546,000, to
20 remain available until transferred: *Provided*, That the Sec-
21 retary of the Army shall, upon determining that such
22 funds are required for environmental restoration, reduc-
23 tion and recycling of hazardous waste, removal of unsafe
24 buildings and debris at sites formerly used by the Depart-
25 ment of Defense, transfer the funds made available by this

1 appropriation to other appropriations made available to
2 the Department of the Army, to be merged with and to
3 be available for the same purposes and for the same time
4 period as the appropriations to which transferred: *Pro-*
5 *vided further*, That upon a determination that all or part
6 of the funds transferred from this appropriation are not
7 necessary for the purposes provided herein, such amounts
8 may be transferred back to this appropriation: *Provided*
9 *further*, That the transfer authority provided under this
10 heading is in addition to any other transfer authority pro-
11 vided elsewhere in this Act.

12 OVERSEAS HUMANITARIAN, DISASTER, AND CIVIC AID

13 For expenses relating to the Overseas Humanitarian,
14 Disaster, and Civic Aid programs of the Department of
15 Defense (consisting of the programs provided under sec-
16 tions 401, 402, 404, 407, 2557, and 2561 of title 10,
17 United States Code), \$108,032,000, to remain available
18 until September 30, 2012.

19 COOPERATIVE THREAT REDUCTION ACCOUNT

20 For assistance to the republics of the former Soviet
21 Union and, with appropriate authorization by the Depart-
22 ment of Defense and Department of State, to countries
23 outside of the former Soviet Union, including assistance
24 provided by contract or by grants, for facilitating the
25 elimination and the safe and secure transportation and

1 storage of nuclear, chemical and other weapons; for estab-
2 lishing programs to prevent the proliferation of weapons,
3 weapons components, and weapon-related technology and
4 expertise; for programs relating to the training and sup-
5 port of defense and military personnel for demilitarization
6 and protection of weapons, weapons components and
7 weapons technology and expertise, and for defense and
8 military contacts, \$522,512,000, to remain available until
9 September 30, 2013: *Provided*, That of the amounts pro-
10 vided under this heading, not less than \$13,500,000 shall
11 be available only to support the dismantling and disposal
12 of nuclear submarines, submarine reactor components,
13 and security enhancements for transport and storage of
14 nuclear warheads in the Russian Far East and North.

15 DEPARTMENT OF DEFENSE ACQUISITION WORKFORCE
16 DEVELOPMENT FUND

17 For the Department of Defense Acquisition Work-
18 force Development Fund, \$217,561,000.

19 TITLE III
20 PROCUREMENT

21 AIRCRAFT PROCUREMENT, ARMY

22 For construction, procurement, production, modifica-
23 tion, and modernization of aircraft, equipment, including
24 ordnance, ground handling equipment, spare parts, and
25 accessories therefor; specialized equipment and training

1 proval of title; and procurement and installation of equip-
2 ment, appliances, and machine tools in public and private
3 plants; reserve plant and Government and contractor-
4 owned equipment layaway; and other expenses necessary
5 for the foregoing purposes, \$1,847,066,000, to remain
6 available for obligation until September 30, 2013.

7 OTHER PROCUREMENT, ARMY

8 (INCLUDING TRANSFER OF FUNDS)

9 For construction, procurement, production, and
10 modification of vehicles, including tactical, support, and
11 non-tracked combat vehicles; the purchase of passenger
12 motor vehicles for replacement only; communications and
13 electronic equipment; other support equipment; spare
14 parts, ordnance, and accessories therefor; specialized
15 equipment and training devices; expansion of public and
16 private plants, including the land necessary therefor, for
17 the foregoing purposes, and such lands and interests
18 therein, may be acquired, and construction prosecuted
19 thereon prior to approval of title; and procurement and
20 installation of equipment, appliances, and machine tools
21 in public and private plants; reserve plant and Govern-
22 ment and contractor-owned equipment layaway; and other
23 expenses necessary for the foregoing purposes,
24 \$8,145,665,000, to remain available for obligation until
25 September 30, 2013: *Provided*, That of the funds made

1 available in this paragraph, \$15,000,000 shall be made
2 available to procure equipment, not otherwise provided for,
3 and may be transferred to other procurement accounts
4 available to the Department of the Army, and that funds
5 so transferred shall be available for the same purposes and
6 the same time period as the account to which transferred.

7 AIRCRAFT PROCUREMENT, NAVY

8 For construction, procurement, production, modifica-
9 tion, and modernization of aircraft, equipment, including
10 ordnance, spare parts, and accessories therefor; specialized
11 equipment; expansion of public and private plants, includ-
12 ing the land necessary therefor, and such lands and inter-
13 ests therein, may be acquired, and construction prosecuted
14 thereon prior to approval of title; and procurement and
15 installation of equipment, appliances, and machine tools
16 in public and private plants; reserve plant and Govern-
17 ment and contractor-owned equipment layaway,
18 \$16,170,868,000, to remain available for obligation until
19 September 30, 2013.

20 WEAPONS PROCUREMENT, NAVY

21 For construction, procurement, production, modifica-
22 tion, and modernization of missiles, torpedoes, other weap-
23 ons, and related support equipment including spare parts,
24 and accessories therefor; expansion of public and private
25 plants, including the land necessary therefor, and such

1 SHIPBUILDING AND CONVERSION, NAVY

2 For expenses necessary for the construction, acquisi-
3 tion, or conversion of vessels as authorized by law, includ-
4 ing armor and armament thereof, plant equipment, appli-
5 ances, and machine tools and installation thereof in public
6 and private plants; reserve plant and Government and con-
7 tractor-owned equipment layaway; procurement of critical,
8 long lead time components and designs for vessels to be
9 constructed or converted in the future; and expansion of
10 public and private plants, including land necessary there-
11 for, and such lands and interests therein, may be acquired,
12 and construction prosecuted thereon prior to approval of

13 bled Chemical Weapons Alternatives (ACWA) program.

14 DRUG INTERDICTION AND COUNTER-DRUG ACTIVITIES,

15 DEFENSE

16 (INCLUDING TRANSFER OF FUNDS)

17 For drug interdiction and counter-drug activities of
18 the Department of Defense, for transfer to appropriations
19 available to the Department of Defense for military per-
20 sonnel of the reserve components serving under the provi-
21 sions of title 10 and title 32, United States Code; for oper-
22 ation and maintenance; for procurement; and for research,
23 development, test and evaluation, \$1,156,957,000: *Pro-*
24 *vided*, That the funds appropriated under this heading
25 shall be available for obligation for the same time period

1 and for the same purpose as the appropriation to which
2 transferred: *Provided further*, That upon a determination
3 that all or part of the funds transferred from this appro-
4 priation are not necessary for the purposes provided here-
5 in, such amounts may be transferred back to this appro-
6 priation: *Provided further*, That the transfer authority pro-
7 vided under this heading is in addition to any other trans-
8 fer authority contained elsewhere in this Act.

9 OFFICE OF THE INSPECTOR GENERAL

10 For expenses and activities of the Office of the In-
11 spector General in carrying out the provisions of the In-
12 spector General Act of 1978, as amended, \$306,794,000,
13 of which \$305,794,000 shall be for operation and mainte-
14 nance, of which not to exceed \$700,000 is available for
15 emergencies and extraordinary expenses to be expended on
16 the approval or authority of the Inspector General, and
17 payments may be made on the Inspector General's certifi-
18 cate of necessity for confidential military purposes; and
19 of which \$1,000,000, to remain available until September
20 30, 2013, shall be for procurement.

1 TITLE VII

3 CENTRAL INTELLIGENCE AGENCY RETIREMENT AND
4 DISABILITY SYSTEM FUND

5 For payment to the Central Intelligence Agency Re-
6 tirement and Disability System Fund, to maintain the
7 proper funding level for continuing the operation of the
8 Central Intelligence Agency Retirement and Disability
9 System, \$292,000,000.

10 INTELLIGENCE COMMUNITY MANAGEMENT ACCOUNT

11 For necessary expenses of the Intelligence Commu-
12 nity Management Account, \$649,732,000.

13 TITLE VIII
14 GENERAL PROVISIONS

15 SEC. 8001. No part of any appropriation contained
16 in this Act shall be used for publicity or propaganda pur-
17 poses not authorized by the Congress.

18 SEC. 8002. During the current fiscal year, provisions
19 of law prohibiting the payment of compensation to, or em-
20 ployment of, any person not a citizen of the United States
21 shall not apply to personnel of the Department of Defense:
22 *Provided*, That salary increases granted to direct and indi-
23 rect hire foreign national employees of the Department of
24 Defense funded by this Act shall not be at a rate in excess
25 of the percentage increase authorized by law for civilian

1 employees of the Department of Defense whose pay is
2 computed under the provisions of section 5332 of title 5,
3 United States Code, or at a rate in excess of the percent-
4 age increase provided by the appropriate host nation to
5 its own employees, whichever is higher: *Provided further*,
6 That, in the case of a host nation that does not provide
7 salary increases on an annual basis, any increase granted
8 by that nation shall be annualized for the purpose of ap-
9 plying the preceding proviso: *Provided further*, That this
10 section shall not apply to Department of Defense foreign
11 service national employees serving at United States diplo-
12 matic missions whose pay is set by the Department of
13 State under the Foreign Service Act of 1980: *Provided*
14 *further*, That the limitations of this provision shall not
15 apply to foreign national employees of the Department of
16 Defense in the Republic of Turkey.

17 SEC. 8003. No part of any appropriation contained
18 in this Act shall remain available for obligation beyond
19 the current fiscal year, unless expressly so provided herein.

20 SEC. 8004. No more than 20 percent of the appro-
21 priations in this Act which are limited for obligation dur-
22 ing the current fiscal year shall be obligated during the
23 last 2 months of the fiscal year: *Provided*, That this sec-
24 tion shall not apply to obligations for support of active

1 duty training of reserve components or summer camp
2 training of the Reserve Officers' Training Corps.

3 (TRANSFER OF FUNDS)

4 SEC. 8005. Upon determination by the Secretary of
5 Defense that such action is necessary in the national inter-
6 est, he may, with the approval of the Office of Manage-
7 ment and Budget, transfer not to exceed \$4,000,000,000
8 of working capital funds of the Department of Defense
9 or funds made available in this Act to the Department
10 of Defense for military functions (except military con-
11 struction) between such appropriations or funds or any
12 subdivision thereof, to be merged with and to be available
13 for the same purposes, and for the same time period, as
14 the appropriation or fund to which transferred: *Provided*,
15 That such authority to transfer may not be used unless
16 for higher priority items, based on unforeseen military re-
17 quirements, than those for which originally appropriated
18 and in no case where the item for which funds are re-
19 quested has been denied by the Congress: *Provided further*,
20 That the Secretary of Defense shall notify the Congress
21 promptly of all transfers made pursuant to this authority
22 or any other authority in this Act: *Provided further*, That
23 no part of the funds in this Act shall be available to pre-
24 pare or present a request to the Committees on Appropria-
25 tions for reprogramming of funds, unless for higher pri-

1 ority items, based on unforeseen military requirements,
2 than those for which originally appropriated and in no
3 case where the item for which reprogramming is requested
4 has been denied by the Congress: *Provided further*, That
5 a request for multiple reprogrammings of funds using au-
6 thority provided in this section shall be made prior to June
7 30, 2011: *Provided further*, That transfers among military
8 personnel appropriations shall not be taken into account
9 for purposes of the limitation on the amount of funds that
10 may be transferred under this section.

11 SEC. 8006. (a) With regard to the list of specific pro-
12 grams, projects, and activities (and the dollar amounts
13 and adjustments to budget activities corresponding to
14 such programs, projects, and activities) contained in the
15 tables titled “Explanation of Project Level Adjustments”
16 in the explanatory statement regarding this Act, the obli-
17 gation and expenditure of amounts appropriated or other-
18 wise made available in this Act for those programs,
19 projects, and activities for which the amounts appro-
20 priated exceed the amounts requested are hereby required
21 by law to be carried out in the manner provided by such
22 tables to the same extent as if the tables were included
23 in the text of this Act.

24 (b) Amounts specified in the referenced tables de-
25 scribed in subsection (a) shall not be treated as subdivi-

1 sions of appropriations for purposes of section 8005 of this
2 Act: *Provided*, That section 8005 shall apply when trans-
3 fers of the amounts described in subsection (a) occur be-
4 tween appropriation accounts.

5 SEC. 8007. (a) Not later than 60 days after enact-
6 ment of this Act, the Department of Defense shall submit
7 a report to the congressional defense committees to estab-
8 lish the baseline for application of reprogramming and
9 transfer authorities for fiscal year 2011: *Provided*, That
10 the report shall include—

11 (1) a table for each appropriation with a sepa-
12 rate column to display the President's budget re-
13 quest, adjustments made by Congress, adjustments
14 due to enacted rescissions, if appropriate, and the
15 fiscal year enacted level;

16 (2) a delineation in the table for each appro-
17 priation both by budget activity and program,
18 project, and activity as detailed in the Budget Ap-
19 pendix; and

20 (3) an identification of items of special congres-
21 sional interest.

22 (b) Notwithstanding section 8005 of this Act, none
23 of the funds provided in this Act shall be available for
24 reprogramming or transfer until the report identified in
25 subsection (a) is submitted to the congressional defense

1 committees, unless the Secretary of Defense certifies in
2 writing to the congressional defense committees that such
3 reprogramming or transfer is necessary as an emergency
4 requirement.

5 (TRANSFER OF FUNDS)

6 SEC. 8008. During the current fiscal year, cash bal-
7 ances in working capital funds of the Department of De-
8 fense established pursuant to section 2208 of title 10,
9 United States Code, may be maintained in only such
10 amounts as are necessary at any time for cash disburse-
11 ments to be made from such funds: *Provided*, That trans-
12 fers may be made between such funds: *Provided further*,
13 That transfers may be made between working capital
14 funds and the “Foreign Currency Fluctuations, Defense”
15 appropriation and the “Operation and Maintenance” ap-
16 propriation accounts in such amounts as may be deter-
17 mined by the Secretary of Defense, with the approval of
18 the Office of Management and Budget, except that such
19 transfers may not be made unless the Secretary of Defense
20 has notified the Congress of the proposed transfer. Except
21 in amounts equal to the amounts appropriated to working
22 capital funds in this Act, no obligations may be made
23 against a working capital fund to procure or increase the
24 value of war reserve material inventory, unless the Sec-

1 retary of Defense has notified the Congress prior to any
2 such obligation.

3 SEC. 8009. Funds appropriated by this Act may not
4 be used to initiate a special access program without prior
5 notification 30 calendar days in advance to the congres-
6 sional defense committees.

7 SEC. 8010. None of the funds provided in this Act
8 shall be available to initiate: (1) a multiyear contract that
9 employs economic order quantity procurement in excess of
10 \$20,000,000 in any one year of the contract or that in-
11 cludes an unfunded contingent liability in excess of
12 \$20,000,000; or (2) a contract for advance procurement
13 leading to a multiyear contract that employs economic
14 order quantity procurement in excess of \$20,000,000 in
15 any one year, unless the congressional defense committees
16 have been notified at least 30 days in advance of the pro-
17 posed contract award: *Provided*, That no part of any ap-
18 propriation contained in this Act shall be available to ini-
19 tiate a multiyear contract for which the economic order
20 quantity advance procurement is not funded at least to
21 the limits of the Government's liability: *Provided further*,
22 That no part of any appropriation contained in this Act
23 shall be available to initiate multiyear procurement con-
24 tracts for any systems or component thereof if the value
25 of the multiyear contract would exceed \$500,000,000 un-

1 less specifically provided in this Act: *Provided further*,
2 That no multiyear procurement contract can be termi-
3 nated without 10-day prior notification to the congres-
4 sional defense committees: *Provided further*, That the exe-
5 cution of multiyear authority shall require the use of a
6 present value analysis to determine lowest cost compared
7 to an annual procurement: *Provided further*, That none of
8 the funds provided in this Act may be used for a multiyear
9 contract executed after the date of the enactment of this
10 Act unless in the case of any such contract—

11 (1) the Secretary of Defense has submitted to
12 Congress a budget request for full funding of units
13 to be procured through the contract and, in the case
14 of a contract for procurement of aircraft, that in-
15 cludes, for any aircraft unit to be procured through
16 the contract for which procurement funds are re-
17 quested in that budget request for production be-
18 yond advance procurement activities in the fiscal
19 year covered by the budget, full funding of procure-
20 ment of such unit in that fiscal year;

21 (2) cancellation provisions in the contract do
22 not include consideration of recurring manufacturing
23 costs of the contractor associated with the produc-
24 tion of unfunded units to be delivered under the con-
25 tract;

1 (3) the contract provides that payments to the
2 contractor under the contract shall not be made in
3 advance of incurred costs on funded units; and

4 (4) the contract does not provide for a price ad-
5 justment based on a failure to award a follow-on
6 contract.

7 Funds appropriated in title III of this Act may be
8 used for a multiyear procurement contract as follows:

9 Navy MH-60R/S Helicopter Systems.

10 SEC. 8011. Within the funds appropriated for the op-
11 eration and maintenance of the Armed Forces, funds are
12 hereby appropriated pursuant to section 401 of title 10,
13 United States Code, for humanitarian and civic assistance
14 costs under chapter 20 of title 10, United States Code.
15 Such funds may also be obligated for humanitarian and
16 civic assistance costs incidental to authorized operations
17 and pursuant to authority granted in section 401 of chap-
18 ter 20 of title 10, United States Code, and these obliga-
19 tions shall be reported as required by section 401(d) of
20 title 10, United States Code: *Provided*, That funds avail-
21 able for operation and maintenance shall be available for
22 providing humanitarian and similar assistance by using
23 Civic Action Teams in the Trust Territories of the Pacific
24 Islands and freely associated states of Micronesia, pursu-
25 ant to the Compact of Free Association as authorized by

1 Public Law 99–239: *Provided further*, That upon a deter-
2 mination by the Secretary of the Army that such action
3 is beneficial for graduate medical education programs con-
4 ducted at Army medical facilities located in Hawaii, the
5 Secretary of the Army may authorize the provision of med-
6 ical services at such facilities and transportation to such
7 facilities, on a nonreimbursable basis, for civilian patients
8 from American Samoa, the Commonwealth of the North-
9 ern Mariana Islands, the Marshall Islands, the Federated
10 States of Micronesia, Palau, and Guam.

11 SEC. 8012. (a) During fiscal year 2011, the civilian
12 personnel of the Department of Defense may not be man-
13 aged on the basis of any end-strength, and the manage-
14 ment of such personnel during that fiscal year shall not
15 be subject to any constraint or limitation (known as an
16 end-strength) on the number of such personnel who may
17 be employed on the last day of such fiscal year.

18 (b) The fiscal year 2012 budget request for the De-
19 partment of Defense as well as all justification material
20 and other documentation supporting the fiscal year 2012
21 Department of Defense budget request shall be prepared
22 and submitted to the Congress as if subsections (a) and
23 (b) of this provision were effective with regard to fiscal
24 year 2012.

1 (c) Nothing in this section shall be construed to apply
2 to military (civilian) technicians.

3 SEC. 8013. None of the funds made available by this
4 Act shall be used in any way, directly or indirectly, to in-
5 fluence congressional action on any legislation or appro-
6 priation matters pending before the Congress.

7 SEC. 8014. None of the funds appropriated by this
8 Act shall be available for the basic pay and allowances of
9 any member of the Army participating as a full-time stu-
10 dent and receiving benefits paid by the Secretary of Vet-
11 erans Affairs from the Department of Defense Education
12 Benefits Fund when time spent as a full-time student is
13 credited toward completion of a service commitment: *Pro-*
14 *vided*, That this section shall not apply to those members
15 who have reenlisted with this option prior to October 1,
16 1987: *Provided further*, That this section applies only to
17 active components of the Army.

18 SEC. 8015. (a) None of the funds appropriated by
19 this Act shall be available to convert to contractor per-
20 formance an activity or function of the Department of De-
21 fense that, on or after the date of the enactment of this
22 Act, is performed by Department of Defense civilian em-
23 ployees unless—

24 (1) the conversion is based on the result of a
25 public-private competition that includes a most effi-

1 cient and cost effective organization plan developed
2 by such activity or function;

3 (2) the Competitive Sourcing Official deter-
4 mines that, over all performance periods stated in
5 the solicitation of offers for performance of the ac-
6 tivity or function, the cost of performance of the ac-
7 tivity or function by a contractor would be less costly
8 to the Department of Defense by an amount that
9 equals or exceeds the lesser of—

10 (A) 10 percent of the most efficient organi-
11 zation's personnel-related costs for performance
12 of that activity or function by Federal employ-
13 ees; or

14 (B) \$10,000,000; and

15 (3) the contractor does not receive an advan-
16 tage for a proposal that would reduce costs for the
17 Department of Defense by—

18 (A) not making an employer-sponsored
19 health insurance plan available to the workers
20 who are to be employed in the performance of
21 that activity or function under the contract; or

22 (B) offering to such workers an employer-
23 sponsored health benefits plan that requires the
24 employer to contribute less towards the pre-
25 mium or subscription share than the amount

1 that is paid by the Department of Defense for
2 health benefits for civilian employees under
3 chapter 89 of title 5, United States Code.

4 (b)(1) The Department of Defense, without regard
5 to subsection (a) of this section or subsection (a), (b), or
6 (c) of section 2461 of title 10, United States Code, and
7 notwithstanding any administrative regulation, require-
8 ment, or policy to the contrary shall have full authority
9 to enter into a contract for the performance of any com-
10 mercial or industrial type function of the Department of
11 Defense that—

12 (A) is included on the procurement list es-
13 tablished pursuant to section 2 of the Javits-
14 Wagner-O’Day Act (section 8503 of title 41,
15 United States Code);

16 (B) is planned to be converted to perform-
17 ance by a qualified nonprofit agency for the
18 blind or by a qualified nonprofit agency for
19 other severely handicapped individuals in ac-
20 cordance with that Act; or

21 (C) is planned to be converted to perform-
22 ance by a qualified firm under at least 51 per-
23 cent ownership by an Indian tribe, as defined in
24 section 4(e) of the Indian Self-Determination
25 and Education Assistance Act (25 U.S.C.

1 authority of this provision or any other transfer authority
2 contained in this Act: *Provided*, That subsection (j) of sec-
3 tion 831 of the National Defense Authorization Act for
4 Fiscal Year 1991 is amended by striking “September 30,
5 2010” and inserting “September 30, 2011”, and by strik-
6 ing “September 30, 2013” and inserting “September 30,
7 2014”.

8 SEC. 8017. None of the funds in this Act may be
9 available for the purchase by the Department of Defense
10 (and its departments and agencies) of welded shipboard
11 anchor and mooring chain 4 inches in diameter and under
12 unless the anchor and mooring chain are manufactured
13 in the United States from components which are substan-
14 tially manufactured in the United States: *Provided*, That
15 for the purpose of this section, the term “manufactured”
16 shall include cutting, heat treating, quality control, testing
17 of chain and welding (including the forging and shot blast-
18 ing process): *Provided further*, That for the purpose of this
19 section substantially all of the components of anchor and
20 mooring chain shall be considered to be produced or manu-
21 factured in the United States if the aggregate cost of the
22 components produced or manufactured in the United
23 States exceeds the aggregate cost of the components pro-
24 duced or manufactured outside the United States: *Pro-*
25 *vided further*, That when adequate domestic supplies are

1 not available to meet Department of Defense requirements
2 on a timely basis, the Secretary of the service responsible
3 for the procurement may waive this restriction on a case-
4 by-case basis by certifying in writing to the Committees
5 on Appropriations that such an acquisition must be made
6 in order to acquire capability for national security pur-
7 poses.

8 SEC. 8018. None of the funds available to the De-
9 partment of Defense may be used to demilitarize or dis-
10 pose of M-1 Carbines, M-1 Garand rifles, M-14 rifles,
11 .22 caliber rifles, .30 caliber rifles, or M-1911 pistols, or
12 to demilitarize or destroy small arms ammunition or am-
13 munition components that are not otherwise prohibited
14 from commercial sale under Federal law, unless the small
15 arms ammunition or ammunition components are certified
16 by the Secretary of the Army or designee as unserviceable
17 or unsafe for further use.

18 SEC. 8019. No more than \$500,000 of the funds ap-
19 propriated or made available in this Act shall be used dur-
20 ing a single fiscal year for any single relocation of an orga-
21 nization, unit, activity or function of the Department of
22 Defense into or within the National Capital Region: *Pro-*
23 *vided*, That the Secretary of Defense may waive this re-
24 striction on a case-by-case basis by certifying in writing

1 to the congressional defense committees that such a relo-
2 cation is required in the best interest of the Government.

3 SEC. 8020. In addition to the funds provided else-
4 where in this Act, \$15,000,000 is appropriated only for
5 incentive payments authorized by section 504 of the In-
6 dian Financing Act of 1974 (25 U.S.C. 1544): *Provided*,
7 That a prime contractor or a subcontractor at any tier
8 that makes a subcontract award to any subcontractor or
9 supplier as defined in section 1544 of title 25, United
10 States Code, or a small business owned and controlled by
11 an individual or individuals defined under section 4221(9)
12 of title 25, United States Code, shall be considered a con-
13 tractor for the purposes of being allowed additional com-
14 pensation under section 504 of the Indian Financing Act
15 of 1974 (25 U.S.C. 1544) whenever the prime contract
16 or subcontract amount is over \$500,000 and involves the
17 expenditure of funds appropriated by an Act making Ap-
18 propriations for the Department of Defense with respect
19 to any fiscal year: *Provided further*, That notwithstanding
20 section 430 of title 41, United States Code, this section
21 shall be applicable to any Department of Defense acquisi-
22 tion of supplies or services, including any contract and any
23 subcontract at any tier for acquisition of commercial items
24 produced or manufactured, in whole or in part by any sub-
25 contractor or supplier defined in section 1544 of title 25,

1 United States Code, or a small business owned and con-
2 trolled by an individual or individuals defined under sec-
3 tion 4221(9) of title 25, United States Code.

4 SEC. 8021. Funds appropriated by this Act for the
5 Defense Media Activity shall not be used for any national
6 or international political or psychological activities.

7 SEC. 8022. During the current fiscal year, the De-
8 partment of Defense is authorized to incur obligations of
9 not to exceed \$350,000,000 for purposes specified in sec-
10 tion 2350j(c) of title 10, United States Code, in anticipa-
11 tion of receipt of contributions, only from the Government
12 of Kuwait, under that section: *Provided*, That upon re-
13 ceipt, such contributions from the Government of Kuwait
14 shall be credited to the appropriations or fund which in-
15 curred such obligations.

16 SEC. 8023. (a) Of the funds made available in this
17 Act, not less than \$30,374,000 shall be available for the
18 Civil Air Patrol Corporation, of which—

19 (1) \$27,048,000 shall be available from “Oper-
20 ation and Maintenance, Air Force” to support Civil
21 Air Patrol Corporation operation and maintenance,
22 readiness, counterdrug activities, and drug demand
23 reduction activities involving youth programs;

24 (2) \$2,424,000 shall be available from “Aircraft
25 Procurement, Air Force”; and

1 (3) \$902,000 shall be available from “Other
2 Procurement, Air Force” for vehicle procurement.

3 (b) The Secretary of the Air Force should waive reim-
4 bursement for any funds used by the Civil Air Patrol for
5 counter-drug activities in support of Federal, State, and
6 local government agencies.

7 SEC. 8024. (a) None of the funds appropriated in this
8 Act are available to establish a new Department of De-
9 fense (department) federally funded research and develop-
10 ment center (FFRDC), either as a new entity, or as a
11 separate entity administrated by an organization man-
12 aging another FFRDC, or as a nonprofit membership cor-
13 poration consisting of a consortium of other FFRDCs and
14 other nonprofit entities.

15 (b) No member of a Board of Directors, Trustees,
16 Overseers, Advisory Group, Special Issues Panel, Visiting
17 Committee, or any similar entity of a defense FFRDC,
18 and no paid consultant to any defense FFRDC, except
19 when acting in a technical advisory capacity, may be com-
20 pensated for his or her services as a member of such enti-
21 ty, or as a paid consultant by more than one FFRDC in
22 a fiscal year: *Provided*, That a member of any such entity
23 referred to previously in this subsection shall be allowed
24 travel expenses and per diem as authorized under the Fed-

1 eral Joint Travel Regulations, when engaged in the per-
2 formance of membership duties.

3 (c) Notwithstanding any other provision of law, none
4 of the funds available to the department from any source
5 during fiscal year 2011 may be used by a defense FFRDC,
6 through a fee or other payment mechanism, for construc-
7 tion of new buildings, for payment of cost sharing for
8 projects funded by Government grants, for absorption of
9 contract overruns, or for certain charitable contributions,
10 not to include employee participation in community service
11 and/or development.

12 (d) Notwithstanding any other provision of law, of
13 the funds available to the department during fiscal year
14 2011, not more than 5,750 staff years of technical effort
15 (staff years) may be funded for defense FFRDCs: *Pro-*
16 *vided*, That of the specific amount referred to previously
17 in this subsection, not more than 1,125 staff years may
18 be funded for the defense studies and analysis FFRDCs:
19 *Provided further*, That this subsection shall not apply to
20 staff years funded in the National Intelligence Program
21 (NIP) and the Military Intelligence Program (MIP).

22 (e) The Secretary of Defense shall, with the submis-
23 sion of the department's fiscal year 2012 budget request,
24 submit a report presenting the specific amounts of staff
25 years of technical effort to be allocated for each defense

1 FFRDC during that fiscal year and the associated budget
2 estimates.

3 (f) Notwithstanding any other provision of this Act,
4 the total amount appropriated in this Act for FFRDCs
5 is hereby reduced by \$125,000,000.

6 SEC. 8025. None of the funds appropriated or made
7 available in this Act shall be used to procure carbon, alloy
8 or armor steel plate for use in any Government-owned fa-
9 cility or property under the control of the Department of
10 Defense which were not melted and rolled in the United
11 States or Canada: *Provided*, That these procurement re-
12 strictions shall apply to any and all Federal Supply Class
13 9515, American Society of Testing and Materials (ASTM)
14 or American Iron and Steel Institute (AISI) specifications
15 of carbon, alloy or armor steel plate: *Provided further*,
16 That the Secretary of the military department responsible
17 for the procurement may waive this restriction on a case-
18 by-case basis by certifying in writing to the Committees
19 on Appropriations of the House of Representatives and the
20 Senate that adequate domestic supplies are not available
21 to meet Department of Defense requirements on a timely
22 basis and that such an acquisition must be made in order
23 to acquire capability for national security purposes: *Pro-*
24 *vided further*, That these restrictions shall not apply to

1 contracts which are in being as of the date of the enact-
2 ment of this Act.

3 SEC. 8026. For the purposes of this Act, the term
4 “congressional defense committees” means the Armed
5 Services Committee of the House of Representatives, the
6 Armed Services Committee of the Senate, the Sub-
7 committee on Defense of the Committee on Appropriations
8 of the Senate, and the Subcommittee on Defense of the
9 Committee on Appropriations of the House of Representa-
10 tives.

11 SEC. 8027. During the current fiscal year, the De-
12 partment of Defense may acquire the modification, depot
13 maintenance and repair of aircraft, vehicles and vessels
14 as well as the production of components and other De-
15 fense-related articles, through competition between De-
16 partment of Defense depot maintenance activities and pri-
17 vate firms: *Provided*, That the Senior Acquisition Execu-
18 tive of the military department or Defense Agency con-
19 cerned, with power of delegation, shall certify that success-
20 ful bids include comparable estimates of all direct and in-
21 direct costs for both public and private bids: *Provided fur-*
22 *ther*, That Office of Management and Budget Circular A-
23 76 shall not apply to competitions conducted under this
24 section.

1 SEC. 8028. (a)(1) If the Secretary of Defense, after
2 consultation with the United States Trade Representative,
3 determines that a foreign country which is party to an
4 agreement described in paragraph (2) has violated the
5 terms of the agreement by discriminating against certain
6 types of products produced in the United States that are
7 covered by the agreement, the Secretary of Defense shall
8 rescind the Secretary's blanket waiver of the Buy Amer-
9 ican Act with respect to such types of products produced
10 in that foreign country.

11 (2) An agreement referred to in paragraph (1) is any
12 reciprocal defense procurement memorandum of under-
13 standing, between the United States and a foreign country
14 pursuant to which the Secretary of Defense has prospec-
15 tively waived the Buy American Act for certain products
16 in that country.

17 (b) The Secretary of Defense shall submit to the Con-
18 gress a report on the amount of Department of Defense
19 purchases from foreign entities in fiscal year 2011. Such
20 report shall separately indicate the dollar value of items
21 for which the Buy American Act was waived pursuant to
22 any agreement described in subsection (a)(2), the Trade
23 Agreement Act of 1979 (19 U.S.C. 2501 et seq.), or any
24 international agreement to which the United States is a
25 party.

1 (c) For purposes of this section, the term “Buy
2 American Act” means chapter 83 of title 41, United
3 States Code.

4 SEC. 8029. During the current fiscal year, amounts
5 contained in the Department of Defense Overseas Military
6 Facility Investment Recovery Account established by sec-
7 tion 2921(c)(1) of the National Defense Authorization Act
8 of 1991 (Public Law 101–510; 10 U.S.C. 2687 note) shall
9 be available until expended for the payments specified by
10 section 2921(c)(2) of that Act.

11 SEC. 8030. (a) Notwithstanding any other provision
12 of law, the Secretary of the Air Force may convey at no
13 cost to the Air Force, without consideration, to Indian
14 tribes located in the States of Nevada, Idaho, North Da-
15 kota, South Dakota, Montana, Oregon, Minnesota, and
16 Washington relocatable military housing units located at
17 Grand Forks Air Force Base, Malmstrom Air Force Base,
18 Mountain Home Air Force Base, Ellsworth Air Force
19 Base, and Minot Air Force Base that are excess to the
20 needs of the Air Force.

21 (b) The Secretary of the Air Force shall convey, at
22 no cost to the Air Force, military housing units under sub-
23 section (a) in accordance with the request for such units
24 that are submitted to the Secretary by the Operation
25 Walking Shield Program on behalf of Indian tribes located

1 in the States of Nevada, Idaho, North Dakota, South Da-
2 kota, Montana, Oregon, Minnesota, and Washington. Any
3 such conveyance shall be subject to the condition that the
4 housing units shall be removed within a reasonable period
5 of time, as determined by the Secretary.

6 (c) The Operation Walking Shield Program shall re-
7 solve any conflicts among requests of Indian tribes for
8 housing units under subsection (a) before submitting re-
9 quests to the Secretary of the Air Force under subsection
10 (b).

11 (d) In this section, the term “Indian tribe” means
12 any recognized Indian tribe included on the current list
13 published by the Secretary of the Interior under section
14 104 of the Federally Recognized Indian Tribe Act of 1994
15 (Public Law 103–454; 108 Stat. 4792; 25 U.S.C. 479a–
16 1).

17 SEC. 8031. During the current fiscal year, appropria-
18 tions which are available to the Department of Defense
19 for operation and maintenance may be used to purchase
20 items having an investment item unit cost of not more
21 than \$250,000.

22 SEC. 8032. (a) During the current fiscal year, none
23 of the appropriations or funds available to the Department
24 of Defense Working Capital Funds shall be used for the
25 purchase of an investment item for the purpose of acquir-

1 ing a new inventory item for sale or anticipated sale dur-
2 ing the current fiscal year or a subsequent fiscal year to
3 customers of the Department of Defense Working Capital
4 Funds if such an item would not have been chargeable
5 to the Department of Defense Business Operations Fund
6 during fiscal year 1994 and if the purchase of such an
7 investment item would be chargeable during the current
8 fiscal year to appropriations made to the Department of
9 Defense for procurement.

10 (b) The fiscal year 2012 budget request for the De-
11 partment of Defense as well as all justification material
12 and other documentation supporting the fiscal year 2012
13 Department of Defense budget shall be prepared and sub-
14 mitted to the Congress on the basis that any equipment
15 which was classified as an end item and funded in a pro-
16 curement appropriation contained in this Act shall be
17 budgeted for in a proposed fiscal year 2012 procurement
18 appropriation and not in the supply management business
19 area or any other area or category of the Department of
20 Defense Working Capital Funds.

21 SEC. 8033. None of the funds appropriated by this
22 Act for programs of the Central Intelligence Agency shall
23 remain available for obligation beyond the current fiscal
24 year, except for funds appropriated for the Reserve for
25 Contingencies, which shall remain available until Sep-

1 tember 30, 2012: *Provided*, That funds appropriated,
2 transferred, or otherwise credited to the Central Intel-
3 ligence Agency Central Services Working Capital Fund
4 during this or any prior or subsequent fiscal year shall
5 remain available until expended: *Provided further*, That
6 any funds appropriated or transferred to the Central Intel-
7 ligence Agency for advanced research and development ac-
8 quisition, for agent operations, and for covert action pro-
9 grams authorized by the President under section 503 of
10 the National Security Act of 1947, as amended, shall re-
11 main available until September 30, 2012.

12 SEC. 8034. Notwithstanding any other provision of
13 law, funds made available in this Act for the Defense In-
14 telligence Agency may be used for the design, develop-
15 ment, and deployment of General Defense Intelligence
16 Program intelligence communications and intelligence in-
17 formation systems for the Services, the Unified and Speci-
18 fied Commands, and the component commands.

19 SEC. 8035. Of the funds appropriated to the Depart-
20 ment of Defense under the heading “Operation and Main-
21 tenance, Defense-Wide”, not less than \$12,000,000 shall
22 be made available only for the mitigation of environmental
23 impacts, including training and technical assistance to
24 tribes, related administrative support, the gathering of in-
25 formation, documenting of environmental damage, and de-

1 veloping a system for prioritization of mitigation and cost
2 to complete estimates for mitigation, on Indian lands re-
3 sulting from Department of Defense activities.

4 SEC. 8036. (a) None of the funds appropriated in this
5 Act may be expended by an entity of the Department of
6 Defense unless the entity, in expending the funds, com-
7 plies with the Buy American Act. For purposes of this
8 subsection, the term “Buy American Act” means chapter
9 83 of title 41, United States Code.

10 (b) If the Secretary of Defense determines that a per-
11 son has been convicted of intentionally affixing a label
12 bearing a “Made in America” inscription to any product
13 sold in or shipped to the United States that is not made
14 in America, the Secretary shall determine, in accordance
15 with section 2410f of title 10, United States Code, wheth-
16 er the person should be debarred from contracting with
17 the Department of Defense.

18 (c) In the case of any equipment or products pur-
19 chased with appropriations provided under this Act, it is
20 the sense of the Congress that any entity of the Depart-
21 ment of Defense, in expending the appropriation, purchase
22 only American-made equipment and products, provided
23 that American-made equipment and products are cost-
24 competitive, quality competitive, and available in a timely
25 fashion.

1 SEC. 8037. None of the funds appropriated by this
2 Act shall be available for a contract for studies, analysis,
3 or consulting services entered into without competition on
4 the basis of an unsolicited proposal unless the head of the
5 activity responsible for the procurement determines—

6 (1) as a result of thorough technical evaluation,
7 only one source is found fully qualified to perform
8 the proposed work;

9 (2) the purpose of the contract is to explore an
10 unsolicited proposal which offers significant sci-
11 entific or technological promise, represents the prod-
12 uct of original thinking, and was submitted in con-
13 fidence by one source; or

14 (3) the purpose of the contract is to take ad-
15 vantage of unique and significant industrial accom-
16 plishment by a specific concern, or to insure that a
17 new product or idea of a specific concern is given fi-
18 nancial support: *Provided*, That this limitation shall
19 not apply to contracts in an amount of less than
20 \$25,000, contracts related to improvements of equip-
21 ment that is in development or production, or con-
22 tracts as to which a civilian official of the Depart-
23 ment of Defense, who has been confirmed by the
24 Senate, determines that the award of such contract
25 is in the interest of the national defense.

1 SEC. 8038. (a) Except as provided in subsections (b)
2 and (c), none of the funds made available by this Act may
3 be used—

4 (1) to establish a field operating agency; or

5 (2) to pay the basic pay of a member of the
6 Armed Forces or civilian employee of the depart-
7 ment who is transferred or reassigned from a head-
8 quarters activity if the member or employee's place
9 of duty remains at the location of that headquarters.

10 (b) The Secretary of Defense or Secretary of a mili-
11 tary department may waive the limitations in subsection
12 (a), on a case-by-case basis, if the Secretary determines,
13 and certifies to the Committees on Appropriations of the
14 House of Representatives and Senate that the granting
15 of the waiver will reduce the personnel requirements or
16 the financial requirements of the department.

17 (c) This section does not apply to—

18 (1) field operating agencies funded within the
19 National Intelligence Program;

20 (2) an Army field operating agency established
21 to eliminate, mitigate, or counter the effects of im-
22 proved explosive devices, and, as determined by the
23 Secretary of the Army, other similar threats; or

24 (3) an Army field operating agency established
25 to improve the effectiveness and efficiencies of bio-

1 metric activities and to integrate common biometric
2 technologies throughout the Department of Defense.

3 SEC. 8039. The Secretary of Defense, notwith-
4 standing any other provision of law, acting through the
5 Office of Economic Adjustment of the Department of De-
6 fense, may use funds made available in this Act under the
7 heading “Operation and Maintenance, Defense-Wide” to
8 make grants and supplement other Federal funds in ac-
9 cordance with the guidance provided in the explanatory
10 statement regarding this Act.

11 (RESCISSIONS)

12 SEC. 8040. Of the funds appropriated in Department
13 of Defense Appropriations Acts, the following funds are
14 hereby rescinded from the following accounts and pro-
15 grams in the specified amounts:

16 “Procurement of Weapons and Tracked Combat
17 Vehicles, Army, 2009/2011”, \$86,300,000.

18 “Other Procurement, Army, 2009/2011”,
19 \$147,600,000.

20 “Aircraft Procurement, Navy, 2009/2011”,
21 \$26,100,000.

22 “Aircraft Procurement, Air Force, 2009/2011”,
23 \$116,900,000.

24 “Aircraft Procurement, Army, 2010/2012”,
25 \$14,000,000.

1 “Procurement of Weapons and Tracked Combat
2 Vehicles, Army, 2010/2012”, \$36,000,000.

3 “Missile Procurement, Army, 2010/2012”,
4 \$9,171,000.

5 “Aircraft Procurement, Navy, 2010/2012”,
6 \$284,847,000.

7 “Procurement of Ammunition, Navy and Ma-
8 rine Corps, 2010/2012”, \$11,576,000.

9 Under the heading, “Shipbuilding and Conver-
10 sion, Navy, 2010/2014”: DDG-51 Destroyer,
11 \$22,000,000.

12 “Other Procurement, Navy, 2010/2012”,
13 \$9,042,000.

14 “Aircraft Procurement, Air Force, 2010/2012”,
15 \$151,300,000.

16 “Other Procurement, Air Force, 2010/2012”,
17 \$36,600,000.

18 “Research, Development, Test and Evaluation,
19 Army, 2010/2011”, \$53,500,000.

20 “Research, Development, Test and Evaluation,
21 Air Force, 2010/2011”, \$198,600,000.

22 “Research, Development, Test and Evaluation,
23 Defense-Wide, 2010/2011”, \$10,000,000.

24 SEC. 8041. None of the funds available in this Act
25 may be used to reduce the authorized positions for mili-

1 tary (civilian) technicians of the Army National Guard,
2 Air National Guard, Army Reserve and Air Force Reserve
3 for the purpose of applying any administratively imposed
4 civilian personnel ceiling, freeze, or reduction on military
5 (civilian) technicians, unless such reductions are a direct
6 result of a reduction in military force structure.

7 SEC. 8042. None of the funds appropriated or other-
8 wise made available in this Act may be obligated or ex-
9 pended for assistance to the Democratic People's Republic
10 of Korea unless specifically appropriated for that purpose.

11 SEC. 8043. Funds appropriated in this Act for oper-
12 ation and maintenance of the Military Departments, Com-
13 batant Commands and Defense Agencies shall be available
14 for reimbursement of pay, allowances and other expenses
15 which would otherwise be incurred against appropriations
16 for the National Guard and Reserve when members of the
17 National Guard and Reserve provide intelligence or coun-
18 terintelligence support to Combatant Commands, Defense
19 Agencies and Joint Intelligence Activities, including the
20 activities and programs included within the National Intel-
21 ligence Program and the Military Intelligence Program:
22 *Provided*, That nothing in this section authorizes deviation
23 from established Reserve and National Guard personnel
24 and training procedures.

1 SEC. 8044. During the current fiscal year, none of
2 the funds appropriated in this Act may be used to reduce
3 the civilian medical and medical support personnel as-
4 signed to military treatment facilities below the September
5 30, 2003, level: *Provided*, That the Service Surgeons Gen-
6 eral may waive this section by certifying to the congres-
7 sional defense committees that the beneficiary population
8 is declining in some catchment areas and civilian strength
9 reductions may be consistent with responsible resource
10 stewardship and capitation-based budgeting.

11 SEC. 8045. (a) None of the funds available to the
12 Department of Defense for any fiscal year for drug inter-
13 diction or counter-drug activities may be transferred to
14 any other department or agency of the United States ex-
15 cept as specifically provided in an appropriations law.

16 (b) None of the funds available to the Central Intel-
17 ligence Agency for any fiscal year for drug interdiction
18 and counter-drug activities may be transferred to any
19 other department or agency of the United States except
20 as specifically provided in an appropriations law.

21 SEC. 8046. None of the funds appropriated by this
22 Act may be used for the procurement of ball and roller
23 bearings other than those produced by a domestic source
24 and of domestic origin: *Provided*, That the Secretary of
25 the military department responsible for such procurement

1 may waive this restriction on a case-by-case basis by certi-
2 fying in writing to the Committees on Appropriations of
3 the House of Representatives and the Senate, that ade-
4 quate domestic supplies are not available to meet Depart-
5 ment of Defense requirements on a timely basis and that
6 such an acquisition must be made in order to acquire ca-
7 pability for national security purposes: *Provided further*,
8 That this restriction shall not apply to the purchase of
9 “commercial items”, as defined by section 4(12) of the
10 Office of Federal Procurement Policy Act, except that the
11 restriction shall apply to ball or roller bearings purchased
12 as end items.

13 SEC. 8047. None of the funds in this Act may be
14 used to purchase any supercomputer which is not manu-
15 factured in the United States, unless the Secretary of De-
16 fense certifies to the congressional defense committees
17 that such an acquisition must be made in order to acquire
18 capability for national security purposes that is not avail-
19 able from United States manufacturers.

20 SEC. 8048. None of the funds made available in this
21 or any other Act may be used to pay the salary of any
22 officer or employee of the Department of Defense who ap-
23 proves or implements the transfer of administrative re-
24 sponsibilities or budgetary resources of any program,
25 project, or activity financed by this Act to the jurisdiction

1 of another Federal agency not financed by this Act with-
2 out the express authorization of Congress: *Provided*, That
3 this limitation shall not apply to transfers of funds ex-
4 pressly provided for in Defense Appropriations Acts, or
5 provisions of Acts providing supplemental appropriations
6 for the Department of Defense.

7 SEC. 8049. (a) Notwithstanding any other provision
8 of law, none of the funds available to the Department of
9 Defense for the current fiscal year may be obligated or
10 expended to transfer to another nation or an international
11 organization any defense articles or services (other than
12 intelligence services) for use in the activities described in
13 subsection (b) unless the congressional defense commit-
14 tees, the Committee on Foreign Affairs of the House of
15 Representatives, and the Committee on Foreign Relations
16 of the Senate are notified 15 days in advance of such
17 transfer.

18 (b) This section applies to—

19 (1) any international peacekeeping or peace-en-
20 forcement operation under the authority of chapter
21 VI or chapter VII of the United Nations Charter
22 under the authority of a United Nations Security
23 Council resolution; and

24 (2) any other international peacekeeping, peace-
25 enforcement, or humanitarian assistance operation.

1 (c) A notice under subsection (a) shall include the
2 following:

3 (1) A description of the equipment, supplies, or
4 services to be transferred.

5 (2) A statement of the value of the equipment,
6 supplies, or services to be transferred.

7 (3) In the case of a proposed transfer of equip-
8 ment or supplies—

9 (A) a statement of whether the inventory
10 requirements of all elements of the Armed
11 Forces (including the reserve components) for
12 the type of equipment or supplies to be trans-
13 ferred have been met; and

14 (B) a statement of whether the items pro-
15 posed to be transferred will have to be replaced
16 and, if so, how the President proposes to pro-
17 vide funds for such replacement.

18 SEC. 8050. None of the funds available to the De-
19 partment of Defense under this Act shall be obligated or
20 expended to pay a contractor under a contract with the
21 Department of Defense for costs of any amount paid by
22 the contractor to an employee when—

23 (1) such costs are for a bonus or otherwise in
24 excess of the normal salary paid by the contractor
25 to the employee; and

1 (2) such bonus is part of restructuring costs as-
2 sociated with a business combination.

3 (INCLUDING TRANSFER OF FUNDS)

4 SEC. 8051. During the current fiscal year, no more
5 than \$30,000,000 of appropriations made in this Act
6 under the heading “Operation and Maintenance, Defense-
7 Wide” may be transferred to appropriations available for
8 the pay of military personnel, to be merged with, and to
9 be available for the same time period as the appropriations
10 to which transferred, to be used in support of such per-
11 sonnel in connection with support and services for eligible
12 organizations and activities outside the Department of De-
13 fense pursuant to section 2012 of title 10, United States
14 Code.

15 SEC. 8052. During the current fiscal year, in the case
16 of an appropriation account of the Department of Defense
17 for which the period of availability for obligation has ex-
18 pired or which has closed under the provisions of section
19 1552 of title 31, United States Code, and which has a
20 negative unliquidated or unexpended balance, an obliga-
21 tion or an adjustment of an obligation may be charged
22 to any current appropriation account for the same purpose
23 as the expired or closed account if—

24 (1) the obligation would have been properly
25 chargeable (except as to amount) to the expired or

1 closed account before the end of the period of avail-
2 ability or closing of that account;

3 (2) the obligation is not otherwise properly
4 chargeable to any current appropriation account of
5 the Department of Defense; and

6 (3) in the case of an expired account, the obli-
7 gation is not chargeable to a current appropriation
8 of the Department of Defense under the provisions
9 of section 1405(b)(8) of the National Defense Au-
10 thorization Act for Fiscal Year 1991, Public Law
11 101-510, as amended (31 U.S.C. 1551 note): *Pro-*
12 *vided*, That in the case of an expired account, if sub-
13 sequent review or investigation discloses that there
14 was not in fact a negative unliquidated or unex-
15 pended balance in the account, any charge to a cur-
16 rent account under the authority of this section shall
17 be reversed and recorded against the expired ac-
18 count: *Provided further*, That the total amount
19 charged to a current appropriation under this sec-
20 tion may not exceed an amount equal to 1 percent
21 of the total appropriation for that account.

22 SEC. 8053. (a) Notwithstanding any other provision
23 of law, the Chief of the National Guard Bureau may per-
24 mit the use of equipment of the National Guard Distance
25 Learning Project by any person or entity on a space-avail-

1 able, reimbursable basis. The Chief of the National Guard
2 Bureau shall establish the amount of reimbursement for
3 such use on a case-by-case basis.

4 (b) Amounts collected under subsection (a) shall be
5 credited to funds available for the National Guard Dis-
6 tance Learning Project and be available to defray the costs
7 associated with the use of equipment of the project under
8 that subsection. Such funds shall be available for such
9 purposes without fiscal year limitation.

10 SEC. 8054. Using funds made available by this Act
11 or any other Act, the Secretary of the Air Force, pursuant
12 to a determination under section 2690 of title 10, United
13 States Code, may implement cost-effective agreements for
14 required heating facility modernization in the
15 Kaiserslautern Military Community in the Federal Repub-
16 lic of Germany: *Provided*, That in the City of
17 Kaiserslautern and at the Rhine Ordnance Barracks area,
18 such agreements will include the use of United States an-
19 thracite as the base load energy for municipal district heat
20 to the United States Defense installations: *Provided fur-*
21 *ther*, That at Landstuhl Army Regional Medical Center
22 and Ramstein Air Base, furnished heat may be obtained
23 from private, regional or municipal services, if provisions
24 are included for the consideration of United States coal
25 as an energy source.

1 SEC. 8055. None of the funds appropriated in title
2 IV of this Act may be used to procure end-items for deliv-
3 ery to military forces for operational training, operational
4 use or inventory requirements: *Provided*, That this restric-
5 tion does not apply to end-items used in development,
6 prototyping, and test activities preceding and leading to
7 acceptance for operational use: *Provided further*, That this
8 restriction does not apply to programs funded within the
9 National Intelligence Program: *Provided further*, That the
10 Secretary of Defense may waive this restriction on a case-
11 by-case basis by certifying in writing to the Committees
12 on Appropriations of the House of Representatives and the
13 Senate that it is in the national security interest to do
14 so.

15 SEC. 8056. None of the funds made available in this
16 Act may be used to approve or license the sale of the F-
17 22A advanced tactical fighter to any foreign government:
18 *Provided*, That the Department of Defense may conduct
19 or participate in studies, research, design and other activi-
20 ties to define and develop a future export version of the
21 F-22A that protects classified and sensitive information,
22 technologies and U.S. warfighting capabilities.

23 SEC. 8057. (a) The Secretary of Defense may, on a
24 case-by-case basis, waive with respect to a foreign country
25 each limitation on the procurement of defense items from

1 foreign sources provided in law if the Secretary determines
2 that the application of the limitation with respect to that
3 country would invalidate cooperative programs entered
4 into between the Department of Defense and the foreign
5 country, or would invalidate reciprocal trade agreements
6 for the procurement of defense items entered into under
7 section 2531 of title 10, United States Code, and the
8 country does not discriminate against the same or similar
9 defense items produced in the United States for that coun-
10 try.

11 (b) Subsection (a) applies with respect to—

12 (1) contracts and subcontracts entered into on
13 or after the date of the enactment of this Act; and

14 (2) options for the procurement of items that
15 are exercised after such date under contracts that
16 are entered into before such date if the option prices
17 are adjusted for any reason other than the applica-
18 tion of a waiver granted under subsection (a).

19 (c) Subsection (a) does not apply to a limitation re-
20 garding construction of public vessels, ball and roller bear-
21 ings, food, and clothing or textile materials as defined by
22 section 11 (chapters 50–65) of the Harmonized Tariff
23 Schedule and products classified under headings 4010,
24 4202, 4203, 6401 through 6406, 6505, 7019, 7218

1 through 7229, 7304.41 through 7304.49, 7306.40, 7502
2 through 7508, 8105, 8108, 8109, 8211, 8215, and 9404.

3 SEC. 8058. (a) None of the funds made available by
4 this Act may be used to support any training program in-
5 volving a unit of the security forces or police of a foreign
6 country if the Secretary of Defense has received credible
7 information from the Department of State that the unit
8 has committed a gross violation of human rights, unless
9 all necessary corrective steps have been taken.

10 (b) The Secretary of Defense, in consultation with the
11 Secretary of State, shall ensure that prior to a decision
12 to conduct any training program referred to in subsection
13 (a), full consideration is given to all credible information
14 available to the Department of State relating to human
15 rights violations by foreign security forces.

16 (c) The Secretary of Defense, after consultation with
17 the Secretary of State, may waive the prohibition in sub-
18 section (a) if he determines that such waiver is required
19 by extraordinary circumstances.

20 (d) Not more than 15 days after the exercise of any
21 waiver under subsection (c), the Secretary of Defense shall
22 submit a report to the congressional defense committees
23 describing the extraordinary circumstances, the purpose
24 and duration of the training program, the United States
25 forces and the foreign security forces involved in the train-

1 ing program, and the information relating to human rights
2 violations that necessitates the waiver.

3 SEC. 8059. None of the funds appropriated or made
4 available in this Act to the Department of the Navy shall
5 be used to develop, lease or procure the T-AKE class of
6 ships unless the main propulsion diesel engines and
7 propulsors are manufactured in the United States by a
8 domestically operated entity: *Provided*, That the Secretary
9 of Defense may waive this restriction on a case-by-case
10 basis by certifying in writing to the Committees on Appro-
11 priations of the House of Representatives and the Senate
12 that adequate domestic supplies are not available to meet
13 Department of Defense requirements on a timely basis
14 and that such an acquisition must be made in order to
15 acquire capability for national security purposes or there
16 exists a significant cost or quality difference.

17 SEC. 8060. None of the funds appropriated or other-
18 wise made available by this or other Department of De-
19 fense Appropriations Acts may be obligated or expended
20 for the purpose of performing repairs or maintenance to
21 military family housing units of the Department of De-
22 fense, including areas in such military family housing
23 units that may be used for the purpose of conducting offi-
24 cial Department of Defense business.

1 SEC. 8061. Notwithstanding any other provision of
2 law, funds appropriated in this Act under the heading
3 “Research, Development, Test and Evaluation, Defense-
4 Wide” for any new start advanced concept technology
5 demonstration project or joint capability demonstration
6 project may only be obligated 30 days after a report, in-
7 cluding a description of the project, the planned acquisi-
8 tion and transition strategy and its estimated annual and
9 total cost, has been provided in writing to the congress-
10 sional defense committees: *Provided*, That the Secretary
11 of Defense may waive this restriction on a case-by-case
12 basis by certifying to the congressional defense committees
13 that it is in the national interest to do so.

14 SEC. 8062. The Secretary of Defense shall provide
15 a classified quarterly report beginning 30 days after enact-
16 ment of this Act, to the House and Senate Appropriations
17 Committees, Subcommittees on Defense on certain mat-
18 ters as directed in the classified annex accompanying this
19 Act.

20 SEC. 8063. During the current fiscal year, none of
21 the funds available to the Department of Defense may be
22 used to provide support to another department or agency
23 of the United States if such department or agency is more
24 than 90 days in arrears in making payment to the Depart-
25 ment of Defense for goods or services previously provided

1 to such department or agency on a reimbursable basis:
2 *Provided*, That this restriction shall not apply if the de-
3 partment is authorized by law to provide support to such
4 department or agency on a nonreimbursable basis, and is
5 providing the requested support pursuant to such author-
6 ity: *Provided further*, That the Secretary of Defense may
7 waive this restriction on a case-by-case basis by certifying
8 in writing to the Committees on Appropriations of the
9 House of Representatives and the Senate that it is in the
10 national security interest to do so.

11 SEC. 8064. Notwithstanding section 12310(b) of title
12 10, United States Code, a Reserve who is a member of
13 the National Guard serving on full-time National Guard
14 duty under section 502(f) of title 32, United States Code,
15 may perform duties in support of the ground-based ele-
16 ments of the National Ballistic Missile Defense System.

17 SEC. 8065. None of the funds provided in this Act
18 may be used to transfer to any nongovernmental entity
19 ammunition held by the Department of Defense that has
20 a center-fire cartridge and a United States military no-
21 menclature designation of “armor penetrator”, “armor
22 piercing (AP)”, “armor piercing incendiary (API)”, or
23 “armor-piercing incendiary tracer (API-T)”, except to an
24 entity performing demilitarization services for the Depart-
25 ment of Defense under a contract that requires the entity

1 to demonstrate to the satisfaction of the Department of
2 Defense that armor piercing projectiles are either: (1) ren-
3 dered incapable of reuse by the demilitarization process;
4 or (2) used to manufacture ammunition pursuant to a con-
5 tract with the Department of Defense or the manufacture
6 of ammunition for export pursuant to a License for Per-
7 manent Export of Unclassified Military Articles issued by
8 the Department of State.

9 SEC. 8066. Notwithstanding any other provision of
10 law, the Chief of the National Guard Bureau, or his des-
11 ignee, may waive payment of all or part of the consider-
12 ation that otherwise would be required under section 2667
13 of title 10, United States Code, in the case of a lease of
14 personal property for a period not in excess of 1 year to
15 any organization specified in section 508(d) of title 32,
16 United States Code, or any other youth, social, or fra-
17 ternal nonprofit organization as may be approved by the
18 Chief of the National Guard Bureau, or his designee, on
19 a case-by-case basis.

20 SEC. 8067. None of the funds appropriated by this
21 Act shall be used for the support of any nonappropriated
22 funds activity of the Department of Defense that procures
23 malt beverages and wine with nonappropriated funds for
24 resale (including such alcoholic beverages sold by the
25 drink) on a military installation located in the United

1 States unless such malt beverages and wine are procured
2 within that State, or in the case of the District of Colum-
3 bia, within the District of Columbia, in which the military
4 installation is located: *Provided*, That in a case in which
5 the military installation is located in more than one State,
6 purchases may be made in any State in which the installa-
7 tion is located: *Provided further*, That such local procure-
8 ment requirements for malt beverages and wine shall
9 apply to all alcoholic beverages only for military installa-
10 tions in States which are not contiguous with another
11 State: *Provided further*, That alcoholic beverages other
12 than wine and malt beverages, in contiguous States and
13 the District of Columbia shall be procured from the most
14 competitive source, price and other factors considered.

15 SEC. 8068. Funds available to the Department of De-
16 fense for the Global Positioning System during the current
17 fiscal year, and hereafter, may be used to fund civil re-
18 quirements associated with the satellite and ground con-
19 trol segments of such system's modernization program.

20 (INCLUDING TRANSFER OF FUNDS)

21 SEC. 8069. Of the amounts appropriated in this Act
22 under the heading "Operation and Maintenance, Army",
23 \$147,258,300 shall remain available until expended: *Pro-*
24 *vided*, That notwithstanding any other provision of law,
25 the Secretary of Defense is authorized to transfer such

1 funds to other activities of the Federal Government: *Pro-*
2 *vided further*, That the Secretary of Defense is authorized
3 to enter into and carry out contracts for the acquisition
4 of real property, construction, personal services, and oper-
5 ations related to projects carrying out the purposes of this
6 section: *Provided further*, That contracts entered into
7 under the authority of this section may provide for such
8 indemnification as the Secretary determines to be nec-
9 essary: *Provided further*, That projects authorized by this
10 section shall comply with applicable Federal, State, and
11 local law to the maximum extent consistent with the na-
12 tional security, as determined by the Secretary of Defense.

13 SEC. 8070. Section 8106 of the Department of De-
14 fense Appropriations Act, 1997 (titles I through VIII of
15 the matter under subsection 101(b) of Public Law 104–
16 208; 110 Stat. 3009–111; 10 U.S.C. 113 note) shall con-
17 tinue in effect to apply to disbursements that are made
18 by the Department of Defense in fiscal year 2011.

19 SEC. 8071. In addition to amounts provided else-
20 where in this Act, \$4,000,000 is hereby appropriated to
21 the Department of Defense, to remain available for obliga-
22 tion until expended: *Provided*, That notwithstanding any
23 other provision of law, that upon the determination of the
24 Secretary of Defense that it shall serve the national inter-
25 est, these funds shall be available only for a grant to the

1 Fisher House Foundation, Inc., only for the construction
2 and furnishing of additional Fisher Houses to meet the
3 needs of military family members when confronted with
4 the illness or hospitalization of an eligible military bene-
5 ficiary.

6 (INCLUDING TRANSFER OF FUNDS)

7 SEC. 8072. Of the amounts appropriated in this Act
8 under the headings “Procurement, Defense-Wide” and
9 “Research, Development, Test and Evaluation, Defense-
10 Wide”, \$415,115,000 shall be for the Israeli Cooperative
11 Programs: *Provided*, That of this amount, \$205,000,000
12 shall be for the Secretary of Defense to provide to the Gov-
13 ernment of Israel for the procurement of the Iron Dome
14 defense system to counter short-range rocket threats,
15 \$84,722,000 shall be for the Short Range Ballistic Missile
16 Defense (SRBMD) program, including cruise missile de-
17 fense research and development under the SRBMD pro-
18 gram, \$58,966,000 shall be available for an upper-tier
19 component to the Israeli Missile Defense Architecture, and
20 \$66,427,000 shall be for the Arrow System Improvement
21 Program including development of a long range, ground
22 and airborne, detection suite, of which \$12,000,000 shall
23 be for producing Arrow missile components in the United
24 States and Arrow missile components in Israel to meet
25 Israel’s defense requirements, consistent with each na-

1 tion's laws, regulations and procedures: *Provided further,*
2 That funds made available under this provision for pro-
3 duction of missiles and missile components may be trans-
4 ferred to appropriations available for the procurement of
5 weapons and equipment, to be merged with and to be
6 available for the same time period and the same purposes
7 as the appropriation to which transferred: *Provided fur-*
8 *ther,* That the transfer authority provided under this pro-
9 vision is in addition to any other transfer authority con-
10 tained in this Act.

11 SEC. 8073. None of the funds available to the De-
12 partment of Defense may be obligated to modify command
13 and control relationships to give Fleet Forces Command
14 administrative and operational control of U.S. Navy forces
15 assigned to the Pacific fleet: *Provided,* That the command
16 and control relationships which existed on October 1,
17 2004, shall remain in force unless changes are specifically
18 authorized in a subsequent Act.

19 SEC. 8074. Notwithstanding any other provision of
20 law or regulation, the Secretary of Defense may exercise
21 the provisions of section 7403(g) of title 38, United States
22 Code, for occupations listed in section 7403(a)(2) of title
23 38, United States Code, as well as the following:

24 Pharmacists, Audiologists, Psychologists, Social
25 Workers, Othotists/Prosthetists, Occupational

1 Therapists, Physical Therapists, Rehabilitation
2 Therapists, Respiratory Therapists, Speech Patholo-
3 gists, Dietitian/Nutritionists, Industrial Hygienists,
4 Psychology Technicians, Social Service Assistants,
5 Practical Nurses, Nursing Assistants, and Dental
6 Hygienists:

7 (A) The requirements of section
8 7403(g)(1)(A) of title 38, United States Code,
9 shall apply.

10 (B) The limitations of section
11 7403(g)(1)(B) of title 38, United States Code,
12 shall not apply.

13 SEC. 8075. Funds appropriated by this Act, or made
14 available by the transfer of funds in this Act, for intel-
15 ligence activities are deemed to be specifically authorized
16 by the Congress for purposes of section 504 of the Na-
17 tional Security Act of 1947 (50 U.S.C. 414) during fiscal
18 year 2011 until the enactment of the Intelligence Author-
19 ization Act for Fiscal Year 2011.

20 SEC. 8076. None of the funds provided in this Act
21 shall be available for obligation or expenditure through a
22 reprogramming of funds that creates or initiates a new
23 program, project, or activity unless such program, project,
24 or activity must be undertaken immediately in the interest

1 of national security and only after written prior notifica-
2 tion to the congressional defense committees.

3 SEC. 8077. The budget of the President for fiscal
4 year 2012 submitted to the Congress pursuant to section
5 1105 of title 31, United States Code, shall include sepa-
6 rate budget justification documents for costs of United
7 States Armed Forces' participation in contingency oper-
8 ations for the Military Personnel accounts, the Operation
9 and Maintenance accounts, and the Procurement ac-
10 counts: *Provided*, That these documents shall include a de-
11 scription of the funding requested for each contingency op-
12 eration, for each military service, to include all Active and
13 Reserve components, and for each appropriations account:
14 *Provided further*, That these documents shall include esti-
15 mated costs for each element of expense or object class,
16 a reconciliation of increases and decreases for each contin-
17 gency operation, and programmatic data including, but
18 not limited to, troop strength for each Active and Reserve
19 component, and estimates of the major weapons systems
20 deployed in support of each contingency: *Provided further*,
21 That these documents shall include budget exhibits OP-
22 5 and OP-32 (as defined in the Department of Defense
23 Financial Management Regulation) for all contingency op-
24 erations for the budget year and the two preceding fiscal
25 years.

1 SEC. 8078. None of the funds in this Act may be
2 used for research, development, test, evaluation, procure-
3 ment or deployment of nuclear armed interceptors of a
4 missile defense system.

5 (INCLUDING TRANSFER OF FUNDS)

6 SEC. 8079. In addition to the amounts appropriated
7 or otherwise made available elsewhere in this Act,
8 \$65,200,000 is hereby appropriated to the Department of
9 Defense: *Provided*, That upon the determination of the
10 Secretary of Defense that it shall serve the national inter-
11 est, he shall make grants in the amounts specified as fol-
12 lows: \$20,000,000 to the United Service Organizations;
13 \$24,000,000 to the Red Cross; \$1,200,000 to the Special
14 Olympics; and \$20,000,000 to the Youth Mentoring
15 Grants Program: *Provided further*, That funds available
16 in this section for the Youth Mentoring Grants Program
17 may be available for transfer to the Department of Justice
18 Youth Mentoring Grants Program.

19 SEC. 8080. None of the funds appropriated or made
20 available in this Act shall be used to reduce or disestablish
21 the operation of the 53rd Weather Reconnaissance Squad-
22 ron of the Air Force Reserve, if such action would reduce
23 the WC-130 Weather Reconnaissance mission below the
24 levels funded in this Act: *Provided*, That the Air Force
25 shall allow the 53rd Weather Reconnaissance Squadron to

1 perform other missions in support of national defense re-
2 quirements during the non-hurricane season.

3 SEC. 8081. None of the funds provided in this Act
4 shall be available for integration of foreign intelligence in-
5 formation unless the information has been lawfully col-
6 lected and processed during the conduct of authorized for-
7 eign intelligence activities: *Provided*, That information
8 pertaining to United States persons shall only be handled
9 in accordance with protections provided in the Fourth
10 Amendment of the United States Constitution as imple-
11 mented through Executive Order No. 12333.

12 SEC. 8082. (a) At the time members of reserve com-
13 ponents of the Armed Forces are called or ordered to ac-
14 tive duty under section 12302(a) of title 10, United States
15 Code, each member shall be notified in writing of the ex-
16 pected period during which the member will be mobilized.

17 (b) The Secretary of Defense may waive the require-
18 ments of subsection (a) in any case in which the Secretary
19 determines that it is necessary to do so to respond to a
20 national security emergency or to meet dire operational
21 requirements of the Armed Forces.

22 (INCLUDING TRANSFER OF FUNDS)

23 SEC. 8083. The Secretary of Defense may transfer
24 funds from any available Department of the Navy appro-
25 priation to any available Navy ship construction appro-

1 priation for the purpose of liquidating necessary changes
2 resulting from inflation, market fluctuations, or rate ad-
3 justments for any ship construction program appropriated
4 in law: *Provided*, That the Secretary may transfer not to
5 exceed \$100,000,000 under the authority provided by this
6 section: *Provided further*, That the Secretary may not
7 transfer any funds until 30 days after the proposed trans-
8 fer has been reported to the Committees on Appropria-
9 tions of the House of Representatives and the Senate, un-
10 less a response from the Committees is received sooner:
11 *Provided further*, That any funds transferred pursuant to
12 this section shall retain the same period of availability as
13 when originally appropriated: *Provided further*, That the
14 transfer authority provided by this section is in addition
15 to any other transfer authority contained elsewhere in this
16 Act.

17 SEC. 8084. For purposes of section 7108 of title 41,
18 United States Code, any subdivision of appropriations
19 made under the heading “Shipbuilding and Conversion,
20 Navy” that is not closed at the time reimbursement is
21 made shall be available to reimburse the Judgment Fund
22 and shall be considered for the same purposes as any sub-
23 division under the heading “Shipbuilding and Conversion,
24 Navy” appropriations in the current fiscal year or any
25 prior fiscal year.

1 SEC. 8085. (a) None of the funds appropriated by
2 this Act may be used to transfer research and develop-
3 ment, acquisition, or other program authority relating to
4 current tactical unmanned aerial vehicles (TUAVs) from
5 the Army.

6 (b) The Army shall retain responsibility for and oper-
7 ational control of the MQ-1C Sky Warrior Unmanned
8 Aerial Vehicle (UAV) in order to support the Secretary
9 of Defense in matters relating to the employment of un-
10 manned aerial vehicles.

11 SEC. 8086. Notwithstanding any other provision of
12 law or regulation, during the current fiscal year and here-
13 after, the Secretary of Defense may adjust wage rates for
14 civilian employees hired for certain health care occupa-
15 tions as authorized for the Secretary of Veterans Affairs
16 by section 7455 of title 38, United States Code.

17 SEC. 8087. Up to \$15,000,000 of the funds appro-
18 priated under the heading “Operation and Maintenance,
19 Navy” may be made available for the Asia Pacific Re-
20 gional Initiative Program for the purpose of enabling the
21 Pacific Command to execute Theater Security Cooperation
22 activities such as humanitarian assistance, and payment
23 of incremental and personnel costs of training and exer-
24 cising with foreign security forces: *Provided*, That funds
25 made available for this purpose may be used, notwith-

1 standing any other funding authorities for humanitarian
2 assistance, security assistance or combined exercise ex-
3 penses: *Provided further*, That funds may not be obligated
4 to provide assistance to any foreign country that is other-
5 wise prohibited from receiving such type of assistance
6 under any other provision of law.

7 SEC. 8088. None of the funds appropriated by this
8 Act for programs of the Office of the Director of National
9 Intelligence shall remain available for obligation beyond
10 the current fiscal year, except for funds appropriated for
11 research and technology, which shall remain available until
12 September 30, 2012.

13 SEC. 8089. For purposes of section 1553(b) of title
14 31, United States Code, any subdivision of appropriations
15 made in this Act under the heading “Shipbuilding and
16 Conversion, Navy” shall be considered to be for the same
17 purpose as any subdivision under the heading “Ship-
18 building and Conversion, Navy” appropriations in any
19 prior fiscal year, and the 1 percent limitation shall apply
20 to the total amount of the appropriation.

21 SEC. 8090. Notwithstanding any other provision of
22 law, not more than 35 percent of funds provided in this
23 Act for environmental remediation may be obligated under
24 indefinite delivery/indefinite quantity contracts with a
25 total contract value of \$130,000,000 or higher.

1 SEC. 8091. The Director of National Intelligence
2 shall include the budget exhibits identified in paragraphs
3 (1) and (2) as described in the Department of Defense
4 Financial Management Regulation with the congressional
5 budget justification books:

6 (1) For procurement programs requesting more
7 than \$20,000,000 in any fiscal year, the P-1, Pro-
8 curement Program; P-5, Cost Analysis; P-5a, Pro-
9 curement History and Planning; P-21, Production
10 Schedule; and P-40, Budget Item Justification.

11 (2) For research, development, test and evalua-
12 tion projects requesting more than \$10,000,000 in
13 any fiscal year, the R-1, RDT&E Program; R-2,
14 RDT&E Budget Item Justification; R-3, RDT&E
15 Project Cost Analysis; and R-4, RDT&E Program
16 Schedule Profile.

17 SEC. 8092. The Secretary of Defense shall create a
18 major force program category for space for each future-
19 years defense program of the Department of Defense sub-
20 mitted to Congress under section 221 of title 10, United
21 States Code, during fiscal year 2011. The Secretary of De-
22 fense shall designate an official in the Office of the Sec-
23 retary of Defense to provide overall supervision of the
24 preparation and justification of program recommendations

1 and budget proposals to be included in such major force
2 program category.

3 SEC. 8093. (a) Not later than 60 days after enact-
4 ment of this Act, the Office of the Director of National
5 Intelligence shall submit a report to the congressional in-
6 telligence committees to establish the baseline for applica-
7 tion of reprogramming and transfer authorities for fiscal
8 year 2011: *Provided*, That the report shall include—

9 (1) a table for each appropriation with a sepa-
10 rate column to display the President's budget re-
11 quest, adjustments made by Congress, adjustments
12 due to enacted rescissions, if appropriate, and the
13 fiscal year enacted level;

14 (2) a delineation in the table for each appro-
15 priation by Expenditure Center and project; and

16 (3) an identification of items of special congres-
17 sional interest.

18 (b) None of the funds provided for the National Intel-
19 ligence Program in this Act shall be available for re-
20 programming or transfer until the report identified in sub-
21 section (a) is submitted to the congressional intelligence
22 committees, unless the Director of National Intelligence
23 certifies in writing to the congressional intelligence com-
24 mittees that such reprogramming or transfer is necessary
25 as an emergency requirement.

1 SEC. 8094. The Director of National Intelligence
2 shall submit to Congress each year, at or about the time
3 that the President's budget is submitted to Congress that
4 year under section 1105(a) of title 31, United States
5 Code, a future-years intelligence program (including asso-
6 ciated annexes) reflecting the estimated expenditures and
7 proposed appropriations included in that budget. Any such
8 future-years intelligence program shall cover the fiscal
9 year with respect to which the budget is submitted and
10 at least the four succeeding fiscal years.

11 SEC. 8095. For the purposes of this Act, the term
12 "congressional intelligence committees" means the Perma-
13 nent Select Committee on Intelligence of the House of
14 Representatives, the Select Committee on Intelligence of
15 the Senate, the Subcommittee on Defense of the Com-
16 mittee on Appropriations of the House of Representatives,
17 and the Subcommittee on Defense of the Committee on
18 Appropriations of the Senate.

19 SEC. 8096. The Department of Defense shall con-
20 tinue to report incremental contingency operations costs
21 for Operation New Dawn and Operation Enduring Free-
22 dom on a monthly basis in the Cost of War Execution
23 Report as prescribed in the Department of Defense Finan-
24 cial Management Regulation Department of Defense In-

1 instruction 7000.14, Volume 12, Chapter 23 “Contingency
2 Operations”, Annex 1, dated September 2005.

3 SEC. 8097. The amounts appropriated in title II of
4 this Act are hereby reduced by \$483,000,000 to reflect
5 excess cash balances in Department of Defense Working
6 Capital Funds, as follows: From “Operation and Mainte-
7 nance, Army”, \$483,000,000.

8 (INCLUDING TRANSFER OF FUNDS)

9 SEC. 8098. During the current fiscal year, not to ex-
10 ceed \$11,000,000 from each of the appropriations made
11 in title II of this Act for “Operation and Maintenance,
12 Army”, “Operation and Maintenance, Navy”, and “Oper-
13 ation and Maintenance, Air Force” may be transferred by
14 the military department concerned to its central fund es-
15 tablished for Fisher Houses and Suites pursuant to sec-
16 tion 2493(d) of title 10, United States Code.

17 (INCLUDING TRANSFER OF FUNDS)

18 SEC. 8099. Of the funds appropriated in the Intel-
19 ligence Community Management Account for the Program
20 Manager for the Information Sharing Environment,
21 \$24,000,000 is available for transfer by the Director of
22 National Intelligence to other departments and agencies
23 for purposes of Government-wide information sharing ac-
24 tivities: *Provided*, That funds transferred under this provi-
25 sion are to be merged with and available for the same pur-

1 poses and time period as the appropriation to which trans-
2 ferred: *Provided further*, That the Office of Management
3 and Budget must approve any transfers made under this
4 provision.

5 SEC. 8100. Funds appropriated by this Act for oper-
6 ation and maintenance may be available for the purpose
7 of making remittances to the Defense Acquisition Work-
8 force Development Fund in accordance with the require-
9 ments of section 1705 of title 10, United States Code.

10 SEC. 8101. (a) Any agency receiving funds made
11 available in this Act, shall, subject to subsections (b) and
12 (c), post on the public website of that agency any report
13 required to be submitted by the Congress in this or any
14 other Act, upon the determination by the head of the agen-
15 cy that it shall serve the national interest.

16 (b) Subsection (a) shall not apply to a report if—

17 (1) the public posting of the report com-
18 promises national security; or

19 (2) the report contains proprietary information.

20 (c) The head of the agency posting such report shall
21 do so only after such report has been made available to
22 the requesting Committee or Committees of Congress for
23 no less than 45 days.

24 SEC. 8102. (a) None of the funds appropriated or
25 otherwise made available by this Act may be expended for

1 any Federal contract for an amount in excess of
2 \$1,000,000 unless the contractor agrees not to—

3 (1) enter into any agreement with any of its
4 employees or independent contractors that requires,
5 as a condition of employment, that the employee or
6 independent contractor agree to resolve through ar-
7 bitration any claim under title VII of the Civil
8 Rights Act of 1964 or any tort related to or arising
9 out of sexual assault or harassment, including as-
10 sult and battery, intentional infliction of emotional
11 distress, false imprisonment, or negligent hiring, su-
12 pervision, or retention; or

13 (2) take any action to enforce any provision of
14 an existing agreement with an employee or inde-
15 pendent contractor that mandates that the employee
16 or independent contractor resolve through arbitra-
17 tion any claim under title VII of the Civil Rights Act
18 of 1964 or any tort related to or arising out of sex-
19 ual assault or harassment, including assault and
20 battery, intentional infliction of emotional distress,
21 false imprisonment, or negligent hiring, supervision,
22 or retention.

23 (b) None of the funds appropriated or otherwise
24 made available by this Act may be expended for any Fed-
25 eral contract unless the contractor certifies that it requires

1 each covered subcontractor to agree not to enter into, and
2 not to take any action to enforce any provision of, any
3 agreement as described in paragraphs (1) and (2) of sub-
4 section (a), with respect to any employee or independent
5 contractor performing work related to such subcontract.
6 For purposes of this subsection, a “covered subcon-
7 tractor” is an entity that has a subcontract in excess of
8 \$1,000,000 on a contract subject to subsection (a).

9 (c) The prohibitions in this section do not apply with
10 respect to a contractor’s or subcontractor’s agreements
11 with employees or independent contractors that may not
12 be enforced in a court of the United States.

13 (d) The Secretary of Defense may waive the applica-
14 tion of subsection (a) or (b) to a particular contractor or
15 subcontractor for the purposes of a particular contract or
16 subcontract if the Secretary or the Deputy Secretary per-
17 sonally determines that the waiver is necessary to avoid
18 harm to national security interests of the United States,
19 and that the term of the contract or subcontract is not
20 longer than necessary to avoid such harm. The determina-
21 tion shall set forth with specificity the grounds for the
22 waiver and for the contract or subcontract term selected,
23 and shall state any alternatives considered in lieu of a
24 waiver and the reasons each such alternative would not
25 avoid harm to national security interests of the United

1 States. The Secretary of Defense shall transmit to Con-
2 gress, and simultaneously make public, any determination
3 under this subsection not less than 15 business days be-
4 fore the contract or subcontract addressed in the deter-
5 mination may be awarded.

6 (e) By March 1, 2011, or within 60 days after enact-
7 ment of this Act, whichever is later, the Government Ac-
8 countability Office shall submit a report to the Congress
9 evaluating the effect that the requirements of this section
10 have had on national security, including recommendations,
11 if any, for changes to these requirements.

12 SEC. 8103. (a) PROHIBITION ON CONVERSION OF
13 FUNCTIONS PERFORMED BY FEDERAL EMPLOYEES TO
14 CONTRACTOR PERFORMANCE.—None of the funds appro-
15 priated by this Act or otherwise available to the Depart-
16 ment of Defense may be used to begin or announce the
17 competition to award to a contractor or convert to per-
18 formance by a contractor any functions performed by Fed-
19 eral employees pursuant to a study conducted under Office
20 of Management and Budget (OMB) Circular A-76.

21 (b) EXCEPTION.—The prohibition in subsection (a)
22 shall not apply to the award of a function to a contractor
23 or the conversion of a function to performance by a con-
24 tractor pursuant to a study conducted under Office of
25 Management and Budget (OMB) Circular A-76 once all

1 reporting and certifications required by section 325 of the
2 National Defense Authorization Act for Fiscal Year 2010
3 (Public Law 111–84) have been satisfactorily completed.

4 SEC. 8104. (a)(1) No National Intelligence Program
5 funds appropriated in this Act may be used for a mission
6 critical or mission essential business management infor-
7 mation technology system that is not registered with the
8 Director of National Intelligence. A system shall be con-
9 sidered to be registered with that officer upon the fur-
10 nishing notice of the system, together with such informa-
11 tion concerning the system as the Director of the Business
12 Transformation Office may prescribe.

13 (2) During the current fiscal year no funds may be
14 obligated or expended for a financial management auto-
15 mated information system, a mixed information system
16 supporting financial and non-financial systems, or a busi-
17 ness system improvement of more than \$3,000,000, within
18 the Intelligence Community without the approval of the
19 Business Transformation Office, and the designated Intel-
20 ligence Community functional lead element.

21 (b) The Director of the Business Transformation Of-
22 fice shall provide the congressional intelligence committees
23 a semi-annual report of approvals under paragraph (1) no
24 later than March 30 and September 30 of each year. The
25 report shall include the results of the Business Trans-

1 formation Investment Review Board's semi-annual activi-
2 ties, and each report shall certify that the following steps
3 have been taken for systems approved under paragraph
4 (1):

5 (1) Business process reengineering.

6 (2) An analysis of alternatives and an economic
7 analysis that includes a calculation of the return on
8 investment.

9 (3) Assurance the system is compatible with the
10 enterprise-wide business architecture.

11 (4) Performance measures.

12 (5) An information assurance strategy con-
13 sistent with the Chief Information Officer of the In-
14 telligence Community.

15 (c) This section shall not apply to any programmatic
16 or analytic systems or programmatic or analytic system
17 improvements.

18 (INCLUDING TRANSFER OF FUNDS)

19 SEC. 8105. Of the funds appropriated in this Act for
20 the Office of the Director of National Intelligence,
21 \$50,000,000, may be transferred to appropriations avail-
22 able to the Central Intelligence Agency, the National Secu-
23 rity Agency, and the National Geospatial Intelligence
24 Agency, the Defense Intelligence Agency and the National
25 Reconnaissance Office for the Business Transformation

1 Transfer Funds, to be merged with and to be available
2 for the same time period and the same purposes as the
3 appropriation to which transferred: *Provided*, That the
4 transfer authority provided under this provision is in addi-
5 tion to any other transfer authority contained in this Act.

6 (INCLUDING TRANSFER OF FUNDS)

7 SEC. 8106. In addition to funds made available else-
8 where in this Act, there is hereby appropriated
9 \$538,875,000, to remain available until transferred: *Pro-*
10 *vided*, That these funds are appropriated to the “Tanker
11 Replacement Transfer Fund” (referred to as “the Fund”
12 elsewhere in this section): *Provided further*, That the Sec-
13 retary of the Air Force may transfer amounts in the Fund
14 to “Operation and Maintenance, Air Force”, “Aircraft
15 Procurement, Air Force”, and “Research, Development,
16 Test and Evaluation, Air Force”, only for the purposes
17 of proceeding with a tanker acquisition program: *Provided*
18 *further*, That funds transferred shall be merged with and
19 be available for the same purposes and for the same time
20 period as the appropriations or fund to which transferred:
21 *Provided further*, That this transfer authority is in addi-
22 tion to any other transfer authority available to the De-
23 partment of Defense: *Provided further*, That the Secretary
24 of the Air Force shall, not fewer than 15 days prior to
25 making transfers using funds provided in this section, no-

1 tify the congressional defense committees in writing of the
2 details of any such transfer: *Provided further*, That the
3 Secretary shall submit a report no later than 30 days after
4 the end of each fiscal quarter to the congressional defense
5 committees summarizing the details of the transfer of
6 funds from this appropriation.

7 (INCLUDING TRANSFER OF FUNDS)

8 SEC. 8107. From within the funds appropriated for
9 operation and maintenance for the Defense Health Pro-
10 gram in this Act, up to \$132,200,000, shall be available
11 for transfer to the Joint Department of Defense-Depart-
12 ment of Veterans Affairs Medical Facility Demonstration
13 Fund in accordance with the provisions of section 1704
14 of the National Defense Authorization Act for Fiscal Year
15 2010, Public Law 111–84: *Provided*, That for purposes
16 of section 1704(b), the facility operations funded are oper-
17 ations of the integrated Captain James A. Lovell Federal
18 Health Care Center, consisting of the North Chicago Vet-
19 erans Affairs Medical Center, the Navy Ambulatory Care
20 Center, and supporting facilities designated as a combined
21 Federal medical facility as described by section 706 of
22 Public Law 110–417: *Provided further*, That additional
23 funds may be transferred from funds appropriated for op-
24 eration and maintenance for the Defense Health Program
25 to the Joint Department of Defense-Department of Vet-

1 erans Affairs Medical Facility Demonstration Fund upon
2 written notification by the Secretary of Defense to the
3 Committees on Appropriations of the House of Represent-
4 atives and the Senate.

5 SEC. 8108. (a) Of the amounts made available in this
6 Act under the heading “Operation and Maintenance,
7 Navy”, not less than \$2,000,000, shall be made available
8 for leveraging the Army’s Contractor Manpower Reporting
9 Application, modified as appropriate for Service-specific
10 requirements, for documenting the number of full-time
11 contractor employees (or its equivalent) pursuant to
12 United States Code title 10, section 2330a(c) and meeting
13 the requirements of United States Code title 10, section
14 2330a(e) and United States Code title 10, section 235.

15 (b) Of the amounts made available in this Act under
16 the heading “Operation and Maintenance, Air Force”, not
17 less than \$2,000,000 shall be made available for
18 leveraging the Army’s Contractor Manpower Reporting
19 Application, modified as appropriate for Service-specific
20 requirements, for documenting the number of full-time
21 contractor employees (or its equivalent) pursuant to
22 United States Code title 10 section 2330a(c) and meeting
23 the requirements of United States Code title 10, section
24 2330a(e) and United States Code title 10, section 235.

1 (c) The Secretaries of the Army, Navy, Air Force,
2 and the Directors of the Defense Agencies and Field Ac-
3 tivities (in coordination with the appropriate Principal
4 Staff Assistant), in coordination with the Under Secretary
5 of Defense for Personnel and Readiness, shall report to
6 the congressional defense committees within 60 days of
7 enactment of this Act their plan for documenting the num-
8 ber of full-time contractor employees (or its equivalent),
9 as required by United States Code title 10, section 2330a.

10 (INCLUDING TRANSFER OF FUNDS)

11 SEC. 8109. In addition to amounts provided else-
12 where in this Act, there is appropriated \$250,000,000, for
13 an additional amount for “Operation and Maintenance,
14 Defense-Wide”, to be available until expended: *Provided*,
15 That such funds shall only be available to the Secretary
16 of Defense, acting through the Office of Economic Adjust-
17 ment of the Department of Defense, or for transfer to the
18 Secretary of Education, notwithstanding any other provi-
19 sion of law, to make grants, conclude cooperative agree-
20 ments, or supplement other Federal funds to construct,
21 renovate, repair, or expand elementary and secondary pub-
22 lic schools on military installations in order to address ca-
23 pacity or facility condition deficiencies at such schools:
24 *Provided further*, That in making such funds available, the
25 Office of Economic Adjustment or the Secretary of Edu-

1 cation shall give priority consideration to those military
2 installations with schools having the most serious capacity
3 or facility condition deficiencies as determined by the Sec-
4 retary of Defense.

5 SEC. 8110. In addition to amounts provided else-
6 where in this Act, there is appropriated \$300,000,000, for
7 an additional amount for “Operation and Maintenance,
8 Defense-Wide”, to remain available until expended. Such
9 funds may be available for the Office of Economic Adjust-
10 ment, notwithstanding any other provision of law, for
11 transportation infrastructure improvements associated
12 with medical facilities related to recommendations of the
13 Defense Base Closure and Realignment Commission.

14 SEC. 8111. Section 310(b) of the Supplemental Ap-
15 propriations Act, 2009 (Public Law 111–32; 124 Stat.
16 1871) is amended by striking “1 year” both places it ap-
17 pears and inserting “2 years”.

18 SEC. 8112. The Office of the Director of National
19 Intelligence shall not employ more Senior Executive em-
20 ployees than are specified in the classified annex: *Pro-*
21 *vided*, That not later than 90 days after enactment of this
22 Act, the Director of National Intelligence shall certify that
23 the Office of the Director of National Intelligence selects
24 individuals for Senior Executive positions in a manner
25 consistent with statutes, regulations, and the requirements

1 of other Federal agencies in making such appointments
2 and will submit its policies and procedures related to the
3 appointment of personnel to Senior Executive positions to
4 the congressional intelligence oversight committees.

5 SEC. 8113. For all major defense acquisition pro-
6 grams for which the Department of Defense plans to pro-
7 ceed to source selection during the current fiscal year, the
8 Secretary of Defense shall perform an assessment of the
9 winning bidder to determine whether or not the proposed
10 costs are realistic and reasonable with respect to proposed
11 development and production costs. The Secretary of De-
12 fense shall provide a report of these assessments, to spe-
13 cifically include whether any cost assessments determined
14 that such proposed costs were unreasonable or unrealistic,
15 to the congressional defense committees not later than 60
16 days after enactment of this Act and on a quarterly basis
17 thereafter.

18 SEC. 8114. (a) The Deputy Under Secretary of De-
19 fense for Installations and Environment, in collaboration
20 with the Secretary of Energy, shall conduct energy secu-
21 rity pilot projects at facilities of the Department of De-
22 fense.

23 (b) In addition to the amounts provided elsewhere in
24 this Act, \$20,000,000, is appropriated to the Department
25 of Defense for “Operation and Maintenance, Defense-

1 Wide” for energy security pilot projects under subsection
2 (a).

3 SEC. 8115. None of the funds appropriated or other-
4 wise made available by this Act may be obligated or ex-
5 pended to pay a retired general or flag officer to serve
6 as a senior mentor advising the Department of Defense
7 unless such retired officer files a Standard Form 278 (or
8 successor form concerning public financial disclosure
9 under part 2634 of title 5, Code of Federal Regulations)
10 to the Office of Government Ethics.

11 SEC. 8116. Not later than 180 days after the date
12 of the enactment of this Act, the Secretary of Defense,
13 the Chief of the Air Force Reserve, and the Director of
14 the National Guard Bureau, in collaboration with the Sec-
15 retary of Agriculture and the Secretary of the Interior,
16 shall submit to the Committees on Appropriations of the
17 House and Senate, the House Committee on Agriculture,
18 the Senate Committee on Agriculture, Nutrition and For-
19 estry, the House Committee on Natural Resources, and
20 the Senate Committee on Energy and Natural Resources
21 a report of firefighting aviation assets. The report re-
22 quired under this section shall include each of the fol-
23 lowing:

24 (1) A description of the programming details
25 necessary to obtain an appropriate mix of fixed wing

1 and rotor wing firefighting assets needed to produce
2 an effective aviation resource base to support the
3 wildland fire management program into the future.
4 Such programming details shall include the acquisition
5 and contracting needs of the mix of aviation re-
6 sources fleet, including the acquisition of up to 24
7 C-130Js equipped with the Mobile Airborne Fire
8 Fighting System II (in this section referred to as
9 “MAFFS”), to be acquired over several fiscal years
10 starting in fiscal year 2012.

11 (2) The costs associated with acquisition and
12 contracting of the aviation assets described in para-
13 graph (1).

14 (3) A description of the costs of the operation,
15 maintenance, and sustainment of a fixed and rotor
16 wing aviation fleet, including a C-130J/MAFFS II
17 in an Air National Guard tactical airlift unit con-
18 struct of 4, 6, or 8 C-130Js per unit starting in fis-
19 cal year 2012, projected out through fiscal year
20 2020. Such description shall include the projected
21 costs associated with each of the following through
22 fiscal year 2020:

23 (A) Crew ratio based on 4, 6, or 8 C-130J
24 Air National Guard unit construct and require-
25 ment for full-time equivalent crews.

1 (B) Associated maintenance and other sup-
2 port personnel and requirement for full-time
3 equivalent positions.

4 (C) Yearly flying hour model and the cost
5 for use of a fixed and rotor wing aviation fleet,
6 including C-130J in its MAFFS capacity sup-
7 porting the United States Forest Service.

8 (D) Yearly flying hour model and cost for
9 use of a C-130J in its capacity supporting Air
10 National Guard tactical airlift training.

11 (E) Any other costs required to conduct
12 both the airlift and firefighting missions, in-
13 cluding the Air National Guard unit construct
14 for C-130Js.

15 (4) Proposed program management, utilization,
16 and cost share arrangements for the aircraft de-
17 scribed in paragraph (1) for primary support of the
18 Forest Service and secondary support, on an as
19 available basis, for the Department of Defense, to-
20 gether with any proposed statutory language needed
21 to authorize and effectuate the same.

22 (5) An integrated plan for the Forest Service
23 and the Department of the Interior wildland fire
24 management programs to operate the fire fighting
25 air tanker assets referred to in this section.

1 SEC. 8117. Notwithstanding any other provision of
2 this Act, to reflect savings from revised economic assump-
3 tions, the total amount appropriated in title II of this Act
4 is hereby reduced by \$244,000,000, the total amount ap-
5 propriated in title III of this Act is hereby reduced by
6 \$258,000,000, and the total amount appropriated in title
7 IV of this Act is hereby reduced by \$175,000,000: *Pro-*
8 *vided*, That the Secretary of Defense shall allocate this
9 reduction proportionally to each budget activity, activity
10 group, subactivity group, and each program, project, and
11 activity, within each appropriation account.

12 SEC. 8118. The total amount available in this Act
13 for pay for civilian personnel of the Department of De-
14 fense for fiscal year 2011 shall be the amount otherwise
15 appropriated or made available by this Act for such pay
16 reduced by \$723,000,000.

17 SEC. 8119. None of the funds appropriated or other-
18 wise made available to the Department of Defense may
19 be used for the disestablishment, closure, or realignment
20 of the Joint Forces Command unless within 120 days of
21 the enactment of this Act—

22 (1) the Secretary of Defense notifies the con-
23 gressional defense committees of the proposed dis-
24 establishment, closure, or realignment of the Joint
25 Forces Command; and

1 (2) the Secretary submits to the congressional
2 defense committees a plan for the disestablishment,
3 closure, or realignment of the Joint Forces Com-
4 mand, which plan shall contain at a minimum—

5 (A) an explanation of the projected savings
6 of the proposed disestablishment, closure, or re-
7 alignment;

8 (B) a cost-benefit analysis of the proposed
9 disestablishment, closure, or realignment;

10 (C) the budgetary impact of the proposed
11 disestablishment, closure, or realignment;

12 (D) the strategic and operational con-
13 sequences of the proposed disestablishment, clo-
14 sure, or realignment; and

15 (E) an appropriate local economic assess-
16 ment of the proposed disestablishment, closure,
17 or realignment, which shall include at a min-
18 imum—

19 (i) a list of Federal, State, and local
20 government departments and agencies that
21 are required by statute or regulation to
22 provide assistance and outreach for the
23 community affected by the proposed dis-
24 establishment, closure, or realignment; and

1 (ii) a list of the contractors and busi-
2 nesses affected by the proposed disestab-
3 lishment, closure, or realignment.

4 SEC. 8120. The explanatory statement regarding this
5 Act, printed in the House of Representatives section of
6 the Congressional Record on or about April 6, 2011, by
7 the Chairman of the Committee on Appropriations of the
8 House of Representatives, shall have the same effect with
9 respect to the allocation of funds and implementation of
10 this Act as if it were a Report of the Committee on Appro-
11 priations.

12 SEC. 8121. None of the funds appropriated or other-
13 wise made available by this Act or any other appropria-
14 tions Act may be used to transfer, release, or assist in
15 the transfer or release to or within the United States, its
16 territories, or possessions Khalid Sheikh Mohammed or
17 any other detainee who—

18 (1) is not a United States citizen or a member
19 of the Armed Forces of the United States; and

20 (2) is or was held on or after June 24, 2009,
21 at the United States Naval Station, Guantanamo
22 Bay, Cuba, by the Department of Defense.

23 SEC. 8122. (a)(1) Except as provided in paragraph
24 (2), none of the funds appropriated or otherwise made
25 available by this Act or any other appropriations Act may

1 be used to transfer any individual detained at Guanta-
2 namo to the custody or effective control of the individual's
3 country of origin, any other foreign country, or any other
4 foreign entity unless the Secretary of Defense submits to
5 Congress the certification described in subsection (b) by
6 not later than 30 days before the transfer of the indi-
7 vidual.

8 (2) Paragraph (1) shall not apply to any action taken
9 by the Secretary of Defense to transfer any individual de-
10 tained at Guantanamo to effectuate an order affecting the
11 disposition of the individual that is issued by a court or
12 competent tribunal of the United States having lawful ju-
13 risdiction. The Secretary of Defense shall notify Congress
14 promptly upon issuance of any such order.

15 (b) The certification described in this subsection is
16 a written certification made by the Secretary of Defense,
17 with the concurrence of the Secretary of State, that the
18 government of the foreign country or the recognized lead-
19 ership of the foreign entity to which the individual de-
20 tained at Guantanamo is to be transferred—

21 (1) is not a designated state sponsor of ter-
22 rorism or a designated foreign terrorist organization;

23 (2) maintains effective control over each deten-
24 tion facility in which an individual is to be detained

1 if the individual is to be housed in a detention facil-
2 ity;

3 (3) is not, as of the date of the certification,
4 facing a threat that is likely to substantially affect
5 its ability to exercise control over the individual;

6 (4) has agreed to take effective steps to ensure
7 that the individual cannot take action to threaten
8 the United States, its citizens, or its allies in the fu-
9 ture;

10 (5) has taken such steps as the Secretary deter-
11 mines are necessary to ensure that the individual
12 cannot engage or re-engage in any terrorist activity;
13 and

14 (6) has agreed to share any information with
15 the United States that—

16 (A) is related to the individual or any asso-
17 ciates of the individual; and

18 (B) could affect the security of the United
19 States, its citizens, or its allies.

20 (c)(1) Except as provided in paragraph (3), none of
21 the funds appropriated or otherwise made available by this
22 Act or any other appropriations Act may be used to trans-
23 fer any individual detained at Guantanamo to the custody
24 or effective control of the individual's country of origin,
25 any other foreign country, or any other foreign entity if

1 there is a confirmed case of any individual who was de-
2 tained at United States Naval Station, Guantanamo Bay,
3 Cuba, at any time after September 11, 2001, who was
4 transferred to the foreign country or entity and subse-
5 quently engaged in any terrorist activity.

6 (2) The Secretary of Defense may waive the prohibi-
7 tion in paragraph (1) if the Secretary determines that
8 such a transfer is in the national security interests of the
9 United States and includes, as part of the certification de-
10 scribed in subsection (b) relating to such transfer, the de-
11 termination of the Secretary under this paragraph.

12 (3) Paragraph (1) shall not apply to any action taken
13 by the Secretary to transfer any individual detained at
14 Guantanamo to effectuate an order affecting the disposi-
15 tion of the individual that is issued by a court or com-
16 petent tribunal of the United States having lawful jurisdic-
17 tion. The Secretary shall notify Congress promptly upon
18 issuance of any such order.

19 (d) For the purposes of this section:

20 (1) The term “individual detained at Guanta-
21 namo” means any individual who is located at
22 United States Naval Station, Guantanamo Bay,
23 Cuba, as of October 1, 2009, who—

1 (A) is not a citizen of the United States or
2 a member of the Armed Forces of the United
3 States; and

4 (B) is—

5 (I) in the custody or under the effec-
6 tive control of the Department of Defense;
7 or

8 (ii) otherwise under detention at
9 United States Naval Station, Guantanamo
10 Bay, Cuba.

11 (2) The term “foreign terrorist organization”
12 means any organization so designated by the Sec-
13 retary of State under section 219 of the Immigra-
14 tion and Nationality Act (8 U.S.C. 1189).

15 SEC. 8123. (a) None of the funds appropriated or
16 otherwise made available by this Act or any other appro-
17 priations Act may be used to construct or modify any facil-
18 ity in the United States, its territories, or possessions to
19 house any individual described in subsection (c)) for the
20 purposes of detention or imprisonment in the custody or
21 under the effective control of the Department of Defense.

22 (b) The prohibition in subsection (a) shall not apply
23 to any modification of facilities at United States Naval
24 Station, Guantanamo Bay, Cuba.

1 (c) An individual described in this subsection is any
2 individual who, as of June 24, 2009, is located at United
3 States Naval Station, Guantanamo Bay, Cuba, and who—

4 (1) is not a citizen of the United States or a
5 member of the Armed Forces of the United States;
6 and

7 (2) is—

8 (A) in the custody or under the effective
9 control of the Department of Defense; or

10 (B) otherwise under detention at United
11 States Naval Station, Guantanamo Bay, Cuba.

3 DRUG INTERDICTION AND COUNTER-DRUG ACTIVITIES,
4 DEFENSE

5 For an additional amount for “Drug Interdiction and
6 Counter-Drug Activities, Defense”, \$440,510,000, to re-
7 main available until September 30, 2012: *Provided*, That
8 each amount in this paragraph is designated as being for
9 contingency operations directly related to the global war
10 on terrorism pursuant to section 3(c)(2) of H. Res. 5
11 (112th Congress) and as an emergency requirement pur-
12 suant to section 403(a) of S. Con. Res. 13 (111th Con-
13 gress), the concurrent resolution on the budget for fiscal
14 year 2010.

15 JOINT IMPROVISED EXPLOSIVE DEVICE DEFEAT FUND
16 (INCLUDING TRANSFER OF FUNDS)

17 For the “Joint Improvised Explosive Device Defeat
18 Fund”, \$2,793,768,000, to remain available until Sep-
19 tember 30, 2013: *Provided*, That such funds shall be avail-
20 able to the Secretary of Defense, notwithstanding any
21 other provision of law, for the purpose of allowing the Di-
22 rector of the Joint Improvised Explosive Device Defeat
23 Organization to investigate, develop and provide equip-
24 ment, supplies, services, training, facilities, personnel and
25 funds to assist United States forces in the defeat of impro-

1 vised explosive devices: *Provided further*, That the Sec-
2 retary of Defense may transfer funds provided herein to
3 appropriations for military personnel; operation and main-
4 tenance; procurement; research, development, test and
5 evaluation; and defense working capital funds to accom-
6 plish the purpose provided herein: *Provided further*, That
7 this transfer authority is in addition to any other transfer
8 authority available to the Department of Defense: *Pro-*
9 *vided further*, That the Secretary of Defense shall, not
10 fewer than 15 days prior to making transfers from this
11 appropriation, notify the congressional defense committees
12 in writing of the details of any such transfer: *Provided*
13 *further*, That each amount in this paragraph is designated
14 as being for contingency operations directly related to the
15 global war on terrorism pursuant to section 3(c)(2) of H.
16 Res. 5 (112th Congress) and as an emergency requirement
17 pursuant to section 403(a) of S. Con. Res. 13 (111th Con-
18 gress), the concurrent resolution on the budget for fiscal
19 year 2010.

20 OFFICE OF THE INSPECTOR GENERAL

21 For an additional amount for the “Office of the In-
22 spector General”, \$10,529,000: *Provided*, That each
23 amount in this paragraph is designated as being for con-
24 tingency operations directly related to the global war on
25 terrorism pursuant to section 3(c)(2) of H. Res. 5 (112th

1 Congress) and as an emergency requirement pursuant to
2 section 403(a) of S. Con. Res. 13 (111th Congress), the
3 concurrent resolution on the budget for fiscal year 2010.

4 GENERAL PROVISIONS—THIS TITLE

5 SEC. 9001. Notwithstanding any other provision of
6 law, funds made available in this title are in addition to
7 amounts appropriated or otherwise made available for the
8 Department of Defense for fiscal year 2011.

9 (INCLUDING TRANSFER OF FUNDS)

10 SEC. 9002. Upon the determination of the Secretary
11 of Defense that such action is necessary in the national
12 interest, the Secretary may, with the approval of the Of-
13 fice of Management and Budget, transfer up to
14 \$4,000,000,000 between the appropriations or funds made
15 available to the Department of Defense in this title: *Pro-*
16 *vided*, That the Secretary shall notify the Congress
17 promptly of each transfer made pursuant to the authority
18 in this section: *Provided further*, That the authority pro-
19 vided in this section is in addition to any other transfer
20 authority available to the Department of Defense and is
21 subject to the same terms and conditions as the authority
22 provided in the Department of Defense Appropriations
23 Act, 2011.

24 SEC. 9003. Supervision and administration costs as-
25 sociated with a construction project funded with appro-

1 priations available for operation and maintenance or the
2 “Afghanistan Security Forces Fund” provided in this Act
3 and executed in direct support of overseas contingency op-
4 erations in Afghanistan, may be obligated at the time a
5 construction contract is awarded: *Provided*, That for the
6 purpose of this section, supervision and administration
7 costs include all in-house Government costs.

8 SEC. 9004. From funds made available in this title,
9 the Secretary of Defense may purchase for use by military
10 and civilian employees of the Department of Defense in
11 Iraq and Afghanistan: (a) passenger motor vehicles up to
12 a limit of \$75,000 per vehicle; and (b) heavy and light
13 armored vehicles for the physical security of personnel or
14 for force protection purposes up to a limit of \$250,000
15 per vehicle, notwithstanding price or other limitations ap-
16 plicable to the purchase of passenger carrying vehicles.

17 SEC. 9005. Not to exceed \$500,000,000 of the
18 amount appropriated in this title under the heading “Op-
19 eration and Maintenance, Army” may be used, notwith-
20 standing any other provision of law, to fund the Com-
21 mander’s Emergency Response Program (CERP), for the
22 purpose of enabling military commanders in Iraq and Af-
23 ghanistan to respond to urgent, small scale, humanitarian
24 relief and reconstruction requirements within their areas
25 of responsibility: *Provided*, That projects (including any

1 ancillary or related elements in connection with such
2 project) executed under this authority shall not exceed
3 \$20,000,000: *Provided further*, That not later than 45
4 days after the end of each fiscal year quarter, the Sec-
5 retary of Defense shall submit to the congressional defense
6 committees a report regarding the source of funds and the
7 allocation and use of funds during that quarter that were
8 made available pursuant to the authority provided in this
9 section or under any other provision of law for the pur-
10 poses described herein: *Provided further*, That, not later
11 than 30 days after the end of each month, the Army shall
12 submit to the congressional defense committees monthly
13 commitment, obligation, and expenditure data for the
14 Commander's Emergency Response Program in Iraq and
15 Afghanistan: *Provided further*, That not less than 15 days
16 before making funds available pursuant to the authority
17 provided in this section or under any other provision of
18 law for the purposes described herein for a project with
19 a total anticipated cost for completion of \$5,000,000 or
20 more, the Secretary shall submit to the congressional de-
21 fense committees a written notice containing each of the
22 following:

- 23 (1) The location, nature and purpose of the
24 proposed project, including how the project is in-

1 tended to advance the military campaign plan for
2 the country in which it is to be carried out.

3 (2) The budget, implementation timeline with
4 milestones, and completion date for the proposed
5 project, including any other CERP funding that has
6 been or is anticipated to be contributed to the com-
7 pletion of the project.

8 (3) A plan for the sustainment of the proposed
9 project, including the agreement with either the host
10 nation, a non-Department of Defense agency of the
11 United States Government or a third party contrib-
12 utor to finance the sustainment of the activities and
13 maintenance of any equipment or facilities to be pro-
14 vided through the proposed project.

15 SEC. 9006. Funds available to the Department of De-
16 fense for operation and maintenance may be used, not-
17 withstanding any other provision of law, to provide sup-
18 plies, services, transportation, including airlift and sealift,
19 and other logistical support to coalition forces supporting
20 military and stability operations in Iraq and Afghanistan:
21 *Provided*, That the Secretary of Defense shall provide
22 quarterly reports to the congressional defense committees
23 regarding support provided under this section.

24 SEC. 9007. None of the funds appropriated or other-
25 wise made available by this or any other Act shall be obli-

1 gated or expended by the United States Government for
2 a purpose as follows:

3 (1) To establish any military installation or
4 base for the purpose of providing for the permanent
5 stationing of United States Armed Forces in Iraq.

6 (2) To exercise United States control over any
7 oil resource of Iraq.

8 (3) To establish any military installation or
9 base for the purpose of providing for the permanent
10 stationing of United States Armed Forces in Af-
11 ghanistan.

12 SEC. 9008. None of the funds made available in this
13 Act may be used in contravention of the following laws
14 enacted or regulations promulgated to implement the
15 United Nations Convention Against Torture and Other
16 Cruel, Inhuman or Degrading Treatment or Punishment
17 (done at New York on December 10, 1984):

18 (1) Section 2340A of title 18, United States
19 Code.

20 (2) Section 2242 of the Foreign Affairs Reform
21 and Restructuring Act of 1998 (division G of Public
22 Law 105–277; 112 Stat. 2681–822; 8 U.S.C. 1231
23 note) and regulations prescribed thereto, including
24 regulations under part 208 of title 8, Code of Fed-

1 eral Regulations, and part 95 of title 22, Code of
2 Federal Regulations.

3 (3) Sections 1002 and 1003 of the Department
4 of Defense, Emergency Supplemental Appropriations
5 to Address Hurricanes in the Gulf of Mexico, and
6 Pandemic Influenza Act, 2006 (Public Law 109–
7 148).

8 SEC. 9009. (a) The Secretary of Defense shall submit
9 to the congressional defense committees not later than 45
10 days after the end of each fiscal quarter a report on the
11 proposed use of all funds appropriated by this or any prior
12 Act under each of the headings Iraq Security Forces
13 Fund, Afghanistan Security Forces Fund, Afghanistan In-
14 frastructure Fund, and Pakistan Counterinsurgency Fund
15 on a project-by-project basis, for which the obligation of
16 funds is anticipated during the 3-month period from such
17 date, including estimates for the accounts referred to in
18 this section of the costs required to complete each such
19 project.

20 (b) The report required by this subsection shall in-
21 clude the following:

22 (1) The use of all funds on a project-by-project
23 basis for which funds appropriated under the head-
24 ings referred to in subsection (a) were obligated
25 prior to the submission of the report, including esti-

1 mates for the accounts referred to in subsection (a)
2 of the costs to complete each project.

3 (2) The use of all funds on a project-by-project
4 basis for which funds were appropriated under the
5 headings referred to in subsection (a) in prior appro-
6 priations Acts, or for which funds were made avail-
7 able by transfer, reprogramming, or allocation from
8 other headings in prior appropriations Acts, includ-
9 ing estimates for the accounts referred to in sub-
10 section (a) of the costs to complete each project.

11 (3) An estimated total cost to train and equip
12 the Iraq, Afghanistan, and Pakistan security forces,
13 disaggregated by major program and sub-elements
14 by force, arrayed by fiscal year.

15 SEC. 9010. Funds made available in this title to the
16 Department of Defense for operation and maintenance
17 may be used to purchase items having an investment unit
18 cost of not more than \$250,000: *Provided*, That, upon de-
19 termination by the Secretary of Defense that such action
20 is necessary to meet the operational requirements of a
21 Commander of a Combatant Command engaged in contin-
22 gency operations overseas, such funds may be used to pur-
23 chase items having an investment item unit cost of not
24 more than \$500,000.

1 (INCLUDING TRANSFER OF FUNDS)

2 SEC. 9011. Of the funds appropriated by this Act for
3 the Office of the Director of National Intelligence,
4 \$3,375,000 is available, as specified in the classified
5 annex, for transfer to other departments and agencies of
6 the Federal Government.

7 SEC. 9012. (a) The Task Force for Business and Sta-
8 bility Operations in Afghanistan may, subject to the direc-
9 tion and control of the Secretary of Defense and with the
10 concurrence of the Secretary of State, carry out projects
11 in fiscal year 2011 to assist the commander of the United
12 States Central Command in developing a link between
13 United States military operations in Afghanistan under
14 Operation Enduring Freedom and the economic elements
15 of United States national power in order to reduce vio-
16 lence, enhance stability, and restore economic normalcy in
17 Afghanistan through strategic business and economic op-
18 portunities.

19 (b) The projects carried out under paragraph (a) may
20 include projects that facilitate private investment, indus-
21 trial development, banking and financial system develop-
22 ment, agricultural diversification and revitalization, and
23 energy development in and with respect to Afghanistan.

24 (c) The Secretary may use up to \$150,000,000 of the
25 funds available for overseas contingency operations in

1 “Operation and Maintenance, Army” for additional activi-
2 ties to carry out projects under paragraph (a).

3 SEC. 9013. (a) Not more than 85 percent of the
4 funds provided in this title for Operation and Maintenance
5 may be available for obligation or expenditure until the
6 date on which the Secretary of Defense submits the report
7 under subsection (b).

8 (b) Not later than 120 days after the date of the en-
9 actment of this Act, the Secretary of Defense shall submit
10 to the congressional defense committees a report on con-
11 tractor employees in the United States Central Command,
12 including—

13 (1) the number of employees of a contractor
14 awarded a contract by the Department of Defense
15 (including subcontractor employees) who are em-
16 ployed at the time of the report in the area of oper-
17 ations of the United States Central Command, in-
18 cluding a list of the number of such employees in
19 each of Iraq, Afghanistan, and all other areas of op-
20 erations of the United States Central Command; and

21 (2) for each fiscal year quarter beginning on
22 the date of the report and ending on September 30,
23 2012—

24 (A) the number of such employees planned
25 by the Secretary to be employed during each

1 such period in each of Iraq, Afghanistan, and
2 all other areas of operations of the United
3 States Central Command; and

4 (B) an explanation of how the number of
5 such employees listed under subparagraph (A)
6 relates to the planned number of military per-
7 sonnel in such locations.

8 SEC. 9014. From funds made available in this title
9 to the Department of Defense for operation and mainte-
10 nance, up to \$129,100,000 may be used by the Secretary
11 of Defense, notwithstanding any other provision of law,
12 to support the United States Government transition activi-
13 ties in Iraq by undertaking facilities renovation and con-
14 struction associated with establishing Office of Security
15 Cooperation locations, at no more than four sites, in Iraq:
16 *Provided*, That not less than 15 days before making funds
17 available pursuant to the authority provided in this sec-
18 tion, the Secretary shall submit to the congressional de-
19 fense committees a written notice containing a detailed
20 justification and timeline for each proposed site and the
21 source of funds.

22 SEC. 9015. Any reference to “this Act” in this divi-
23 sion shall apply solely to this division.

24 This division may be cited as the “Department of De-
25 fense Appropriations Act, 2011”.
