

<b>2016 IMPORTANT DATES AND IDAHO DEADLINES – Idaho Specific</b>	
January 1	Offices closed in observance of New Year's Day
January 4	Reporting date for 2015 honeybee colonies for honey for Noninsured Crop Disaster Assistance Program (NAP)
January 15	Reporting date for 2016 acreage for apples, cherries, fresh freestone peaches, fresh nectarines, grapes and plums
January 18	Offices closed in observance of Martin Luther King, Jr's Birthday
January 30	Deadline to apply for 2013 Livestock Forage Disaster Program (LFP) and 2013, 2014, and 2015 Livestock Indemnity Program (LIP)
February 2	Deadline to apply for Market Assistance Loans (MAL) for wool or mohair or Loan Deficiency Payments (LDP) for unshorn pelts produced during the 2015 crop year
February 15	Offices closed in observance of George Washington's Birthday
March 15	Deadline to apply for 2015 coverage of spring-planted non-insurable crops (excluding annual planted mixed forage) under the Noninsured Crop Disaster Assistance Program (NAP)
March 31	Final date to obtain MALs or Loan Deficiency Payments (LDP's) on 2015 barley, canola, flaxseed, honey, oats, rapeseed, sesame seed & wheat
April 1	Deadline to sign ARC or PLC contract
May 30	Offices closed in observance of Memorial Day
June 1	Final date to obtain MALs or LDPs on 2015 corn, dry peas, sorghum, lentils, mustard seed, safflower, chickpeas, & sunflower seed
June 1	Date used to establish ownership interest for person or legal entity for program purposes
June 1	Date used for the determination of minor child for program purposes
June 1	Last day to file AD-1026 for crop insurance subsidy
July 1	MPP-Dairy 2017 registration and election begins
July 4	Offices closed in observance of Independence Day
July 15	Reporting date for all other crops including CRP, Spring Planted Alfalfa (forage or seed), Spring barley, Spring canola, corn, dry beans, dry peas, flax, green peas, Spring mint, mustard, oats, onions potatoes, processing beans, safflower, sugar beets, sweet corn, Spring wheat.
August 1	Deadline to request farm reconstitution for 2015
September 5	Offices closed in observance of Labor Day
September 15	NAP application for payment date (application & supporting documentation) for 2016 NAP
September 30	MPP-Dairy 2017 registration and buy-up ends
October 10	Offices closed in observance of Columbus Day
November 1	Final application for payment for ELAP for program year loss occurred
November 11	Offices closed in observance of Veteran's Day
November 15	Reporting date for Pasture, Rangeland, Forage (including mixed forages, grass hay and Alfalfa for hay, not Alfalfa for seed) and Apiculture (honey bee forage)
November 24	Offices closed in observance of Thanksgiving Day
December 15	Reporting date for 2016 Fall planted and established alfalfa for seed, Fall barley, Fall canola, fall-planted dry peas, Fall mint Fall wheat and all other Fall-planted small grains.
December 26	Offices closed in observance of Christmas Day
Continuous	For calendar year 2015 and subsequent years, deadline to file Tree Assistance Program (TAP) application for losses is the later of 90 calendar days of the disaster event, or the date when the loss is apparent.
NOTE: The final acreage reporting dates are listed in this table. However, the final date for reporting any specific crop acreage <b>for which NAP assistance may be paid is earlier of the date listed above or 15 calendar days BEFORE the onset of harvest or grazing.</b>	

<b>APPLICATION DEADLINES FOR COVERAGE FOR NAP FINAL DATES</b>	
March 15	All yield-based, spring planted crops (melons, tomatoes, peppers, etc.)
May 2	Nursery crops for the following year's crop
September 1	Value Loss Crops for the following year (onion sets, Christmas trees, aquaculture, etc.)
December 1	Grazing/forage crops, fall-seeded annuals crops, and mint crops for the following year's crop
December 1	Perennial crops (non-forage) for the following year's crop (apples, peaches, etc.)
December 1	Honey for the following year
