SUBJECT:      Updated: Modification of AWIPS PILs in WFO Guam's product suite  
              Effective on Date to be Determined

Updated to delay implementation due to intense tropical weather affecting Guam. An amended notice will be sent with the new date.

Effective on data to be determined Weather Forecast Office (WFO) Guam will issue modified products to support Advanced Weather Interactive Processing System (AWIPS) applications. There will be no other changes to these products beyond correcting the AWIPS Product Inventory Lists (PILS) to comply with NWS policy. WFO Guam's AWIPS IDs were determined before the modernization of NWS and AWIPS. These headers do not work properly with AWIPS Warngen software. In addition, this change will standardize the AWIPS IDs for all WFO Guam products.
