New Castle County USDA Farm Service Agency (FSA) Executive Director Maryann Reed announced that farmers in Delaware now can receive notifications from their county office through text messages on their cell phone.

Whether producers are in the field, on a tractor or even on horseback, this service enables FSA customers and stakeholders to receive notifications while on the go.

Producers will receive text messages regarding important program deadlines, reporting requirements, outreach events and updates.

Producers can text **DENEWCATTLE** to FSANOW (372-669) to subscribe to text message alerts from New Castle County. Standard text messaging rates apply. Contact your wireless carrier for details associated with your particular data plan. Participants may unsubscribe at any time.

NAP Coverage Application Closing Dates

Eligible producers must apply for coverage and pay the applicable service fees annually by the application closing date. Acreage and production reports are also due annually.

August 1 - strawberries

September 1 - forage crops

September 15 - spinach, Swiss chard, kale

November 20 - orchard crops, honey

March 15 - melons, fresh market sweet corn, squash, pumpkins, peppers, tomatoes, most annual fruits and vegetables
