Are you facing barriers to trade abroad?

- Are foreign customs officials inappropriately classifying or valuing your products in assessing customs duties?
- Are unique and burdensome product, testing, or certification requirements keeping your goods out of a foreign market?

Making trade agreements work for you

Our mission is to ensure compliance by foreign governments with U.S. trade agreements.

Examples of TANC Successes:

- Ensured that China's bidding process for the 2009–10 rollout of Motorola's 3G network would not discriminate against foreign participants.
- Assisted a U.S. company in persuading the Argentine government to withdraw an unnecessarily burdensome and costly requirement on toy packaging.
- Advocated successfully against the dramatic increase of fees on audiovisual products imported into Jordan.

The U.S. Department of Commerce's Trade Agreements Compliance Program is a network of Commerce Department and other U.S. government resources working together to reduce or eliminate foreign government-imposed trade barriers by making trade agreements work.

How does the program work to overcome foreign trade barriers?

The Office of Trade Agreements Negotiations and Compliance (TANC) leads a team of U.S. government experts to pursue your case. These experts work with foreign governments to resolve your problems accessing foreign markets and ensure that your company receives the benefits of all U.S. trade agreements.
