## PUBLIC SAFETY AND HOMELAND SECURITY BUREAU NOTES RESCHEDULING OF NATIONWIDE TEST OF WIRELESS EMERGENCY ALERTS AND THE EMERGENCY ALERT SYSTEM FOR OCTOBER 3, 2018

PS Docket Nos. 15-91, 15-94

The Federal Emergency Management Agency (FEMA) has announced that the nationwide test of Wireless Emergency Alerts (WEA) and the Emergency Alert System (EAS), originally scheduled for September 20, 2018,<sup>1</sup> has been postponed to the back-up test date of October 3, 2018. The WEA test will originate at 2:18 p.m. Eastern Daylight Time (EDT), and the EAS test will originate at 2:20 p.m. The test is being rescheduled due to ongoing response efforts to Hurricane Florence.<sup>2</sup>

All Participating Commercial Mobile Service Providers and EAS Participants are required to participate in this nationwide test.<sup>3</sup> EAS Participants shall file the “day of test” information sought by ETRS Form Two at or before 11:59 PM EDT on October 3, 2018.<sup>4</sup> EAS Participants shall file the detailed post-test data sought by ETRS Form Three on or before November 19, 2018.<sup>5</sup>
