- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 That the following sums are appropriated, out of any
- 4 money in the Treasury not otherwise appropriated, for the
- 5 fiscal year ending September 30, 2005, namely:

1	DEPARTMENT OF HOMELAND SECURITY
2	EMERGENCY PREPAREDNESS AND RESPONSE
3	DISASTER RELIEF
4	For an additional amount for "Disaster Relief",
5	\$10,000,000,000, to remain available until expended: Pro-
6	vided, That the amount provided herein is designated as
7	an emergency requirement pursuant to section 402 of H
8	Con. Res. 95 (109th Congress).
9	DEPARTMENT OF DEFENSE
10	OPERATION AND MAINTENANCE
11	OPERATION AND MAINTENANCE, DEFENSE-WIDE
12	(INCLUDING TRANSFER OF FUNDS)
13	For an additional amount for "Operation and Main-
14	tenance, Defense-Wide", \$500,000,000 for emergency
15	hurricane expenses, to support costs of evacuation, emer-
16	gency repairs, deployment of personnel, and other costs
17	resulting from immediate relief efforts, to remain available
18	until September 30, 2006: Provided, That the Secretary
19	of Defense may transfer these funds to appropriations for
20	military personnel, operation and maintenance, procure-
21	ment, family housing, Defense Health Program, and work-
22	ing capital funds: Provided further, That funds transferred
23	shall be merged with and be available for the same pur-
24	poses and for the same time period as the appropriation
25	or fund to which transferred: Provided further. That this

- 1 transfer authority is in addition to any other transfer au-
- 2 thority available to the Department of Defense: Provided
- 3 further, That upon a determination that all or part of the
- 4 funds transferred from this appropriation are not nec-
- 5 essary for the purposes provided herein, such amounts
- 6 may be transferred back to this appropriation: Provided
- 7 further, That the Secretary of Defense shall, not more
- 8 than 5 days after making transfers from this appropria-
- 9 tion, notify the congressional defense committees in writ-
- 10 ing of any such transfer: Provided further, That the
- 11 amount provided herein is designated as an emergency re-
- 12 quirement pursuant to section 402 of H. Con. Res. 95
- 13 (109th Congress).
- 14 This Act may be cited as the "Emergency Supple-
- 15 mental Appropriations Act to Meet Immediate Needs Aris-
- 16 ing From the Consequences of Hurricane Katrina, 2005".
