INTRODUCING THE MORTALITY DATA INTERAGENCY WORKING GROUP TO IMPROVE HEALTH



The Mortality Data Interagency Working Group to Improve Health fosters collaboration among federal agencies to improve mortality data access, collection, reporting and analysis.

Mortality data provides key information to federal agencies working in health, public health, science, and defense. Mortality data, collected by states and provided to the federal government through the National Center for Health Statistics, do not currently

meet timeliness or accuracy needs of those addressing key health issues and emerging public health concerns that federal agencies must surveil and manage today.

Initiation

The Centers for Disease
Control and Prevention
(CDC) National Center for
Health Statistics (NCHS),
in collaboration with
federal agencies and
programs whose missions
depend on vital records
and who agree to
dedicate time and
resources to building vital
records capacity,
established the Mortality
Data Interagency Working
Group to Improve Health.

Participation

Initially, federal agencies and programs including the CDC's Office of Public Health Preparedness and Response (OPHPR), National Center for Immunization and Respiratory Diseases (NCIRD), National Center for Chronic Disease Prevention and Health Promotion (NCCDPHP), National Center for Injury Prevention and Control (NCIPC), National Center for HIV/AIDS, Viral Hepatitis, STD, and TB Prevention (NCHHSTP); and institutes and programs from the National Institutes of Health and the Food and Drug Administration, will participate.

WHY MORTALITY DATA?

Mortality data are important to many stakeholders for public and population health purposes, programming and policy decisions, and for health research. They are also used to establish fact of death for administrative purposes.

 - Enhance mortality data matching and use to improve public and population health
