- 3.10.3-9 Use of Contractor Equipment or Software Permitted Edited to reference the FAA Order.

Reason for Change: 1. AAP 110 was advised by AGC to replace the word "shall" in the AMS clauses. Responsibilities outlined in AMS Clauses for FAA will be replaced with the word "will". Responsibilities outlined in the AMS Clauses for contractors will be replaced with the word "must".

- 2. The word FAA was replaced with Government to identify Government-Wide regulations that were not FAA only regulations. The regulations referenced in the clauses are mandated by the Federal Government and FAA was not exempted from the mandate.
- 3. 3.6.3-4 Recycled Content Products Certification Clause edited to provide the correct link to the EPA Comprehensive Procurement Guideline (CPG) Program.
- 3.6.2-39 Trafficking in Persons The clause revisions are needed in order to further define prohibited activities and possible remedies. The changes have been approved by the AAQ Managers and by the ASAG.
- 3.10.3-9 Use of Contractor Equipment or Software Permitted The clause was revised to update the FAA Order reference from 1280.1B to 1370.121.
