## A BILL

To amend title 18, United States Code, to prohibit the unlawful disposal of fetal remains, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Protecting the Dignity  
5 of Unborn Children Act of 2018”.

1 **SEC. 2. PROHIBITING UNLAWFUL DISPOSAL OF FETAL RE-**  
2 **MAINS.**

3 (a) PROHIBITING UNLAWFUL DISPOSAL OF FETAL  
4 REMAINS.—Part I of title 18, United States Code, is  
5 amended by adding at the end the following:

6 **“CHAPTER 125—UNLAWFUL DISPOSAL OF**  
7 **FETAL REMAINS**

8 **“SEC. 2741. UNLAWFUL DISPOSAL OF FETAL REMAINS.**

9 “(a) IN GENERAL.—Whoever recklessly disposes of  
10 or abandons fetal remains in a landfill or in any of the  
11 navigable waters of the United States shall be imprisoned  
12 not more than 3 years or fined under this title, or both.

13 “(b) RULE OF CONSTRUCTION.—Nothing in this sec-  
14 tion shall be construed to authorize the prosecution of any  
15 woman for the disposal of the remains of her unborn child.

16 “(c) DEFINITIONS.—In this section:

17 “(1) FETAL REMAINS.—The term ‘fetal re-  
18 mains’ means any part of a human fetus that is de-  
19 ceased by reason of an abortion, but does not in-  
20 clude any such part that has been cremated.

21 “(2) LANDFILL.—The term ‘landfill’ means a  
22 sanitary landfill, as such term is defined in section  
23 1004(26) of the Solid Waste Disposal Act.

24 “(3) NAVIGABLE WATERS.—The term ‘navi-  
25 gable waters’ has the meaning given such term in

1 section 502(7) of the Federal Water Pollution Con-  
2 trol Act.”.

3 (b) CLERICAL AMENDMENT.—The table of chapters  
4 for such part is amended by inserting, after the item per-  
5 taining to chapter 123, the following:

“125. Unlawful disposal of fetal remains ..... 2741”.
