7	SEC. 5. TRAINING ON ADMINISTRATION OF FIRE GRANT
8	PROGRAMS.
9	(a) In General.—The Administrator of the Federal
10	Emergency Management Agency, acting through the Ad-
11	ministrator of the United States Fire Administration, may
12	develop and make widely available an electronic, online
13	training course for members of the fire and emergency re-
14	sponse community on matters relating to the administra-
15	tion of grants under sections 33 and 34 of the Federal
16	Fire Prevention and Control Act of 1974 (15 U.S.C. 2229)
17	and 2229a).
18	(b) REQUIREMENTS.—The Administrator of the Fed-
19	eral Emergency Management Agency shall ensure that
20	any training developed and made available under sub-
21	section (a) is—
22	(1) tailored to the financial and time con-
23	straints of members of the fire and emergency re-
24	sponse community: and

1	(2) accessible to all individuals in the career,
2	combination, paid-on-call, and volunteer fire and
3	emergency response community.
4	SEC. 6. FRAMEWORK FOR OVERSIGHT AND MONITORING
5	OF THE ASSISTANCE TO FIREFIGHTERS
6	GRANTS PROGRAM, THE FIRE PREVENTION
7	AND SAFETY GRANTS PROGRAM, AND THE
8	STAFFING FOR ADEQUATE FIRE AND EMER-
9	GENCY RESPONSE GRANT PROGRAM.
10	(a) Framework.—Not later than 90 days after the
11	date of enactment of this Act, the Administrator of the
12	Federal Emergency Management Agency, acting through
13	the Administrator of the United States Fire Administra-
14	tion, shall develop and implement a grant monitoring and
15	oversight framework to mitigate and minimize risks of
16	fraud, waste, abuse, and mismanagement relating to the
17	grants programs under sections 33 and 34 of the Federal
18	Fire Prevention and Control Act of 1974 (15 U.S.C. 2229
19	and 2229a).
20	(b) Elements.—The framework required under sub-
21	section (a) shall include the following:
22	(1) Developing standardized guidance and
23	training for all participants in the grant programs
24	described in subsection (a).
25	(2) Conducting regular risk assessments.

1	(3) Conducting desk reviews and site visits.
2	(4) Enforcement actions to recoup potential
3	questionable costs of grant recipients.
4	(5) Such other oversight and monitoring tools
5	as the Administrator of the Federal Emergency
6	Management Agency considers necessary to mitigate
7	and minimize fraud, waste, abuse, and mismanage-
8	ment relating to the grant programs described in
9	subsection (a).
