AN ACT

- To require the Secretary of State to take such actions as may be necessary for the United States to rejoin the Bureau of International Expositions, and for other purposes.
 - 1 Be it enacted by the Senate and House of Representa-
 - 2 tives of the United States of America in Congress assembled,

1 SECTION 1. SHORT TITLE.

- This Act may be cited as the "U.S. Wants to Com-
- 3 pete for a World Expo Act".
- 4 SEC. 2. FINDINGS.
- 5 Congress finds the following:
- 6 (1) The Bureau of International Expositions
- 7 (BIE) is the organization responsible for governing
- 8 World Fairs and International Expositions.
- 9 (2) Section 1(a) of Public Law 91–269 (22)
- 10 U.S.C. 2801(a)) found that "international expo-
- sitions * * * have a significant impact on the eco-
- 12 nomic growth of the region surrounding the expo-
- sition and * * * are important instruments of na-
- tional policy".
- 15 (3) The United States has not been an active
- member of the BIE since 2001.
- 17 (4) State and local governments and private en-
- tities in the United States have continued to partici-
- pate in international expositions held in foreign
- countries as a means of promoting United States ex-
- 21 ports and creating jobs, but face significantly higher
- 22 costs for such participation because the United
- 23 States is not an active member.
- 24 (5) State and local governments and private en-
- 25 tities in the United States have expressed interest in
- an international exposition being hosted in the

- 1 United States, but the bid of a United States city,
- 2 region, or State to host an international exposition
- 3 is unlikely to be successful if the United States is
- 4 not a member of the BIE.

5 SEC. 3. SENSE OF CONGRESS.

- 6 It is the sense of Congress that—
- 7 (1) the United States should rejoin the BIE im-8 mediately to promote domestic job creation, global
- 9 branding, and tourism to the United States;
- 10 (2) the Secretary of State, in partnership with
- the Secretary of Commerce, State and local govern-
- ments, and private and non-profit entities, should
- take all necessary steps to facilitate the timely sub-
- mission of a request to rejoin the BIE; and
- 15 (3) funding for the participation of the United
- 16 States in international expositions or other events
- facilitated by the BIE should continue to be pri-
- vately solicited and sourced, in accordance with ex-
- isting law.

20 SEC. 4. AUTHORIZATION.

- 21 (a) In General.—The Secretary of State is author-
- 22 ized to take such actions as the Secretary determines nec-
- 23 essary for the United States to rejoin and maintain mem-
- 24 bership in the BIE.

- 2 TRIBUTIONS.—In addition to funds otherwise available to
- 3 the Secretary to carry out this section, the Secretary is
- 4 authorized to accept contributions for such purpose.

- 6 tify the Committees on Foreign Affairs and Appropria-
- 7 tions of the House of Representatives and the Committees
- 8 on Foreign Relations and Appropriations of the Senate
- 9 upon taking any action under subsection (a).
- 10 SEC. 5. CONTINUATION OF PROHIBITION ON USE OF FED-
- 11 ERAL FUNDS FOR WORLD'S FAIR PAVILIONS
- 12 AND EXHIBITS.
- Nothing in this Act may be construed to authorize
- 14 any obligation or expenditure prohibited by section 204
- 15 of the Admiral James W. Nance and Meg Donovan For-
- 16 eign Relations Authorization Act, Fiscal Years 2000 and
- 17 2001 (22 U.S.C. 2452b) (relating to limitations on the
- 18 obligation or expenditure of funds by the Department of
- 19 State for a United States pavilion or exhibit at an inter-
- 20 national exposition or world's fair registered by the BIE).
