# **A BILL**

To designate the Veterans Memorial and Museum in Columbus, Ohio, as the National Veterans Memorial and Museum, and for other purposes.

1        *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4        *This Act may be cited as the “National Veterans Me-*  
5 *morial and Museum Act”.*

6 **SEC. 2. DESIGNATION OF NATIONAL VETERANS MEMORIAL**  
7 **AND MUSEUM.**

8        (a) *DESIGNATION.*—*Subject to the condition described*  
9 *in subsection (b), the memorial and museum that is, as of*  
10 *the date of the enactment of this Act, being constructed on*  
11 *an approximately 7-acre area on West Broad Street, Co-*  
12 *lumbus, Ohio, bounded by the Scioto River and the Scioto*  
13 *Greenway, shall be designated as the “National Veterans*  
14 *Memorial and Museum”.*

15        (b) *REPORT TO CONGRESS.*—

16            (1) *IN GENERAL.*—*As a condition of the designa-*  
17 *tion under subsection (a), the director of the memorial*  
18 *and museum described in that subsection shall submit*  
19 *to Congress a report on the memorial and museum by*  
20 *not later than the date specified in paragraph (2).*

21        *Such report shall include each of the following:*

22            (A) *The projected budget for the memorial*  
23 *and museum for the five-year period beginning*  
24 *on the date the memorial and museum is ex-*  
25 *pected to open to the public.*

1           (B) *A description of the outreach conducted*  
2           *by the memorial and museum to veterans across*  
3           *the United States to receive input about the de-*  
4           *sign and contents of the memorial and museum.*

5           (C) *A description of the process by which*  
6           *decisions are made about the contents of the ex-*  
7           *hibits displayed at the memorial and museum.*

8           (D) *A description of the organizational*  
9           *structure of the memorial and museum.*

10          (E) *A copy of the bylaws and rules of the*  
11          *memorial and museum.*

12          (F) *A list of any organizations or entities*  
13          *that have accredited the memorial and museum.*

14          (2) *DEADLINE FOR REPORT.*—*The date specified*  
15          *in this paragraph is the earlier of the following dates:*

16               (A) *The date that is 90 days after the date*  
17               *of the enactment of this Act.*

18               (B) *The date that is 30 days before the date*  
19               *on which the memorial and museum is first open*  
20               *to the public.*

21          (c) *EFFECT OF DESIGNATION.*—*The national memo-*  
22          *rial and museum designated by subsection (a) is not a unit*  
23          *of the National Park System, and the designation of the*  
24          *national memorial and museum shall not be construed to*

- 1 *require Federal funds to be expended for any purpose re-*
- 2 *lated to the national memorial and museum.*
