# A BILL

To establish a grant program under the Federal Aviation Administration to improve the preparation and representation of certain students in aviation-related fields.

1       *Be it enacted by the Senate and House of Representa-*  
2       *tives of the United States of America in Congress assembled,*

3       **SECTION 1. SHORT TITLE.**

4       This Act may be cited as the “Minorities in Aviation  
5       Education Act of 2018”.

1     **SEC. 2. BESSIE COLEMAN AVIATION EDUCATION PROGRAM.**

2         (a) IN GENERAL.—The Administrator of the Federal  
3     Aviation Administration shall establish the Bessie Cole-  
4     man Aviation Education Program to improve the prepara-  
5     tion and representation of students, particularly women  
6     and minorities, in aviation-related fields.

7         (b) AUTHORIZED ACTIVITIES.—The Administrator  
8     shall award grants under this subsection on the basis of  
9     a competitive peer review process. Grants awarded under  
10    this subsection may be used for increasing exposure and  
11    access to aviation-related education and jobs through such  
12    means as—

13                 (1) internships that offer students experience in  
14             the aviation industry;

15                 (2) programs that introduce students to un-  
16             manned aircraft operations;

17                 (3) career exploration and educational programs  
18             that teach technical skills used in aviation mainte-  
19             nance, or to improve existing such programs; and

20                 (4) programs to increase the recruitment and  
21             retention of underrepresented minorities in postsec-  
22             ondary aviation degree programs.

23         (c) APPLICATION AND REVIEW PROCEDURES.—

24                 (1) IN GENERAL.—An entity described in para-  
25             graph (3) seeking funding under this subsection  
26             shall submit an application to the Administrator at

1       such time, in such manner, and containing such in-  
2       formation as the Administrator may require. Such  
3       application, at a minimum, shall include a descrip-  
4       tion of how the funds will be used to carry out the  
5       activities described in subsection (b).

6                 (2) PRIORITY.—In making awards under this  
7       subsection, the Administrator shall give priority to  
8       applicants that will encourage the participation of  
9       women and minorities.

10                (3) ELIGIBILITY.—Local educational agencies,  
11       State educational agencies, and State and local gov-  
12       ernments, which may enter into a partnership agree-  
13       ment with institutions of higher education, nonprofit  
14       organizations, or other entities, shall be eligible to  
15       apply for grants under this subsection.

16               (d) DEFINITIONS.—In this subsection, the following  
17       definitions apply:

18                         (1) INSTITUTION OF HIGHER EDUCATION.—The  
19       term “institution of higher education” has the  
20       meaning given that term in section 101 of the High-  
21       er Education Act of 1965 (20 U.S.C. 1001).

22                         (2) LOCAL EDUCATIONAL AGENCY.—The term  
23       “local educational agency” has the meaning given  
24       that term in section 8101 of the Elementary and  
25       Secondary Education Act of 1965 (20 U.S.C. 7801).

1                             (3) STATE EDUCATIONAL AGENCY.—The term  
2                             “State educational agency” has the meaning given  
3                             that term in section 8101 of the Elementary and  
4                             Secondary Education Act of 1965 (20 U.S.C. 7801).  
5                             (e) AUTHORIZATION OF APPROPRIATIONS.—There  
6                             are authorized to be appropriated to carry out this section  
7                             \$5,000,000 for each of fiscal years 2019, 2020, 2021,  
8                             2022, and 2023.
