## A BILL

To amend title II of the Social Security Act to exclude from creditable wages and self-employment income wages earned for services by aliens illegally performed in the United States and self-employment income derived from a trade or business illegally conducted in the United States.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “No Social Security for  
5 Illegal Immigrants Act of 2017”.

1 **SEC. 2. EXCLUSION OF UNAUTHORIZED EMPLOYMENT**  
2 **FROM EMPLOYMENT UPON WHICH CRED-**  
3 **ITABLE WAGES MAY BE BASED.**

4 Section 210(a)(19) of the Social Security Act (42  
5 U.S.C. 410(a)(19)) is amended—

6 (1) by striking “(19) Service” and inserting the  
7 following:

8 “(19)(A) Service performed by an alien while  
9 employed in the United States for any period during  
10 which the alien is not authorized to be so employed;

11 “(B) Service”.

12 **SEC. 3. EXCLUSION OF UNAUTHORIZED FUNCTIONS AND**  
13 **SERVICES FROM TRADE OR BUSINESS FROM**  
14 **WHICH CREDITABLE SELF-EMPLOYMENT IN-**  
15 **COME MAY BE DERIVED.**

16 Section 211(c) of the Social Security Act (42 U.S.C.  
17 411(c)) is amended—

18 (1) in paragraph (5), by striking “or” at the  
19 end;

20 (2) in paragraph (6), by striking “him.” and in-  
21 serting “him; or”; and

22 (3) by inserting after paragraph (6) the fol-  
23 lowing new paragraph:

24 “(7) The performance of a function or service  
25 in the United States by an alien during any period

1       for which the alien is not authorized to perform such  
2       function or service in the United States.”.

3 **SEC. 4. EFFECTIVE DATE.**

4       The amendments made by this Act shall apply with  
5       respect to wages earned, and self-employment income de-  
6       rived, before, on, or after the date of the enactment of  
7       this Act. Notwithstanding section 215(f)(1) of the Social  
8       Security Act (42 U.S.C. 415(f)(1)), as soon as practicable  
9       after the date of the enactment of this Act, the Commis-  
10      sioner of Social Security shall recompute all primary in-  
11      surance amounts to the extent necessary to carry out such  
12      amendments. Such amendments shall affect benefits only  
13      for months after the date of the enactment of this Act.
