A BILL

To reauthorize the New Jersey Coastal Heritage Trail Route,
and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. NEW JERSEY COASTAL HERITAGE TRAIL**
4 **ROUTE.**

5 (a) REAUTHORIZATION.—Section 6 of Public Law
6 100–515 (16 U.S.C. 1244 note) is amended—

7 (1) by striking subsection (a);

8 (2) by redesignating subsections (b) and (c) as
9 subsections (a) and (b), respectively;

10 (3) in subsection (a) (as so redesignated by
11 paragraph (2)), by striking “under subsection (a)”
12 each place that it appears and inserting “to carry
13 out this Act”; and

14 (4) in subsection (b) (as so redesignated by
15 paragraph (2)), by striking “2011” and inserting
16 “2025”.

17 (b) STRATEGIC PLAN.—

18 (1) IN GENERAL.—

19 (A) PLAN REQUIRED.—Not later than 3
20 years after the date on which funds are first
21 made available after the date of enactment of
22 this Act to carry out Public Law 100–515 (16
23 U.S.C. 1244 note), the Secretary of the Interior
24 shall prepare a strategic plan for the New Jer-
25 sey Coastal Heritage Trail Route.

1 (B) CONTENTS.—The strategic plan shall
2 describe—

3 (i) opportunities to increase participa-
4 tion by national and local private and pub-
5 lic interests in the planning, development,
6 and administration of the New Jersey
7 Coastal Heritage Trail Route; and

8 (ii) organizational options for sus-
9 taining the New Jersey Coastal Heritage
10 Trail Route.

11 (2) CONFORMING AMENDMENT.—Section
12 703(b) of the National Heritage Areas Act of 2006
13 (Public Law 109–338; 120 Stat. 1859) is repealed.
