3 **SECTION 1. SHORT TITLE.**

4 *This Act may be cited as the “Keep America’s Refuges*
5 *Operational Act”.*

6 **SEC. 2. REAUTHORIZATION OF NATIONAL WILDLIFE REF-**
7 **UGE SYSTEM VOLUNTEER SERVICES, COMMU-**
8 **NITY PARTNERSHIP, AND REFUGE EDU-**
9 **CATION PROGRAMS.**

10 *Section 7 of the Fish and Wildlife Act of 1956 (16*
11 *U.S.C. 742f) is amended in subsection (g), by striking*
12 *“2011 through 2014” and inserting “2018 through 2022”.*
