A BILL

To amend the Internal Revenue Code of 1986 to allow first responders to continue to exclude service-connected disability pension payments after reaching the age of retirement.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Putting Our First-
- 5 Responders First Act of 2018".

1	SEC. 2. CONTINUED EXCLUSION OF FIRST RESPONDER
2	SERVICE-CONNECTED DISABILITY PAYMENTS
3	AFTER AGE OF RETIREMENT.
4	(a) In General.—Section 104 of the Internal Rev-
5	enue Code of 1986 is amended by redesignating subsection
6	(d) as subsection (e) and by inserting after subsection (e)
7	the following new subsection:
8	"(d) Special Rule for First Responder Serv-
9	ICE-CONNECTED DISABILITY PAYMENTS AFTER AGE OF
10	RETIREMENT.—
11	"(1) In general.—In the case of an individual
12	who receives a service-connected disability excludable
13	amount, gross income shall not include such amount
14	of any retirement pension or annuity which—
15	"(A) is received by such individual with re-
16	spect to the service to which the service-con-
17	nected disability excludable amount relates,
18	"(B) is determined by reference to the in-
19	dividual's age, length of service, or contribu-
20	tions, and
21	"(C) does not exceed the service-connected
22	disability excludable amount (determined on an
23	annualized basis under such regulations or
24	other guidance as the Secretary may prescribe).
25	"(2) Service-connected disability exclud-
26	ABLE AMOUNT.—For purposes of this subsection,

1 the term 'service-connected disability excludable 2 amount' means an amount received by an individual 3 which ceases upon reaching retirement age and is not includible in gross income under subsection 5 (a)(1) by reason of a service-connected disability as 6 a law enforcement officer (as such term is defined 7 in section 1204 of the Omnibus Crime Control and 8 Safe Streets Act of 1968), an employee in fire pro-9 tection activities (as such term is defined in section 10 3(y) of the Fair Labor Standards Act of 1938), or 11 an individual who provides out-of-hospital emergency 12 medical care (including emergency medical techni-13 cian, paramedic, or first-responder).".

14 (b) Effective Date.—The amendments made by 15 this section shall apply to taxable years beginning after 16 the date of the enactment of this Act.
