### A BILL

Making appropriations for the Department of the Interior and related agencies for the fiscal year ending September 30, 1997, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 That the following sums are appropriated, out of any
- 4 money in the Treasury not otherwise appropriated, for the
- 5 Department of the Interior and related agencies for the
- 6 fiscal year ending September 30, 1997, and for other pur-
- 7 poses, namely:

1	TITLE I—DEPARTMENT OF THE INTERIOR
2	BUREAU OF LAND MANAGEMENT
3	MANAGEMENT OF LANDS AND RESOURCES
4	For expenses necessary for protection, use, improve-
5	ment, development, disposal, cadastral surveying, classi-
6	fication, acquisition of easements and other interests in
7	lands, and performance of other functions, including main-
8	tenance of facilities, as authorized by law, in the manage-
9	ment of lands and their resources under the jurisdiction
10	of the Bureau of Land Management, including the general
11	administration of the Bureau, and assessment of mineral
12	potential of public lands pursuant to Public Law 96–487
13	(16 U.S.C. 3150(a)), \$566,514,000, to remain available
14	until expended, of which \$2,000,000 shall be available for
15	assessment of the mineral potential of public lands in
16	Alaska pursuant to section 1010 of Public Law 96–487
17	(16 U.S.C. 3150); and of which \$3,000,000 shall be de-
18	rived from the special receipt account established by the
19	Land and Water Conservation Act of 1965, as amended
20	(16 U.S.C. 460l–6a(i)); and of which \$1,000,000 shall be
21	available in fiscal year 1997 subject to a match by at least
22	an equal amount by the National Fish and Wildlife Foun-
23	dation, to such Foundation for challenge cost share
24	projects supporting fish and wildlife conservation affecting
25	Bureau lands; in addition, \$27,300,000 for Mining Law

Administration program operations, to remain available until expended, to be reduced by amounts collected by the 3 Bureau and credited to this appropriation from annual 4 mining claim fees so as to result in a final appropriation estimated at not more than \$566,514,000; and in addition, not to exceed \$5,000,000, to remain available until 6 expended, from annual mining claim fees; which shall be 8 credited to this account for the costs of administering the mining claim fee program, and \$2,000,000 from commu-10 nication site rental fees established by the Bureau for the cost of administering communication site activities: Pro-11 12 vided, That appropriations herein made shall not be available for the destruction of healthy, unadopted, wild horses and burros in the care of the Bureau or its contractors: 14 15 Provided further, That in fiscal year 1997 and thereafter, all fees, excluding mining claim fees, in excess of the fiscal 16 year 1996 collections established by the Secretary of the Interior under the authority of 43 U.S.C. 1734 for proc-18 19 essing, recording, or documenting authorizations to use public lands or public land natural resources (including 21 cultural, historical, and mineral) and for providing specific 22 services to public land users, and which are not presently 23 being covered into any Bureau of Land Management appropriation accounts, and not otherwise dedicated by law for a specific distribution, shall be made immediately

- 1 available for program operations in this account and re-
- 2 main available until expended.
- 3 WILDLAND FIRE MANAGEMENT
- 4 For necessary expenses for fire use and management,
- 5 fire preparedness, suppression operations, and emergency
- 6 rehabilitation by the Department of the Interior,
- 7 \$247,924,000, to remain available until expended, of
- 8 which not to exceed \$5,025,000 shall be for the renovation
- 9 or construction of fire facilities: *Provided*, That such funds
- 10 are also available for repayment of advances to other ap-
- 11 propriation accounts from which funds were previously
- 12 transferred for such purposes: Provided further, That per-
- 13 sons hired pursuant to 43 U.S.C. 1469 may be furnished
- 14 subsistence and lodging without costs from funds available
- 15 from this appropriation: Provided further, That unobli-
- 16 gated balances of amounts previously appropriated to the
- 17 "Fire Protection" and "Emergency Department of the In-
- 18 terior Firefighting Fund" may be transferred to this ap-
- 19 propriation.
- 20 CENTRAL HAZARDOUS MATERIALS FUND
- 21 For necessary expenses of the Department of the In-
- 22 terior and any of its component offices and bureaus for
- 23 the remedial action, including associated activities, of haz-
- 24 ardous waste substances, pollutants, or contaminants pur-
- 25 suant to the Comprehensive Environmental Response,

- 1 Compensation and Liability Act, as amended (42 U.S.C.
- 2 9601 et seq.), \$12,000,000, to remain available until ex-
- 3 pended: Provided, That notwithstanding 31 U.S.C. 3302,
- 4 sums recovered from or paid by a party in advance of or
- 5 as reimbursement for remedial action or response activi-
- 6 ties conducted by the Department pursuant to sections
- 7 107 or 113(f) of such Act, shall be credited to this account
- 8 to be available until expended without further appropria-
- 9 tion: Provided further, That such sums recovered from or
- 10 paid by any party are not limited to monetary payments
- 11 and may include stocks, bonds or other personal or real
- 12 property, which may be retained, liquidated, or otherwise
- 13 disposed of by the Secretary and which shall be credited
- 14 to this account.
- 15 CONSTRUCTION
- 16 For construction of buildings, recreation facilities,
- 17 roads, trails, and appurtenant facilities, \$3,103,000, to re-
- 18 main available until expended.
- 19 PAYMENTS IN LIEU OF TAXES
- For expenses necessary to implement the Act of Octo-
- 21 ber 20, 1976, as amended (31 U.S.C. 6901–07),
- 22 \$113,500,000, of which not to exceed \$400,000 shall be
- 23 available for administrative expenses.

### LAND ACQUISITION

- 2 For expenses necessary to carry out sections 205,
- 3 206, and 318(d) of Public Law 94–579 including adminis-
- 4 trative expenses and acquisition of lands or waters, or in-
- 5 terests therein, \$10,000,000, to be derived from the Land
- 6 and Water Conservation Fund, to remain available until
- 7 expended.

### 8 OREGON AND CALIFORNIA GRANT LANDS

- 9 For expenses necessary for management, protection,
- 10 and development of resources and for construction, oper-
- 11 ation, and maintenance of access roads, reforestation, and
- 12 other improvements on the revested Oregon and California
- 13 Railroad grant lands, on other Federal lands in the Or-
- 14 egon and California land-grant counties of Oregon, and
- 15 on adjacent rights-of-way; and acquisition of lands or in-
- 16 terests therein including existing connecting roads on or
- 17 adjacent to such grant lands; \$98,365,000, to remain
- 18 available until expended: Provided, That 25 per centum
- 19 of the aggregate of all receipts during the current fiscal
- 20 year from the revested Oregon and California Railroad

- 23 to the General Fund in the Treasury in accordance with

- 25 ed, and Public Law 93–153, to remain available until ex-

- 1 pended: *Provided*, That notwithstanding any provision to
- 2 the contrary of section 305(a) of Public Law 94–579 (43)
- 3 U.S.C. 1735(a)), any moneys that have been or will be
- 4 received pursuant to that section, whether as a result of
- 5 forfeiture, compromise, or settlement, if not appropriate
- 6 for refund pursuant to section 305(c) of that Act (43
- 7 U.S.C. 1735(c)), shall be available and may be expended
- 8 under the authority of this Act by the Secretary to im-
- 9 prove, protect, or rehabilitate any public lands adminis-
- 10 tered through the Bureau of Land Management which
- 11 have been damaged by the action of a resource developer,
- 12 purchaser, permittee, or any unauthorized person, without
- 13 regard to whether all moneys collected from each such ac-
- 14 tion are used on the exact lands damaged which led to
- 15 the action: Provided further, That any such moneys that
- 16 are in excess of amounts needed to repair damage to the
- 17 exact land for which funds were collected may be used to
- 18 repair other damaged public lands.
- 19 MISCELLANEOUS TRUST FUNDS
- In addition to amounts authorized to be expended
- 21 under existing laws, there is hereby appropriated such
- 22 amounts as may be contributed under section 307 of the
- 23 Act of October 21, 1976 (43 U.S.C. 1701), and such
- 24 amounts as may be advanced for administrative costs, sur-
- 25 veys, appraisals, and costs of making conveyances of omit-

15	U.S.C. 501, the Bureau may, under cooperative cost-shar-
16	ing and partnership arrangements authorized by law, pro-
17	cure printing services from cooperators in connection with
18	jointly-produced publications for which the cooperators
19	share the cost of printing either in cash or in services,
20	and the Bureau determines the cooperator is capable of
21	meeting accepted quality standards.
22	UNITED STATES FISH AND WILDLIFE SERVICE
23	RESOURCE MANAGEMENT
24	For expenses necessary for scientific and economic
25	studies, conservation, management, investigations, protec-

- 1 tion, and utilization of fishery and wildlife resources, ex-
- 2 cept whales, seals, and sea lions, and for the performance
- 3 of other authorized functions related to such resources; for
- 4 the general administration of the United States Fish and
- 5 Wildlife Service; for maintenance of the herd of long-
- 6 horned cattle on the Wichita Mountains Wildlife Refuge;
- 7 and not less than \$1,000,000 for high priority projects
- 8 within the scope of the approved budget which shall be
- 9 carried out by the Youth Conservation Corps as author-
- 10 ized by the Act of August 13, 1970, as amended,
- 11 \$520,519,000, to remain available until September 30,
- 12 1998, of which \$11,557,000 shall remain available until
- 13 expended for operation and maintenance of fishery mitiga-
- 14 tion facilities constructed by the Corps of Engineers under
- 15 the Lower Snake River Compensation Plan, authorized by
- 16 the Water Resources Development Act of 1976, to com-
- 17 pensate for loss of fishery resources from water develop-
- 18 ment projects on the Lower Snake River, and of which
- 19 \$1,000,000 shall be provided to the National Fish and
- 20 Wildlife Foundation for implementation of the Natural
- 21 Communities Conservation Plan, and shall be available
- 22 only to the extent matched by at least an equal amount
- 23 from the Foundation and shall remain available until ex-
- 24 pended: *Provided*, That pursuant to 31 U.S.C. 9701, the
- 25 Secretary shall charge reasonable fees for the full costs

- 1 of providing training by the National Education and
- 2 Training Center, to be credited to this account, notwith-
- 3 standing 31 U.S.C. 3302, of which not to exceed
- 4 \$2,000,000 shall be available for the direct costs of provid-
- 5 ing such training: Provided further, That not to exceed
- 6 \$1,000,000 of the funds provided herein may be used for
- 7 contaminant sample analysis.
- 8 CONSTRUCTION
- 9 For construction and acquisition of buildings and
- 10 other facilities required in the conservation, management,
- 11 investigation, protection, and utilization of fishery and
- 12 wildlife resources, and the acquisition of lands and inter-
- 13 ests therein; \$38,298,000, to remain available until ex-
- 14 pended.
- 15 NATURAL RESOURCE DAMAGE ASSESSMENT FUND
- To conduct natural resource damage assessment ac-
- 17 tivities by the Department of the Interior necessary to
- 18 carry out the provisions of the Comprehensive Environ-
- 19 mental Response, Compensation, and Liability Act, as
- 20 amended (42 U.S.C. 9601, et seq.), Federal Water Pollu-
- 21 tion Control Act, as amended (33 U.S.C. 1251, et seq.),
- 22 the Oil Pollution Act of 1990 (Public Law 101–380), and
- 23 Public Law 101–337; \$4,000,000, to remain available
