

2018 DEMOCRACY SCORECARD

IN 1970, JOHN W. GARDNER, a Republican whose sense of duty to country over party led him to serve in the cabinet in the administration of a Democratic president, had a simple but powerful idea: citizens engaged in the democratic process can make a difference. “We want public officials to have literally millions of American citizens looking over their shoulders at every move they make,” Gardner wrote. “We want phones to ring in Washington and state capitols and town halls. We want people watching and influencing every move that government makes.”

Gardner’s letter launched Common Cause; his idea continues to animate our work, including this 2018 Democracy Scorecard. This Scorecard is geared to help amplify the voices of everyday Americans who have been silenced by big money in politics, voter suppression tactics, and other schemes to block people from participating in our democracy. Common Cause’s 2018 Democracy Scorecard reflects our continued commitment to ensuring that all Americans’ voices can be heard in our government and that everyone plays by the same set of common sense rules. The Scorecard provides data on every current member of Congress based on their sponsorship or cosponsorship of key democracy reform bills that Common Cause and our 1.2 million members support.

Bills in this Scorecard would strengthen our money-in-politics, voting, ethics, and media and democracy laws, as well as ensure that all residents are counted in the census. Bills in the Scorecard would enhance transparency requirements for political contributions and spending, break the power of big money in our elections by incentivizing small-dollar contributions, and crack down on foreign influence in our election. Other money-in-politics bills in the package would overturn the Supreme Court’s disastrous *Citizens United* decision and tighten the prohibition on political spending by foreign entities.

The Scorecard also includes bills to strengthen our voting laws by updating and strengthening provisions of the Voting Rights Act gutted by the

Shelby v. Holder Supreme Court ruling, securing and enhancing voting systems, providing automatic registration so that voters are added to voter rolls when they do business with state agencies, and creating independent citizens’ commissions to draw new districts after each census so that politicians cannot cherry-pick their voters. And one of the ethics bills would mandate the disclosure of tax returns by the incumbent President and presidential nominees of a major political party for the three most recent taxable years.

Cosponsorships are just one metric to gauge support for democracy reform, and there are democracy reform champions in Congress who this Scorecard might not fully recognize. Republican leadership and committee chairs in this Congress have blocked debate and mark-ups on dozens of key bills that are desperately needed to give all Americans a greater voice in our democracy, so there are not votes to consider for this Scorecard. Despite its limitations, we believe the Scorecard provides a useful tool for voters to see that there are solutions for strengthening our democracy. In recent months, we’ve sent multiple staff in each congressional office four letters listing the bills included in this year’s Scorecard; we wanted to make sure every member of Congress knew which bills he or she was being evaluated on. Since these letters were sent, a combined total of more than 250 cosponsors have been added to these bills.

Common Cause never endorses or opposes candidates for elected office. We publish this Scorecard as a guide so concerned citizens can evaluate the records of their members of Congress on key democracy reform issues and build support for these solutions. We urge all readers to check the performance of their senators and representatives on issues covered in the Scorecard. In Gardner’s spirit, all citizens should work to hold power accountable by making the phones ring in Washington, their state capitols, and local government offices to ensure that government will always be of, by, and for the people.

Bill descriptions

HOUSE

MONEY-IN-POLITICS BILLS

HR 20, Government by the People Act: Small-dollar donor public financing; would create a small donor matching fund system to lessen congressional candidates' dependence on special interest and lobbyist money and instead raise small in-state donations

HR 1134/HR 6239, DISCLOSE Act: Disclosure of political spending; would require all corporations, unions, other outside groups, and Super PACs to report to the FEC within 24 hours of making a \$10,000 campaign expenditure or financial transfer to other groups which can then be used for campaign-related activity; would require leaders of entities engaging in political spending >\$10,000 to “stand by their ads”

HR 1615, Get Foreign Money out of U.S. Elections Act: would close that loophole by banning campaign contributions and expenditures by corporations that are controlled, influenced, or owned by foreign nationals.

HJR 31, Democracy for All Amendment: Overturn *Citizens United* decision; would authorize Congress and the states to set reasonable limits on the raising and spending of money by candidates and others to influence elections

HR 12, Voter Empowerment Act: Modernize and enhance voting systems; would modernize registration systems and create online voter registration, allow same-day registration, ensuring the ballots of military/overseas Americans are counted, and create a national voting hotline

HR 2840/HR 2876, Automatic Voter Registration Act: Create automatic voter registration systems; would ensure that eligible individuals interacting with certain government agencies would automatically be registered to vote

HR 2978, Voting Rights Advancement Act/**HR 3239**, Voting Rights Amendment Act: Update the Voting Rights Act; would modernize the Voting Rights Act pre-clearance formula to ensure that states/localities with a history of discriminating against voters must get changes approved by the Justice Department

HR 1562, HR 3132, HR 3751, HR 4276, HR 5011, HR 5147, election security bills: would secure and modernize our election systems and protect them from vulnerabilities by requiring paper ballots, post-election risk-limiting audits, and other safeguards.

ETHICS, CONFLICTS OF INTEREST, AND ABUSE OF POWER

HR 371, Presidential Conflicts of Interest Act: strengthens ethics requirements for the President; would require the President and Vice President to submit to Congress and the Office of Government Ethics a disclosure of financial interests and a disclosure of tax returns by the incumbent President and presidential nominees of a major political party for the three most recent taxable years

HR 1960, Supreme Court Ethics Act: Create judicial code of conduct for Supreme Court; would require the Supreme Court to establish a judicial code of conduct for justices to comply with similar to all other federal judges

HR 3654, HR 5476, HR 5505, would protect current and future Special Counsels from indiscriminate termination

HR 356, Protecting Our Democracy Act: would create an independent, Watergate-like commission to investigate Russian hacking in the 2016 elections

FAIR REPRESENTATION AND MEDIA & DEMOCRACY

HR 1102, Redistricting Reform Act/**HR 712**, John Tanner Fairness and Independence in Redistricting Act: Create independent redistricting commissions; outlines criteria for states to create independent redistricting commissions to help eliminate partisan gerrymandering

HJR 129, Congressional Review Act resolution of disapproval to preserve the open Internet: would restore the FCC's 2015 rule on net neutrality

HR 1439, Keeping Our Campaigns Honest Act: directs the FCC to revise its sponsorship identification rules to require the names of top donors to be included for political ads

S 1585/S 3150, DISCLOSE Act: Disclosure of political spending; would require all corporations, unions, other outside groups, and Super PACs to report to the FEC within 24 hours of making a \$10,000 campaign expenditure or financial transfer to other groups which can then be used for campaign-related activity; would require leaders of entities engaging in political spending >\$10,000 to “stand by their ads”

S 1640, Fair Elections Now Act: Small-dollar donor public financing; would create a small donor matching fund system to lessen congressional candidates' dependence on special interest and lobbyist money and incentivize raising small in-state donations

SJR 8, Democracy for All Amendment: Overturn *Citizens United* decision; would authorize Congress and the states to set reasonable limits on the raising and spending of money by candidates, individuals, and groups to influence elections

S 1989, Honest Ads Act: Disclosure of online political ads; would ensure that online political ads have the same disclosure requirements as television, print, and radio political ads do

S 1437, Voter Empowerment Act: Modernize and enhance voting systems; would modernize registration systems and create online voter registration, allow same-day registration, ensuring the ballots of military/overseas Americans are counted, and create a national voting hotline

S 1419, Voting Rights Advancement Act: Update the Voting Rights Act; would modernize the Voting Rights Act pre-clearance formula to ensure that states/localities with a history of discriminating against voters must get changes approved by the Justice Department

S 1588, Democracy Restoration Act: Restore voting rights for individuals who have served their time; would establish criteria for formerly incarcerated citizens to have their voting rights restored in federal elections

S 2593, S 3049, S 3116, election security bills: would secure and modernize our election systems and protect them from vulnerabilities by requiring paper ballots, post-election risk-limiting audits, and other safeguards.

ETHICS, CONFLICTS OF INTEREST, AND ABUSE OF POWER

S 65, Presidential Conflicts of Interest Act: strengthens ethics requirements for the President; would require the President and Vice President to submit to Congress and the Office of Government Ethics a disclosure of financial interests and a disclosure of tax returns by the incumbent President and presidential nominees of a major political party for the three most recent taxable years

S 835, Supreme Court Ethics Act: Create judicial code of conduct for Supreme Court; would require the Supreme Court to establish a judicial code of conduct for justices to comply with similar to all other federal judges

S 27, establish a Commission to End Russian Interference in United States Elections: would create an independent commission to examine and report on the facts regarding the extent of Russian official and unofficial cyber operations and other attempts to interfere in the 2016 U.S. elections

MEDIA & DEMOCRACY, FAIR REPRESENTATION, AND OTHER DEMOCRACY REFORMS

SJR 52, Congressional Review Act resolution of disapproval to preserve the open Internet: would restore the FCC's 2015 rule on net neutrality (voting for SJR 52 counts the same as cosponsoring)

S 2578, 2020 Census IDEA Act/**S 2580**, Every Person Counts Act: would require the Secretary of Commerce to provide advanced notice to Congress before changing any questions on the census; instruct the Census Bureau to count the total number of people living in each state during each decennial census; and prohibit the Census Bureau from asking for or collecting information on individuals' citizenship or immigration status

S 1880, We the People Democracy Reform Act: Omnibus democracy reform bill; would reform the Federal Election Commission, require common sense disclosure of political spending, strengthen lobbying guidelines, and strengthen other money-in-politics, voting, and ethics laws.
