AN ACT

Making appropriations for military construction, the Department of Veterans Affairs, and related agencies for the fiscal year ending September 30, 2013, and for other purposes.

1 Be it enacted by the Senate and House of Representa-2 tives of the United States of America in Congress assembled, 3 That the following sums are appropriated, out of any 4 money in the Treasury not otherwise appropriated, for 5 military construction, the Department of Veterans Affairs, 6 and related agencies for the fiscal year ending September 7 30, 2013, and for other purposes, namely: 1

TITLE I

DEPARTMENT OF DEFENSE

MILITARY CONSTRUCTION, ARMY

4 For acquisition, construction, installation, and equip-5 ment of temporary or permanent public works, military installations, facilities, and real property for the Army as 6 7 currently authorized by law, including personnel in the 8 Army Corps of Engineers and other personal services nec-9 essary for the purposes of this appropriation, and for con-10 struction and operation of facilities in support of the functions of the Commander in Chief, \$1,820,323,000, to re-11 12 main available until September 30, 2017: Provided, That 13 of this amount, not to exceed \$80,173,000 shall be avail-14 able for study, planning, design, architect and engineer 15 services, and host nation support, as authorized by law, unless the Secretary of Army determines that additional 16 17 obligations are necessary for such purposes and notifies 18 the Committees on Appropriations of both Houses of Con-19 gress of the determination and the reasons therefor.

20 MILITARY CONSTRUCTION, NAVY AND MARINE CORPS

For acquisition, construction, installation, and equipment of temporary or permanent public works, naval installations, facilities, and real property for the Navy and Marine Corps as currently authorized by law, including personnel in the Naval Facilities Engineering Command

and other personal services necessary for the purposes of 1 this appropriation, \$1,551,217,000, to remain available 2 3 until September 30, 2017: Provided, That of this amount, 4 not to exceed \$102,619,000 shall be available for study, 5 planning, design, and architect and engineer services, as authorized by law, unless the Secretary of Navy deter-6 7 mines that additional obligations are necessary for such 8 purposes and notifies the Committees on Appropriations 9 of both Houses of Congress of the determination and the 10 reasons therefor.

MILITARY CONSTRUCTION, AIR FORCE

12 For acquisition, construction, installation, and equip-13 ment of temporary or permanent public works, military installations, facilities, and real property for the Air Force 14 15 as currently authorized by law, \$388,200,000, to remain available until September 30, 2017: Provided, That of this 16 17 amount, not to exceed \$18,635,000 shall be available for 18 study, planning, design, and architect and engineer services, as authorized by law, unless the Secretary of Air 19 20 Force determines that additional obligations are necessary 21 for such purposes and notifies the Committees on Appro-22 priations of both Houses of Congress of the determination 23 and the reasons therefor.

For construction, acquisition, expansion, rehabilitation, and conversion of facilities for the training and administration of the Air National Guard, and contributions therefor, as authorized by law, \$42,386,000, to remain available until September 30, 2017: *Provided*, That of the amount appropriated, not to exceed \$4,000,000 shall be available for study, planning, design, and architect and engineer services, as authorized by law, unless the Director
 of the Air National Guard determines that additional obli gations are necessary for such purposes and notifies the
 Committees on Appropriations of both Houses of Congress
 of the determination and the reasons therefor.

6 MILITARY CONSTRUCTION, ARMY RESERVE

7 For construction, acquisition, expansion, rehabilita-8 tion, and conversion of facilities for the training and ad-9 ministration of the Army Reserve as authorized by law, 10 \$305,846,000, to remain available until September 30, 2017: Provided, That of the amount appropriated, not to 11 12 exceed \$15,951,000 shall be available for study, planning, 13 design, and architect and engineer services, as authorized by law, unless the Chief of the Army Reserve determines 14 15 that additional obligations are necessary for such purposes and notifies the Committees on Appropriations of both 16 17 Houses of Congress of the determination and the reasons therefor. 18

19 MILITARY CONSTRUCTION, NAVY RESERVE

For construction, acquisition, expansion, rehabilitation, and conversion of facilities for the training and administration of the reserve components of the Navy and Marine Corps as authorized by law, \$49,532,000, to remain available until September 30, 2017: *Provided*, That of the amount appropriated, not to exceed \$2,118,000 shall be available for study, planning, design, and architect
 and engineer services, as authorized by law, unless the
 Secretary of the Navy determines that additional obliga tions are necessary for such purposes and notifies the
 Committees on Appropriations of both Houses of Congress
 of the determination and the reasons therefor.

10 For deposit into the Department of Defense Base 11 Closure Account 2005, established by section 2906A(a)(1)of the Defense Base Closure and Realignment Act of 1990 12 13 (10 U.S.C. 2687 note), \$126,697,000, to remain available until expended: *Provided*, That the Department of Defense 14 15 shall notify the Committees on Appropriations of both Houses of Congress 14 days prior to obligating an amount 16 for a construction project that exceeds or reduces the 17 18 amount identified for that project in the most recently 19 submitted budget request for this account by 20 percent 20 or \$2,000,000, whichever is less: *Provided further*, That 21 the previous proviso shall not apply to projects costing less 22 than \$5,000,000, except for those projects not previously 23 identified in any budget submission for this account and 24 exceeding the minor construction threshold under section 25 2805 of title 10, United States Code.

Administrative Provisions

SEC. 101. None of the funds made available in this title shall be expended for payments under a cost-plus-afixed-fee contract for construction, where cost estimates exceed \$25,000, to be performed within the United States, except Alaska, without the specific approval in writing of the Secretary of Defense setting forth the reasons therefor.

9 SEC. 102. Funds made available in this title for con10 struction shall be available for hire of passenger motor ve11 hicles.

12 SEC. 103. Funds made available in this title for con-13 struction may be used for advances to the Federal High-14 way Administration, Department of Transportation, for 15 the construction of access roads as authorized by section 16 210 of title 23, United States Code, when projects author-17 ized therein are certified as important to the national de-18 fense by the Secretary of Defense.

SEC. 104. None of the funds made available in this
title may be used to begin construction of new bases in
the United States for which specific appropriations have
not been made.

SEC. 105. None of the funds made available in this
title shall be used for purchase of land or land easements
in excess of 100 percent of the value as determined by

1 the Army Corps of Engineers or the Naval Facilities Engi2 neering Command, except: (1) where there is a determina3 tion of value by a Federal court; (2) purchases negotiated
4 by the Attorney General or the designee of the Attorney
5 General; (3) where the estimated value is less than
6 \$25,000; or (4) as otherwise determined by the Secretary
7 of Defense to be in the public interest.

8 SEC. 106. None of the funds made available in this 9 title shall be used to: (1) acquire land; (2) provide for site 10 preparation; or (3) install utilities for any family housing, 11 except housing for which funds have been made available 12 in annual Acts making appropriations for military con-13 struction.

14 SEC. 107. None of the funds made available in this 15 title for minor construction may be used to transfer or 16 relocate any activity from one base or installation to an-17 other, without prior notification to the Committees on Ap-18 propriations of both Houses of Congress.

19 SEC. 108. None of the funds made available in this 20 title may be used for the procurement of steel for any con-21 struction project or activity for which American steel pro-22 ducers, fabricators, and manufacturers have been denied 23 the opportunity to compete for such steel procurement.

SEC. 109. None of the funds available to the Depart-ment of Defense for military construction or family hous-

ing during the current fiscal year may be used to pay real
 property taxes in any foreign nation.

3 SEC. 110. None of the funds made available in this 4 title may be used to initiate a new installation overseas 5 without prior notification to the Committees on Appro-6 priations of both Houses of Congress.

7 SEC. 111. None of the funds made available in this 8 title may be obligated for architect and engineer contracts 9 estimated by the Government to exceed \$500,000 for 10 projects to be accomplished in Japan, in any North Atlan-11 tic Treaty Organization member country, or in countries bordering the Arabian Sea, unless such contracts are 12 13 awarded to United States firms or United States firms in joint venture with host nation firms. 14

15 SEC. 112. None of the funds made available in this title for military construction in the United States terri-16 17 tories and possessions in the Pacific and on Kwajalein Atoll, or in countries within the United States Central 18 19 Command Area of Responsibility, may be used to award 20any contract estimated by the Government to exceed 21 \$1,000,000 to a foreign contractor: *Provided*, That this 22 section shall not be applicable to contract awards for 23 which the lowest responsive and responsible bid of a 24 United States contractor exceeds the lowest responsive 25 and responsible bid of a foreign contractor by greater than

20 percent: *Provided further*, That this section shall not
 apply to contract awards for military construction on
 Kwajalein Atoll for which the lowest responsive and re sponsible bid is submitted by a Marshallese contractor.

5 SEC. 113. The Secretary of Defense shall inform the 6 appropriate committees of both Houses of Congress, in-7 cluding the Committees on Appropriations, of plans and 8 scope of any proposed military exercise involving United 9 States personnel 30 days prior to its occurring, if amounts 10 expended for construction, either temporary or permanent, 11 are anticipated to exceed \$100,000.

12 SEC. 114. Funds appropriated to the Department of 13 Defense for construction in prior years shall be available 14 for construction authorized for each such military depart-15 ment by the authorizations enacted into law during the 16 current session of Congress.

SEC. 115. For military construction or family housing
projects that are being completed with funds otherwise expired or lapsed for obligation, expired or lapsed funds may
be used to pay the cost of associated supervision, inspection, overhead, engineering and design on those projects
and on subsequent claims, if any.

SEC. 116. Notwithstanding any other provision of
law, any funds made available to a military department
or defense agency for the construction of military projects

may be obligated for a military construction project or 1 contract, or for any portion of such a project or contract, 2 3 at any time before the end of the fourth fiscal year after 4 the fiscal year for which funds for such project were made 5 available, if the funds obligated for such project: (1) are obligated from funds available for military construction 6 7 projects; and (2) do not exceed the amount appropriated 8 for such project, plus any amount by which the cost of 9 such project is increased pursuant to law.

10 (INCLUDING TRANSFER OF FUNDS)

11 SEC. 117. In addition to any other transfer authority 12 available to the Department of Defense, proceeds depos-13 ited to the Department of Defense Base Closure Account established by section 207(a)(1) of the Defense Authoriza-14 15 tion Amendments and Base Closure and Realignment Act 16 (10 U.S.C. 2687 note) pursuant to section 207(a)(2)(C)17 of such Act, may be transferred to the account established by section 2906(a)(1) of the Defense Base Closure and 18 Realignment Act of 1990 (10 U.S.C. 2687 note), to be 19 20merged with, and to be available for the same purposes 21 and the same time period as that account.

22 (INCLUDING TRANSFER OF FUNDS)

SEC. 118. Subject to 30 days prior notification, or
14 days for a notification provided in an electronic medium pursuant to sections 480 and 2883 of title 10,

United States Code, to the Committees on Appropriations 1 2 of both Houses of Congress, such additional amounts as 3 may be determined by the Secretary of Defense may be 4 transferred to: (1) the Department of Defense Family 5 Housing Improvement Fund from amounts appropriated for construction in "Family Housing" accounts, to be 6 7 merged with and to be available for the same purposes 8 and for the same period of time as amounts appropriated 9 directly to the Fund; or (2) the Department of Defense 10 Military Unaccompanied Housing Improvement Fund from amounts appropriated for construction of military 11 12 unaccompanied housing in "Military Construction" ac-13 counts, to be merged with and to be available for the same purposes and for the same period of time as amounts ap-14 15 propriated directly to the Fund: *Provided*, That appropriations made available to the Funds shall be available to 16 17 cover the costs, as defined in section 502(5) of the Con-18 gressional Budget Act of 1974, of direct loans or loan 19 guarantees issued by the Department of Defense pursuant to the provisions of subchapter IV of chapter 169 of title 20 21 10, United States Code, pertaining to alternative means 22 of acquiring and improving military family housing, mili-23 tary unaccompanied housing, and supporting facilities.

(INCLUDING TRANSFER OF FUNDS)

2 SEC. 119. In addition to any other transfer authority 3 available to the Department of Defense, amounts may be 4 transferred from the accounts established by sections 5 2906(a)(1) and 2906A(a)(1) of the Defense Base Closure and Realignment Act of 1990 (10 U.S.C. 2687 note), to 6 7 the fund established by section 1013(d) of the Demonstra-8 tion Cities and Metropolitan Development Act of 1966 (42) 9 U.S.C. 3374) to pay for expenses associated with the 10 Homeowners Assistance Program incurred under 42 U.S.C. 3374(a)(1)(A). Any amounts transferred shall be 11 merged with and be available for the same purposes and 12 13 for the same time period as the fund to which transferred. 14 SEC. 120. Notwithstanding any other provision of 15 law, funds made available in this title for operation and maintenance of family housing shall be the exclusive 16 17 source of funds for repair and maintenance of all family housing units, including general or flag officer quarters: 18 19 *Provided*, That not more than \$35,000 per unit may be 20spent annually for the maintenance and repair of any gen-21 eral or flag officer quarters without 30 days prior notifica-22 tion, or 14 days for a notification provided in an electronic 23 medium pursuant to sections 480 and 2883 of title 10, 24 United States Code, to the Committees on Appropriations 25 of both Houses of Congress, except that an after-the-fact notification shall be submitted if the limitation is exceeded
 solely due to costs associated with environmental remedi ation that could not be reasonably anticipated at the time
 of the budget submission.

5 SEC. 121. Amounts contained in the Ford Island Im-6 provement Account established by subsection (h) of sec-7 tion 2814 of title 10, United States Code, are appro-8 priated and shall be available until expended for the pur-9 poses specified in subsection (i)(1) of such section or until 10 transferred pursuant to subsection (i)(3) of such section.

11 SEC. 122. None of the funds made available in this 12 title, or in any Act making appropriations for military con-13 struction which remain available for obligation, may be ob-14 ligated or expended to carry out a military construction, 15 land acquisition, or family housing project at or for a military installation approved for closure, or at a military in-16 17 stallation for the purposes of supporting a function that has been approved for realignment to another installation, 18 in 2005 under the Defense Base Closure and Realignment 19 Act of 1990 (part A of title XXIX of Public Law 101– 20 21 510; 10 U.S.C. 2687 note), unless such a project at a mili-22 tary installation approved for realignment will support a 23 continuing mission or function at that installation or a 24 new mission or function that is planned for that installa-25 tion, or unless the Secretary of Defense certifies that the

cost to the United States of carrying out such project 1 2 would be less than the cost to the United States of cancel-3 ling such project, or if the project is at an active compo-4 nent base that shall be established as an enclave or in the 5 case of projects having multi-agency use, that another 6 Government agency has indicated it will assume ownership 7 of the completed project. The Secretary of Defense may 8 not transfer funds made available as a result of this limi-9 tation from any military construction project, land acquisi-10 tion, or family housing project to another account or use such funds for another purpose or project without the 11 12 prior approval of the Committees on Appropriations of 13 both Houses of Congress. This section shall not apply to military construction projects, land acquisition, or family 14 15 housing projects for which the project is vital to the national security or the protection of health, safety, or envi-16 ronmental quality: *Provided*, That the Secretary of De-17 18 fense shall notify the congressional defense committees 19 within seven days of a decision to carry out such a military 20 construction project.

21 (INCLUDING TRANSFER OF FUNDS)

SEC. 123. During the 5-year period after appropriations available in this Act to the Department of Defense
for military construction and family housing operation and
maintenance and construction have expired for obligation,

upon a determination that such appropriations will not be 1 necessary for the liquidation of obligations or for making 2 3 authorized adjustments to such appropriations for obliga-4 tions incurred during the period of availability of such ap-5 propriations, unobligated balances of such appropriations may be transferred into the appropriation "Foreign Cur-6 7 rency Fluctuations, Construction, Defense", to be merged 8 with and to be available for the same time period and for 9 the same purposes as the appropriation to which trans-10 ferred.

11 SEC. 124. None of the funds made available by this 12 Act may be used by the Secretary of Defense to take bene-13 ficial occupancy of more than 2,000 parking spaces (other than handicap-reserved spaces) to be provided by the 14 15 BRAC 133 project: *Provided*, That this limitation may be waived in part if: (1) the Secretary of Defense certifies 16 to Congress that levels of service at existing intersections 17 in the vicinity of the project have not experienced failing 18 19 levels of service as defined by the Transportation Research 20 Board Highway Capacity Manual over a consecutive 90-21 day period; (2) the Department of Defense and the Vir-22 ginia Department of Transportation agree on the number 23 of additional parking spaces that may be made available 24 to employees of the facility subject to continued 90-day 25 traffic monitoring; and (3) the Secretary of Defense notifies the congressional defense committees in writing at
 least 14 days prior to exercising this waiver of the number
 of additional parking spaces to be made available.

4 SEC. 125. None of the funds made available by this
5 Act may be used for any action that relates to or promotes
6 the expansion of the boundaries or size of the Pinon Can7 yon Maneuver Site, Colorado.

8 SEC. 126. (a) Except as provided in subsection (b), 9 none of the funds made available in this Act may be used 10 by the Secretary of the Army to relocate a unit in the 11 Army that—

(1) performs a testing mission or function that
is not performed by any other unit in the Army and
is specifically stipulated in title 10, United States
Code; and

(2) is located at a military installation at which
the total number of civilian employees of the Department of the Army and Army contractor personnel
employed exceeds 10 percent of the total number of
members of the regular and reserve components of
the Army assigned to the installation.

(b) EXCEPTION.—Subsection (a) shall not apply if
the Secretary of the Army certifies to the congressional
defense committees that in proposing the relocation of the
unit of the Army, the Secretary complied with Army Regu-

lation 5–10 relating to the policy, procedures, and respon sibilities for Army stationing actions.

3 (INCLUDING RESCISSION OF FUNDS)

4 SEC. 127. None of the funds made available by this Act may be used to enter into a contract, memorandum 16 17 of understanding, or cooperative agreement with, make a grant to, or provide a loan or loan guarantee to any cor-18 19 poration that was convicted (or had an officer or agent 20 of such corporation acting on behalf of the corporation 21 convicted) of a felony criminal violation under any Federal 22 law within the preceding 24 months, where the awarding 23 agency is aware of the conviction, unless the agency has 24 considered suspension or debarment of the corporation, or 25 such officer or agent, and made a determination that this further action is not necessary to protect the interests of
 the Government.

3 SEC. 516. None of the funds made available by this 4 Act may be used to enter into a contract, memorandum 5 of understanding, or cooperative agreement with, make a grant to, or provide a loan or loan guarantee to, any cor-6 7 poration that any unpaid Federal tax liability that has 8 been assessed, for which all judicial and administrative 9 remedies have been exhausted or have lapsed, and that 10 is not being paid in a timely manner pursuant to an agreement with the authority responsible for collecting the tax 11 liability, where the awarding agency is aware of the unpaid 12 13 tax liability, unless the agency has considered suspension or debarment of the corporation and made a determination 14 that this further action is not necessary to protect the in-15 terests of the Government. 16

SEC. 522. None of the funds made available by thisAct shall be available to enforce section 526 of the Energy

Independence and Security Act of 2007 (Public Law 110–
 140; 42 U.S.C. 17142).

SEC. 523. None of the funds made available by this
Act may be used for the salary or compensation of a Director of Construction and Facilities Management of the
Department of Veterans Affairs (or an individual acting
as such Director) who does not meet the qualifications for
such position required under section 312A(b) of title 38,
United States Code.

SEC. 524. None of the funds made available by this
Act may be used by the Secretary of Veterans Affairs to
pay a performance award under section 5384 of title 5,
