AN ACT

Making appropriations for the Department of the Interior and related agencies for the fiscal year ending September 30, 2001, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*
3 ~~(1) That the following sums are appropriated, out of any~~
4 ~~money in the Treasury not otherwise appropriated, for the~~
5 ~~Department of the Interior and related agencies for the~~
6 ~~fiscal year ending September 30, 2001, and for other pur-~~
7 ~~poses, namely:~~

8 ~~TITLE I—DEPARTMENT OF THE INTERIOR~~

9 ~~BUREAU OF LAND MANAGEMENT~~

10 ~~MANAGEMENT OF LANDS AND RESOURCES~~

11 ~~For expenses necessary for protection, use, improve-~~
12 ~~ment, development, disposal, cadastral surveying, classi-~~

1 fication, acquisition of easements and other interests in
2 lands, and performance of other functions, including
3 maintenance of facilities, as authorized by law, in the
4 management of lands and their resources under the juris-
5 diction of the Bureau of Land Management, including
6 the general administration of the Bureau, and assessment
7 of mineral potential of public lands pursuant to Public
8 Law 96-487 (16 U.S.C. 3150(a)), \$674,571,000 (re-
9 duced by \$4,000,000), to remain available until ex-
10 pended, of which \$2,198,000 shall be available for assess-
11 ment of the mineral potential of public lands in Alaska
12 pursuant to section 1010 of Public Law 96-487 (16
13 U.S.C. 3150); and of which not to exceed \$1,000,000
14 shall be derived from the special receipt account estab-
15 lished by the Land and Water Conservation Act of 1965,
16 as amended (16 U.S.C. 4601-6a(i)); and of which
17 \$2,500,000 shall be available in fiscal year 2001 subject
18 to a match by at least an equal amount by the National
19 Fish and Wildlife Foundation, to such Foundation for
20 cost-shared projects supporting conservation of Bureau
21 lands and such funds shall be advanced to the Founda-
22 tion as a lump sum grant without regard to when ex-
23 penses are incurred; in addition, \$33,366,000 for Mining
24 Law Administration program operations, including the
25 cost of administering the mining claim fee program; to

1 remain available until expended, to be reduced by
2 amounts collected by the Bureau and credited to this ap-
3 propriation from annual mining claim fees so as to result
4 in a final appropriation estimated at not more than
5 \$674,571,000, and \$2,000,000, to remain available until
6 expended, from communication site rental fees estab-
7 lished by the Bureau for the cost of administering com-
8 munication site activities: *Provided*, That appropriations
9 herein made shall not be available for the destruction of
10 healthy, unadopted, wild horses and burros in the care of
11 the Bureau or its contractors.

12 WILDLAND FIRE MANAGEMENT

13 For necessary expenses for fire preparedness, sup-
14 pression operations, emergency rehabilitation and haz-
15 ardous fuels reduction by the Department of the Interior,
16 \$292,197,000, to remain available until expended, of
17 which not to exceed \$9,300,000 shall be for the renovation
18 or construction of fire facilities: *Provided*, That such funds
19 are also available for repayment of advances to other ap-
20 propriation accounts from which funds were previously
21 transferred for such purposes: *Provided further*, That un-
22 obligated balances of amounts previously appropriated to
23 the "Fire Protection" and "Emergency Department of the
24 Interior Firefighting Fund" may be transferred and
25 merged with this appropriation: *Provided further*, That

1 persons hired pursuant to ~~43~~ U.S.C. 1469 may be fur-
2 nished subsistence and lodging without cost from funds
3 available from this appropriation: *Provided further*, That
4 notwithstanding ~~42~~ U.S.C. 1856d, sums received by a bu-
5 reau or office of the Department of the Interior for fire
6 protection rendered pursuant to ~~42~~ U.S.C. 1856 et seq.,
7 protection of United States property, may be credited to
8 the appropriation from which funds were expended to pro-
9 vide that protection, and are available without fiscal year
10 limitation.

11 CENTRAL HAZARDOUS MATERIALS FUND

12 For necessary expenses of the Department of the In-
13 terior and any of its component offices and bureaus for
14 the remedial action, including associated activities, of haz-
15 ardous waste substances, pollutants, or contaminants pur-
16 suant to the Comprehensive Environmental Response,
17 Compensation, and Liability Act, as amended (~~42~~ U.S.C.
18 ~~9601~~ et seq.), \$10,000,000, to remain available until ex-
19 pended: *Provided*, That notwithstanding ~~31~~ U.S.C. 3302,
20 sums recovered from or paid by a party in advance of or
21 as reimbursement for remedial action or response activi-
22 ties conducted by the Department pursuant to section 107
23 or 113(f) of such Act, shall be credited to this account
24 to be available until expended without further appropria-
25 tion: *Provided further*, That such sums recovered from or

1 paid by any party are not limited to monetary payments
2 and may include stocks, bonds or other personal or real
3 property, which may be retained, liquidated, or otherwise
4 disposed of by the Secretary and which shall be credited
5 to this account.

6 CONSTRUCTION

7 For construction of buildings, recreation facilities,
8 roads, trails, and appurtenant facilities, \$5,300,000 (re-
9 duced by \$1,000,000 and increased by \$1,000,000), to re-
10 main available until expended.

11 PAYMENTS IN LIEU OF TAXES

12 For expenses necessary to implement the Act of Octo-
13 ber 20, 1976, as amended (31 U.S.C. 6901-6907),
14 \$134,385,000 (increased by \$10,000,000), of which not
15 to exceed \$400,000 shall be available for administrative
16 expenses: *Provided*, That no payment shall be made to oth-
17 erwise eligible units of local government if the computed
18 amount of the payment is less than \$100.

19 LAND ACQUISITION

20 For expenses necessary to carry out sections 205,
21 206, and 318(d) of Public Law 94-579, including admin-
22 istrative expenses and acquisition of lands or waters, or
23 interests therein, \$19,000,000 (reduced by \$3,000,000
24 and increased by \$3,000,000), to be derived from the

1 Land and Water Conservation Fund, to remain available
2 until expended.

3 OREGON AND CALIFORNIA GRANT LANDS

4 For expenses necessary for management, protection,
5 and development of resources and for construction, oper-
6 ation, and maintenance of access roads, reforestation, and
7 other improvements on the revested Oregon and California
8 Railroad grant lands, on other Federal lands in the Or-
9 egon and California land-grant counties of Oregon, and
10 on adjacent rights-of-way, and acquisition of lands or in-
11 terests therein including existing connecting roads on or
12 adjacent to such grant lands, \$100,467,000, to remain
13 available until expended: *Provided*, That 25 percent of the
14 aggregate of all receipts during the current fiscal year
15 from the revested Oregon and California Railroad grant
16 lands is hereby made a charge against the Oregon and
17 California land-grant fund and shall be transferred to the
18 General Fund in the Treasury in accordance with the sec-
19 ond paragraph of subsection (b) of title II of the Act of
20 August 28, 1937 (50 Stat. 876).

21 FOREST ECOSYSTEMS HEALTH AND RECOVERY FUND

22 (REVOLVING FUND, SPECIAL ACCOUNT)

23 In addition to the purposes authorized in Public Law
24 102-381, funds made available in the Forest Ecosystem
25 Health and Recovery Fund can be used for the purpose

1 of planning, preparing, and monitoring salvage timber
2 sales and forest ecosystem health and recovery activities
3 such as release from competing vegetation and density
4 control treatments. The Federal share of receipts (defined
5 as the portion of salvage timber receipts not paid to the
6 counties under ~~43 U.S.C. 1181f~~ and ~~43 U.S.C. 1181-1~~
7 ~~et seq.~~, and Public Law ~~103-66~~) derived from treatments
8 funded by this account shall be deposited into the Forest
9 Ecosystem Health and Recovery Fund.

10 RANGE IMPROVEMENTS

11 For rehabilitation, protection, and acquisition of
12 lands and interests therein, and improvement of Federal
13 rangelands pursuant to section 401 of the Federal Land
14 Policy and Management Act of 1976 (~~43 U.S.C. 1701~~),
15 notwithstanding any other Act, sums equal to 50 percent
16 of all moneys received during the prior fiscal year under
17 sections ~~3~~ and ~~15~~ of the Taylor Grazing Act (~~43 U.S.C.~~
18 ~~315~~ et seq.) and the amount designated for range improve-
19 ments from grazing fees and mineral leasing receipts from
20 Bankhead-Jones lands transferred to the Department of
21 the Interior pursuant to law, but not less than
22 \$10,000,000, to remain available until expended: *Pro-*
23 *vided*, That not to exceed \$600,000 shall be available for
24 administrative expenses.

1 SERVICE CHARGES, DEPOSITS, AND FORFEITURES

2 For administrative expenses and other costs related
3 to processing application documents and other authoriza-
4 tions for use and disposal of public lands and resources;
5 for costs of providing copies of official public land docu-
6 ments, for monitoring construction, operation, and termi-
7 nation of facilities in conjunction with use authorizations;
8 and for rehabilitation of damaged property, such amounts
9 as may be collected under Public Law 94-579, as amend-
10 ed, and Public Law 93-153, to remain available until ex-
11 pended: *Provided*, That notwithstanding any provision to
12 the contrary of section 305(a) of Public Law 94-579 (43
13 U.S.C. 1735(a)), any moneys that have been or will be
14 received pursuant to that section, whether as a result of
15 forfeiture, compromise, or settlement, if not appropriate
16 for refund pursuant to section 305(c) of that Act (43
17 U.S.C. 1735(c)), shall be available and may be expended
18 under the authority of this Act by the Secretary to im-
19 prove, protect, or rehabilitate any public lands adminis-
20 tered through the Bureau of Land Management which
21 have been damaged by the action of a resource developer,
22 purchaser, permittee, or any unauthorized person, without
23 regard to whether all moneys collected from each such ac-
24 tion are used on the exact lands damaged which led to
25 the action: *Provided further*, That any such moneys that

1 are in excess of amounts needed to repair damage to the
2 exact land for which funds were collected may be used to
3 repair other damaged public lands.

4 MISCELLANEOUS TRUST FUNDS

5 In addition to amounts authorized to be expended
6 under existing laws, there is hereby appropriated such
7 amounts as may be contributed under section 307 of the
8 Act of October 21, 1976 (43 U.S.C. 1701), and such
9 amounts as may be advanced for administrative costs, sur-
10 veys, appraisals, and costs of making conveyances of omit-
11 ted lands under section 211(b) of that Act, to remain
12 available until expended.

13 ADMINISTRATIVE PROVISIONS

14 Appropriations for the Bureau of Land Management
15 shall be available for purchase, erection, and dismantle-
16 ment of temporary structures, and alteration and mainte-
17 nance of necessary buildings and appurtenant facilities to
18 which the United States has title; up to \$100,000 for pay-
19 ments, at the discretion of the Secretary, for information
20 or evidence concerning violations of laws administered by
21 the Bureau; miscellaneous and emergency expenses of en-
22 forcement activities authorized or approved by the Sec-
23 retary and to be accounted for solely on his certificate,
24 not to exceed \$10,000: *Provided*, That notwithstanding 44
25 U.S.C. 501, the Bureau may, under cooperative cost-shar-

1 ing and partnership arrangements authorized by law, pro-
2 cure printing services from cooperators in connection with
3 jointly produced publications for which the cooperators
4 share the cost of printing either in cash or in services,
5 and the Bureau determines the cooperator is capable of
6 meeting accepted quality standards.

7 UNITED STATES FISH AND WILDLIFE SERVICE

8 RESOURCE MANAGEMENT

9 For necessary expenses of the United States Fish and
10 Wildlife Service, for scientific and economic studies, con-
11 servation, management, investigations, protection, and
12 utilization of fishery and wildlife resources, except whales,
13 seals, and sea lions, maintenance of the herd of long-
14 horned cattle on the Wichita Mountains Wildlife Refuge,
15 general administration, and for the performance of other
16 authorized functions related to such resources by direct
17 expenditure, contracts, grants, cooperative agreements
18 and reimbursable agreements with public and private enti-
19 ties, \$731,400,000, to remain available until September
20 30, 2002, except as otherwise provided herein, of which
21 not less than \$2,000,000 shall be provided to local govern-
22 ments in southern California for planning associated with
23 the Natural Communities Conservation Planning (NCCP)
24 program and shall remain available until expended: *Pro-*
25 *vided*, That not less than \$2,000,000 for high priority

1 projects which shall be carried out by the Youth Conserva-
2 tion Corps as authorized by the Act of August 13, 1970,
3 as amended: *Provided further*, That not to exceed
4 \$6,395,000 shall be used for implementing subsections
5 (a), (b), (c), and (e) of section 4 of the Endangered Spe-
6 cies Act, as amended, for species that are indigenous to
7 the United States (except for processing petitions, devel-
8 oping and issuing proposed and final regulations, and tak-
9 ing any other steps to implement actions described in sub-
10 section (c)(2)(A), (c)(2)(B)(i), or (c)(2)(B)(ii)): *Provided*
11 *further*, That of the amount available for law enforcement,
12 up to \$400,000 to remain available until expended, may
13 at the discretion of the Secretary, be used for payment
14 for information, rewards, or evidence concerning violations
15 of laws administered by the Service, and miscellaneous
16 and emergency expenses of enforcement activity, author-
17 ized or approved by the Secretary and to be accounted
18 for solely on his certificate: *Provided further*, That of the
19 amount provided for environmental contaminants, up to
20 \$1,000,000 may remain available until expended for con-
21 taminant sample analyses.

22 CONSTRUCTION

23 For construction, improvement, acquisition, or re-
24 moval of buildings and other facilities required in the con-
25 servation, management, investigation, protection, and uti-

1 lization of fishery and wildlife resources, and the acqui-
2 tion of lands and interests therein, \$48,395,000, to remain
3 available until expended.

4 LAND ACQUISITION

5 For expenses necessary to carry out the Land and
6 Water Conservation Fund Act of 1965, as amended (16
7 U.S.C. 4601-4 through 11), including administrative ex-
8 penses, and for acquisition of land or waters, or interest
9 therein, in accordance with statutory authority applicable
10 to the United States Fish and Wildlife Service,
11 \$30,000,000, to be derived from the Land and Water Con-
12 servation Fund, to remain available until expended.

13 COOPERATIVE ENDANGERED SPECIES CONSERVATION

14 FUND

15 For expenses necessary to carry out the provisions
16 of the Endangered Species Act of 1973 (16 U.S.C. 1531-
17 1543), as amended, \$23,000,000, to be derived from the
18 Cooperative Endangered Species Conservation Fund, to
19 remain available until expended.

20 NATIONAL WILDLIFE REFUGE FUND

21 For expenses necessary to implement the Act of Octo-
22 ber 17, 1978 (16 U.S.C. 715s), \$10,439,000.

23 NORTH AMERICAN WETLANDS CONSERVATION FUND

24 For expenses necessary to carry out the provisions
25 of the North American Wetlands Conservation Act, Public

1 ~~Law 101-233~~, as amended, \$15,499,000, to remain avail-
 2 able until expended.

3 ~~WILDLIFE CONSERVATION AND APPRECIATION FUND~~

4 For necessary expenses of the Wildlife Conservation
 5 and Appreciation Fund, \$797,000, to remain available
 6 until expended.

7 ~~MULTINATIONAL SPECIES CONSERVATION FUND~~

8 For expenses necessary to carry out the African Ele-
 9 phant Conservation Act (16 U.S.C. 4201-4203, 4211-
 10 4213, 4221-4225, 4241-4245, and 1538), the Asian Ele-
 11 phant Conservation Act of 1997 (Public Law 105-96; 16
 12 U.S.C. 4261-4266), and the Rhinoceros and Tiger Con-
 13 servation Act of 1994 (16 U.S.C. 5301-5306),
 14 \$2,391,000, to remain available until expended: *Provided*,
 15 That funds made available under this Act, Public Law
 16 105-277, and hereafter in annual appropriations Acts for
 17 rhinoceros, tiger, and Asian elephant conservation pro-
 18 grams are exempt from any sanctions imposed against any
 19 country under section 102 of the Arms Export Control Act
 20 (22 U.S.C. 2799aa-1).

21 ~~ADMINISTRATIVE PROVISIONS~~

22 Appropriations and funds available to the United
 23 States Fish and Wildlife Service shall be available for pur-
 24 chase of not to exceed 79 passenger motor vehicles, of
 25 which 72 are for replacement only (including 41 for police-

1 type use); repair of damage to public roads within and
2 adjacent to reservation areas caused by operations of the
3 Service; options for the purchase of land at not to exceed
4 \$1 for each option; facilities incident to such public rec-
5 reational uses on conservation areas as are consistent with
6 their primary purpose; and the maintenance and improve-
7 ment of aquaria, buildings, and other facilities under the
8 jurisdiction of the Service and to which the United States
9 has title, and which are used pursuant to law in connection
10 with management and investigation of fish and wildlife re-
11 sources: *Provided*, That notwithstanding 44 U.S.C. 501,
12 the Service may, under cooperative cost sharing and part-
13 nership arrangements authorized by law, procure printing
14 services from cooperators in connection with jointly pro-
15 duced publications for which the cooperators share at least
16 one-half the cost of printing either in cash or services and
17 the Service determines the cooperator is capable of meet-
18 ing accepted quality standards: *Provided further*, That the
19 Service may accept donated aircraft as replacements for
20 existing aircraft: *Provided further*, That notwithstanding
21 any other provision of law, the Secretary of the Interior
22 may not spend any of the funds appropriated in this Act
23 for the purchase of lands or interests in lands to be used
24 in the establishment of any new unit of the National Wild-
25 life Refuge System unless the purchase is approved in ad-

1 vance by the House and Senate Committees on Appropria-
2 tions in compliance with the reprogramming procedures
3 contained in Senate Report 105-56.

4 NATIONAL PARK SERVICE

5 OPERATION OF THE NATIONAL PARK SYSTEM

6 For expenses necessary for the management, oper-
7 ation, and maintenance of areas and facilities adminis-
8 tered by the National Park Service (including special road
9 maintenance service to trucking permittees on a reimburs-
10 able basis); and for the general administration of the Na-
11 tional Park Service, including not less than \$2,000,000
12 for high priority projects within the scope of the approved
13 budget which shall be carried out by the Youth Conserva-
14 tion Corps as authorized by 16 U.S.C. 1706,
15 \$1,425,617,000 (increased by \$10,000,000) (increased by
16 \$66,500,000), of which \$8,727,000 for research, planning
17 and interagency coordination in support of land acquisi-
18 tion for Everglades restoration shall remain available until
19 expended, and of which not to exceed \$7,000,000, to re-
20 main available until expended, is to be derived from the
21 special fee account established pursuant to title V, section
22 5201 of Public Law 100-203.

23 NATIONAL RECREATION AND PRESERVATION

24 For expenses necessary to carry out recreation pro-
25 grams, natural programs, cultural programs, heritage

1 partnership programs, environmental compliance and re-
2 view, international park affairs, statutory or contractual
3 aid for other activities, and grant administration, not oth-
4 erwise provided for, \$49,956,000, of which \$2,000,000
5 shall be available to carry out the Urban Park and Recre-
6 ation Recovery Act of 1978 (16 U.S.C. 2501 et seq.).

7 HISTORIC PRESERVATION FUND

8 For expenses necessary in carrying out the Historic
9 Preservation Act of 1966, as amended (16 U.S.C. 470),
10 and the Omnibus Parks and Public Lands Management
11 Act of 1996 (Public Law 104-333), \$41,347,000, to be
12 derived from the Historic Preservation Fund, to remain
13 available until September 30, 2002, of which \$7,177,000
14 pursuant to section 507 of Public Law 104-333 shall re-
15 main available until expended.

16 CONSTRUCTION

17 For construction, improvements, repair or replace-
18 ment of physical facilities, including the modifications au-
19 thorized by section 104 of the Everglades National Park
20 Protection and Expansion Act of 1989, \$150,004,000, to
21 remain available until expended.

22 LAND AND WATER CONSERVATION FUND

23 (RESCISSION)

24 The contract authority provided for fiscal year 2001
25 by 16 U.S.C. 4601-10a is rescinded.

1 LAND ACQUISITION AND STATE ASSISTANCE

2 For expenses necessary to carry out the Land and
3 Water Conservation Act of 1965, as amended (16 U.S.C.
4 4601-4 through 11), including administrative expenses,
5 and for acquisition of lands or waters, or interest therein,
6 in accordance with the statutory authority applicable to
7 the National Park Service, \$65,000,000 (increased by
8 \$10,000,000) (increased by \$20,000,000), to be derived
9 from the Land and Water Conservation Fund, to remain
10 available until expended, of which \$21,000,000 (increased
11 by \$10,000,000) is for the State assistance program in-
12 cluding \$1,000,000 to administer the program, and of
13 which \$10,000,000 may be for State grants for land acqui-
14 sition in the State of Florida: *Provided*, That the
15 \$20,000,000 (increased by \$10,000,000) provided for
16 grants in the State assistance program shall be used solely
17 to acquire land for State and local parks for the benefit
18 of outdoor recreation: *Provided further*, That the Secretary
19 may provide Federal assistance to the State of Florida for
20 the acquisition of lands or waters, or interests therein,
21 within the Everglades watershed (consisting of lands and
22 waters within the boundaries of the South Florida Water
23 Management District, Florida Bay and the Florida Keys,
24 and excluding the Eight and One-Half Square Mile Area)
25 under terms and conditions deemed necessary by the Sec-

1 retary to improve and restore the hydrological function of
2 the Everglades watershed: *Provided further*, That funds
3 provided under this heading for assistance to the State
4 of Florida to acquire lands within the Everglades water-
5 shed are contingent upon new matching non-Federal funds
6 by the State and shall be subject to an agreement that
7 the lands to be acquired will be managed in perpetuity
8 for the restoration of the Everglades.

9 ADMINISTRATIVE PROVISIONS

10 Appropriations for the National Park Service shall be
11 available for the purchase of not to exceed 340 passenger
12 motor vehicles, of which 273 shall be for replacement only,
13 including not to exceed 319 for police-type use, 12 buses,
14 and 9 ambulances: *Provided*, That none of the funds ap-
15 propriated to the National Park Service may be used to
16 process any grant or contract documents which do not in-
17 clude the text of 18 U.S.C. 1913: *Provided further*, That
18 none of the funds appropriated to the National Park Serv-
19 ice may be used to implement an agreement for the rede-
20 velopment of the southern end of Ellis Island until such
21 agreement has been submitted to the Congress and shall
22 not be implemented prior to the expiration of 30 calendar
23 days (not including any day in which either House of Con-
24 gress is not in session because of adjournment of more
25 than three calendar days to a day certain) from the receipt

1 by the Speaker of the House of Representatives and the
2 President of the Senate of a full and comprehensive report
3 on the development of the southern end of Ellis Island,
4 including the facts and circumstances relied upon in sup-
5 port of the proposed project.

6 None of the funds in this Act may be spent by the
7 National Park Service for activities taken in direct re-
8 sponse to the United Nations Biodiversity Convention.

9 The National Park Service may distribute to oper-
10 ating units based on the safety record of each unit the
11 costs of programs designed to improve workplace and em-
12 ployee safety, and to encourage employees receiving work-
13 ers' compensation benefits pursuant to chapter 81 of title
14 5, United States Code, to return to appropriate positions
15 for which they are medically able.

16 UNITED STATES GEOLOGICAL SURVEY

17 SURVEYS, INVESTIGATIONS, AND RESEARCH

18 For expenses necessary for the United States Geo-
19 logical Survey to perform surveys, investigations, and re-
20 search covering topography, geology, hydrology, biology,
21 and the mineral and water resources of the United States,
22 its territories and possessions, and other areas as author-
23 ized by 43 U.S.C. 31, 1332, and 1340; classify lands as
24 to their mineral and water resources; give engineering su-
25 pervision to power permittees and Federal Energy Regu-

1 latory Commission licensees; administer the minerals ex-
2 ploration program (30 U.S.C. 641); and publish and dis-
3 seminate data relative to the foregoing activities; and to
4 conduct inquiries into the economic conditions affecting
5 mining and materials processing industries (30 U.S.C. 3,
6 21a, and 1603; 50 U.S.C. 98g(1)) and related purposes
7 as authorized by law and to publish and disseminate data;
8 \$816,676,000, of which \$60,553,000 shall be available
9 only for cooperation with States or municipalities for
10 water resources investigations; and of which \$16,400,000
11 shall remain available until expended for conducting in-
12 quires into the economic conditions affecting mining and
13 materials processing industries; and of which \$32,763,000
14 shall be available until September 30, 2002 for the oper-
15 ation and maintenance of facilities and deferred mainte-
16 nance; and of which \$140,416,000 shall be available until
17 September 30, 2002 for the biological research activity
18 and the operation of the Cooperative Research Units: *Pro-*
19 *vided*, That none of these funds provided for the biological
20 research activity shall be used to conduct new surveys on
21 private property, unless specifically authorized in writing
22 by the property owner: *Provided further*, That no part of
23 this appropriation shall be used to pay more than one-
24 half the cost of topographic mapping or water resources

1 data collection and investigations carried on in cooperation
2 with States and municipalities.

3 ADMINISTRATIVE PROVISIONS

4 The amount appropriated for the United States Geo-
5 logical Survey shall be available for the purchase of not
6 to exceed ~~53~~ passenger motor vehicles, of which 48 are
7 for replacement only; reimbursement to the General Serv-
8 ices Administration for security guard services; reimburse-
9 ment to the United States Fish and Wildlife Service
10 (FWS) for Refuge Revenue Sharing payments made by
11 FWS to local entities for the FWS real property trans-
12 ferred to the Geological Survey; contracting for the fur-
13 nishing of topographic maps and for the making of geo-
14 physical or other specialized surveys when it is administra-
15 tively determined that such procedures are in the public
16 interest; construction and maintenance of necessary build-
17 ings and appurtenant facilities; acquisition of lands for
18 gauging stations and observation wells; expenses of the
19 United States National Committee on Geology; and pay-
20 ment of compensation and expenses of persons on the rolls
21 of the Survey duly appointed to represent the United
22 States in the negotiation and administration of interstate
23 compacts: *Provided*, That activities funded by appropria-
24 tions herein made may be accomplished through the use

1 of contracts, grants, or cooperative agreements as defined
2 in 31 U.S.C. 6302 et seq.

3 MINERALS MANAGEMENT SERVICE

4 ROYALTY AND OFFSHORE MINERALS MANAGEMENT

5 For expenses necessary for minerals leasing and envi-
6 ronmental studies, regulation of industry operations, and
7 collection of royalties, as authorized by law, for enforcing
8 laws and regulations applicable to oil, gas, and other min-
9 erals leases, permits, licenses and operating contracts; and
10 for matching grants or cooperative agreements; including
11 the purchase of not to exceed eight passenger motor vehi-
12 cles for replacement only, \$127,200,000, of which
13 \$84,362,000, shall be available for royalty management
14 activities; and an amount not to exceed \$107,000,000, to
15 be credited to this appropriation and to remain available
16 until expended; from additions to receipts resulting from
17 increases to rates in effect on August 5, 1993, from rate
18 increases to fee collections for Outer Continental Shelf ad-
19 ministrative activities performed by the Minerals Manage-
20 ment Service over and above the rates in effect on Sep-
21 tember 30, 1993, and from additional fees for Outer Con-
22 tinental Shelf administrative activities established after
23 September 30, 1993: *Provided*, That to the extent
24 \$107,000,000 in additions to receipts are not realized
25 from the sources of receipts stated above, the amount

1 needed to reach \$107,000,000 shall be credited to this ap-
2 propriation from receipts resulting from rental rates for
3 Outer Continental Shelf leases in effect before August 5,
4 1993: *Provided further*, That \$3,000,000 for computer ac-
5 quisitions shall remain available until September 30,
6 2002: *Provided further*, That funds appropriated under
7 this Act shall be available for the payment of interest in
8 accordance with 30 U.S.C. 1721(b) and (d): *Provided fur-*
9 *ther*, That not to exceed \$3,000 shall be available for rea-
10 sonable expenses related to promoting volunteer beach and
11 marine cleanup activities: *Provided further*, That notwith-
12 standing any other provision of law, \$15,000 under this
13 heading shall be available for refunds of overpayments in
14 connection with certain Indian leases in which the Direc-
15 tor of the Minerals Management Service (MMS) concurred
16 with the claimed refund due, to pay amounts owed to In-
17 dian allottees or tribes, or to correct prior unrecoverable
18 erroneous payments: *Provided further*, That MMS may
19 under the royalty-in-kind pilot program use a portion of
20 the revenues from royalty-in-kind sales, without regard to
21 fiscal year limitation, to pay for transportation to whole-
22 sale market centers and processing of royalty production
23 taken in kind: *Provided further*, That MMS shall analyze
24 and document the expected return in advance of any roy-
25 alty-in-kind sales to assure to the maximum extent prac-

1 ticable that royalty income under the pilot program is
 2 equal to or greater than royalty income recognized under
 3 a comparable royalty-in-value program.

5 For necessary expenses to carry out title I, section

 8 \$6,118,000, which shall be derived from the Oil Spill Li-
 9 ability Trust Fund, to remain available until expended.

11 ENFORCEMENT

12 REGULATION AND TECHNOLOGY

13 For necessary expenses to carry out the provisions
 14 of the Surface Mining Control and Reclamation Act of
 15 1977, Public Law 95-87, as amended, including the pur-
 16 chase of not to exceed 10 passenger motor vehicles, for
 17 replacement only, \$97,478,000: *Provided*, That the Sec-
 18 retary of the Interior, pursuant to regulations, may use
 19 directly or through grants to States, moneys collected in
 20 fiscal year 2001 for civil penalties assessed under section
 21 518 of the Surface Mining Control and Reclamation Act
 22 of 1977 (30 U.S.C. 1268), to reclaim lands adversely af-
 23 fected by coal mining practices after August 3, 1977, to
 24 remain available until expended: *Provided further*, That
 25 appropriations for the Office of Surface Mining Reclama-

1 tion and Enforcement may provide for the travel and per
2 diem expenses of State and tribal personnel attending Of-
3 fice of Surface Mining Reclamation and Enforcement
4 sponsored training.

5 ABANDONED MINE RECLAMATION FUND

6 For necessary expenses to carry out title IV of the
7 Surface Mining Control and Reclamation Act of 1977,
8 Public Law 95-87, as amended, including the purchase
9 of not more than 10 passenger motor vehicles for replace-
10 ment only, \$197,873,000, to be derived from receipts of
11 the Abandoned Mine Reclamation Fund and to remain
12 available until expended; of which up to \$8,000,000, to
13 be derived from the Federal Expenses Share of the Fund,
14 shall be for supplemental grants to States for the reclama-
15 tion of abandoned sites with acid mine rock drainage from
16 coal mines, and for associated activities, through the Ap-
17 palachian Clean Streams Initiative: *Provided*, That grants
18 to minimum program States will be \$1,500,000 per State
19 in fiscal year 2000: *Provided further*, That of the funds
20 herein provided up to \$18,000,000 may be used for the
21 emergency program authorized by section 410 of Public
22 Law 95-87, as amended, of which no more than 25 per-
23 cent shall be used for emergency reclamation projects in
24 any one State and funds for federally administered emer-
25 gency reclamation projects under this proviso shall not ex-

1 exceed \$11,000,000: *Provided further*, That prior year unob-
2 ligated funds appropriated for the emergency reclamation
3 program shall not be subject to the 25 percent limitation
4 per State and may be used without fiscal year limitation
5 for emergency projects: *Provided further*, That pursuant
6 to Public Law 97-365, the Department of the Interior is
7 authorized to use up to 20 percent from the recovery of
8 the delinquent debt owed to the United States Government
9 to pay for contracts to collect these debts: *Provided fur-*
10 *ther*, That funds made available under title IV of Public
11 Law 95-87 may be used for any required non-Federal
12 share of the cost of projects funded by the Federal Gov-
13 ernment for the purpose of environmental restoration re-
14 lated to treatment or abatement of acid mine drainage
15 from abandoned mines: *Provided further*, That such
16 projects must be consistent with the purposes and prior-
17 ities of the Surface Mining Control and Reclamation Act:
18 *Provided further*, That from the funds provided herein, in
19 addition to the amount granted to the Commonwealth of
20 Pennsylvania under Sections 402(g)(1) and 402(g)(5) of
21 the Surface Mining Control and Reclamation Act, an addi-
22 tional \$2,000,000 shall be made available to the Common-
23 wealth of Pennsylvania to reclaim abandoned coal mine
24 sites and for acid mine drainage remediation caused by
25 past coal mining practices: *Provided further*, That the ad-

ditional funds are to be used to address such problems
in the anthracite region of Pennsylvania.

OPERATION OF INDIAN PROGRAMS

For expenses necessary for the operation of Indian
programs, as authorized by law, including the Snyder Act
of November 2, 1921 (25 U.S.C. 13), the Indian Self-De-
termination and Education Assistance Act of 1975 (25
U.S.C. 450 et seq.), as amended, the Education Amend-
ments of 1978 (25 U.S.C. 2001–2019), and the Tribally
Controlled Schools Act of 1988 (25 U.S.C. 2501 et seq.),
as amended, \$1,657,446,000, to remain available until
September 30, 2002 except as otherwise provided herein,
of which not to exceed \$93,225,000 shall be for welfare
assistance payments and notwithstanding any other provi-
sion of law, including but not limited to the Indian Self-
Determination Act of 1975, as amended, not to exceed
\$125,229,000 shall be available for payments to tribes and
tribal organizations for contract support costs associated
with ongoing contracts, grants, compacts, or annual fund-
ing agreements entered into with the Bureau prior to or
during fiscal year 2001, as authorized by such Act, except
that tribes and tribal organizations may use their tribal
priority allocations for unmet indirect costs of ongoing
contracts, grants, or compacts, or annual funding agree-

1 ments and for unmet welfare assistance costs; and of
2 which not to exceed \$406,010,000 for school operations
3 costs of Bureau-funded schools and other education pro-
4 grams shall become available on July 1, 2001, and shall
5 remain available until September 30, 2002; and of which
6 not to exceed \$39,722,000 shall remain available until ex-
7 pended for housing improvement, road maintenance, at-
8 torney fees, litigation support, self-governance grants, the
9 Indian Self-Determination Fund, land records improve-
10 ment, and the Navajo-Hopi Settlement Program: *Pro-*
11 *vided*, That notwithstanding any other provision of law,
12 including but not limited to the Indian Self-Determination
13 Act of 1975, as amended, and 25 U.S.C. 2008, not to ex-
14 ceed \$42,160,000 within and only from such amounts
15 made available for school operations shall be available to
16 tribes and tribal organizations for administrative cost
17 grants associated with the operation of Bureau-funded
18 schools: *Provided further*, That any forestry funds allo-
19 cated to a tribe which remain unobligated as of September
20 30, 2002, may be transferred during fiscal year 2003 to
21 an Indian forest land assistance account established for
22 the benefit of such tribe within the tribe's trust fund ac-
23 count: *Provided further*, That any such unobligated bal-
24 ances not so transferred shall expire on September 30,
25 2003.

CONSTRUCTION

2 For construction, repair, improvement, and mainte-
3 nance of irrigation and power systems, buildings, utilities,
4 and other facilities, including architectural and engineer-
5 ing services by contract; acquisition of lands, and interests
6 in lands; and preparation of lands for farming, and for
7 construction of the Navajo Indian Irrigation Project pur-
8 suant to Public Law 87-483, \$184,404,000, to remain
9 available until expended: *Provided*, That such amounts as
10 may be available for the construction of the Navajo Indian
11 Irrigation Project may be transferred to the Bureau of
12 Reclamation: *Provided further*, That not to exceed 6 per-
13 cent of contract authority available to the Bureau of In-
14 dian Affairs from the Federal Highway Trust Fund may
15 be used to cover the road program management costs of
16 the Bureau: *Provided further*, That any funds provided for
17 the Safety of Dams program pursuant to 25 U.S.C. 13
18 shall be made available on a nonreimbursable basis: *Pro-*
19 *vided further*, That for fiscal year 2001, in implementing
20 new construction or facilities improvement and repair
21 project grants in excess of \$100,000 that are provided to
22 tribally controlled grant schools under Public Law 100-
23 297, as amended, the Secretary of the Interior shall use
24 the Administrative and Audit Requirements and Cost
25 Principles for Assistance Programs contained in 43 CFR

1 part 12 as the regulatory requirements: *Provided further*,
2 That such grants shall not be subject to section 12.61 of
3 43 CFR; the Secretary and the grantee shall negotiate and
4 determine a schedule of payments for the work to be per-
5 formed: *Provided further*, That in considering applications,
6 the Secretary shall consider whether the Indian tribe or
7 tribal organization would be deficient in assuring that the
8 construction projects conform to applicable building stand-
9 ards and codes and Federal, tribal, or State health and
10 safety standards as required by 25 U.S.C. 2005(a), with
11 respect to organizational and financial management capa-
12 bilities: *Provided further*, That if the Secretary declines an
13 application, the Secretary shall follow the requirements
14 contained in 25 U.S.C. 2505(f): *Provided further*, That
15 any disputes between the Secretary and any grantee con-
16 cerning a grant shall be subject to the disputes provision
17 in 25 U.S.C. 2508(e).

18 INDIAN LAND AND WATER CLAIM SETTLEMENTS AND

19 MISCELLANEOUS PAYMENTS TO INDIANS

20 For miscellaneous payments to Indian tribes and in-
21 dividuals and for necessary administrative expenses,
22 \$34,026,000, to remain available until expended; of which
23 \$25,149,000 shall be available for implementation of en-
24 acted Indian land and water claim settlements pursuant
25 to Public Laws 101-618 and 102-575, and for implemen-

1 tation of other enacted water rights settlements; of which
2 \$8,000,000 shall be available for Tribal compact adminis-
3 tration, economic development and future water supplies
4 facilities under Public Law 106-163; and of which
5 \$877,000 shall be available pursuant to Public Laws 99-
6 264 and 100-580.

7 INDIAN GUARANTEED LOAN PROGRAM ACCOUNT

8 For the cost of guaranteed loans, \$4,500,000, as au-
9 thorized by the Indian Financing Act of 1974, as amend-
10 ed: *Provided*, That such costs, including the cost of modi-
11 fying such loans, shall be as defined in section 502 of the
12 Congressional Budget Act of 1974: *Provided further*, That
13 these funds are available to subsidize total loan principal,
14 any part of which is to be guaranteed, not to exceed
15 \$59,682,000.

16 In addition, for administrative expenses to carry out
17 the guaranteed loan programs, \$485,000.

18 ADMINISTRATIVE PROVISIONS

19 The Bureau of Indian Affairs may carry out the oper-
20 ation of Indian programs by direct expenditure, contracts,
21 cooperative agreements, compacts and grants, either di-
22 rectly or in cooperation with States and other organiza-
23 tions.

24 Appropriations for the Bureau of Indian Affairs (ex-
25 cept the revolving fund for loans, the Indian loan guar-

1 antee and insurance fund; and the Indian Guaranteed
2 Loan Program account) shall be available for expenses of
3 exhibits; and purchase of not to exceed 229 passenger
4 motor vehicles; of which not to exceed 187 shall be for
5 replacement only.

6 Notwithstanding any other provision of law, no funds
7 available to the Bureau of Indian Affairs for central office
8 operations; pooled overhead general administration (except
9 facilities operations and maintenance); or provided to im-
10 plement the recommendations of the National Academy of
11 Public Administration's August 1999 report shall be avail-
12 able for tribal contracts, grants, compacts, or cooperative
13 agreements with the Bureau of Indian Affairs under the
14 provisions of the Indian Self-Determination Act or the
15 Tribal Self-Governance Act of 1994 (Public Law 103-
16 413).

17 In the event any tribe returns appropriations made
18 available by this Act to the Bureau of Indian Affairs for
19 distribution to other tribes; this action shall not diminish
20 the Federal Government's trust responsibility to that
21 tribe; or the government-to-government relationship be-
22 tween the United States and that tribe; or that tribe's abil-
23 ity to access future appropriations.

24 Notwithstanding any other provision of law, no funds
25 available to the Bureau, other than the amounts provided

1 herein for assistance to public schools under 25 U.S.C.
2 452 et seq., shall be available to support the operation of
3 any elementary or secondary school in the State of Alaska.

4 Appropriations made available in this or any other
5 Act for schools funded by the Bureau shall be available
6 only to the schools in the Bureau school system as of Sep-
7 tember 1, 1996. No funds available to the Bureau shall
8 be used to support expanded grades for any school or dor-
9 mitory beyond the grade structure in place or approved
10 by the Secretary of the Interior at each school in the Bu-
11 reau school system as of October 1, 1995. Funds made
12 available under this Act may not be used to establish a
13 charter school at a Bureau-funded school (as that term
14 is defined in section 1146 of the Education Amendments
15 of 1978 (25 U.S.C. 2026)), except that a charter school
16 that is in existence on the date of the enactment of this
17 Act and that has operated at a Bureau-funded school be-
18 fore September 1, 1999, may continue to operate during
19 that period, but only if the charter school pays to the Bu-
20 reau a pro-rata share of funds to reimburse the Bureau
21 for the use of the real and personal property (including
22 buses and vans); the funds of the charter school are kept
23 separate and apart from Bureau funds; and the Bureau
24 does not assume any obligation for charter school pro-
25 grams of the State in which the school is located if the

1 charter school loses such funding. Employees of Bureau-
2 funded schools sharing a campus with a charter school and
3 performing functions related to the charter school's oper-
4 ation and employees of a charter school shall not be treat-
5 ed as Federal employees for purposes of chapter 171 of
6 title 28, United States Code (commonly known as the
7 "Federal Tort Claims Act"). Not later than June 15,
8 2001, the Secretary of the Interior shall evaluate the effec-
9 tiveness of Bureau-funded schools sharing facilities with
10 charter schools in the manner described in the preceding
11 sentence and prepare and submit a report on the finding
12 of that evaluation to the Committees on Appropriations
13 of the Senate and of the House.

2 enues, for construction and support of governmental func-
3 tions; grants to the Government of the Virgin Islands as
4 authorized by law; grants to the Government of Guam,
5 as authorized by law; and grants to the Government of
6 the Northern Mariana Islands as authorized by law (Pub-
7 lic Law 94-241, 90 Stat. 272); and (2) \$4,395,000 shall
8 be available for salaries and expenses of the Office of Insu-
9 lar Affairs: *Provided*, That all financial transactions of the
10 territorial and local governments herein provided for, in-
11 cluding such transactions of all agencies or instrumental-
12 ities established or used by such governments, may be au-
13 dited by the General Accounting Office, at its discretion,
14 in accordance with chapter 35 of title 31, United States
15 Code: *Provided further*, That Northern Mariana Islands
16 Covenant grant funding shall be provided according to
17 those terms of the Agreement of the Special Representa-
18 tives on Future United States Financial Assistance for the
19 Northern Mariana Islands approved by Public Law 104-
20 134: *Provided further*, That of the amounts provided for
21 technical assistance, not to exceed \$300,000 may be made
22 available for transfer to the Disaster Assistance Direct
23 Loan Program Account of the Federal Emergency Man-
24 agement Agency for the purpose of covering the cost of
25 forgiving a portion of the obligation of the Government

1 of the Virgin Islands to pay interest which has accrued
2 on Community Disaster Loan 841 during fiscal year 2000,
3 as required by section 504 of the Congressional Budget
4 Act of 1974, as amended (2 U.S.C. 661e). *Provided fur-*
5 *ther*, That of the amounts provided for technical assist-
6 ance, sufficient funding shall be made available for a grant
7 to the Close Up Foundation. *Provided further*, That of the
8 amounts provided for technical assistance, the amount of
9 \$700,000 shall be made available to the Prior Service Ben-
10 efits Trust Fund for its program of benefit payments to
11 individuals. *Provided further*, That none of this amount
12 shall be used for administrative expenses of the Prior
13 Service Benefits Trust Fund. *Provided further*, That the
14 funds for the program of operations and maintenance im-
15 provement are appropriated to institutionalize routine op-
16 erations and maintenance improvement of capital infra-
17 structure in American Samoa, Guam, the Virgin Islands,
18 the Commonwealth of the Northern Mariana Islands, the
19 Republic of Palau, the Republic of the Marshall Islands,
20 and the Federated States of Micronesia through assess-
21 ments of long-range operations maintenance needs, im-
22 proved capability of local operations and maintenance in-
23 stitutions and agencies (including management and voca-
24 tional education training), and project-specific mainte-
25 nance (with territorial participation and cost sharing to

1 be determined by the Secretary based on the individual

13 the Marshall Islands as provided for in sections 122, 221,
14 223, 232, and 233 of the Compact of Free Association,
15 and for economic assistance and necessary expenses for
16 the Republic of Palau as provided for in sections 122, 221,
17 223, 232, and 233 of the Compact of Free Association,
18 \$20,745,000, to remain available until expended, as au-
19 thorized by Public Law 99-239 and Public Law 99-658.

20 DEPARTMENTAL MANAGEMENT

21 SALARIES AND EXPENSES

22 For necessary expenses for management of the De-
23 partment of the Interior, \$62,406,000, of which not to ex-
24 ceed \$8,500 may be for official reception and representa-
25 tion expenses and of which up to \$1,000,000 shall be

1 available for workers compensation payments and unem-
2 ployment compensation payments associated with the or-
3 derly closure of the United States Bureau of Mines.

4 OFFICE OF THE SOLICITOR

5 SALARIES AND EXPENSES

6 For necessary expenses of the Office of the Solicitor,
7 \$40,196,000.

8 OFFICE OF INSPECTOR GENERAL

9 SALARIES AND EXPENSES

10 For necessary expenses of the Office of Inspector
11 General, \$26,086,000.

12 OFFICE OF SPECIAL TRUSTEE FOR AMERICAN INDIANS

13 FEDERAL TRUST PROGRAMS

14 For operation of trust programs for Indians by direct
15 expenditure, contracts, cooperative agreements, compacts,
16 and grants, \$82,428,000, to remain available until ex-
17 pended: *Provided*, That funds for trust management im-
18 provements may be transferred, as needed, to the Bureau
19 of Indian Affairs "Operation of Indian Programs" account
20 and to the Departmental Management "Salaries and Ex-
21 penses" account: *Provided further*, That funds made avail-
22 able to tribes and tribal organizations through contracts
23 or grants obligated during fiscal year 2001, as authorized
24 by the Indian Self-Determination Act of 1975 (25 U.S.C.
25 450 et seq.), shall remain available until expended by the

1 contractor or grantee: *Provided further,* That notwith-
 2 standing any other provision of law, the statute of limita-
 3 tions shall not commence to run on any claim, including
 4 any claim in litigation pending on the date of the enact-
 5 ment of this Act, concerning losses to or mismanagement
 6 of trust funds, until the affected tribe or individual Indian
 7 has been furnished with an accounting of such funds from
 8 which the beneficiary can determine whether there has
 9 been a loss: *Provided further,* That notwithstanding any
 10 other provision of law, the Secretary shall not be required
 11 to provide a quarterly statement of performance for any
 12 Indian trust account that has not had activity for at least
 13 18 months and has a balance of \$1.00 or less: *Provided*

3 tive expenses: *Provided*, That the Secretary may enter into
4 a cooperative agreement, which shall not be subject to
5 Public law 93-638, as amended, with a tribe having juris-
6 diction over the reservation to implement the program to
7 acquire fractional interests on behalf of such tribe: *Pro-*
8 *vided further*, That the Secretary may develop a reserva-
9 tion-wide system for establishing the fair market value of
10 various types of lands and improvements to govern the
11 amounts offered for acquisition of fractional interests:
12 *Provided further*, That acquisitions shall be limited to one
13 or more reservations as determined by the Secretary: *Pro-*
14 *vided further*, That funds shall be available for acquisition
15 of fractional interests in trust or restricted lands with the
16 consent of its owners and at fair market value, and the
17 Secretary shall hold in trust for such tribe all interests
18 acquired pursuant to this program: *Provided further*, That
19 all proceeds from any lease, resource sale contract, right-
20 of-way or other transaction derived from the fractional in-
21 terests shall be credited to this appropriation, and remain
22 available until expended, until the purchase price paid by
23 the Secretary under this appropriation has been recovered
24 from such proceeds: *Provided further*, That once the pur-
25 chase price has been recovered, all subsequent proceeds

1 shall be managed by the Secretary for the benefit of the
 2 applicable tribe or paid directly to the tribe.

3 NATURAL RESOURCE DAMAGE ASSESSMENT AND
 4 RESTORATION

5 NATURAL RESOURCE DAMAGE ASSESSMENT FUND

6 To conduct natural resource damage assessment ac-
 7 tivities by the Department of the Interior necessary to
 8 carry out the provisions of the Comprehensive Environ-
 9 mental Response, Compensation, and Liability Act, as
 10 amended (~~42 U.S.C. 9601 et seq.~~), Federal Water Pollu-
 11 tion Control Act, as amended (~~33 U.S.C. 1251 et seq.~~),
 12 the Oil Pollution Act of 1990 (Public Law ~~101-380~~) (~~33~~
 13 U.S.C. 2701 et seq.), and Public Law ~~101-337~~, as amend-
 14 ed (~~16 U.S.C. 19jj et seq.~~), \$5,374,000, to remain avail-
 15 able until expended.

16 ADMINISTRATIVE PROVISIONS

17 There is hereby authorized for acquisition from avail-
 18 able resources within the Working Capital Fund, ~~15~~ air-
 19 craft, ~~10~~ of which shall be for replacement and which may
 20 be obtained by donation, purchase or through available ex-
 21 cess surplus property: *Provided*, That notwithstanding any
 22 other provision of law, existing aircraft being replaced may
 23 be sold, with proceeds derived or trade-in value used to
 24 offset the purchase price for the replacement aircraft: *Pro-*
 25 *vided further*, That no programs funded with appropriated

1 funds in the “Departmental Management”, “Office of the
2 Solicitor”, and “Office of Inspector General” may be aug-
3 mented through the Working Capital Fund or the Consoli-
4 dated Working Fund.

5 GENERAL PROVISIONS, DEPARTMENT OF THE
6 INTERIOR

7 SEC. 101. Appropriations made in this title shall be
8 available for expenditure or transfer (within each bureau
9 or office), with the approval of the Secretary, for the emer-
10 gency reconstruction, replacement, or repair of aircraft,
11 buildings, utilities, or other facilities or equipment dam-
12 aged or destroyed by fire, flood, storm, or other unavoid-
13 able causes: *Provided*, That no funds shall be made avail-
14 able under this authority until funds specifically made
15 available to the Department of the Interior for emer-
16 gencies shall have been exhausted: *Provided further*, That
17 all funds used pursuant to this section are hereby des-
18 ignated by Congress to be “emergency requirements” pur-
19 suant to section 251(b)(2)(A) of the Balanced Budget and
20 Emergency Deficit Control Act of 1985, and must be re-
21 plenished by a supplemental appropriation which must be
22 requested as promptly as possible.

23 SEC. 102. The Secretary may authorize the expendi-
24 ture or transfer of any no year appropriation in this title,
25 in addition to the amounts included in the budget pro-

1 grams of the several agencies, for the suppression or emer-
2 gency prevention of wildland fires on or threatening lands
3 under the jurisdiction of the Department of the Interior;
4 for the emergency rehabilitation of burned-over lands
5 under its jurisdiction; for emergency actions related to po-
6 tential or actual earthquakes, floods, volcanoes, storms, or
7 other unavoidable causes; for contingency planning subse-
8 quent to actual oil spills; for response and natural resource
9 damage assessment activities related to actual oil spills;
10 for the prevention, suppression, and control of actual or
11 potential grasshopper and Mormon cricket outbreaks on
12 lands under the jurisdiction of the Secretary, pursuant to
13 the authority in section 1773(b) of Public Law 99-198
14 (99 Stat. 1658); for emergency reclamation projects under
15 section 410 of Public Law 95-87; and shall transfer, from
16 any no year funds available to the Office of Surface Min-
17 ing Reclamation and Enforcement, such funds as may be
18 necessary to permit assumption of regulatory authority in
19 the event a primacy State is not carrying out the regu-
20 latory provisions of the Surface Mining Act: *Provided,*
21 That appropriations made in this title for wildland fire
22 operations shall be available for the payment of obligations
23 incurred during the preceding fiscal year, and for reim-
24 bursement to other Federal agencies for destruction of ve-
25 hicles, aircraft, or other equipment in connection with

1 their use for wildland fire operations, such reimbursement
2 to be credited to appropriations currently available at the
3 time of receipt thereof: *Provided further*, That for wildland
4 fire operations, no funds shall be made available under
5 this authority until the Secretary determines that funds
6 appropriated for “wildland fire operations” shall be ex-
7 hausted within thirty days: *Provided further*, That all
8 funds used pursuant to this section are hereby designated
9 by Congress to be “emergency requirements” pursuant to
10 section 251(b)(2)(A) of the Balanced Budget and Emer-
11 gency Deficit Control Act of 1985, and must be replen-
12 ished by a supplemental appropriation which must be re-
13 quested as promptly as possible: *Provided further*, That
14 such replenishment funds shall be used to reimburse, on
15 a pro rata basis, accounts from which emergency funds
16 were transferred.

17 SEC. 103. Appropriations made in this title shall be
18 available for operation of warehouses, garages, shops, and
19 similar facilities, wherever consolidation of activities will
20 contribute to efficiency or economy, and said appropria-
21 tions shall be reimbursed for services rendered to any
22 other activity in the same manner as authorized by sec-
23 tions 1535 and 1536 of title 31, United States Code: *Pro-*
24 *vided*, That reimbursements for costs and supplies, mate-
25 rials, equipment, and for services rendered may be cred-

1 ited to the appropriation current at the time such reim-
2 bursements are received.

3 SEC. 104. Appropriations made to the Department
4 of the Interior in this title shall be available for services
5 as authorized by ~~5~~ U.S.C. 3109, when authorized by the
6 Secretary, in total amount not to exceed \$500,000; hire,
7 maintenance, and operation of aircraft; hire of passenger
8 motor vehicles; purchase of reprints; payment for tele-
9 phone service in private residences in the field, when au-
10 thorized under regulations approved by the Secretary; and
11 the payment of dues, when authorized by the Secretary,
12 for library membership in societies or associations which
13 issue publications to members only or at a price to mem-
14 bers lower than to subscribers who are not members.

15 SEC. 105. Appropriations available to the Depart-
16 ment of the Interior for salaries and expenses shall be
17 available for uniforms or allowances therefor, as author-
18 ized by law (~~5~~ U.S.C. 5901-5902 and D.C. Code 4-204).

19 SEC. 106. Annual appropriations made in this title
20 shall be available for obligation in connection with con-
21 tracts issued for services or rentals for periods not in ex-
22 cess of ~~12~~ months beginning at any time during the fiscal
23 year.

24 SEC. 107. No funds provided in this title may be ex-
25 pended by the Department of the Interior for the conduct

1 of offshore leasing and related activities placed under re-
2 striction in the President's moratorium statement of June
3 26, 1990, in the areas of northern, central, and southern
4 California; the North Atlantic; Washington and Oregon;
5 and the eastern Gulf of Mexico south of 26 degrees north
6 latitude and east of 86 degrees west longitude.

7 SEC. 108. No funds provided in this title may be ex-
8 pended by the Department of the Interior for the conduct
9 of offshore oil and natural gas preleasing, leasing, and re-
10 lated activities, on lands within the North Aleutian Basin
11 planning area.

12 SEC. 109. No funds provided in this title may be ex-
13 pended by the Department of the Interior to conduct off-
14 shore oil and natural gas preleasing, leasing and related
15 activities in the eastern Gulf of Mexico planning area for
16 any lands located outside Sale 181, as identified in the
17 final Outer Continental Shelf 5-Year Oil and Gas Leasing
18 Program, 1997-2002.

19 SEC. 110. No funds provided in this title may be ex-
20 pended by the Department of the Interior to conduct oil
21 and natural gas preleasing, leasing and related activities
22 in the Mid-Atlantic and South Atlantic planning areas.

23 SEC. 111. Advance payments made under this title
24 to Indian tribes, tribal organizations, and tribal consortia
25 pursuant to the Indian Self-Determination and Education

1 Assistance Act (25 U.S.C. 450 et seq.) or the Tribally
2 Controlled Schools Act of 1988 (25 U.S.C. 2501 et seq.)
3 may be invested by the Indian tribe, tribal organization,
4 or consortium before such funds are expended for the pur-
5 poses of the grant, compact, or annual funding agreement
6 so long as such funds are—

7 (1) invested by the Indian tribe, tribal organiza-
8 tion, or consortium only in obligations of the United
9 States, or in obligations or securities that are guar-
10 anteed or insured by the United States, or mutual
11 (or other) funds registered with the Securities and
12 Exchange Commission and which only invest in obli-
13 gations of the United States or securities that are
14 guaranteed or insured by the United States; or

15 (2) deposited only into accounts that are in-
16 sured by an agency or instrumentality of the United
17 States, or are fully collateralized to ensure protec-
18 tion of the funds, even in the event of a bank failure.

19 SEC. 112. Notwithstanding any other provisions of
20 law, the National Park Service shall not develop or imple-
21 ment a reduced entrance fee program to accommodate
22 non-local travel through a unit. The Secretary may provide
23 for and regulate local non-recreational passage through
24 units of the National Park System, allowing each unit to

1 develop guidelines and permits for such activity appro-
2 priate to that unit.

3 SEC. 113. Refunds or rebates received on an on-going
4 basis from a credit card services provider under the De-
5 partment of the Interior's charge card programs, hereafter
6 may be deposited to and retained without fiscal year limi-
7 tation in the Departmental Working Capital Fund estab-
8 lished under 43 U.S.C. 1467 and used to fund manage-
9 ment initiatives of general benefit to the Department of
10 the Interior's bureaus and offices as determined by the
11 Secretary or his designee.

12 SEC. 114. Appropriations made in this title under the
13 headings Bureau of Indian Affairs and Office of Special
14 Trustee for American Indians and any available unobli-
15 gated balances from prior appropriations Acts made under
16 the same headings, shall be available for expenditure or
17 transfer for Indian trust management activities pursuant
18 to the Trust Management Improvement Project High
19 Level Implementation Plan.

20 SEC. 115. Notwithstanding any provision of law,
21 hereafter the Secretary of the Interior is authorized to ne-
22 gotiate and enter into agreements and leases, without re-
23 gard to section 321 of chapter 314 of the Act of June
24 30, 1932 (40 U.S.C. 303b), with any person, firm, asso-
25 ciation, organization, corporation, or governmental entity

1 for all or part of the property within Fort Baker adminis-
2 tered by the Secretary as part of Golden Gate National
3 Recreation Area. The proceeds of the agreements or leases
4 shall be retained by the Secretary and such proceeds shall
5 be available, without future appropriation, for the preser-
6 vation, restoration, operation, maintenance and interpre-
7 tation and related expenses incurred with respect to Fort
8 Baker properties.

9 ~~SEC. 116.~~ A grazing permit or lease that expires (or
10 is transferred) during fiscal year 2001 may be renewed
11 under section 402 of the Federal Land Policy and Man-
12 agement Act of 1976, as amended (~~43 U.S.C. 1752~~) or
13 if applicable, sections 306 and 510 of the California
14 Desert Protection Act (~~16 U.S.C. 410aaa-50~~). The terms
15 and conditions contained in the expiring permit or lease
16 may at the discretion of the Secretary continue in effect
17 under the new permit or lease until such time as the Sec-
18 retary of the Interior completes processing of such permit
19 or lease in compliance with all applicable laws and regula-
20 tions, at which time such permit or lease may be canceled,
21 suspended or modified, in whole or in part, to meet the
22 requirements of such applicable laws and regulations.
23 Nothing in this section shall be deemed to alter the Sec-
24 retary's statutory authority.

1 SEC. 117. Notwithstanding any other provision of
2 law, for the purpose of reducing the backlog of Indian pro-
3 bate cases in the Department of the Interior, the hearing
4 requirements of chapter 10 of title 25, United States
5 Code, are deemed satisfied by a proceeding conducted by
6 an Indian probate judge, appointed by the Secretary with-
7 out regard to the provisions of title 5, United States Code,
8 governing the appointments in the competitive service, for
9 such period of time as the Secretary determines necessary:
10 *Provided*, That the basic pay of an Indian probate judge
11 so appointed may be fixed by the Secretary without regard
12 to the provisions of chapter 51, and subchapter III of
13 chapter 53 of title 5, United States Code, governing the
14 classification and pay of General Schedule employees, ex-
15 cept that no such Indian probate judge may be paid at
16 a level which exceeds the maximum rate payable for the
17 highest grade of the General Schedule, including locality
18 pay.

19 SEC. 118. Notwithstanding any other provision of
20 law, the Secretary of the Interior is authorized to redis-
21 tribute any Tribal Priority Allocation funds, including
22 tribal base funds, to alleviate tribal funding inequities by
23 transferring funds to address identified, unmet needs,
24 dual enrollment, overlapping service areas or inaccurate
25 distribution methodologies. No tribe shall receive a reduc-

1 tion in Tribal Priority Allocation funds of more than 10
2 percent in fiscal year 2001. Under circumstances of dual
3 enrollment, overlapping service areas or inaccurate dis-
4 tribution methodologies, the 10 percent limitation does not
5 apply.

6 SEC. 119. None of the funds in this Act may be used
7 to establish a new National Wildlife Refuge in the Kan-
8 kakee River basin that is inconsistent with the United
9 States Army Corps of Engineers' efforts to control flood-
10 ing and siltation in that area. Written certification of con-
11 sistency shall be submitted to the House and Senate Com-
12 mittees on Appropriations prior to refuge establishment.

13 SEC. 120. The Great Marsh Trail at the Mason Neck
14 National Wildlife Refuge in Virginia is hereby named for
15 Joseph V. Gartlan, Jr. and shall hereafter be referred to
16 in any law, document, or records of the United States as
17 the "Joseph V. Gartlan, Jr. Great Marsh Trail".

18 SEC. 121. Funds appropriated for the Bureau of In-
19 dian Affairs for postsecondary schools for fiscal year 2001
20 shall be allocated among the schools proportionate to the
21 unmet need of the schools as determined by the Postsec-
22 ondary Funding Formula adopted by the Office of Indian
23 Education Programs.

24 SEC. 122. The amounts otherwise provided by this
25 title are revised by reducing the amount made available

1 under the heading “NATIONAL PARK SERVICE—
 2 CONSTRUCTION” by \$9,000,000 and by increasing the
 3 amount made available under the heading “NATIONAL
 4 PARK SERVICE—LAND ACQUISITION AND STATE
 5 ASSISTANCE” for acquisition of lands or waters, or in-
 6 terests therein, by \$9,000,000.

7 SEC. 123. Any limitation imposed under this Act on
 8 funds made available by this Act related to planning and
 9 management of national monuments, or activities related
 10 to the Interior Columbia Basin Ecosystem Management
 11 Plan shall not apply to any activity which is otherwise au-
 12 thorized by law.

13 TITLE II—RELATED AGENCIES

14 DEPARTMENT OF AGRICULTURE

15 FOREST SERVICE

16 FOREST AND RANGELAND RESEARCH

17 For necessary expenses of forest and rangeland re-
 18 search as authorized by law, \$224,966,000, to remain
 19 available until expended.

20 STATE AND PRIVATE FORESTRY

21 For necessary expenses of cooperating with and pro-
 22 viding technical and financial assistance to States, terri-
 23 tories, possessions, and others, and for forest health man-
 24 agement, cooperative forestry, and education and land
 25 conservation activities and conducting an international

1 program as authorized, \$197,337,000 (reduced by
2 \$500,000) (increased by \$500,000), to remain available
3 until expended, as authorized by law: *Provided*, That none
4 of the funds appropriated or otherwise made available by
5 this Act or otherwise available to the Secretary shall be
6 used to carry out any activity related to the urban re-
7 sources partnership or similar or successor programs.

8 NATIONAL FOREST SYSTEM

9 For necessary expenses of the Forest Service, not
10 otherwise provided for, for management, protection, im-
11 provement, and utilization of the National Forest System,
12 \$1,207,545,000, to remain available until expended, which
13 shall include 50 percent of all moneys received during
14 prior fiscal years as fees collected under the Land and
15 Water Conservation Fund Act of 1965, as amended, in
16 accordance with section 4 of the Act (16 U.S.C. 4601-
17 6a(i)): *Provided*, That unobligated balances available at
18 the start of fiscal year 2001 shall be displayed by extended
19 budget line item in the fiscal year 2002 budget justifica-
20 tion.

21 WILDLAND FIRE MANAGEMENT

22 For necessary expenses for forest fire presuppression
23 activities on National Forest System lands, for emergency
24 fire suppression on or adjacent to such lands or other
25 lands under fire protection agreement, and for emergency

1 rehabilitation of burned-over National Forest System
2 lands and water, \$614,343,000 (increased by \$4,000,000),
3 to remain available until expended: *Provided*, That such
4 funds are available for repayment of advances from other
5 appropriations accounts previously transferred for such
6 purposes: *Provided further*, That not less than 50 percent
7 of any unobligated balances remaining (exclusive of
8 amounts for hazardous fuels reduction) at the end of fiscal
9 year 2000 shall be transferred, as repayment for post ad-
10 vances that have not been repaid, to the fund established
11 pursuant to section 3 of Public Law 71-319 (16 U.S.C.
12 576 et seq.): *Provided further*, That notwithstanding any
13 other provision of law, up to \$4,000,000 of funds appro-
14 priated under this appropriation may be used for Fire
15 Science Research in support of the Joint Fire Science Pro-
16 gram: *Provided further*, That all authorities for the use
17 of funds, including the use of contracts, grants, and coop-
18 erative agreements, available to execute the Forest Service
19 and Rangeland Research appropriation, are also available
20 in the utilization of these funds for Fire Science Research.

21 CAPITAL IMPROVEMENT AND MAINTENANCE

22 For necessary expenses of the Forest Service, not
23 otherwise provided for, \$424,466,000 (increased by
24 \$10,000,000), to remain available until expended for con-
25 struction, reconstruction, maintenance and acquisition of

1 buildings and other facilities, and for construction, recon-
2 struction, repair and maintenance of forest roads and
3 trails by the Forest Service as authorized by 16 U.S.C.
4 532-538 and 23 U.S.C. 101 and 205: *Provided*, That up
5 to \$15,000,000 of the funds provided herein for road
6 maintenance shall be available for the decommissioning of
7 roads, including unauthorized roads not part of the trans-
8 portation system, which are no longer needed: *Provided*
9 *further*, That no funds shall be expended to decommission
10 any system road until notice and an opportunity for public
11 comment has been provided on each decommissioning
12 project: *Provided further*, That any unobligated balances
13 of amounts previously appropriated to the Forest Service
14 "Construction", "Reconstruction and Construction", or
15 "Reconstruction and Maintenance" accounts as well as
16 any unobligated balances remaining in the "National For-
17 est System" account for the facility maintenance and trail
18 maintenance extended budget line items may be trans-
19 ferred to and merged with the "Capital Improvement and
20 Maintenance" account.

21 LAND ACQUISITION

22 For expenses necessary to carry out the provisions
23 of the Land and Water Conservation Fund Act of 1965,
24 as amended (16 U.S.C. 4601-4 through 11), including ad-
25 ministrative expenses, and for acquisition of land or wa-

1 ters, or interest therein, in accordance with statutory au-
 2 thority applicable to the Forest Service, \$50,000,000 (and
 3 in addition \$2,000,000, to be available to the Department
 4 of the Interior for the acquisition of Cat Island, Mis-
 5 sissippi); to be derived from the Land and Water Con-
 6 servation Fund, to remain available until expended.

7 ACQUISITION OF LANDS FOR NATIONAL FORESTS SPECIAL
 8 ACTS

9 For acquisition of lands within the exterior bound-
 10 aries of the Cache, Uinta, and Wasatch National Forests,
 11 Utah; the Toiyabe National Forest, Nevada; and the An-
 12 geles, San Bernardino, Sequoia, and Cleveland National
 13 Forests, California, as authorized by law, \$1,068,000, to
 14 be derived from forest receipts.

15 ACQUISITION OF LANDS TO COMPLETE LAND EXCHANGES

16 For acquisition of lands, such sums, to be derived
 17 from funds deposited by State, county, or municipal gov-
 18 ernments, public school districts, or other public school au-
 19 thorities pursuant to the Act of December 4, 1967, as
 20 amended (16 U.S.C. 484a), to remain available until ex-
 21 pended.

22 RANGE BETTERMENT FUND

23 For necessary expenses of range rehabilitation, pro-
 24 tection, and improvement, 50 percent of all moneys re-
 25 ceived during the prior fiscal year, as fees for grazing do-

1 mestic livestock on lands in National Forests in the 16
2 Western States, pursuant to section 401(b)(1) of Public
3 Law 94-579, as amended, to remain available until ex-
4 pended, of which not to exceed 6 percent shall be available
5 for administrative expenses associated with on-the-ground
6 range rehabilitation, protection, and improvements.

7 GIFTS, DONATIONS AND BEQUESTS FOR FOREST AND
8 RANGELAND RESEARCH

9 For expenses authorized by 16 U.S.C. 1643(b),
10 \$92,000, to remain available until expended, to be derived
11 from the fund established pursuant to the above Act.

12 ADMINISTRATIVE PROVISIONS, FOREST SERVICE

13 Appropriations to the Forest Service for the current
14 fiscal year shall be available for: (1) purchase of not to
15 exceed 132 passenger motor vehicles of which 13 will be
16 used primarily for law enforcement purposes and of which
17 129 shall be for replacement; acquisition of 25 passenger
18 motor vehicles from excess sources; and hire of such vehi-
19 cles; operation and maintenance of aircraft, the purchase
20 of not to exceed six for replacement only, and acquisition
21 of sufficient aircraft from excess sources to maintain the
22 operable fleet at 192 aircraft for use in Forest Service
23 wildland fire programs and other Forest Service programs;
24 notwithstanding other provisions of law, existing aircraft
25 being replaced may be sold, with proceeds derived or

1 trade-in value used to offset the purchase price for the
2 replacement aircraft; (2) services pursuant to 7 U.S.C.
3 2225, and not to exceed \$100,000 for employment under
4 5 U.S.C. 3109; (3) purchase, erection, and alteration of
5 buildings and other public improvements (7 U.S.C. 2250);
6 (4) acquisition of land, waters, and interests therein, pur-
7 suant to 7 U.S.C. 428a; (5) for expenses pursuant to the
8 Volunteers in the National Forest Act of 1972 (16 U.S.C.
9 558a, 558d, and 558a note); (6) the cost of uniforms as
10 authorized by 5 U.S.C. 5901–5902; and (7) for debt col-
11 lection contracts in accordance with 31 U.S.C. 3718(e).

12 None of the funds made available under this Act shall
13 be obligated or expended to abolish any region, to move
14 or close any regional office for National Forest System
15 administration of the Forest Service, Department of Agri-
16 culture without the consent of the House and Senate Com-
17 mittees on Appropriations.

18 Any appropriations or funds available to the Forest
19 Service may be transferred to the Wildland Fire Manage-
20 ment appropriation for forest firefighting, emergency re-
21 habilitation of burned-over or damaged lands or waters
22 under its jurisdiction, and fire preparedness due to severe
23 burning conditions if and only if all previously appro-
24 priated emergency contingent funds under the heading

1 “Wildland Fire Management” have been released by the
2 President and apportioned.

3 Funds appropriated to the Forest Service shall be
4 available for assistance to or through the Agency for Inter-
5 national Development and the Foreign Agricultural Serv-
6 ice in connection with forest and rangeland research, tech-
7 nical information, and assistance in foreign countries, and
8 shall be available to support forestry and related natural
9 resource activities outside the United States and its terri-
10 tories and possessions, including technical assistance, edu-
11 cation and training, and cooperation with United States
12 and international organizations.

13 None of the funds made available to the Forest Serv-
14 ice under this Act shall be subject to transfer under the
15 provisions of section 702(b) of the Department of Agri-
16 culture Organic Act of 1944 (7 U.S.C. 2257) or 7 U.S.C.
17 147b unless the proposed transfer is approved in advance
18 by the House and Senate Committees on Appropriations
19 in compliance with the reprogramming procedures con-
20 tained in House Report No. 105–163.

21 None of the funds available to the Forest Service may
22 be reprogrammed without the advance approval of the
23 House and Senate Committees on Appropriations in ac-
24 cordance with the procedures contained in House Report
25 No. 105–163.

1 No funds appropriated to the Forest Service shall be
2 transferred to the Working Capital Fund of the Depart-
3 ment of Agriculture without the approval of the Chief of
4 the Forest Service.

5 Funds available to the Forest Service shall be avail-
6 able to conduct a program of not less than \$2,000,000
7 for high priority projects within the scope of the approved
8 budget which shall be carried out by the Youth Conserva-
9 tion Corps as authorized by the Act of August 13, 1970,
10 as amended by Public Law 93-408.

11 Of the funds available to the Forest Service, \$1,500
12 is available to the Chief of the Forest Service for official
13 reception and representation expenses.

14 Pursuant to sections 405(b) and 410(b) of Public
15 Law 101-593, of the funds available to the Forest Service,
16 up to \$1,250,000 may be advanced in a lump sum as Fed-
17 eral financial assistance to the National Forest Founda-
18 tion, without regard to when the Foundation incurs ex-
19 penses, for administrative expenses or projects on or bene-
20 fitting National Forest System lands or related to Forest
21 Service programs: *Provided*, That of the Federal funds
22 made available to the Foundation, no more than \$200,000
23 shall be available for administrative expenses: *Provided*
24 *further*, That the Foundation shall obtain, by the end of
25 the period of Federal financial assistance, private con-

1 tributions to match on at least one-for-one basis funds
2 made available by the Forest Service: *Provided further,*
3 That the Foundation may transfer Federal funds to a
4 non-Federal recipient for a project at the same rate that
5 the recipient has obtained the non-Federal matching
6 funds: *Provided further,* That hereafter, the National For-
7 est Foundation may hold Federal funds made available
8 but not immediately disbursed and may use any interest
9 or other investment income earned (before, on, or after
10 the date of the enactment of this Act) on Federal funds
11 to carry out the purposes of Public Law 101-593: *Pro-*
12 *vided further,* That such investments may be made only
13 in interest-bearing obligations of the United States or in
14 obligations guaranteed as to both principal and interest
15 by the United States.

16 Pursuant to section 2(b)(2) of Public Law 98-244,
17 \$2,650,000 of the funds available to the Forest Service
18 shall be available for matching funds to the National Fish
19 and Wildlife Foundation, as authorized by 16 U.S.C.
20 6201-3709, and shall be advanced in a lump sum as Fed-
21 eral financial assistance within 60 days of the enactment
22 of this Act, without regard to when expenses are incurred,
23 for projects on or benefitting National Forest System
24 lands or related to Forest Service programs: *Provided,*
25 That the Foundation shall obtain, by the end of the period

1 of Federal financial assistance, private contributions to
2 match on at least one-for-one basis funds advanced by the
3 Forest Service: *Provided further*, That the Foundation
4 may transfer Federal funds to a non-Federal recipient for
5 a project at the same rate that the recipient has obtained
6 the non-Federal matching funds.

7 Funds appropriated to the Forest Service shall be
8 available for interactions with and providing technical as-
9 sistance to rural communities for sustainable rural devel-
10 opment purposes.

11 Notwithstanding any other provision of law, 80 per-
12 cent of the funds appropriated to the Forest Service in
13 the “National Forest System” and “Reconstruction and
14 Construction” accounts and planned to be allocated to ac-
15 tivities under the “Jobs in the Woods” program for
16 projects on National Forest land in the State of Wash-
17 ington may be granted directly to the Washington State
18 Department of Fish and Wildlife for accomplishment of
19 planned projects. 20 percent of said funds shall be re-
20 tained by the Forest Service for planning and admin-
21 istering projects. Project selection and prioritization shall
22 be accomplished by the Forest Service with such consulta-
23 tion with the State of Washington as the Forest Service
24 deems appropriate.

1 Funds appropriated to the Forest Service shall be
2 available for payments to counties within the Columbia
3 River Gorge National Scenic Area, pursuant to sections
4 14(c)(1) and (2), and section 16(a)(2) of Public Law 99-
5 663.

6 The Secretary of Agriculture is authorized to enter
7 into grants, contracts, and cooperative agreements as ap-
8 propriate with the Pinchot Institute for Conservation, as
9 well as with public and other private agencies, organiza-
10 tions, institutions, and individuals, to provide for the de-
11 velopment, administration, maintenance, or restoration of
12 land, facilities, or Forest Service programs, at the Grey
13 Towers National Historic Landmark: *Provided*, That, sub-
14 ject to such terms and conditions as the Secretary of Agri-
15 culture may prescribe, any such public or private agency,
16 organization, institution, or individual may solicit, accept,
17 and administer private gifts of money and real or personal
18 property for the benefit of, or in connection with, the ac-
19 tivities and services at the Grey Towers National Historic
20 Landmark: *Provided further*, That such gifts may be ac-
21 cepted notwithstanding the fact that a donor conducts
22 business with the Department of Agriculture in any capac-
23 ity.

24 Funds appropriated to the Forest Service shall be
25 available, as determined by the Secretary, for payments

1 to Del Norte County, California, pursuant to sections
2 13(e) and 14 of the Smith River National Recreation Area
3 Act (Public Law 101-612).

4 Notwithstanding any other provision of law, any ap-
5 propriations or funds available to the Forest Service not
6 to exceed \$500,000 may be used to reimburse the Office
7 of the General Counsel (OGC), Department of Agri-
8 culture, for travel and related expenses incurred as a re-
9 sult of OGC assistance or participation requested by the
10 Forest Service at meetings, training sessions, management
11 reviews, land purchase negotiations and similar non-litiga-
12 tion related matters. Future budget justifications for both
13 the Forest Service and the Department of Agriculture
14 should clearly display the sums previously transferred and
15 the requested funding transfers.

16 No employee of the Department of Agriculture may
17 be detailed or assigned from an agency or office funded
18 by this Act to any other agency or office of the Depart-
19 ment for more than 30 days unless the individual's em-
20 ploying agency or office is fully reimbursed by the receiv-
21 ing agency or office for the salary and expenses of the
22 employee for the period of assignment.

23 The Forest Service shall fund overhead, national
24 commitments, indirect expenses, and any other category
25 for use of funds which are expended at any units, that

1 are not directly related to the accomplishment of specific
2 work on-the-ground (referred to as “indirect expendi-
3 tures”), from funds available to the Forest Service, unless
4 otherwise prohibited by law. *Provided*, That the Forest
5 Service shall implement and adhere to the definitions of
6 indirect expenditures established pursuant to Public Law
7 105-277 on a nationwide basis without flexibility for
8 modification by any organizational level except the Wash-
9 ington Office, and when changed by the Washington Of-
10 fice, such changes in definition shall be reported in budget
11 requests submitted by the Forest Service. *Provided fur-*
12 *ther*, That the Forest Service shall provide in all future
13 budget justifications, planned indirect expenditures in ac-
14 cordance with the definitions, summarized and displayed
15 to the Regional, Station, Area, and detached unit office
16 level. The justification shall display the estimated source
17 and amount of indirect expenditures, by expanded budget
18 line item, of funds in the agency’s annual budget justifica-
19 tion. The display shall include appropriated funds and the
20 Knutson-Vandenberg, Brush Disposal, Cooperative Work-
21 Other, and Salvage Sale funds. Changes between esti-
22 mated and actual indirect expenditures shall be reported
23 in subsequent budget justifications. *Provided further*, That
24 during fiscal year 2001 the Secretary shall limit total an-
25 nual indirect obligations from the Brush Disposal, Cooper-

1 ative Work-Other, Knutson-Vandenberg, Reforestation,
 2 Salvage Sale, and Roads and Trails funds to 20 percent
 3 of the total obligations from each fund.

4 Any appropriations or funds available to the Forest
 5 Service may be used for necessary expenses in the event
 6 of law enforcement emergencies as necessary to protect
 7 natural resources and public or employee safety: *Provided*,
 8 That such amounts shall not exceed \$500,000.

9 Section 551 of the Land Between the Lakes Protec-
 10 tion Act of 1998 (16 U.S.C. 460ll-61) is amended by add-
 11 ing at the end the following new subsection:

12 “(e) TRANSITION.—Until September 30, 2002, the
 13 Secretary of Agriculture may expend amounts appro-
 14 priated or otherwise made available to carry out this title
 15 in a manner consistent with the authorities exercised by
 16 the Tennessee Valley Authority, before the transfer of the
 17 Recreation Area to the administrative jurisdiction of the
 18 Secretary, regarding procurement of property, services,
 19 supplies, and equipment.”.

20 DEPARTMENT OF ENERGY

21 CLEAN COAL TECHNOLOGY

22 (DEFERRAL)

23 Of the funds made available under this heading for
 24 obligation in prior years, \$67,000,000 (increased by
 25 \$22,000,000) shall not be available until October 1, 2001:

1 ~~Provided~~, That funds made available in previous appro-
2 priations Acts shall be available for any ongoing project
3 regardless of the separate request for proposal under
4 which the project was selected.

5 ENERGY RESOURCE, SUPPLY AND EFFICIENCY

6 (INCLUDING TRANSFER OF FUNDS)

7 For necessary expenses in carrying out energy con-
8 servation activities and for fossil energy research and de-
9 velopment activities, under the authority of the Depart-
10 ment of Energy Organization Act (Public Law 95-91), in-
11 cluding the acquisition of interest, including defeasible and
12 equitable interests in any real property or any facility or
13 for plant or facility acquisition or expansion, and for con-
14 ducting inquiries, technological investigations and re-
15 search concerning the extraction, processing, use, and dis-
16 posal of mineral substances without objectionable social
17 and environmental costs (30 U.S.C. 3, 1602, and 1603),
18 performed under the minerals and materials science pro-
19 grams at the Albany Research Center in Oregon,
20 \$1,139,611,000 (reduced by \$126,500,000) (reduced by
21 \$45,000,000) (increased by \$20,000,000) (increased by
22 \$3,500,000) (increased by \$9,500,000) (increased by
23 \$5,000,000) (increased by \$7,000,000), to remain avail-
24 able until expended, of which \$2,000,000 shall be derived
25 by transfer from unobligated balances in the Biomass En-

1 ergy Development account: *Provided*, That \$153,500,000
2 (increased by \$23,500,000) shall be for use in energy con-
3 servation programs as defined in section 3008(3) of Public
4 Law 99-509 (15 U.S.C. 4507): *Provided further*, That
5 notwithstanding section 3003(d)(2) of Public Law 99-
6 509, such sums shall be allocated to the eligible programs
7 as follows: \$120,000,000 (increased by \$20,000,000) for
8 weatherization assistance grants and \$33,500,000 (in-
9 creased by \$3,500,000) for State energy conservation
10 grants: *Provided further*, That no part of the sum herein
11 made available shall be used for the field testing of nuclear
12 explosives in the recovery of oil and gas.

14 (RESCISSION)

15 Of the unobligated balances under this heading,
16 \$1,000,000 are rescinded.

17 NAVAL PETROLEUM AND OIL SHALE RESERVES

18 The requirements of 10 U.S.C. 7430(b)(2)(B) shall
19 not apply to fiscal year 2001 and any fiscal year there-
20 after: *Provided*, That, notwithstanding any other provision
21 of law, unobligated funds remaining from prior years shall
22 be available for all naval petroleum and oil shale reserve
23 activities.

1 ELK HILLS SCHOOL LANDS FUND

2 For necessary expenses in fulfilling the third install-
3 ment payment under the Settlement Agreement entered
4 into by the United States and the State of California on
5 October 11, 1996, as authorized by section 3415 of Public
6 Law 104-106, \$36,000,000, to become available on Octo-
7 ber 1, 2001 for payment to the State of California for
8 the State Teachers' Retirement Fund from the Elk Hills
9 School Lands Fund.

10 ECONOMIC REGULATION

11 For necessary expenses in carrying out the activities
12 of the Office of Hearings and Appeals, \$1,992,000, to re-
13 main available until expended.

14 STRATEGIC PETROLEUM RESERVE

15 For necessary expenses for Strategic Petroleum Re-
16 serve facility development and operations and program
17 management activities pursuant to the Energy Policy and
18 Conservation Act of 1975, as amended (42 U.S.C. 6201
19 et seq.), \$157,000,000, to remain available until expended.

20 ENERGY INFORMATION ADMINISTRATION

21 For necessary expenses in carrying out the activities
22 of the Energy Information Administration, \$72,368,000
23 (reduced by \$2,000,000), to remain available until ex-
24 pended.

1 ADMINISTRATIVE PROVISIONS, DEPARTMENT OF ENERGY

2 Appropriations under this Act for the current fiscal
3 year shall be available for hire of passenger motor vehicles;
4 hire, maintenance, and operation of aircraft; purchase, re-
5 pair, and cleaning of uniforms; and reimbursement to the
6 General Services Administration for security guard serv-
7 ices.

8 From appropriations under this Act, transfers of
9 sums may be made to other agencies of the Government
10 for the performance of work for which the appropriation
11 is made.

12 None of the funds made available to the Department
13 of Energy under this Act shall be used to implement or
14 finance authorized price support or loan guarantee pro-
15 grams unless specific provision is made for such programs
16 in an appropriations Act.

17 The Secretary is authorized to accept lands, build-
18 ings, equipment, and other contributions from public and
19 private sources and to prosecute projects in cooperation
20 with other agencies, Federal, State, private or foreign:
21 *Provided,* That revenues and other moneys received by or
22 for the account of the Department of Energy or otherwise
23 generated by sale of products in connection with projects
24 of the Department appropriated under this Act may be
25 retained by the Secretary of Energy, to be available until

1 expended, and used only for plant construction, operation,
2 costs, and payments to cost-sharing entities as provided
3 in appropriate cost-sharing contracts or agreements: *Pro-*
4 *vided further,* That the remainder of revenues after the
5 making of such payments shall be covered into the Treas-
6 ury as miscellaneous receipts: *Provided further,* That any
7 contract, agreement, or provision thereof entered into by
8 the Secretary pursuant to this authority shall not be exe-

23 lic and private sources, to be deposited in a contributed
24 funds account, and prosecute projects using such fees and

6 INDIAN HEALTH SERVICES

7 For expenses necessary to carry out the Act of Au-
8 gust 5, 1954 (68 Stat. 674), the Indian Self-Determina-
9 tion Act, the Indian Health Care Improvement Act, and
10 titles II and III of the Public Health Service Act with re-
11 spect to the Indian Health Service, \$2,084,178,000, (in-
12 creased by \$22,000,000) together with payments received
13 during the fiscal year pursuant to 42 U.S.C. 238(b) for
14 services furnished by the Indian Health Service: *Provided,*
15 That funds made available to tribes and tribal organiza-
16 tions through contracts, grant agreements, or any other
17 agreements or compacts authorized by the Indian Self-De-
18 termination and Education Assistance Act of 1975 (25
19 U.S.C. 450), shall be deemed to be obligated at the time
20 of the grant or contract award and thereafter shall remain
21 available to the tribe or tribal organization without fiscal
22 year limitation: *Provided further,* That \$12,000,000 shall
23 remain available until expended, for the Indian Cata-
24 strophic Health Emergency Fund: *Provided further,* That
25 \$394,756,000 for contract medical care shall remain avail-

1 able for obligation until September 30, 2002: *Provided fur-*
2 *ther*, That of the funds provided, up to \$17,000,000 shall
3 be used to carry out the loan repayment program under
4 section 108 of the Indian Health Care Improvement Act:
5 *Provided further*, That funds provided in this Act may be
6 used for 1-year contracts and grants which are to be per-
7 formed in 2 fiscal years, so long as the total obligation
8 is recorded in the year for which the funds are appro-
9 priated: *Provided further*, That the amounts collected by
10 the Secretary of Health and Human Services under the
11 authority of title IV of the Indian Health Care Improve-

19 tion facilities for Indians, as authorized by section 7 of

1 ~~\$336,423,000~~, to remain available until expended: *Pro-*
2 *vided*, That notwithstanding any other provision of law,
3 funds appropriated for the planning, design, construction
4 or renovation of health facilities for the benefit of an In-
5 dian tribe or tribes may be used to purchase land for sites
6 to construct, improve, or enlarge health or related facili-
7 ties: *Provided further*, That notwithstanding any provision
8 of law governing Federal construction, \$240,000 of the
9 funds provided herein shall be provided to the Hopi Tribe
10 to reduce the debt incurred by the Tribe in providing staff
11 quarters to meet the housing needs associated with the
12 new Hopi Health Center: *Provided further*, That not to
13 exceed \$500,000 shall be used by the Indian Health Serv-
14 ice to purchase TRANSAM equipment from the Depart-

5 lent to the maximum rate payable for senior-level positions
6 under 5 U.S.C. 5376; hire of passenger motor vehicles and
7 aircraft; purchase of medical equipment; purchase of re-
8 prints; purchase, renovation and erection of modular
9 buildings and renovation of existing facilities; payments
10 for telephone service in private residences in the field;
11 when authorized under regulations approved by the Sec-
12 retary; and for uniforms or allowances therefore as au-

22 proceeds along with funds recovered under the Federal

24 be credited to the account of the facility providing the
25 service and shall be available without fiscal year limitation:

1 *Provided further*, That notwithstanding any other law or
2 regulation, funds transferred from the Department of
3 Housing and Urban Development to the Indian Health
4 Service shall be administered under Public Law 86-121
5 (the Indian Sanitation Facilities Act) and Public Law 93-
6 638, as amended: *Provided further*, That funds appro-
7 priated to the Indian Health Service in this Act, except
8 those used for administrative and program direction pur-
9 poses, shall not be subject to limitations directed at cur-
10 tailing Federal travel and transportation: *Provided further*,
11 That notwithstanding any other provision of law, funds
12 previously or herein made available to a tribe or tribal or-
13 ganization through a contract, grant, or agreement au-
14 thorized by title I or III of the Indian Self-Determination
15 and Education Assistance Act of 1975 (25 U.S.C. 450),
16 may be deobligated and reobligated to a self-determination
17 contract under title I, or a self-governance agreement
18 under title III of such Act and thereafter shall remain
19 available to the tribe or tribal organization without fiscal
20 year limitation: *Provided further*, That none of the funds
21 made available to the Indian Health Service in this Act
22 shall be used to implement the final rule published in the
23 Federal Register on September 16, 1987, by the Depart-
24 ment of Health and Human Services, relating to the eligi-
25 bility for the health care services of the Indian Health

1 Service until the Indian Health Service has submitted a
2 budget request reflecting the increased costs associated
3 with the proposed final rule, and such request has been
4 included in an appropriations Act and enacted into law:
5 *Provided further*, That funds made available in this Act
6 are to be apportioned to the Indian Health Service as ap-
7 propriated in this Act, and accounted for in the appropria-
8 tion structure set forth in this Act: *Provided further*, That
9 with respect to functions transferred by the Indian Health
10 Service to tribes or tribal organizations, the Indian Health
11 Service is authorized to provide goods and services to
12 those entities, on a reimbursable basis, including payment
13 in advance with subsequent adjustment, and the reim-
14 bursements received therefrom, along with the funds re-

6 For necessary expenses of the Office of Navajo and
7 Hopi Indian Relocation as authorized by Public Law 93-
8 531, \$8,000,000, to remain available until expended: *Pro-*
9 *vided*, That funds provided in this or any other appropria-
10 tions Act are to be used to relocate eligible individuals and
11 groups including evictees from District 6, Hopi-partitioned
12 lands residents, those in significantly substandard hous-
13 ing, and all others certified as eligible and not included
14 in the preceding categories: *Provided further*, That none
15 of the funds contained in this or any other Act may be
16 used by the Office of Navajo and Hopi Indian Relocation
17 to evict any single Navajo or Navajo family who, as of
18 November 30, 1985, was physically domiciled on the lands
19 partitioned to the Hopi Tribe unless a new or replacement
20 home is provided for such household: *Provided further*,
21 That no relocatee will be provided with more than one new
22 or replacement home: *Provided further*, That the Office
23 shall relocate any certified eligible relocatees who have se-
24 lected and received an approved homesite on the Navajo
25 reservation or selected a replacement residence off the

1 Navajo reservation or on the land acquired pursuant to
2 25 U.S.C. 640d-10.

4 SALARIES AND EXPENSES

5 For necessary expenses of the Smithsonian Institu-
6 tion, as authorized by law, including research in the fields

11 tions; conduct of education, training, and museum assist-
12 ance programs; maintenance, alteration, operation, lease
13 (for terms not to exceed 30 years), and protection of build-
14 ings, facilities, and approaches; not to exceed \$100,000
15 for services as authorized by 5 U.S.C. 3109; up to five
16 replacement passenger vehicles; purchase, rental, repair,
17 and cleaning of uniforms for employees, \$375,230,000, of
18 which not to exceed \$47,126,000 for the instrumentation
19 program, collections acquisition, Museum Support Center
20 equipment and move, exhibition reinstallation, the Na-
21 tional Museum of the American Indian, the repatriation
22 of skeletal remains program, research equipment, informa-
23 tion management, and Latino programming shall remain
24 available until expended, including such funds as may be
25 necessary to support American overseas research centers

1 and of which \$125,000 is for the Council of American
2 Overseas Research Centers: *Provided*, That funds appro-
3 priated herein are available for advance payments to inde-
4 pendent contractors performing research services or par-
5 ticipating in official Smithsonian presentations: *Provided*
6 *further*, That the Smithsonian Institution may expend
7 Federal appropriations designated in this Act for lease or
8 rent payments for long term and swing space, as rent pay-
9 able to the Smithsonian Institution, and such rent pay-
10 ments may be deposited into the general trust funds of
11 the Institution to the extent that federally supported ac-
12 tivities are housed in the 900 H Street, N.W. building in
13 the District of Columbia: *Provided further*, That this use
14 of Federal appropriations shall not be construed as debt
15 service, a Federal guarantee of, a transfer of risk to, or
16 an obligation of, the Federal Government: *Provided fur-*
17 *ther*, That no appropriated funds may be used to service
18 debt which is incurred to finance the costs of acquiring
19 the 900 H Street building or of planning, designing, and
20 constructing improvements to such building.

5 SALARIES AND EXPENSES

6 For the upkeep and operations of the National Gal-
7 lery of Art, the protection and care of the works of art
8 therein, and administrative expenses incident thereto, as
9 authorized by the Act of March 24, 1937 (50 Stat. 51),
10 as amended by the public resolution of April 13, 1939
11 (Public Resolution 9, Seventy-sixth Congress), including
12 services as authorized by 5 U.S.C. 3109; payment in ad-
13 vance when authorized by the treasurer of the Gallery for
14 membership in library, museum, and art associations or
15 societies whose publications or services are available to
16 members only, or to members at a price lower than to the
17 general public; purchase, repair, and cleaning of uniforms
18 for guards, and uniforms, or allowances therefor, for other
19 employees as authorized by law (5 U.S.C. 5901–5902);
20 purchase or rental of devices and services for protecting
21 buildings and contents thereof, and maintenance, alter-
22 ation, improvement, and repair of buildings, approaches,
23 and grounds; and purchase of services for restoration and
24 repair of works of art for the National Gallery of Art by
25 contracts made, without advertising, with individuals,

1 firms, or organizations at such rates or prices and under
2 such terms and conditions as the Gallery may deem prop-
3 er, \$61,279,000, of which not to exceed \$3,026,000 for
4 the special exhibition program shall remain available until
5 expended.

6 REPAIR, RESTORATION AND RENOVATION OF BUILDINGS

7 For necessary expenses of repair, restoration and
8 renovation of buildings, grounds and facilities owned or
9 occupied by the National Gallery of Art, by contract or
10 otherwise, as authorized, \$8,903,000, to remain available
11 until expended: *Provided*, That contracts awarded for envi-
12 ronmental systems, protection systems, and exterior repair
13 or renovation of buildings of the National Gallery of Art
14 may be negotiated with selected contractors and awarded
15 on the basis of contractor qualifications as well as price.

18 OPERATIONS AND MAINTENANCE

19 For necessary expenses for the operation, mainte-
20 nance and security of the John F. Kennedy Center for
21 the Performing Arts, \$13,947,000.

22 CONSTRUCTION

23 For necessary expenses for capital repair and restora-
24 tion of the existing features of the building and site of

1 NATIONAL ENDOWMENT FOR THE HUMANITIES

2 GRANTS AND ADMINISTRATION

3 For necessary expenses to carry out the National
4 Foundation on the Arts and the Humanities Act of 1965,
5 as amended, \$100,604,000, shall be available to the Na-
6 tional Endowment for the Humanities for support of ae-
7 tivities in the humanities, pursuant to section 7(e) of the
8 Act, and for administering the functions of the Act, to
9 remain available until expended.

10 MATCHING GRANTS

7 ADMINISTRATIVE PROVISIONS

8 None of the funds appropriated to the National
9 Foundation on the Arts and the Humanities may be used
10 to process any grant or contract documents which do not
11 include the text of 18 U.S.C. 1913: *Provided*, That none
12 of the funds appropriated to the National Foundation on
13 the Arts and the Humanities may be used for official re-
14 ception and representation expenses: *Provided further*,
15 That funds from nonappropriated sources may be used as
16 necessary for official reception and representation ex-
17 penses.

18 COMMISSION OF FINE ARTS

19 SALARIES AND EXPENSES

20 For expenses made necessary by the Act establishing

8 For necessary expenses of the Advisory Council on

10 \$2,989,000: *Provided*, That none of these funds shall be
11 available for compensation of level V of the Executive
12 Schedule or higher positions.

13 NATIONAL CAPITAL PLANNING COMMISSION

14 SALARIES AND EXPENSES

15 For necessary expenses, as authorized by the Na-
16 tional Capital Planning Act of 1952 (40 U.S.C. 71-71i),
17 including services as authorized by 5 U.S.C. 3109,
18 \$6,288,000: *Provided*, That all appointed members of the
19 Commission will be compensated at a rate not to exceed
20 the daily equivalent of the annual rate for positions at level

9 PRESIDIO TRUST

10 PRESIDIO TRUST FUND

11 For necessary expenses to carry out title I of the Om-
12 nibus Parks and Public Lands Management Act of 1996,
13 \$23,400,000 shall be available to the Presidio Trust, to
14 remain available until expended, of which up to
15 \$1,040,000 may be for the cost of guaranteed loans, as
16 authorized by section 104(d) of the Act: *Provided*, That

12 ural gas by noncompetitive bidding on publicly owned
13 lands within the boundaries of the Shawnee National For-
14 est, Illinois: *Provided*, That nothing herein is intended to
15 inhibit or otherwise affect the sale, lease, or right to access
16 to minerals owned by private individuals.

17 SEC. 303. No part of any appropriation contained in
18 this Act shall be available for any activity or the publica-
19 tion or distribution of literature that in any way tends to
20 promote public support or opposition to any legislative
21 proposal on which congressional action is not complete.

22 SEC. 304. No part of any appropriation contained in
23 this Act shall remain available for obligation beyond the
24 current fiscal year unless expressly so provided herein.

1 SEC. 305. None of the funds provided in this Act to
2 any department or agency shall be obligated or expended
3 to provide a personal cook, chauffeur, or other personal
4 servants to any officer or employee of such department
5 or agency except as otherwise provided by law.

6 SEC. 306. No assessments may be levied against any
7 program, budget activity, subactivity, or project funded by
8 this Act unless advance notice of such assessments and
9 the basis therefor are presented to the Committees on Ap-
10 propriations and are approved by such committees.

11 SEC. 307. (a) COMPLIANCE WITH BUY AMERICAN
12 ACT.—None of the funds made available in this Act may
13 be expended by an entity unless the entity agrees that in
14 expending the funds the entity will comply with sections
15 2 through 4 of the Act of March 3, 1933 (41 U.S.C. 10a–
16 10c; popularly known as the “Buy American Act”).

17 (b) SENSE OF THE CONGRESS; REQUIREMENT RE-
18 GARDING NOTICE.—

19 (1) PURCHASE OF AMERICAN-MADE EQUIPMENT
20 AND PRODUCTS.—In the case of any equipment or
21 product that may be authorized to be purchased
22 with financial assistance provided using funds made
23 available in this Act, it is the sense of the Congress
24 that entities receiving the assistance should, in ex-

1 pending the assistance, purchase only American-
2 made equipment and products.

3 (2) NOTICE TO RECIPIENTS OF ASSISTANCE.—

4 In providing financial assistance using funds made
5 available in this Act, the head of each Federal agen-
6 ey shall provide to each recipient of the assistance
7 a notice describing the statement made in paragraph
8 (1) by the Congress.

9 (c) PROHIBITION OF CONTRACTS WITH PERSONS
10 FALSELY LABELING PRODUCTS AS MADE IN AMERICA.—

11 If it has been finally determined by a court or Federal
12 agency that any person intentionally affixed a label bear-
13 ing a “Made in America” inscription, or any inscription
14 with the same meaning, to any product sold in or shipped
15 to the United States that is not made in the United
16 States, the person shall be ineligible to receive any con-
17 tract or subcontract made with funds made available in
18 this Act, pursuant to the debarment, suspension, and ineli-
19 gibility procedures described in sections 9.400 through
20 9.409 of title 48, Code of Federal Regulations.

21 (d) EFFECTIVE DATE.—The provisions of this sec-
22 tion are applicable in fiscal year 2000 and thereafter.

23 SEC. 308. None of the funds in this Act may be used
24 to plan, prepare, or offer for sale timber from trees classi-
25 fied as giant sequoia (*Sequoiadendron giganteum*) which

1 are located on National Forest System or Bureau of Land
2 Management lands in a manner different than such sales
3 were conducted in fiscal year 2000.

4 SEC. 309. None of the funds made available by this
5 Act may be obligated or expended by the National Park
6 Service to enter into or implement a concession contract
7 which permits or requires the removal of the underground
8 lunchroom at the Carlsbad Caverns National Park.

9 SEC. 310. None of the funds appropriated or other-
10 wise made available by this Act may be used for the
11 AmeriCorps program, unless the relevant agencies of the
12 Department of the Interior and/or Agriculture follow ap-
13 propriate reprogramming guidelines: *Provided*, That if no
14 funds are provided for the AmeriCorps program by the
15 Departments of Veterans Affairs and Housing and Urban
16 Development, and Independent Agencies Appropriations
17 Act, 2001, then none of the funds appropriated or other-
18 wise made available by this Act may be used for the
19 AmeriCorps programs.

20 SEC. 311. None of the funds made available in this
21 Act may be used: (1) to demolish the bridge between Jer-
22 sey City, New Jersey, and Ellis Island; or (2) to prevent
23 pedestrian use of such bridge, when it is made known to
24 the Federal official having authority to obligate or expend

1 such funds that such pedestrian use is consistent with gen-
2 erally accepted safety standards.

3 SEC. 312. (a) LIMITATION OF FUNDS.—None of the
4 funds appropriated or otherwise made available pursuant
5 to this Act shall be obligated or expended to accept or
6 process applications for a patent for any mining or mill
7 site claim located under the general mining laws.

8 (b) EXCEPTIONS.—The provisions of subsection (a)
9 shall not apply if the Secretary of the Interior determines

11 filed with the Secretary on or before September 30, 1994;

20 (c) REPORT.—On September 30, 2001, the Secretary
21 of the Interior shall file with the House and Senate Com-

24 mittee on Energy and Natural Resources of the Senate
25 a report on actions taken by the Department under the

4 (d) MINERAL EXAMINATIONS.—In order to process
5 patent applications in a timely and responsible manner,
6 upon the request of a patent applicant, the Secretary of
7 the Interior shall allow the applicant to fund a qualified
8 third-party contractor to be selected by the Bureau of
9 Land Management to conduct a mineral examination of
10 the mining claims or mill sites contained in a patent appli-
11 cation as set forth in subsection (b). The Bureau of Land
12 Management shall have the sole responsibility to choose
13 and pay the third-party contractor in accordance with the
14 standard procedures employed by the Bureau of Land
15 Management in the retention of third-party contractors.

12 the Pacific Northwest, or the Jobs in the Woods Program

23 total cost of the facility exceeds \$500,000.

24 SEC. 316. All interests created under leases, conces-
25 sions, permits and other agreements associated with the

1 properties administered by the Presidio Trust, hereafter
2 shall be exempt from all taxes and special assessments of
3 every kind by the State of California and its political sub-
4 divisions.

5 SEC. 317. None of the funds made available in this
6 or any other Act for any fiscal year may be used to des-

7 SEC. 319. The National Endowment for the Arts and
8 the National Endowment for the Humanities are author-
9 ized to solicit, accept, receive, and invest in the name of
10 the United States, gifts, bequests, or devises of money and
11 other property or services and to use such in furtherance
12 of the functions of the National Endowment for the Arts
13 and the National Endowment for the Humanities. Any
14 proceeds from such gifts, bequests, or devises, after ac-
15 ceptance by the National Endowment for the Arts or the
16 National Endowment for the Humanities, shall be paid by
17 the donor or the representative of the donor to the Chair-
18 man. The Chairman shall enter the proceeds in a special

2 section 5 of the National Foundation on the Arts and Hu-

4 (1) the Chairperson shall establish a grant cat-

6 grams that are of national impact or availability or
7 are able to tour several States;

8 (2) the Chairperson shall not make grants ex-
9 ceeding 15 percent, in the aggregate, of such funds

5 in the Interior Columbia Basin Ecosystem study area; and
6 the White Mountain National Forest are exempt from this
7 section and may use funds in this Act and proceed to com-
8 plete the forest plan revision in accordance with current
9 forest planning regulations.

10 SEC. 322. No part of any appropriation contained in
11 this Act shall be expended or obligated to complete and
12 issue the 5-year program under the Forest and Rangeland
13 Renewable Resources Planning Act.

14 SEC. 323. None of the funds in this Act may be used
15 to support Government-wide administrative functions un-

3 SEC. 326. Amounts deposited during fiscal year 2000
4 in the roads and trails fund provided for in the fourteenth
5 paragraph under the heading "FOREST SERVICE" of
6 the Act of March 4, 1913 (37 Stat. 843; 16 U.S.C. 501),
7 shall be used by the Secretary of Agriculture, without re-

11 SEC. 328. Other than in emergency situations, none

13 answering machines during core business hours unless
14 such answering machines include an option that enables
15 callers to reach promptly an individual on-duty with the
16 agency being contacted.

17 SEC. 329. No timber sale in Region 10 shall be adver-
18 tised if the indicated rate is deficit when appraised under
19 the transaction evidence appraisal system using domestic
20 Alaska values for western red cedar: *Provided*, That sales
21 which are deficit when appraised under the transaction
22 evidence appraisal system using domestic Alaska values
23 for western red cedar may be advertised upon receipt of
24 a written request by a prospective, informed bidder, who
25 has the opportunity to review the Forest Service's cruise

1 and harvest cost estimate for that timber. Program accom-
2 plishments shall be based on volume sold. Should Region

13 ation of those specific activities for which self-determina-
14 tion and self-governance contracts, compacts and grants
15 currently exist or the renewal of contracts, compacts and

23 as set forth in chapter 6 of title 5, United States Code.

24 SEC. 335. None of the funds provided in this Act,
25 for the agencies funded by this Act, shall be expended for

1 the purposes of design, planning or management of Fed-
2 eral Lands as National Monuments that are designated
3 as National Monuments under the 1906 Antiquities Act,
4 since 1999.

3 *SEC. 106. Annual appropriations made in this title*
4 *shall be available for obligation in connection with con-*
5 *tracts issued for services or rentals for periods not in excess*
6 *of 12 months beginning at any time during the fiscal year.*

7 *SEC. 107. No funds provided in this title may be ex-*
8 *pende**d by the Department of the Interior for the conduct*
9 *of offshore leasing and related activities placed under re-*
10 *striction in the President’s moratorium statement of June*
11 *26, 1990, in the areas of northern, central, and southern*
12 *California; the North Atlantic; Washington and Oregon;*
13 *and the eastern Gulf of Mexico south of 26 degrees north*
14 *latitude and east of 86 degrees west longitude.*

15 *SEC. 108. No funds provided in this title may be ex-*
16 *pende**d by the Department of the Interior for the conduct*
17 *of offshore oil and natural gas preleasing, leasing, and re-*
18 *lated activities, on lands within the North Aleutian Basin*
19 *planning area.*

20 *SEC. 109. No funds provided in this title may be ex-*
21 *pende**d by the Department of the Interior to conduct offshore*
22 *oil and natural gas preleasing, leasing and related activi-*
23 *ties in the eastern Gulf of Mexico planning area for any*
24 *lands located outside Sale 181, as identified in the final*

1 *Outer Continental Shelf 5-Year Oil and Gas Leasing Pro-*
2 *gram, 1997–2002.*

3 *SEC. 110. No funds provided in this title may be ex-*
4 *pended by the Department of the Interior to conduct oil and*
5 *natural gas preleasing, leasing and related activities in the*
6 *Mid-Atlantic and South Atlantic planning areas.*

7 *SEC. 111. Advance payments made under this title to*
8 *Indian tribes, tribal organizations, and tribal consortia*
9 *pursuant to the Indian Self-Determination and Education*
10 *Assistance Act (25 U.S.C. 450 et seq.) or the Tribally Con-*
11 *trolled Schools Act of 1988 (25 U.S.C. 2501 et seq.) may*
12 *be invested by the Indian tribe, tribal organization, or con-*
13 *sortium before such funds are expended for the purposes of*
14 *the grant, compact, or annual funding agreement so long*
15 *as such funds are—*

16 *(1) invested by the Indian tribe, tribal organiza-*

3 *SEC. 115. Notwithstanding any provision of law, the*
4 *Secretary of the Interior is authorized to negotiate and*
5 *enter into agreements and leases, without regard to section*
6 *321 of chapter 314 of the Act of June 30, 1932 (40 U.S.C.*
7 *303b), with any person, firm, association, organization,*
8 *corporation, or governmental entity for all or part of the*
9 *property within Fort Baker administered by the Secretary*
10 *as part of Golden Gate National Recreation Area. The pro-*
11 *ceeds of the agreements or leases shall be retained by the*

2 *is composed of at least 25 individuals who are Natives (as*
3 *such term is defined in section 3(b) of the Alaska Native*
4 *Claims Settlement Act).*

5 *(b) Amounts that would have been made available for*
6 *tribal priority allocations in Alaska but for the limitation*
7 *contained in subsection (a) shall be provided to the respec-*
8 *tive Alaska Native regional nonprofit corporation (as listed*

7 *ondary Funding Formula adopted by the Office of Indian*

9 *that, after the corporate reorganization, holds entry permit*
10 *CP–GLBA004–00 each”.*

11 *SEC. 128. Notwithstanding any other provision of law,*
12 *the Secretary of the Interior shall designate Anchorage,*
13 *Alaska, as a port of entry for the purpose of section 9(f)(1)*
14 *of the Endangered Species Act of 1973 (16 U.S.C.*
15 *1538(f)(1)).*

16 *SEC. 129. (a) The first section of Public Law 92–501*
17 *(86 Stat. 904) is amended by inserting after the first sen-*
18 *tence “The park shall also include the land as generally de-*
19 *picted on the map entitled ‘subdivision of a portion of U.S.*
20 *Survey 407, Tract B, dated May 12, 2000’ ”.*

21 *(b) Section 3 of Public Law 92–501 is amended to read*
22 *as follows: “There are authorized to be appropriated such*
23 *sums as are necessary to carry out the terms of this Act.”.*

24 *SEC. 130. (a) All proceeds of Oil and Gas Lease sale*
25 *991, held by the Bureau of Land Management on May 5,*

16 *(3) the partial settlement was paid by the*

18 *\$82,000,000;*

19 *(4) the Judgment Fund was established to pay*
20 *for legal judgments awarded to plaintiffs who have*
21 *filed suit against the United States;*

22 *(5) the Contract Disputes Act of 1978 requires*
23 *that the Judgment Fund be reimbursed by the respon-*
24 *sible agency following the payment of an award from*
25 *the Fund; and*

1 (6) *the shortfall in contract support payments*
2 *found by the Court of Appeals for the 10th Circuit in*
3 *Ramah resulted primarily from the non-payment or*
4 *underpayment of indirect costs by agencies other than*
5 *the Bureau of Indian Affairs and the Indian Health*
6 *Service.*

7 (b) *SENSE OF THE SENATE.—It is the sense of the Sen-*
8 *ate that—*

9 (1) *repayment of the Judgment Fund for the*
10 *partial settlement in Ramah from the accounts of the*
11 *Bureau of Indian Affairs and Indian Health Service*
12 *would significantly reduce funds appropriated to ben-*
13 *efit tribes and individual Native Americans; and*

14 (2) *the Secretary of the Interior should work*

12 *line item in the fiscal year 2002 budget justification: Pro-*
13 *vided further, That of the amount available for vegetation*
14 *and watershed management, the Secretary may authorize*
15 *the expenditure or transfer of such sums as necessary to*
16 *the Department of the Interior, Bureau of Land Manage-*
17 *ment for removal, preparation, and adoption of excess wild*
18 *horses and burros from National Forest System lands: Pro-*
19 *vided further, That \$5,000,000 shall be allocated to the Alas-*
20 *ka Region, in addition to its normal allocation for the pur-*
21 *poses of preparing additional timber for sale, to establish*
22 *a 3-year timber supply and such funds may be transferred*
23 *to other appropriations accounts as necessary to maximize*
24 *accomplishment: Provided further, That of funds available*
25 *for Wildlife and Fish Habitat Management, \$400,000 shall*

2 *toring activities, and of the funds provided for Forest Prod-*
3 *ucts, \$700,000 shall be provided to the State of Alaska for*

7 *For an additional amount for emergency expenses re-*

5 *this Act for any consulting service through procurement*
6 *contract, pursuant to 5 U.S.C. 3109, shall be limited to*
7 *those contracts where such expenditures are a matter of pub-*
8 *lic record and available for public inspection, except where*
9 *otherwise provided under existing law, or under existing*
10 *Executive order issued pursuant to existing law.*

11 *SEC. 302. No part of any appropriation under this*
12 *Act shall be available to the Secretary of the Interior or*
13 *the Secretary of Agriculture for the leasing of oil and nat-*
14 *ural gas by noncompetitive bidding on publicly owned*
15 *lands within the boundaries of the Shawnee National For-*
16 *est, Illinois: Provided, That nothing herein is intended to*
17 *inhibit or otherwise affect the sale, lease, or right to access*
18 *to minerals owned by private individuals.*

19 *SEC. 303. No part of any appropriation contained in*
20 *this Act shall be available for any activity or the publica-*
21 *tion or distribution of literature that in any way tends to*
22 *promote public support or opposition to any legislative pro-*
23 *posal on which congressional action is not complete.*

1 *SEC. 304. No part of any appropriation contained in*
2 *this Act shall remain available for obligation beyond the*
3 *current fiscal year unless expressly so provided herein.*

4 *SEC. 305. None of the funds provided in this Act to*
5 *any department or agency shall be obligated or expended*
6 *to provide a personal cook, chauffeur, or other personal serv-*
7 *ants to any officer or employee of such department or agen-*
8 *cy except as otherwise provided by law.*

9 *SEC. 306. No assessments may be levied against any*
10 *program, budget activity, subactivity, or project funded by*
11 *this Act unless advance notice of such assessments and the*
12 *basis therefor are presented to the Committees on Appro-*
13 *priations and are approved by such committees.*

14 *SEC. 307. None of the funds in this Act may be used*
15 *to plan, prepare, or offer for sale timber from trees classified*
16 *as giant sequoia (*Sequoiadendron giganteum*) which are lo-*
17 *cated on National Forest System or Bureau of Land Man-*
18 *agement lands in a manner different than such sales were*
19 *conducted in fiscal year 2000.*

20 *SEC. 308. None of the funds made available by this*
21 *Act may be obligated or expended by the National Park*
22 *Service to enter into or implement a concession contract*
23 *which permits or requires the removal of the underground*
24 *lunchroom at the Carlsbad Caverns National Park.*

1 *SEC. 309. None of the funds appropriated or otherwise*
2 *made available by this Act may be used for the AmeriCorps*
3 *program, unless the relevant agencies of the Department of*
4 *the Interior and/or Agriculture follow appropriate re-*
5 *programming guidelines: Provided, That if no funds are*
6 *provided for the AmeriCorps program by the Departments*
7 *of Veterans Affairs and Housing and Urban Development,*
8 *and Independent Agencies Appropriations Act, 2001, then*
9 *none of the funds appropriated or otherwise made available*
10 *by this Act may be used for the AmeriCorps programs.*

11 *SEC. 310. None of the funds made available in this*
12 *Act may be used: (1) to demolish the bridge between Jersey*
13 *City, New Jersey, and Ellis Island; or (2) to prevent pedes-*
14 *trian use of such bridge, when it is made known to the Fed-*
15 *eral official having authority to obligate or expend such*
16 *funds that such pedestrian use is consistent with generally*
17 *accepted safety standards.*

18 *SEC. 311. (a) LIMITATION OF FUNDS.—None of the*
19 *funds appropriated or otherwise made available pursuant*
20 *to this Act shall be obligated or expended to accept or proc-*
21 *ess applications for a patent for any mining or mill site*
22 *claim located under the general mining laws.*

23 *(b) EXCEPTIONS.—The provisions of subsection (a)*
24 *shall not apply if the Secretary of the Interior determines*
25 *that, for the claim concerned: (1) a patent application was*

1 *filed with the Secretary on or before September 30, 1994;*
2 *and (2) all requirements established under sections 2325*
3 *and 2326 of the Revised Statutes (30 U.S.C. 29 and 30)*
4 *for vein or lode claims and sections 2329, 2330, 2331, and*
5 *2333 of the Revised Statutes (30 U.S.C. 35, 36, and 37)*
6 *for placer claims, and section 2337 of the Revised Statutes*
7 *(30 U.S.C. 42) for mill site claims, as the case may be,*
8 *were fully complied with by the applicant by that date.*

9 (c) *REPORT.*—*On September 30, 2001, the Secretary*
10 *of the Interior shall file with the House and Senate Com-*
11 *mittees on Appropriations and the Committee on Resources*
12 *of the House of Representatives and the Committee on En-*
13 *ergy and Natural Resources of the Senate a report on ac-*
14 *tions taken by the department under the plan submitted*
15 *pursuant to section 314(c) of the Department of the Interior*
16 *and Related Agencies Appropriations Act, 1997 (Public*
17 *Law 104–208).*

18 (d) *MINERAL EXAMINATIONS.*—*In order to process*
19 *patent applications in a timely and responsible manner,*
20 *upon the request of a patent applicant, the Secretary of the*
21 *Interior shall allow the applicant to fund a qualified third-*
22 *party contractor to be selected by the Bureau of Land Man-*
23 *agement to conduct a mineral examination of the mining*
24 *claims or mill sites contained in a patent application as*
25 *set forth in subsection (b). The Bureau of Land Manage-*

1 *ment shall have the sole responsibility to choose and pay*
2 *the third-party contractor in accordance with the standard*
3 *procedures employed by the Bureau of Land Management*
4 *in the retention of third-party contractors.*

5 *SEC. 312. Notwithstanding any other provision of law,*
6 *amounts appropriated to or earmarked in committee re-*
7 *ports for the Bureau of Indian Affairs and the Indian*
8 *Health Service by Public Laws 103–138, 103–332, 104–*
9 *134, 104–208, 105–83, 105–277, and 106–113 for payments*
10 *to tribes and tribal organizations for contract support costs*
11 *associated with self-determination or self-governance con-*
12 *tracts, grants, compacts, or annual funding agreements*
13 *with the Bureau of Indian Affairs or the Indian Health*
14 *Service as funded by such Acts, are the total amounts avail-*
15 *able for fiscal years 1994 through 2001 for such purposes,*
16 *except that, for the Bureau of Indian Affairs, tribes and*
17 *tribal organizations may use their tribal priority alloca-*
18 *tions for unmet indirect costs of ongoing contracts, grants,*
19 *self-governance compacts or annual funding agreements.*

20 *SEC. 313. Notwithstanding any other provision of law,*
21 *for fiscal year 2001 the Secretaries of Agriculture and the*
22 *Interior are authorized to limit competition for watershed*
23 *restoration project contracts as part of the “Jobs in the*
24 *Woods” component of the President’s Forest Plan for the*
25 *Pacific Northwest or the Jobs in the Woods Program estab-*

1 lished in Region 10 of the Forest Service to individuals and
2 entities in historically timber-dependent areas in the States
3 of Washington, Oregon, northern California and Alaska
4 that have been affected by reduced timber harvesting on
5 Federal lands.

6 SEC. 314. None of the funds collected under the Rec-
7 reational Fee Demonstration program may be used to plan,
8 design, or construct a visitor center or any other permanent
9 structure without prior approval of the House and the Sen-
10 ate Committees on Appropriations if the estimated total
11 cost of the facility exceeds \$500,000.

12 SEC. 315. All interests created under leases, conces-
13 sions, permits and other agreements associated with the
14 properties administered by the Presidio Trust shall be ex-
15 empt from all taxes and special assessments of every kind
16 by the State of California and its political subdivisions.

17 SEC. 316. None of the funds made available in this
18 or any other Act for any fiscal year may be used to des-
19 ignate, or to post any sign designating, any portion of Ca-
20 navaeral National Seashore in Brevard County, Florida, as
21 a clothing-optional area or as an area in which public nu-
22 dity is permitted, if such designation would be contrary to
23 county ordinance.

24 SEC. 317. Of the funds provided to the National En-
25 dowment for the Arts—

1 (1) *The Chairperson shall only award a grant to*
2 *an individual if such grant is awarded to such indi-*
3 *vidual for a literature fellowship, National Heritage*
4 *Fellowship, or American Jazz Masters Fellowship.*

5 (2) *The Chairperson shall establish procedures to*
6 *ensure that no funding provided through a grant, ex-*
7 *cept a grant made to a State or local arts agency, or*
8 *regional group, may be used to make a grant to any*
9 *other organization or individual to conduct activity*
10 *independent of the direct grant recipient. Nothing in*
11 *this subsection shall prohibit payments made in ex-*
12 *change for goods and services.*

13 (3) *No grant shall be used for seasonal support*
14 *to a group, unless the application is specific to the*
15 *contents of the season, including identified programs*
16 *and/or projects.*

17 *SEC. 318. The National Endowment for the Arts and*
18 *the National Endowment for the Humanities are authorized*
19 *to solicit, accept, receive, and invest in the name of the*
20 *United States, gifts, bequests, or devises of money and other*
21 *property or services and to use such in furtherance of the*
22 *functions of the National Endowment for the Arts and the*
23 *National Endowment for the Humanities. Any proceeds*
24 *from such gifts, bequests, or devises, after acceptance by the*
25 *National Endowment for the Arts or the National Endow-*

1 *ment for the Humanities, shall be paid by the donor or the*
2 *representative of the donor to the Chairman. The Chairman*
3 *shall enter the proceeds in a special interest-bearing account*
4 *to the credit of the appropriate endowment for the purposes*
5 *specified in each case.*

6 *SEC. 319. (a) In providing services or awarding finan-*
7 *cial assistance under the National Foundation on the Arts*
8 *and the Humanities Act of 1965 from funds appropriated*
9 *under this Act, the Chairperson of the National Endowment*
10 *for the Arts shall ensure that priority is given to providing*
11 *services or awarding financial assistance for projects, pro-*
12 *ductions, workshops, or programs that serve underserved*
13 *populations.*

14 *(b) In this section:*

15 *(1) The term “underserved population” means a*
16 *population of individuals, including urban minori-*
17 *ties, who have historically been outside the purview of*
18 *arts and humanities programs due to factors such as*
19 *a high incidence of income below the poverty line or*
20 *to geographic isolation.*

21 *(2) The term “poverty line” means the poverty*
22 *line (as defined by the Office of Management and*
23 *Budget, and revised annually in accordance with sec-*
24 *tion 673(2) of the Community Services Block Grant*

1 *Act (42 U.S.C. 9902(2))) applicable to a family of the*
2 *size involved.*

3 *(c) In providing services and awarding financial as-*
4 *sistance under the National Foundation on the Arts and*
5 *Humanities Act of 1965 with funds appropriated by this*
6 *Act, the Chairperson of the National Endowment for the*
7 *Arts shall ensure that priority is given to providing services*
8 *or awarding financial assistance for projects, productions,*
9 *workshops, or programs that will encourage public knowl-*
10 *edge, education, understanding, and appreciation of the*
11 *arts.*

12 *(d) With funds appropriated by this Act to carry out*
13 *section 5 of the National Foundation on the Arts and Hu-*
14 *manities Act of 1965—*

15 *(1) the Chairperson shall establish a grant cat-*
16 *egory for projects, productions, workshops, or pro-*
17 *grams that are of national impact or availability or*
18 *are able to tour several States;*

19 *(2) the Chairperson shall not make grants ex-*
20 *ceeding 15 percent, in the aggregate, of such funds to*
21 *any single State, excluding grants made under the*
22 *authority of paragraph (1);*

23 *(3) the Chairperson shall report to the Congress*
24 *annually and by State, on grants awarded by the*

1 *Chairperson in each grant category under section 5 of*
2 *such Act; and*

3 *(4) the Chairperson shall encourage the use of*
4 *grants to improve and support community-based*
5 *music performance and education.*

6 *SEC. 320. No part of any appropriation contained in*
7 *this Act shall be expended or obligated to fund new revisions*
8 *of national forest land management plans until new final*
9 *or interim final rules for forest land management planning*
10 *are published in the Federal Register. Those national forests*
11 *which are currently in a revision process, having formally*
12 *published a Notice of Intent to revise prior to October 1,*
13 *1997; those national forests having been court-ordered to re-*
14 *vis; those national forests where plans reach the 15 year*
15 *legally mandated date to revise before or during calendar*
16 *year 2001; national forests within the Interior Columbia*
17 *Basin Ecosystem study area; and the White Mountain Na-*
18 *tional Forest are exempt from this section and may use*
19 *funds in this Act and proceed to complete the forest plan*
20 *revision in accordance with current forest planning regula-*
21 *tions.*

22 *SEC. 321. No part of any appropriation contained in*
23 *this Act shall be expended or obligated to complete and issue*
24 *the 5-year program under the Forest and Rangeland Re-*
25 *newable Resources Planning Act.*

1 *SEC. 322. None of the funds in this Act may be used*
2 *to support Government-wide administrative functions un-*
3 *less such functions are justified in the budget process and*
4 *funding is approved by the House and Senate Committees*
5 *on Appropriations.*

6 *SEC. 323. Notwithstanding any other provision of law,*
7 *none of the funds in this Act may be used for GSA Tele-*
8 *communication Centers or the President's Council on Sus-*
9 *tainable Development.*

10 *SEC. 324. None of the funds in this Act may be used*
11 *for planning, design or construction of improvements to*
12 *Pennsylvania Avenue in front of the White House without*
13 *the advance approval of the House and Senate Committees*
14 *on Appropriations.*

15 *SEC. 325. Amounts deposited during fiscal year 2000*
16 *in the roads and trails fund provided for in the fourteenth*
17 *paragraph under the heading "FOREST SERVICE" of the*
18 *Act of March 4, 1913 (37 Stat. 843; 16 U.S.C. 501), shall*
19 *be used by the Secretary of Agriculture, without regard to*
20 *the State in which the amounts were derived, to repair or*
21 *reconstruct roads, bridges, and trails on National Forest*
22 *System lands or to carry out and administer projects to*
23 *improve forest health conditions, which may include the re-*
24 *pair or reconstruction of roads, bridges, and trails on Na-*
25 *tional Forest System lands in the wildland-community*

1 *interface where there is an abnormally high risk of fire. The*
2 *projects shall emphasize reducing risks to human safety and*
3 *public health and property and enhancing ecological func-*
4 *tions, long-term forest productivity, and biological integ-*
5 *riety. The Secretary shall commence the projects during fis-*
6 *cal year 2001, but the projects may be completed in a subse-*
7 *quent fiscal year. Funds shall not be expended under this*
8 *section to replace funds which would otherwise appro-*
9 *priately be expended from the timber salvage sale fund.*
10 *Nothing in this section shall be construed to exempt any*
11 *project from any environmental law.*

12 *SEC. 326. None of the funds provided in this or pre-*
13 *vious appropriations Acts for the agencies funded by this*
14 *Act or provided from any accounts in the Treasury of the*
15 *United States derived by the collection of fees available to*
16 *the agencies funded by this Act, shall be transferred to and*
17 *used to fund personnel, training, or other administrative*
18 *activities of the Council on Environmental Quality or other*
19 *offices in the Executive Office of the President for purposes*
20 *related to the American Heritage Rivers program.*

21 *SEC. 327. Other than in emergency situations, none*
22 *of the funds in this Act may be used to operate telephone*
23 *answering machines during core business hours unless such*
24 *answering machines include an option that enables callers*

1 to reach promptly an individual on-duty with the agency
2 being contacted.

3 SEC. 328. No timber sale in Region 10 shall be adver-
4 tised if the indicated rate is deficit when appraised under
5 the transaction evidence appraisal system using domestic
6 Alaska values for western red cedar: Provided, That sales
7 which are deficit when appraised under the transaction evi-
8 dence appraisal system using domestic Alaska values for
9 western red cedar may be advertised upon receipt of a writ-
10 ten request by a prospective, informed bidder, who has the
11 opportunity to review the Forest Service's cruise and har-
12 vest cost estimate for that timber. Program accomplish-
13 ments shall be based on volume sold. Should Region 10 sell,
14 in fiscal year 2001, the annual average portion of the
15 decadal allowable sale quantity called for in the current
16 Tongass Land Management Plan in sales which are not def-
17 icit when appraised under the transaction evidence ap-
18 praisal system using domestic Alaska values for western red
19 cedar, all of the western red cedar timber from those sales
20 which is surplus to the needs of domestic processors in Alas-
21 ka, shall be made available to domestic processors in the
22 contiguous 48 United States at prevailing domestic prices.
23 Should Region 10 sell, in fiscal year 2001, less than the
24 annual average portion of the decadal allowable sale quan-
25 tity called for in the current Tongass Land Management

1 *Plan in sales which are not deficit when appraised under*
2 *the transaction evidence appraisal system using domestic*
3 *Alaska values for western red cedar, the volume of western*
4 *red cedar timber available to domestic processors at pre-*
5 *vailing domestic prices in the contiguous 48 United States*
6 *shall be that volume: (i) which is surplus to the needs of*
7 *domestic processors in Alaska; and (ii) is that percent of*
8 *the surplus western red cedar volume determined by calcu-*
9 *lating the ratio of the total timber volume which has been*
10 *sold on the Tongass to the annual average portion of the*
11 *decadal allowable sale quantity called for in the current*
12 *Tongass Land Management Plan. The percentage shall be*
13 *calculated by Region 10 on a rolling basis as each sale is*
14 *sold (for purposes of this amendment, a “rolling basis” shall*
15 *mean that the determination of how much western red cedar*
16 *is eligible for sale to various markets shall be made at the*
17 *time each sale is awarded). Western red cedar shall be*
18 *deemed “surplus to the needs of domestic processors in Alas-*
19 *ka” when the timber sale holder has presented to the Forest*
20 *Service documentation of the inability to sell western red*
21 *cedar logs from a given sale to domestic Alaska processors*
22 *at price equal to or greater than the log selling value stated*
23 *in the contract. All additional western red cedar volume*
24 *not sold to Alaska or contiguous 48 United States domestic*
25 *processors may be exported to foreign markets at the election*

1 *of the timber sale holder. All Alaska yellow cedar may be*
2 *sold at prevailing export prices at the election of the timber*
3 *sale holder.*

4 *SEC. 329. None of the funds appropriated by this Act*
5 *shall be used to propose or issue rules, regulations, decrees,*
6 *or orders for the purpose of implementation, or in prepara-*
7 *tion for implementation, of the Kyoto Protocol which was*
8 *adopted on December 11, 1997, in Kyoto, Japan at the*
9 *Third Conference of the Parties to the United Nations*
10 *Framework Convention on Climate Change, which has not*
11 *been submitted to the Senate for advice and consent to rati-*
12 *fication pursuant to article II, section 2, clause 2, of the*
13 *United States Constitution, and which has not entered into*
14 *force pursuant to article 25 of the Protocol.*

15 *SEC. 330. The Forest Service, in consultation with the*
16 *Department of Labor, shall review Forest Service camp-*
17 *ground concessions policy to determine if modifications can*
18 *be made to Forest Service contracts for campgrounds so that*
19 *such concessions fall within the regulatory exemption of 29*
20 *CFR 4.122(b). The Forest Service shall offer in fiscal year*
21 *2001 such concession prospectuses under the regulatory ex-*
22 *emption, except that, any prospectus that does not meet the*
23 *requirements of the regulatory exemption shall be offered as*
24 *a service contract in accordance with the requirements of*
25 *41 U.S.C. 351–358.*

1 *SEC. 331. A project undertaken by the Forest Service*
2 *under the Recreation Fee Demonstration Program as au-*
3 *thorized by section 315 of the Department of the Interior*
4 *and Related Agencies Appropriations Act for Fiscal Year*
5 *1996, as amended, shall not result in—*

6 (1) *displacement of the holder of an authoriza-*
7 *tion to provide commercial recreation services on Fed-*
8 *eral lands. Prior to initiating any project, the Sec-*
9 *retary shall consult with potentially affected holders*
10 *to determine what impacts the project may have on*
11 *the holders. Any modifications to the authorization*
12 *shall be made within the terms and conditions of the*
13 *authorization and authorities of the impacted agency.*

14 (2) *the return of a commercial recreation service*
15 *to the Secretary for operation when such services have*
16 *been provided in the past by a private sector pro-*
17 *vider, except when—*

18 (A) *the private sector provider fails to bid*
19 *on such opportunities;*

20 (B) *the private sector provider terminates*
21 *its relationship with the agency; or*

22 (C) *the agency revokes the permit for non-*
23 *compliance with the terms and conditions of the*
24 *authorization.*

1 *In such cases, the agency may use the Recreation Fee Dem-*
2 *onstration Program to provide for operations until a subse-*
3 *quent operator can be found through the offering of a new*
4 *prospectus.*

5 *SEC. 332. Section 801 of the National Energy Con-*
6 *servation Policy Act (42 U.S.C. 8287(a)(2)(D)(iii)) is*
7 *amended by striking “\$750,000” and inserting*
8 *“\$10,000,000”.*

9 *SEC. 333. From the funds appropriated in Title V of*
10 *Public Law 105–83 for the purposes of section 502(e) of*
11 *that Act, the following amounts are hereby rescinded:*
12 *\$1,000,000 for snow removal and pavement preservation*
13 *and \$4,000,000 for pavement rehabilitation.*

14 *SEC. 334. In section 315(f) of Title III of Section*
15 *101(c) of Public Law 104–134 (16 U.S.C. 460l–6a note),*
16 *as amended, strike “September 30, 2001” and insert “Sep-*
17 *tember 30, 2002”, and strike “September 30, 2004” and in-*
18 *sert “September 30, 2005”.*

19 *SEC. 335. None of the funds in this Act may be used*
20 *by the Secretary of the Interior to issue a prospecting per-*
21 *mit for hardrock mineral exploration on Mark Twain Na-*
22 *tional Forest land in the Current River/Jack’s Fork*
23 *River—Eleven Point Watershed (not including Mark*
24 *Twain National Forest land in Townships 31N and 32N,*
25 *Range 2 and Range 3 West, on which mining activities are*

1 *taking place as of the date of the enactment of this Act):*
2 *Provided, That none of the funds in this Act may be used*
3 *by the Secretary of the Interior to segregate or withdraw*
4 *land in the Mark Twain National Forest, Missouri under*
5 *section 204 of the Federal Land Policy and Management*
6 *Act of 1976 (43 U.S.C. 1714).*

7 *SEC. 336. The authority to enter into stewardship and*
8 *end result contracts provided to the Forest Service in ac-*
9 *cordance with Section 347 of Title III of Section 101(e)*
10 *of Division A of Public Law 105–825 is hereby expanded*
11 *to authorize the Forest Service to enter into an additional*
12 *28 contracts subject to the same terms and conditions as*
13 *provided in that section: Provided, That of the additional*
14 *contracts authorized by this section at least 9 shall be allo-*
15 *cated to Region 1 and at least 3 to Region 6.*

16 *SEC. 337. Any regulations or policies promulgated or*
17 *adopted by the Departments of Agriculture or the Interior*
18 *regarding recovery of costs for processing authorizations to*
19 *occupy and use Federal lands under their control shall ad-*
20 *here to and incorporate the following principle arising from*
21 *Office of Management and Budget Circular, A–25; no*
22 *charge should be made for a service when the identification*
23 *of the specific beneficiary is obscure, and the service can*
24 *be considered primarily as benefiting broadly the general*
25 *public.*

1 *SEC. 338. LOCAL EXEMPTIONS FROM FOREST SERV-*
2 *ICE DEMONSTRATION PROGRAM FEES. Section 6906 of Title*
3 *31, United States Code, is amended—*

4 (1) *by inserting “(a) IN GENERAL.—” before*
5 *“Necessary”; and*

6 (2) *by adding at the end the following:*

7 *“(b) LOCAL EXEMPTIONS FROM DEMONSTRATION*
8 *PROGRAM FEES.—*

9 *“(1) IN GENERAL.—Each unit of general local*
10 *government that lies in whole or in part within the*
11 *White Mountain National Forest and persons residing*
12 *within the boundaries of that unit of general local*
13 *government shall be exempt during that fiscal year*
14 *from any requirement to pay a Demonstration Pro-*
15 *gram Fee (parking permit or passport) imposed by*
16 *the Secretary of Agriculture for access to the Forest.*

17 *“(2) ADMINISTRATION.—The Secretary of Agri-*
18 *culture shall establish a method of identifying persons*
19 *who are exempt from paying user fees under para-*
20 *graph (1). This method may include valid form of*
21 *identification including a drivers license.”.*

22 *SEC. 339. None of the funds made available in this*
23 *or any other Act may be used by the Bureau of Land Man-*
24 *agement or the U.S. Forest Service to assess, appraise, de-*
25 *termine, proceed to determine, or collect rents for right-of-*

1 way uses for federal lands except as such rents have been
2 or may be determined in accordance with the linear fee
3 schedule published on July 8, 1997 ([43 CFR 2803.1–
4 2(c)(1)(i)]).

5 *SEC. 340. Notwithstanding any other provision of law,*
6 *for fiscal year 2001, the Secretary of Agriculture is author-*
7 *ized to limit competition for fire and fuel treatment and*
8 *watershed restoration contracts in the Giant Sequoia Na-*
9 *tional Monument and the Sequoia National Forest. Pref-*
10 *erence for employment shall be given to dislocated and dis-*
11 *placed workers in Tulare, Kern and Fresno Counties, Cali-*
12 *fornia, for work associated with the establishment of the Se-*
13 *quoia National Monument.*

14 *SEC. 341. The Chief of the Forest Service, in consulta-*
15 *tion with the Administrator of the Small Business Admin-*
16 *istration, shall prepare a regulatory flexibility analysis, in*
17 *accordance with chapter 6 of part I of title 5, United States*
18 *Code, of the impact of the White River National Forest Plan*
19 *on communities that are within the boundaries of the White*
20 *River National Forest.*

21 *SEC. 342. None of the funds appropriated or otherwise*
22 *made available by this Act may be used to finalize or imple-*
23 *ment the published roadless area conservation rule of the*
24 *Forest Service published on May 10, 2000 (36 Fed. Reg.*

1 30276, 30288), or any similar rule, in any inventoried
2 roadless area in the White Mountain National Forest.

3 SEC. 343. From funds previously appropriated in
4 Public Law 105–277, under the heading “Department of
5 Energy, Fossil Energy Research and Development”, the
6 Secretary of Energy shall make available within 30 days
7 after enactment of this Act \$750,000 for the purpose of exe-
8 cuting proposal #FT40770.

9 SEC. 344. (a) In addition to any amounts otherwise
10 made available under this Act to carry out the Tribally
11 Controlled College or University Assistance Act of 1978,
12 \$1,891,000 is appropriated to carry out such Act for fiscal
13 year 2001.

14 (b) Notwithstanding any other provision of this Act,
15 the amount of funds provided to a Federal agency that re-
16 ceives appropriations under this Act in an amount greater
17 than \$20,000,000 shall be reduced, on a pro rata basis, by
18 an amount equal to the percentage necessary to achieve an
19 aggregate reduction of \$1,891,000 in funds provided to all
20 such agencies under this Act. Each head of a Federal agency

10 *diately available from unobligated balances for computa-*
11 *tional services at the National Energy Technology Labora-*

13 *SEC. 346. None of the funds made available in this*
14 *Act may be used to publish Class III gaming procedures*
15 *under part 291 of title 25, Code of Federal Regulations.*

16 *SEC. 347. Of the funds appropriated in title I of this*
17 *Act, the Secretary shall provide \$300,000 in the form of*
18 *a grant to the Alaska Pacific University’s Institute of the*
19 *North for the development of a curriculum on the Alaska*
20 *National Interest Lands Conservation Act (ANILCA). At*
21 *a minimum this ANILCA curriculum should contain com-*
22 *ponents which explain the law, its legislative history, the*
23 *subsequent amendments, and the principal case studies on*
24 *issues that have risen during 20 years of implementation*
25 *of the Act; examine challenges faced by conservation system*

1 *managers in implementing the Act; and link ANILCA to*

11 *SEC. 348. BACKCOUNTRY LANDING STRIP ACCESS. (a)*

15 *(b) AIRCRAFT LANDING STRIPS.—An aircraft landing*
16 *strip referred to in subsection (a) is a landing strip on Fed-*
17 *eral land administered by the Secretary of the Interior or*
18 *the Secretary of Agriculture that is commonly known and*
19 *has been or is consistently used for aircraft landing and*
20 *departure activities.*

21 *(c) PERMANENT CLOSURE.—For the purposes of sub-*
22 *section (a), an aircraft landing strip shall be considered*
23 *to be closed permanently if the intended duration of the clo-*
24 *sure is more than 180 days in any calendar year.*

1 *SEC. 349. PROHIBITION ON USE OF FUNDS FOR AP-*
2 *PLICATION OF UNAPPROVED PESTICIDES IN CERTAIN*
3 *AREAS THAT MAY BE USED BY CHILDREN. (a) DEFINITION*
4 *OF PESTICIDE.—In this section, the term “pesticide” has*
5 *the meaning given the term in section 2 of the Federal In-*
6 *secticide, Fungicide, and Rodenticide Act (7 U.S.C. 136).*

7 *(b) PROHIBITION ON USE OF FUNDS.—None of the*
8 *funds appropriated under this Act may be used for the ap-*
9 *plication of a pesticide that is not approved for use by the*
10 *Environmental Protection Agency in any area owned or*
11 *managed by the Department of the Interior that may be*
12 *used by children, including any national park.*

13 *(c) COORDINATION.—The Secretary of the Interior*
14 *shall coordinate with the Administrator of the Environ-*
15 *mental Protection Agency to ensure that the methods of pest*
16 *control used by the Department of the Interior do not lead*
17 *to unacceptable exposure of children to pesticides.*

19 *quirement pursuant to section 251(b)(2)(A) of the Balanced*
20 *Budget and Emergency Deficit Control Act of 1985, as*
21 *amended: Provided further, That the entire amount shall*
22 *be available only to the extent an official budget request,*
23 *that includes designation of the entire amount of the request*
24 *as an emergency requirement as defined by such Act, is*

1 *transmitted by the President to the Congress: Provided fur-*
2 *ther, That:*

3 (1) *In expending the funds provided in any Act*
4 *with respect to any fiscal year for hazardous fuels re-*
5 *duction, the Secretary of the Interior and the Sec-*
6 *retary of Agriculture may hereafter conduct fuel re-*
7 *duction treatments on Federal lands using all con-*
8 *tracting and hiring authorities available to the Secre-*
9 *taries. Notwithstanding Federal Government procure-*
10 *ment and contracting laws, the Secretaries may here-*
11 *after conduct fuel reduction treatments on Federal*
12 *lands using grants and cooperative agreements. Not-*
13 *withstanding Federal Government procurement and*
14 *contracting laws, in order to provide employment and*

14 (B) an identification of communities

7 *Fire-Adapted Ecosystems, and an explanation of any*
8 *differences between the Cohesive Strategy and other*
9 *related ongoing policymaking activities including:*
10 *Proposed regulations revising the National Forest*
11 *System transportation policy; proposed roadless area*
12 *protection regulations; the Interior Columbia Basin*
13 *Draft Supplemental Environmental Impact State-*
14 *ment; and the Sierra Nevada Framework/Sierra Ne-*
