AN ACT

Making appropriations for the Department of the Interior and related agencies for the fiscal year ending September 30, 2001, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 That the following sums are appropriated, out of any
- 4 money in the Treasury not otherwise appropriated, for the
- 5 Department of the Interior and related agencies for the
- 6 fiscal year ending September 30, 2001, and for other pur-
- 7 poses, namely:

8 TITLE I—DEPARTMENT OF THE INTERIOR

- 9 Bureau of Land Management
- 10 management of Lands and resources
- 11 For expenses necessary for protection, use, improve-
- 12 ment, development, disposal, cadastral surveying, classi-
- 13 fication, acquisition of easements and other interests in
- 14 lands, and performance of other functions, including
- 15 maintenance of facilities, as authorized by law, in the
- 16 management of lands and their resources under the juris-
- 17 diction of the Bureau of Land Management, including
- 18 the general administration of the Bureau, and assessment
- 19 of mineral potential of public lands pursuant to Public
- 20 Law 96-487 (16 U.S.C. 3150(a)), \$674,571,000 (re-
- 21 duced by \$4,000,000), to remain available until ex-
- 22 pended, of which \$2,198,000 shall be available for assess-
- 23 ment of the mineral potential of public lands in Alaska
- 24 pursuant to section 1010 of Public Law 96-487 (16
- 25 U.S.C. 3150); and of which not to exceed \$1,000,000

- shall be derived from the special receipt account established by the Land and Water Conservation Act of 1965, as amended (16 U.S.C. 460l-6a(i)); and of which 3 4 \$2,500,000 shall be available in fiscal year 2001 subject to a match by at least an equal amount by the National Fish and Wildlife Foundation, to such Foundation for cost-shared projects supporting conservation of Bureau 8 lands and such funds shall be advanced to the Foundation as a lump sum grant without regard to when expenses are incurred; in addition, \$33,366,000 for Mining Law Administration program operations, including the cost of administering the mining claim fee program; to remain available until expended, to be reduced by amounts collected by the Bureau and credited to this appropriation from annual mining claim fees so as to result
- 18 expended, from communication site rental fees estab19 lished by the Bureau for the cost of administering com20 munication site activities: *Provided*, That appropriations

in a final appropriation estimated at not more than

\$674,571,000, and \$2,000,000, to remain available until

- 21 herein made shall not be available for the destruction of
- 22 healthy, unadopted, wild horses and burros in the care of
- 23 the Bureau or its contractors.

1 WILDLAND FIRE MANAGEMENT

2	For necessary expenses for fire preparedness, sup-
3	pression operations, emergency rehabilitation and haz-
4	ardous fuels reduction by the Department of the Interior,
5	\$292,197,000, to remain available until expended, of
6	which not to exceed \$9,300,000 shall be for the renovation
7	or construction of fire facilities: Provided, That such funds
8	are also available for repayment of advances to other ap-
9	propriation accounts from which funds were previously
10	transferred for such purposes: Provided further, That un-
11	obligated balances of amounts previously appropriated to
12	the "Fire Protection" and "Emergency Department of the
13	Interior Firefighting Fund" may be transferred and
14	merged with this appropriation: Provided further, That
15	persons hired pursuant to 43 U.S.C. 1469 may be fur-
16	nished subsistence and lodging without cost from funds
17	available from this appropriation: Provided further, That
18	notwithstanding 42 U.S.C. 1856d, sums received by a bu-
19	reau or office of the Department of the Interior for fire
20	protection rendered pursuant to 42 U.S.C. 1856 et seq.,
21	protection of United States property, may be credited to
22	the appropriation from which funds were expended to pro-
23	vide that protection, and are available without fiscal year
24	limitation.

1 CENTRAL HAZARDOUS MATERIALS FUND

2 For necessary expenses of the Department of the Interior and any of its component offices and bureaus for 3 the remedial action, including associated activities, of haz-4 5 ardous waste substances, pollutants, or contaminants pursuant to the Comprehensive Environmental Response, Compensation, and Liability Act, as amended (42 U.S.C. 8 9601 et seq.), \$10,000,000, to remain available until expended: Provided, That notwithstanding 31 U.S.C. 3302, 10 sums recovered from or paid by a party in advance of or as reimbursement for remedial action or response activities conducted by the Department pursuant to section 107 or 113(f) of such Act, shall be credited to this account to be available until expended without further appropriation: Provided further, That such sums recovered from or paid by any party are not limited to monetary payments and may include stocks, bonds or other personal or real property, which may be retained, liquidated, or otherwise disposed of by the Secretary and which shall be credited to this account. 20

21 CONSTRUCTION

For construction of buildings, recreation facilities, 23 roads, trails, and appurtenant facilities, \$5,300,000 (re24 duced by \$1,000,000 and increased by \$1,000,000), to re25 main available until expended.

1	PAYMENTS IN LIEU OF TAXES
2	For expenses necessary to implement the Act of Octo-
3	ber 20, 1976, as amended (31 U.S.C. 6901–6907),
4	\$134,385,000 (increased by \$10,000,000), of which not
5	to exceed \$400,000 shall be available for administrative
6	expenses: Provided, That no payment shall be made to oth-
7	erwise eligible units of local government if the computed
8	amount of the payment is less than \$100.
9	LAND ACQUISITION
10	For expenses necessary to carry out sections 205,
11	206, and 318(d) of Public Law 94–579, including admin-
12	istrative expenses and acquisition of lands or waters, or
13	interests therein, $$19,000,000$ (reduced by $$3,000,000$
14	and increased by \$3,000,000), to be derived from the
15	Land and Water Conservation Fund, to remain available
16	until expended.
17	OREGON AND CALIFORNIA GRANT LANDS
18	For expenses necessary for management, protection,
19	and development of resources and for construction, oper-
20	ation, and maintenance of access roads, reforestation, and
21	other improvements on the revested Oregon and California
22	Railroad grant lands, on other Federal lands in the Or-
23	egon and California land-grant counties of Oregon, and
24	on adjacent rights-of-way; and acquisition of lands or in-
25	terests therein including existing connecting roads on or

- 1 adjacent to such grant lands, \$100,467,000, to remain
- 2 available until expended: Provided, That 25 percent of the
- 3 aggregate of all receipts during the current fiscal year
- 4 from the revested Oregon and California Railroad grant
- 5 lands is hereby made a charge against the Oregon and
- 6 California land-grant fund and shall be transferred to the
- 7 General Fund in the Treasury in accordance with the sec-
- 8 ond paragraph of subsection (b) of title H of the Act of

- 10 FOREST ECOSYSTEMS HEALTH AND RECOVERY FUND
- 11 (REVOLVING FUND, SPECIAL ACCOUNT)
- 12 In addition to the purposes authorized in Public Law
- 13 102-381, funds made available in the Forest Ecosystem
- 14 Health and Recovery Fund can be used for the purpose
- 15 of planning, preparing, and monitoring salvage timber
- 16 sales and forest ecosystem health and recovery activities
- 17 such as release from competing vegetation and density
- 18 control treatments. The Federal share of receipts (defined)
- 19 as the portion of salvage timber receipts not paid to the
- 20 counties under 43 U.S.C. 1181f and 43 U.S.C. 1181-1
- 21 et seq., and Public Law 103-66) derived from treatments
- 22 funded by this account shall be deposited into the Forest

22	nation of facilities in conjunction with use authorizations.
23	and for rehabilitation of damaged property, such amounts
24	as may be collected under Public Law 94–579, as amend-
25	ed and Public Law 93-153 to remain available until ex-

24	For necessary expenses of the United States Fish and
25	Wildlife Service, for scientific and economic studies, con-

servation, management, investigations, protection, and utilization of fishery and wildlife resources, except whales, seals, and sea lions, maintenance of the herd of long-3 horned cattle on the Wichita Mountains Wildlife Refuge, 4 5 general administration, and for the performance of other authorized functions related to such resources by direct expenditure, contracts, grants, cooperative agreements 8 and reimbursable agreements with public and private entities, \$731,400,000, to remain available until September 10 30, 2002, except as otherwise provided herein, of which not less than \$2,000,000 shall be provided to local governments in southern California for planning associated with the Natural Communities Conservation Planning (NCCP) program and shall remain available until expended: Pro-15 vided, That not less than \$2,000,000 for high priority projects which shall be carried out by the Youth Conservation Corps as authorized by the Act of August 13, 1970, as amended: Provided further, That not to exceed 18 \$6,395,000 shall be used for implementing subsections 19 (a), (b), (c), and (e) of section 4 of the Endangered Speeies Act, as amended, for species that are indigenous to 21 the United States (except for processing petitions, developing and issuing proposed and final regulations, and taking any other steps to implement actions described in subsection (e)(2)(A), (e)(2)(B)(i), or (e)(2)(B)(ii): Provided

- 8 Cooperative Endangered Species Conservation Fund, to
- 9 remain available until expended.
- 10 NATIONAL WILDLIFE REFUGE FUND
- 11 For expenses necessary to implement the Act of Octo-
- 12 ber 17, 1978 (16 U.S.C. 715s), \$10,439,000.
- 13 NORTH AMERICAN WETLANDS CONSERVATION FUND
- 14 For expenses necessary to earry out the provisions
- 15 of the North American Wetlands Conservation Act, Public
- 16 Law 101–233, as amended, \$15,499,000, to remain avail-
- 17 able until expended.
- 18 WILDLIFE CONSERVATION AND APPRECIATION FUND
- 19 For necessary expenses of the Wildlife Conservation
- 20 and Appreciation Fund, \$797,000, to remain available
- 21 until expended.
- 22 <u>MULTINATIONAL SPECIES CONSERVATION FUND</u>
- For expenses necessary to earry out the African Ele-
- 24 phant Conservation Act (16 U.S.C. 4201-4203, 4211-
- 25 4213, 4221–4225, 4241–4245, and 1538), the Asian Ele-

- 1 phant Conservation Act of 1997 (Public Law 105–96; 16
- 2 U.S.C. 4261–4266), and the Rhinoceros and Tiger Con-

21	For expenses necessary for the management, oper-
22	ation, and maintenance of areas and facilities adminis-
23	tered by the National Park Service (including special road
24	maintenance service to trucking permittees on a reimburs-
25	able basis), and for the general administration of the Na-

- 1 tional Park Service, including not less than \$2,000,000
- 2 for high priority projects within the scope of the approved
- 3 budget which shall be carried out by the Youth Conserva-
- 4 tion Corps as authorized by 16 U.S.C. 1706,
- 5 \$1,425,617,000 (increased by \$10,000,000) (increased by
- 6 \$66,500,000), of which \$8,727,000 for research, planning

- 22 HISTORIC PRESERVATION FUND
- 23 For expenses necessary in earrying out the Historie
- 24 Preservation Act of 1966, as amended (16 U.S.C. 470),

- 17 For expenses necessary to earry out the Land and
- 18 Water Conservation Act of 1965, as amended (16 U.S.C.
- 19 460l-4 through 11), including administrative expenses,
- 20 and for acquisition of lands or waters, or interest therein,
- 21 in accordance with the statutory authority applicable to
- 22 the National Park Service, \$65,000,000 (increased by
- 23 \$10,000,000) (increased by \$20,000,000), to be derived
- 24 from the Land and Water Conservation Fund, to remain
- 25 available until expended, of which \$21,000,000 (increased

by \$10,000,000) is for the State assistance program ineluding \$1,000,000 to administer the program, and of which \$10,000,000 may be for State grants for land acqui-4 sition in the State of Florida: Provided, That the \$20,000,000 (increased by \$10,000,000) provided for grants in the State assistance program shall be used solely to acquire land for State and local parks for the benefit 8 of outdoor recreation: Provided further, That the Secretary may provide Federal assistance to the State of Florida for 10 the acquisition of lands or waters, or interests therein, within the Everglades watershed (consisting of lands and waters within the boundaries of the South Florida Water Management District, Florida Bay and the Florida Keys, and excluding the Eight and One-Half Square Mile Area) under terms and conditions deemed necessary by the Secretary to improve and restore the hydrological function of the Everglades watershed: Provided further, That funds provided under this heading for assistance to the State of Florida to acquire lands within the Everglades watershed are contingent upon new matching non-Federal funds by the State and shall be subject to an agreement that the lands to be acquired will be managed in perpetuity for the restoration of the Everglades.

14	not be implemented prior to the expiration of 30 calendar

- 4 ployee safety, and to encourage employees receiving work-
- 5 ers' compensation benefits pursuant to chapter 81 of title
- 6 5, United States Code, to return to appropriate positions
- 7 for which they are medically able.
- 8 United States Geological Survey
- 9 SURVEYS, INVESTIGATIONS, AND RESEARCH
- 10 For expenses necessary for the United States Geo-
- 11 logical Survey to perform surveys, investigations, and re-
- 12 search covering topography, geology, hydrology, biology,
- 13 and the mineral and water resources of the United States,
- 14 its territories and possessions, and other areas as author-
- 15 ized by 43 U.S.C. 31, 1332, and 1340; classify lands as
- 16 to their mineral and water resources; give engineering su-
- 17 pervision to power permittees and Federal Energy Regu-
- 18 latory Commission licensees; administer the minerals ex-
- 19 ploration program (30 U.S.C. 641); and publish and dis-
- 20 seminate data relative to the foregoing activities; and to
- 21 conduct inquiries into the economic conditions affecting
- 22 mining and materials processing industries (30 U.S.C. 3,
