2018 FSA County Committee Elections What is a County Committee?

- Authorized by Congress in 1930s.
- Critical component of the day-to-day operations of FSA.
- More than 7,700
 committee members
 serve on more than
 2,200 committees
 nationwide.











2018 FSA County Committee Elections Role of County Committee Members

- Help area farmers, ranchers and foresters.
- Deliver federal programs locally.











2018 FSA County Committee Elections Why Are County Committees Important?

Make Decisions on:

- Price support loans& payments
- Acreage verification
- Conservation programs
- Incentive, indemnity& disasterpayments
- Payment eligibility







2018 FSA County Committee Elections Duties of the County Committee

- Inform farmers of the purpose and provisions of FSA programs.
- Keep the State FSA
 Committee informed of local administrative area (LAA) conditions.
- Monitor changes in farm programs.











2018 FSA County Committee Elections Duties of the County Committee Continued...

- Participate in monthly meetings.
- Make recommendations to State Committee on existing programs.
- Ensure underserved farmers and ranchers are fairly represented.











2018 FSA County Committee Elections Get Involved

USDA encourages <u>all</u> eligible farmers, ranchers and foresters to participate in the county committee election process.











2018 FSA County Committee Elections Who serves on County Committees?

To hold office as a COC member or alternate, a person must fulfill <u>each</u> requirement:

- ✓ Be a producer with an interest in farming or ranching operations
- ✓ Participate or cooperate in any FSA program provided for by law
- ✓ Be a U.S. Citizen
- ✓ Be of legal voting age
- ✓ Meet the basic eligibility requirements
- ✓ Reside in the county or multi-county jurisdiction in which they will be serving.



2018 FSA County Committee Elections Committee Basics

- 3 to 11 Members
- 3-year Terms
- Advisors appointed annually to represent women and minority interests









2018 FSA County Committee Elections Role of the Advisor

Officially appointed by the FSA state committee based on county committee or community-based organizations recommendations.



Appointed to county committees in counties or multi-county jurisdictions that have significant numbers of underserved producers, but lack such members on FSA county committee.

Provide diverse viewpoints and represent the interests of underserved communities in the decisions made by the County Committee.

2018 FSA County Committee Elections Who can Vote?

- Be of legal voting age and have an interest in a farm or ranch as either:
 - > An individual who meets one or more of the following:
 - ☐ Is eligible to vote in one's own right
 - □ Is a partner of a general partnership
 - ☐ Is a member of a joint venture



2018 FSA County Committee Elections Who can Vote? Continued...

- Be of legal voting age and have an interest in a farm or ranch as either:
 - ➤ A non-individual who is the authorized representative of a legal entity, such as:
 - □A corporation, estate, trust, limited partnership or other business enterprise, excluding general partnership and joint ventures
 - ☐ A state, political subdivision of a state or any state agency. (only the designated representative may cast a vote for the entity)



2018 FSA County Committee Elections Who can Vote? Continued...

<u>OR</u>

2. Not of legal voting age, but supervises and conducts the farming operations of an entire farm.

<u>AND</u>

3. Participates or cooperates in an FSA program that is provided by law.

2018 FSA County Committee Elections County Committee Elections 2018 Timeline

- June 15, 2018 Nomination period begins.
 Request nomination forms from any local USDA
 Service Center or obtain online at www.fsa.usda.gov/elections.
- Aug. 1, 2018 Last day to file nomination forms at the local USDA Service Center.

2018 FSA County Committee Elections County Committee Elections 2018 Timeline Continued...

- Nov. 5, 2018 Ballots mailed to eligible voters.
- Dec. 3, 2018 Last day to return voted ballots to the USDA Service Center.
- Jan. 1, 2019 Newly elected county committee members take office.
