A BILL

To amend the Wilderness Act to authorize U.S. Customs and Border Protection to conduct certain activities to secure the international land borders of the United States, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 *This Act may be cited as the “Securing Our Borders*
5 *and Wilderness Act”.*

6 **SEC. 2. U.S. CUSTOMS AND BORDER PROTECTION ACCESS**
7 **TO WILDERNESS AREAS.**

8 *Section 4(d) of the Wilderness Act is amended by add-*
9 *ing at the end the following:*

10 *“(8) U.S. CUSTOMS AND BORDER PROTECTION*
11 *ACCESS.—*

12 *“(A) PERMISSIBLE ACTIVITIES.—Notwith-*
13 *standing any other provision of this Act, the*
14 *Commissioner of U.S. Customs and Border Pro-*
15 *tection may conduct the following activities*
16 *within a wilderness area for the purpose of se-*
17 *curing the international land borders of the*
18 *United States:*

19 *“(i) Access structures, installations,*
20 *and roads.*

21 *“(ii) Execute search and rescue oper-*
22 *ations.*

23 *“(iii) Use motor vehicles, motorboats,*
24 *and motorized equipment.*

1 “(iv) *Conduct patrols on foot and on*
2 *horseback.*

3 “(v) *Notwithstanding any other law or*
4 *regulation relating specifically to use of air-*
5 *craft in a wilderness area or in the airspace*
6 *above a wilderness area, use aircraft, in-*
7 *cluding approach, landing, and takeoff.*

8 “(vi) *Deploy tactical infrastructure*
9 *and technology.*

10 “(vii) *Construct and maintain roads*
11 *and physical barriers.*

12 “(B) *PROTECTION OF WILDERNESS CHAR-*
13 *ACTER.—Any activity conducted by the Commis-*
14 *sioner of U.S. Customs and Border Protection*
15 *under subparagraph (A) shall be carried out in*
16 *a manner that, to the greatest extent possible,*
17 *protects the wilderness character of the area.”.*
